Comparing counts for April 30, 1999 with those on April 30, 1998, the following changes are noted:

**RESIDENTS**

10% increase	from	28,354	to	31,251	for the jurisdictional population; (state inmates in county facilities, prison and youth complexes);
60% increase	from	2,933	to	4,690	for state inmates in county facilities;
6% increase	from	20,618	to	21,826	for the prison complex;
-1% decrease	from	4,803	to	4,735	for the youth facilities.

**ADMISSIONS**

6% increase	from	1,234	to	1,302	for total admissions.

**RELEASES**

11% increase	from	1,180	to	1,304	for total releases;
0% increase	from	740	to	741	for male parole releases;
-20% decrease	from	75	to	60	for female parole releases;
-2% decrease	from	815	to	801	for total parole releases;
15% increase	from	365	to	421	for offenders discharged at max.

**NOTES: DEFINITIONS OF INMATES INCLUDED IN COUNTS**

- a/ RESIDENTS include inmates in the institutions and on furlough on the last day of the reporting period. Past counts for major institutions may include the count for units that are no longer open. Housing security levels are designated as follows: SL I-community, SL II-minimum, SL III-medium, SL IV-maximum and SL V-close.
- b/ ADMISSIONS include commitments, parole returns for technical violation and prison and correctional returns from escape entered into the OBCIS database each month.
- c/ DISCHARGE AT MAX includes adult offenders released upon expiration of maximum sentence. Juvenile offenders are not included in this count.

REPORTING OF JUVENILE RESIDENTS ADMISSIONS AND RELEASES DATA has been discontinued. All juvenile offenders became the responsibility of the Juvenile Justice Commission, Department of Law and Public Safety as of July 1, 1996.

NOTE: Commencing April 1998 County Contract/Assistance and County Waiting figures are merged and reported as State Inmates in County Facilities.
