To His Excellency, Joel Parker, Governor and Commander in Chief:

SIR:—I have the honor to submit the following report of this department for the year 1873:

The daily routine business of this office remains the same as in previous years, with however an increased demand for searches for the records of soldiers of the volunteer army.

Our time has during the year been principally devoted to revising and correcting the manuscripts and proof-sheets of the "Official Register of the Officers and Men of New Jersey in the War of the Rebellion." This work is passing through the press as rapidly as the most careful examination and verification of each date and record will admit. We are laboring to make this volume the most complete and exact register of soldiers ever published. The style and execution of the work thus far cannot fail to be commended. In addition to the roster of New Jersey organizations we hope to show a record of all credited to this State who served in the United States Regular Army and Navy, Marine Corps, Veteran Reserve Corps and Colored Troops. If this is done the record of no State will be as complete as our own. We have been fortunate in obtaining some valuable documents relating to Jersey men who participated actively in the French War. These documents give the various positions held and the terms of service of about two thousand soldiers. The papers are still in a rough state, but will be properly arranged by companies and battalions so that the war record of this State may be carried back even to this early period.

The National Guard of this State now consists of sixty-nine (69) companies of Infantry, two (2) companies of Cavalry, and two (2) companies of Artillery. The force is complete as allowed by law, except one company of Colored Infantry as yet unorganized.

During the year, Company B, Second Regiment, at Orange, and Company F, Second Regiment, at Franklin, were disbanded and new companies have been organized ; in Fifth Regiment, Company B, at Newark ; in the Seventh Regiment, Company F, at Mt. Holly, and Company G, at Trenton ; in the Eighth Regiment, Company G, at Jersey City, Company II, at Newark, and Company I, at Camden ; in the Fourth Battalion, Company D, at Vineland. Cavalry Companies A at Elizabeth, and B at Trenton, have also been mustered into the service.

The parades and inspections of the military force have all been held as required by law. The annual parade and review of the Second Brigade took place at Camden, June 9th, and of the First Brigade at Newark, October 2d.

In accordance with law the Second Brigade was ordered into camp at Cape May, August 18th, and remained there one week. Since the organization of the National Guard, nearly five years ago, no general encampment has been held, and it was thought proper that the troops should now receive the military instruction only to be obtained when companies, battalions and regiments now so widely scattered are brought together. The most rigid discipline was observed and every detail of camp life was carried out in the most exact and soldierly manner. The daily improvement of the troops under almost constant drill was very marked, and commendation therefor was freely bestowed. On these men who so cheerfully left their employments to study a soldier's life with its fatigue and exposure, and its indirect cost, on such volunteer organizations this country must ever rely. It is not an idle boast to say that no State can to-day, according to its population, put so rapidly in the field as strong a body of well officered and disciplined men. In twenty-four hours a force can be placed at any point of this State fully able to put down any disturbance that can possibly occur. Rallying on these organizations a corps of veterans can be sent to the field at any time for any service. The emergency may occur at any moment when this force may be needed instantly, and no one can say how soon.

Every muster, every drill, parade or review, every encampment of troops is worth all it costs.

It is right that I should mention here the death of Brevet-Major General Thomas Cadwalader, which occurred on the 22d instant. For many years he was identified with the public interest of this State, and especially so while holding the office of Adjutant General. It is proper that I should speak of the careful and accurate manner he performed every duty, as is clearly shown by the complete records of his office.


The report of the Assistant Adjutant General, Chief of Enrolling and Drafting, has been received and is herewith presented.

The report of the Inspector General, with the returns of Brigade Inspectors of the National Guard, is annexed, to which you are referred for special information as to its numbers and general efficiency.

GENERAL:—I have the honor to report that the estimated number “of persons between the ages of eighteen (18) and forty-five (45) years, who are liable to perform military duty” in this State, at this date, is one hundred and thirty-one thousand five hundred and seventy-eight (131,578). This constitutes the reserve militia of the State. It is divided by counties:

REPORT OF THE INSPECTOR GENERAL.

STATE OF NEW JERSEY,
INSPECTOR GENERAL'S OFFICE,
ELIZABETH, November 15, 1873. }

GENERAL:—I have the honor to make the following report as to the condition of the National Guard for the year 1873, and to transmit to you therewith a consolidated return of its strength as well as a certified Inspection Return in detail of the various companies composing the Guard:

There have been received at this office Inspection Returns for fifty-seven companies of Infantry, two batteries of Artillery, and two troops of Cavalry, attached to the First and Second Brigades, and also for nine companies of Colored Infantry comprised in the Eighth Regiment. With reference to the latter, I respectfully recommend that Company F, Eighth Regiment, be disbanded, because it has fallen below the minimum required by law, and that Company E, Eighth Regiment, which returns the exact minimum required, by including the names of fifteen enlisted men upon its rolls at muster and inspection none of whom are in any wise accounted for to the inspecting officer, be consolidated with the other companies of the said Eighth Regiment stationed at Camden, and that the annual appropriation be withheld from that company.

Company F, Sixth Regiment, Company H, Second Regiment and Company G, Fourth Regiment, having failed to parade for inspection have forfeited their annual appropriations, and I respectfully recommend that they be disbanded.

Cavalry Company A, by its return shows a membership of only thirty-eight enlisted men, which falls short of the minimum required by law, but as it is a Cavalry company, and is, as it were, in its infancy, I do not recommend its disbandment, but simply that no appropriation be granted to the troop for the coming year.

The two batteries of Artillery are both very creditable organizations and worthy of special mention.

The fifty-seven companies of Infantry from which returns have been received, are divided between the First and Second Brigades; the First Brigade having thirty-two companies, and the Second Brigade twenty-five companies.

The thirty-two companies of Infantry comprised in the First Brigade are designated as follows: Companies A. B. C. D. E. and F., of the First Regiment; Companies A. B. C. D. and E., of the Second Regiment; Companies A. B. C. D. E. and F., of the Fourth Regiment; Companies A. B. C. D. E. F. G. and H., of the Fifth Regiment; Companies A. B. C. and D., of the First Battalion, and Companies A. B. and C., of the Second Battalion.

Of the above companies, none fall below the minimum required by law so far as their inspection rolls show their strength, but a number of them make up their minimum of forty enlisted men to a company by including in the returns those "absent without leave." There are, however, some companies which are striking exceptions, and which deserve honorable mention—the Second Battalion composed of but three companies paraded for inspection an average of thirty-eight enlisted men per company. Each company is entitled to equal praise for including their three company officers; they paraded as follows: Company A., forty-two present; Company B., forty present; Company C., forty-one present. In the First Battalion, Company C., paraded two officers and thirty-five enlisted men; twelve enlisted men being absent with leave and five absent sick, so that the company is entitled to be mentioned among the efficient organizations. The average of enlisted men present at inspection in the First Battalion was twenty-nine and one-quarter per company. Companies B. and A., having paraded respectively twenty-nine and thirty and Company D. having mustered but twenty-three enlisted men present, is entitled to some extent to be charged with being the cause of the average being so small. With reference to the latter company, inasmuch as it fills up its quota to the minimum by including seventeen of its twenty enlisted men reported absent without leave, I respectfully suggest, that, its annual appropriation be withheld until it is satisfactorily ascertained by some special inspection, to be hereafter held, whether the men thus reported as absent without leave are simply kept upon the rolls to fill the organization, when they should be reported as deserters, or are men doing active duty who happened not to be present at inspection.

The rolls of the First Regiment show an average present at inspection of twenty-four and five-sixths enlisted men per company. No company is deserving of special mention, and the rolls of Company D. are in a very unsatisfactory condition, for while the company paraded twenty-seven enlisted men which was the largest number of any company in the Regiment, (with the exception of Company B., which paraded twenty-nine enlisted men) only three of its absentees were accounted for, so that it is impossible to determine whether its minimum is made up by including as active members of the company at least ten men absent without leave. Lest such may be the case, I recommend that the same course be pursued as to the appropriation of this company, which I have above recommended with regard to

Company D, of the First Battalion. I recommend, also, the same course with regard to Company A, of the First Regiment, because, out of a total of forty-three enlisted men, it reports twenty as absent from inspection, and of the absentees, accounts only for three sick and two absent with leave, neglecting altogether to give any cause for the absence of the remainder.

It seems to me, that whenever a company fails specifically to account for more than three-quarters of its minimum, or makes its strength appear equal to the minimum required, by including in that minimum one-quarter of its strength as absent without leave, no appropriation should be received by it for the current year, until it is satisfactorily established that the company has a bona fide minimum strength of capable arms bearing men, and it is in acting upon that view that I have made the above suggestions, and shall in this report as I refer to each Regiment, make a similar recommendation with regard to every company which fails to account for over thirty enlisted men without including absentees without leave.

The rolls of the Second Regiment show an average attendance at inspection of twenty-nine and two-fifths enlisted men per company; but that is far below what would have been their average, had all the companies emulated the handsome example set them by Company B, which paraded forty-nine enlisted men at inspection. Companies A and E make a very fair report; but Companies C and D are both far from making even a passable report, inasmuch as Company C having a membership of but forty-two enlisted men reports twenty-three as absent without leave, and Company D with fifty-four enlisted men reports thirty-one as absent without leave. The annual appropriations of the last two Companies should be withheld for further investigation for the reasons above set forth.

The average present at the inspection of the Fourth Regiment, was twenty-seven and one-sixth enlisted men per company. Company D is entitled to honorable mention having paraded forty enlisted men for inspection. Company A, though with but thirty-six present, has shown itself a good and reliable organization. Company C, so far as its enlisted men are concerned turned out with creditable numbers, namely, thirty-one, a matter hardly to be expected, as all its officers were absent without leave from inspection. Company E is highly spoken of by the Brigade Inspector, having mustered three officers and thirty-two enlisted men present at inspection, the fact however that five non-commissioned officers and eighteen privates are reported as absent without leave detracts from the credit which would otherwise be its due. I regret that the two remaining organizations of that regiment, viz: Company B and F should have fallen far below the standard of the other companies, and I am constrained to report that until further inspections be made their annual appropriations be withheld, for the reason that Company B, out of a membership of forty-two enlisted men, reports sixteen as absent without

leave; two of whom certainly by the rolls appear to have served their full term, and Company F reports twenty-three absent without leave in a total membership of forty-seven.

The Fifth Regiment is composed of eight companies, and its average present at the inspection being only twenty-three and seven-eighths enlisted men per company, is the smallest average of any regiment or battalion of the Guard; but Companies A and D having each paraded thirty-three enlisted men, and properly accounted for their absentees should be relieved of the odium which the actions of the other companies have cast upon the regiment. As to the remaining companies their appropriations should be withheld for the present, as none of them come up to the minimum except by relying upon the paper strength made up by their "absent without leave." Company B has on its rolls forty-one enlisted men, of whom thirteen are absent without leave. Company C with fifty enlisted men, has twenty-one absent without leave. Company E with forty enlisted men, reports thirteen absent without leave, the term of service of some of whom has expired. Company F with forty-one enlisted men, reports fourteen absent without leave. Company G with forty-two enlisted men, reports twenty-one absent without leave, and Company H with forty-one enlisted men, reports twenty-one absent without leave.

The twenty-five companies of infantry composing the Second Brigade, from which reports have been received, are designated as follows:

Companies A, B, C, D, E, F, G and H of the Third Regiment; Companies A, B, C, D, E and G of the Sixth Regiment; Companies A, B, C, D, E, F and G of the Seventh Regiment, and Companies A, B, C and D of the Fourth Battalion.

The average present of enlisted men per company at inspection in each of said organizations was as follows:

In the Third Regiment thirty-one and seven-eighths per company.

In the Sixth Regiment twenty-six and one-half per company.

In the Seventh Regiment thirty-seven and five-sevenths per company.

In the Fourth Battalion thirty-one and one-fourth per company.

The following companies of the Third Regiment are entitled to special and honorable mention for their strength present at inspection and for their discipline and military appearance, viz., Company B, which paraded thirty-seven enlisted men, Company C, which paraded forty enlisted men, Company E, which paraded thirty-six enlisted men, and Company F, which paraded thirty-five enlisted men. Three of the remaining companies, viz., A, D, and G, turned out with well filled ranks and are good and efficient companies, having more than the minimum strength, and which paraded twenty-nine, thirty, and thirty-two enlisted men, respectively; but as to Company H, I am compelled to recommend that its appropriation be

withheld, as at the inspection it paraded but two officers and nineteen enlisted men; one officer and twenty-five enlisted men being reported as absent, but no cause given or detailed statement as to whether absent with or without leave.

In the Sixth Regiment companies C and G have rendered a good account of themselves, and mustered at inspection present as follows: Company C, thirty-eight enlisted men, and Company G, thirty-five enlisted men. Companies A, B, and E, are fully up to the standard required, but Company D is reported by the Brigade Inspector as follows: "Discipline, very bad," and from the returns it would appear that such a report is fully justified, for at inspection they appear with the following strength present, two officers and ten enlisted men, and report forty-six enlisted men absent as follows: fifteen deserters, and six non-commissioned officers and twenty-five privates as absent without leave. Such a report unquestionably shows that the organization is unworthy of the generous assistance derived from the State by its annual appropriation and a reproach to the National Guard. I therefore respectfully recommend either that it be disbanded or its material consolidated with some more worthy company.

It is very gratifying in looking over the rolls of the Seventh Regiment to find that I am obliged to report all of the companies as being fully up to the standard. With the exception of the Second Battalion no organization has equalled them in strength and discipline. Companies F and G paraded over fifty strong, Company B paraded thirty-nine, Company C thirty-eight, and Company E thirty-seven men, while companies A and D paraded thirty-two enlisted men each, all absentees in each case being properly accounted for.

In the Fourth Battalion companies A and D are entitled to special mention, Company A out of a total membership of forty-three enlisted men having paraded forty for inspection, and Company D having paraded thirty-six for inspection out of a total membership of forty-two enlisted men. The rolls of companies B and C show that they have as active members the number required by law.

In summarizing my report I find that exclusive of the State and General Staff the force of the active militia is 3,664 men, of which number there were present at inspection 2,396, which is a considerable increase over the last Inspection Report.
