MEMORANDUM TO: THE HONORABLE JAMES E. McGREEVEY AND THE LEGISLATURE OF THE STATE OF NEW JERSEY

The New Jersey Wiretapping and Electronic Surveillance Control Act (N.J.S.A. 2A:156A-1 to - 34) requires the Chief Justice to submit an annual report to the Governor and the Legislature (N.J.S.A. 2A:156A-23E). In accordance with that section, I am submitting this report to inform you of the operation of the Act during 2003.

N.J.S.A. 2A:156A-2(i) provides that only Superior Court judges designated by the Chief Justice are authorized to hear wiretap applications. For the year 2003, the following judges were authorized wiretap judges: by order dated April 26, 1994, Judges Kevin G. Callahan, Arthur N. D'Italia, and Robert A. Longhi; by order dated March 19, 1997, Judge Joseph A. Falcone; by order of July 22, 1997, Judge Linda R. Feinberg; by order dated December 3, 1997, Judge Samuel D. Natal; by order dated June 11, 1999, Judge Albert J. Garofolo; and by order dated July 22, 1999, Judge Marilyn C. Clark.

The data for the year 2003 include reports of all orders granting permission to intercept wire, electronic and/or oral communications, or to perform electronic surveillance, for any period that ended in 2003. It is the actual termination date of the surveillance that governs which reports are included within the reporting year. During 2003, the reports to the Administrative Office of the Courts reflected 165 seeking permission to intercept wire, electronic or oral applications¹ communications. There was 1 application denied. Thus, in 2003 the authorized judges entered 164 orders granting permission to intercept wire, electronic and/or oral communications.

¹ Note that the Office of the Attorney General reports 130 applications. The numbers differ because of differences in reporting methods for the two reports. The Judiciary reports a wiretap in the year that it terminated. The Attorney General does not report a wiretap until the investigation in the case is complete.

Of the 164 orders entered, 158 permitted interception of wire communications, 5 permitted interception of electronic communication, and 1 permitted interception of oral communication. There were 94 orders authorized for 30 days each, 68 were specified for 20 days each, and 2 others were authorized for less than 20 days each. Additionally, 70 extensions of previously entered orders were granted during the reporting year. Of these, 50 extensions were for 30 days and 1 extension was for 15 days. There were another 19 extensions for 10 days or less.

Please note that because some orders involved the investigation of more than one offense, the total number of offenses listed (185) is greater than the number of orders issued (164).

N.J.S.A. 2A:156A-11 provides that in certain instances a showing of special need is required before an order for interception of wire, electronic and/or oral communication is to be granted. The reports made by the authorized judges indicate that in reporting year 2003, a showing of special need was required in 5 of the orders, a showing was not required in 51 orders, and the special need information was not available in 108 orders.

Data reported pursuant to *N.J.S.A.* 2A:156A-23 were compiled to report on the operation of the New Jersey Wiretapping and Electronic Surveillance Control Act. As required by statute, this report contains data concerning:

- (1) The number of applications made.
- (2) The number of orders issued.
- (3) The effective periods of such orders.
- (4) The number and duration of any renewals.
- (5) The crime in connection with electronic surveillance orders.
- (6) The name of the applicants.
- (7) Indictments resulting from each application.
- (8) The crime which each indictment charges.
- (9) The disposition of each indictment.

In addition to the detailed information provided for 2003 applications and orders, supplemental follow-up data is provided for electronic surveillance orders reported in previous calendar years.

APPLICATIONS

In 2003, 130 applications were made statewide for electronic surveillance orders pursuant to the Wiretap Act. The applications made were authorized by prosecution officials as follows.

- In all, the 130 applications for electronic surveillance resulted in 129 orders granting the use of electronic surveillance.
- One application for electronic surveillance was denied. This application was re-submitted and subsequently authorized.

ORDERS FOR ELECTRONIC SURVEILLANCE

In all, 129 court orders were entered granting court authorization for electronic surveillance in 2003.¹

- **Bergen County.** While the 2003 federal AOC report lists two electronic surveillance orders for Bergen, Bergen County reports three orders. The third application for Bergen County was processed and approved through the Passaic County Prosecutor's Office.
- Cumberland County. Cumberland County (Bridgeton Police Department) reports one electronic surveillance order (AJGCUM3703). This order is not listed in the 2003 federal AOC report.
 - Essex County. The five orders reported by the federal AOC (application dates7/10/02, 7/10/02, 7/18/02, 7/29/02, and 10/25/02) were previously reported by New Jersey. New Jersey, however, reports six electronic surveillance orders terminated during the current report year which were not reported by the federal AOC.
- Middlesex County. One order (application date 12/9/02) reported by the federal AOC was previously reported by New Jersey.
 - **Passaic County.** The federal AOC report lists 29 court authorized electronic surveillance orders; New Jersey lists 30 orders. The one order not listed by the federal AOC, MCCPASS1203 (application date 4/8/03), was initially denied. This application was re-submitted and ultimately authorized (MCCPAS1303, application date 5/6/03).
- **Salem County.** New Jersey reports eight orders, while the federal AOC reports seven orders. One order, AJGSAL1403 (application date 8/15/03) was not reported by the federal AOC. This intercept was never installed.

¹ The United States Administrative Office of the Courts 2003wiretap report (Table B-1) lists 132 electronic surveillance orders for New Jersey. The state report lists 130 electronic surveillance orders for New Jersey. This includes 129 orders granting authorization and one order denying authorization. While authorization was initially denied for one application, the application was re-submitted and ultimately granted. Discrepancies between federal and state reports are described below.

Extensions were requested and granted for 29 intercept orders. In addition to the first extension granted in 29 instances, second extensions were granted in 12 instances and third extensions were granted in 3 instances.

- Of the 129 orders granting electronic surveillance, 125 authorized wire (telephone) intercepts.
- . For the remaining four orders, one authorized an electronic communication intercept (microphone eavesdrop), one authorized an oral communication intercept, one authorized a video recorder/tape intercept, and one authorized both a wire intercept and an electronic communication intercept.

State Attorney General. New Jersey reports 14 electronic surveillance orders. The federal AOC reports 27 electronic surveillance orders. The discrepancies between state and federal reporting are generally the result of differences in reporting procedures. For example, the federal report will include orders terminated in the current report year, but used in conjunction with ongoing investigations. Orders terminated in a report year, but used in conjunction with an ongoing investigation, are not reported by the New Jersey Attorney General's Office until the investigation has concluded. This often results in orders being reported in years following the year the order was terminated.

Eleven orders listed in the federal AOC report are not reported by New Jersey as they are in conjunction with ongoing electronic surveillance investigations. These orders will be reported upon conclusion of the ongoing investigations.

One order listed in the federal report, AO #8 (application date 4/3/03), is a duplicate of AO #7 (application date 4/3/03). The second entry (AO #8) pertains to an extension granted on the original order (AO #7). (This order is one of those New Jersey will report upon conclusion of the ongoing investigation.)

One order listed in the federal report, AO #18, application date 11/29/01, was previously reported in the 2002 New Jersey state report.

Eleven orders listed in the federal AOC report are included in the 2003 New Jersey report. In addition, the state report includes three orders, KGCHUD1902 (application date 5/28/02), RALMID2402 (application date 6/14/02), and RALMIC2502 (application date 7/12/02) previously reported by the federal AOC. These orders were not reported previously as they were part of an ongoing investigation, which concluded in 2003.

- Of the 129 orders granted for electronic surveillance, 123 were installed and utilized. Six intercepts were never installed or utilized.
- Of the total 129 original orders, 68 authorized use of intercepts for 30 days, 60 authorized use of intercepts for 20 days, and 1 order authorized an intercept for 1 day.

Section 8 of the Wiretap Act specifies the crime for which electronic surveillance may be granted. Offense data collected and analyzed for court-authorized electronic surveillance consider the most serious offense investigated. Offense data consider only substantive offenses and not conspiracy to commit the offense.

Overall, electronic surveillance orders were granted in connection with investigations involving the following offense categories: controlled dangerous substance offenses, racketeering, theft, murder offenses, sexual assault, gambling, and forgery or fraud.

- Of the 129 orders authorizing electronic surveillance, considering the most serious offense, 84 (65%) involved controlled dangerous substance offenses.
- In addition, 18 (14%) of the orders involved racketeering offenses, 12 (9%) involved theft, 6 (5%) involved murder offenses, 5 (4%) involved sexual assault, 3 (2%) involved gambling, and 1 (1%) involved forgery or fraud.

DEFENDANT INDICTMENTS AND DISPOSITIONS

Summary information concerning defendant indictments resulting from electronic surveillance applications is provided below with detailed information on the following pages.² The information provided concerns defendant indictments resulting from each application, the offenses charged, and indictment dispositions.

- At the close of the report year (December 31, 2003, a total of 187 defendants were indicted statewide as a result of 2003 electronic surveillance applications and orders.
- Of those 187 defendants indicted, 152 (81%) were indicted for controlled dangerous substance offenses.
- In addition, 28 defendants were indicted for theft offenses, 3 were indicted for weapons violations, 2 were indicted for obstruction of justice, 1 was indicted for murder and 1 for robbery.
- An additional 183 defendants were arrested and awaiting grand jury action, 23 were referred for criminal prosecution, 1 was referred to family court, 2 pled guilty to disorderly persons offenses (pre-indictment), 2 had charges no billed, and 7 had charges administratively dismissed.
- At the close of the report year, 118 of the 187 defendants indicted reached final disposition.
- Of those defendants reaching final disposition, 88 were convicted through guilty pleas, 21 were admitted into a pre-trial intervention program, 8 had charges dismissed, and 1 was convicted at trial.

² In addition to defendant indictment and disposition data for 2002 electronic surveillance applications, supplementary report or follow-up data is provided for electronic surveillance orders reported in previous calendar years.
