I must again call the attention of the legislature to the necessity of having the library room finished, as we are now so short of shelf room that we are compelled to pack away all books received, except those in constant use, and unless the room is finished before another year, the laws and reports added will have to be placed on the floor for want of shelf room. There was an appropriation made in eighteen hundred and seventy-three, which was intended, in part, for this purpose, but has been expended without reaching it. I would respectfully suggest a sufficient appropriation especially for the library room, the work to be done during the coming summer. The library also needs an extra room for storing duplicates and papers on file, which now take up much valuable room.
