**Trenton, NJ** – Acting Governor Kim Guadagno today announced that New Jersey’s nonprofit organizations now have one-stop access to valuable state resources thanks to a new webpage from the New Jersey Department of State.

The New Jersey Nonprofit Information Center portal – [nonprofit.nj.gov](http://nonprofit.nj.gov) – offers information on funding sources and other assistance available to nonprofits through state government.

The portal lists links to department and agency web pages dedicated to nonprofit resources. Resources include funding, volunteer opportunities, forms and guidance documents.

“New Jersey’s nonprofit organizations provide vital services across a range of areas,” said Acting Governor Kim Guadagno, who serves concurrently as Secretary of State. “To help nonprofits fulfill their mission, it makes sense to assemble this information in one convenient place.”

Earlier this year, Governor Chris Christie signed legislation requiring the Department of State to maintain an accessible directory of state departments and agencies that provide resources to assist nonprofits.

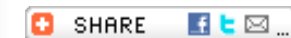
With a single mouse click, groups can access useful information. Clicking the Treasury Department’s link delivers information for starting a nonprofit corporation and tax filing requirements. The link for the Department of Community Affairs offers grant information and a resource guide. The Department of Law and Public Safety provides information on grants and registering as a charity.
