#### **College and Career Readiness**

This school outperforms 55% of schools statewide as noted by its statewide percentile ranking and 8% of schools educating students with similar demographic characteristics as noted in its peer school percentile ranking in the performance area of College and Career Readiness. Additionally, this school is meeting 40% of its performance targets in the area of College and Career Readiness.



College and Career Readiness measures the degree to which students are demonstrating behaviors that are indicative of future attendance and/or success in college and careers. 






## **Enrollment by Ethnic/Racial Subgroup**






## **Proficiency Trends - Math**











This graph presents the count of students who were 'on roll' by grade in October of each school year.

































This graph presents the count of students who were 'on roll' by grade in October of each school year.






## **Enrollment by Ethnic/Racial Subgroup**












