2009 Annual Report on Access to Employer-Based Health Insurance

Background

In August 2006, legislation was enacted (P.L. 2006, c.87) directing the Commissioner of the Department of Human Services (DHS) to prepare an annual report on Access to Employer-Based Health Insurance for NJ FamilyCare (NJFC) enrollees.

The purpose of this report is to identify those employers, with 50 or more NJFC/Medicaid enrollees, in the State whose employees and their dependents do not have access to employer-based health insurance coverage and receive, instead, insurance coverage through the publicly-funded NJFC/Medicaid program.

Data Report Source

The Department of Labor and Workforce Development (LWD) utilized their database to match against a file containing NJFC/Medicaid enrollee social security numbers provided by DHS' Division of Medical Assistance and Health Services (DMAHS). The file utilized by the Department of Labor was not collected for the intent of producing this report.

It is important to note again this year, that there are limitations inherent in the information available for this report. The LWD file does not contain enrollee quarterly income or number of hours worked. As a result, the report cannot provide information on whether an employee is full-time or part-time or how long the employee has been employed with a particular employer. The report illustrates a "period of time" (January 1, 2009 to March 31, 2009) and is a representation of what the employment picture looks like for certain NJFC/Medicaid enrollees in New Jersey.

Although the enabling legislation calls for the employer's address or work site, the data source utilized does not list individual employment sites. Instead the data file provides an address directly related to each tax identification number which may be a corporate site or a payroll vendor. For this report, the tax identification number is listed for each employer.

NJ FamilyCare

NJ FamilyCare provides free or low cost comprehensive health insurance for uninsured children and certain low income parents. This program is both state and federally funded and eligibility is based on income and household size. Children can be eligible with household income up to 350% of the federal poverty

level (FPL). As the result of a new law in New Jersey (P.L. 2008, c.38), effective September 1, 2008, the income standard for uninsured parents/caretakers increased from 133 percent to 200 percent of the FPL which, for a family size of four, is \$42,400 annually.

In most instances, to be eligible for NJFC, the enrollee must have been uninsured for three months. While there are a few exceptions to this rule, such as the family lost health insurance through no fault of their own, i.e., parent was laid off, higher income families cannot drop employer sponsored health care coverage to access NJFC.

Data Report Summary

The data shows that there are 442 employers in New Jersey with 50 or more NJFC/Medicaid enrollees. They employ a total of 64,157 employees (see Column A of Table 1) who are receiving health care coverage through NJFC/Medicaid. In addition, the data shows that 127,307 spouses and dependents (see Column B) of these employees are also receiving NJFC/Medicaid.

Of these 64,157 employees, 7,179 have private insurance (see Column F). "Traditional" Medicaid clients (funded under Title XIX of the federal Social Security Act of 1965) may have private insurance or third party liability (TPL). In these instances, Medicaid becomes the payer of last resort once the private coverage has reimbursed for allowable medical services.

Column D in the table shows there are 1,010 employees who are receiving services through the NJ Workability Program and are employed. NJ Workability offers full New Jersey Medicaid health coverage to people with disabilities who are working, and whose earnings would otherwise make them ineligible for Medicaid. Generally to be eligible for NJ Workability, a person must be between the ages of 16 and 64, working part time, full time or be self-employed, have a permanent disability and meet certain income and resource guidelines.

Also included in the data is information on government employers with 50 or more NJFC/Medicaid enrollees, for which there are 32. These 32 government employers employed 3,204 NJFC/Medicaid enrollees with 6,880 spouses or dependents at a total cost of \$5,619,653.54. The cost to New Jersey for these enrollees is \$2,417,782.27.

Cost to the State

The total NJFC/Medicaid expenditures for the three month period from January 1, March 31, 2009 were \$109,896,713.32. Of this nearly \$110 million, \$78,013,849.30 was spent for Medicaid coverage while \$25,422,386.07 was spent for NJFC coverage.

In terms of state versus federal dollars spent for Medicaid expenditures, the cost to New Jersey was \$32,157,308.68 and for NJFC expenditures, the cost to New Jersey for this same time period was \$8,897,835.12.

The remainder of the funds, \$6,460,477.95, was state only funds. While not specifically reflected in the data provided, for the same time period noted, \$5.7 million was paid in premium support payments by enrolled families. The Premium Support Program (PSP) subsidizes employer-sponsored coverage by "buying in" to private coverage available to the employee when it is cost-effective. To be eligible to participate in the PSP, the employee must be NJFC eligible and dependent children must be under the age of 19 and uninsured. The employee must also have access to employer sponsored insurance.

Comparison to 2008

It was expected that overall, all reported numbers would increase given the lack of affordable health care coverage in New Jersey and in the nation. The number of NJFC/Medicaid enrollees employed by an employer with more than 50 employees rose by almost 6800 or an 11.8% increase. The additional 6800 enrolled employees represent an increase in costs of \$708,067.27 or a .65% increase in total costs. The costs to the state decreased by \$7.2 million or a 13% decrease. The State share of the costs decreased because the Federal share increased due to enhanced funding through The American Recovery and Reinvestment Act of 2009 (ARRA).

It is interesting to note that Title XIX (Medicaid) state costs decreased (\$41.3 million in 2008 vs. \$32.2 million in 2009) while Title XXI (SCHIP) costs increased (\$7.1 million in 2007 vs. \$8.9 million in 2008).

Charity Care Information Submitted by the Department of Health and Senior Services

The statute requires the Department of Health and Senior Services (DHSS) to compile, to the extent data are available, information about employed recipients of Charity Care. Specifically, the law requests the following information: the employer's name and address; the number of recipients on Charity Care who are employed by the employer; and the cost to the State of providing Charity Care for employer's employees and their dependents. The DHSS is currently reviewing hospital specific procedures to determine the most effective means of capturing the necessary information at the point of entry. In addition, DHSS as required by the "Charity Care Fraud Prevention and Detection Act," has met with the Division of Taxation to determine the potential for file matching to ascertain the employer and wage data for Charity Care recipients. The result of the meeting indicated that the lack of a consistent identification number such as social security remains a significant impediment.
