## Introduction

Following is the Biannual Report of the New Jersey Schools Development Authority (SDA) for the period April 1 through September 30, 2009. This report is submitted under the provisions of P.L. 2007, c. 137 ("The August 2007 legislative amendments"), which modified the Educational Facilities Construction and Financing Act (EFCFA) (P.L. 2000, c.72).

This report summarizes the progress and accomplishments of New Jersey's school construction program during the six-month reporting period. The Authority fully funds and manages the construction of new and modernized school facilities projects in 31 school districts ("The SDA Districts"). The Authority is advancing projects identified in 2008 in its New Funding Allocation and Capital Plan for SDA Districts, as well as the previous 2005 Capital Plan. In addition, the SDA is expediting renovations deemed emergent by the Department of Education (DOE) due to health-and-safety reasons. For a County/District listing of these projects, please see appendix B-1.


The SDA also distributes grants approved by the DOE for projects in Regular Operating District (ROD) projects throughout New Jersey. These grants fund at least 40 percent of project costs, with the remaining share coming from local communities, contingent on budget or voter approval. For a County/District listing of all grants executed within the reporting period, please see Appendix B-2.

The SDA operates under EFCFA and the subsequent August 2007 legislative amendments. EFCFA authorized an initial program funding allocation of \$8.6 billion. The funding allocation was increased by \$3.9 billion upon Governor Jon S. Corzine's approval of P.L. 2008, c. 39 (New Funding Legislation) in July 2008.


The school construction program has an authorized total of \$12.5 billion, comprising \$8.9 billion for SDA Districts and \$3.6 billion for RODs. Of the ROD funding, \$150 million is set aside for vocational schools.

# **Growing New Jersey's Economy**

With the nation struggling to recover from the worst economic crisis since the Great Depression, and the construction industry absorbing much of the brunt of rising unemployment levels, the SDA has accelerated school projects to create and save jobs while investing in the future of New Jersey's children. These projects support enhanced student achievement and serve as a long-term infrastructure investment.



The result of project acceleration during the six-month period ending September 30, 2009 has been the initiation of 23 school projects with an overall project value of \$1.05 billion and the creation of 3,421 private sector jobs.



While accelerating school projects and grants, the SDA remains vigilant in ensuring that taxpayer dollars are spent efficiently. The SDA will continue to seek savings and efficiencies as it moves to initiate remaining schools identified in its 2008 Capital Plan. Such initiatives are discussed in greater detail on page 9 of this report.

## **Increasing Opportunities for Small, Minority- and Women-Owned Businesses**

A crucial component of SDA efforts to boost the economy is initiatives to increase opportunities for small, minority- and women-owned businesses. The SDA works under the State's small business set-aside program, which was established with the goal of awarding a minimum of 25 percent of state contract dollars to small businesses. The SDA continues to exceed this minimum. During the reporting period, the SDA awarded \$26.6 million in construction contracts to Small Business Enterprises (SBEs), or 41.3 percent of all contracts awarded. The SDA, however, recognizes efforts must continue to ensure SBEs, including minority- and women-owned businesses have ample opportunity to win contracts. Planned efforts to increase M/W/SBE participation are discussed on page 15 of this report.

# **Accomplishments - School Openings and Grants**

The culmination of SDA efforts comes in September, when construction projects are turned over to school districts for their students and staff. These new schools provide 21st century science laboratories, media centers and classrooms to enhance opportunities for students. There were 12 school openings and three emergent projects completed during the reporting period.

<sup>\*</sup>Demonstration project: Such projects, which incorporate community features and are coordinated with wider economic development, are managed by a municipal redevelopment entity and a redeveloper/developer. SDA provides 100 percent funding and conducts oversight.

Since inception, the SDA has completed 613 projects in SDA Districts. In addition to 50 new schools, it has opened 44 extensive additions, renovations and/or rehabilitations; five demonstration projects and more than 500 other projects. Also, the SDA has completed 22 projects in RODs: five new schools and 17 extensive additions, renovations and/or rehabilitations.

The SDA has also restarted its ROD grant program which provides a State share of at least 40 percent of DOE approved project costs, with the remaining share coming from local communities, contingent on budget or voter approval. ROD grant projects prioritized by DOE specifically address health-and-safety concerns as well as overcrowding and early childhood education. During two rounds of grant funding over the course of the reporting period, the SDA offered 853 grants with \$59.4 million in State share. Of these offers, the SDA executed 245 grants during the reporting period. The next round of ROD grant funding is expected to be offered in 2010.

# **Fiscal Responsibility**

The SDA has undertaken a number of initiatives to ensure that taxpayer money is spent efficiently. A design review process has been implemented to ensure that previous school designs meet current educational needs and standards and eliminate any design excesses. The SDA continues to identify and pursue opportunities to recover costs for environmental remediation, correcting design errors or omissions, and other expenses created by responsible parties. In addition, there are multiple efforts being made by the Authority to mitigate risks that could otherwise have financial implications.

In addition to the more expansive programmatic fiscal controls outlined in this section, the SDA continues to identify internal operational efficiencies. Recently, SDA transferred 6,400 cubic feet of archived Authority records from a private storage facility to DocuSafe Records Management - the State's records storage center - a move with projected savings of at least \$120,000 by December 2010. Additionally, the SDA has saved hundreds of thousands of dollars through changing vendors, tightening inventory controls, using less expensive systems for backing up its databases, installing lighting timers and replacing bottled water with filtered water systems.

## **Design Review Process**

Since the adoption of the Capital Plan in July 2008, the SDA and DOE have engaged in design reviews of projects to ensure that taxpayer dollars are most efficiently used by designing appropriately sized schools that are consistent with the district's educational needs as well as current SDA design standards. The design review process includes DOE's review of educational programs and SDA's review of designs to identify opportunities for value management and cost efficiencies.

Thus far the design review process has identified and implemented numerous design changes in 19 projects, with millions of dollars in reduced construction costs anticipated as a result. For example, a DOE review of projected enrollment for the new Phillipsburg High School project determined that the planned capacity of the school could be reduced. Subsequent redesign by the SDA has eliminated approximately 50,000 square feet of excess area. The design review process also led to the planned use of more cost-effective construction materials for the project.

The SDA's review of the Elizabeth Academic High School project resulted in redesign of the exterior wall and HVAC systems, providing improved performance at a lower cost as well as a reduction in overall building area.

The SDA continues to review designs as previously initiated projects are restarted, balancing the need to stimulate the economy, meet school occupancy schedules and ensure designs are both effective and efficient.

## **Cost-Recovery Actions**

To protect the interests of New Jersey taxpayers, the SDA uses mediation and, if necessary, litigation, to recover certain costs for which the state should not be responsible. Among these efforts is legal action to seek funds from responsible parties for the costs incurred to conduct environmental site remediation on school-project sites. These matters are identified and prioritized by the SDA's Environmental Cost Recovery Initiative Team, which includes Legal, Real Estate, Environmental and Project Management staffs. The SDA then coordinates the filing of new complaints for recovery with the Office of the Attorney General. In addition to the filed recovery efforts, SDA continues to identify further cases for cost recovery actions and has recently submitted potential complaints equaling an additional \$5 million in actions for the Attorney General's consideration.

## **Mitigating Project Risk**

## Closeout of Open Projects

A multi-divisional task force formed in January 2009 is working to close out a multitude of projects, contracts and DCA permits that had remained open over the past several years. The initiative created a formalized project closeout procedure for Authority-managed projects. The procedure provides for standardized, consistent and timely transition of ownership of a school facilities project to the school district upon substantial completion. Closeout of contracts and permits, in addition to property transfer (deed transfer) to the district where applicable, is tracked and memorialized through final project completion (approximately one year after construction is finished). Full project close out occurs after school transfer and when all contracts associated with the projects

have been completed. The process drastically reduces the liability faced by the State as it decreases the inventory of buildings that should be under local school district control.

This effort has yielded significant results. To date 50% of the projects eligible for transfer have been transferred to the school districts. Twenty-five percent of those projects have been fully closed out.

## Purchase of Owners Protective Professional Insurance

The SDA has launched a new initiative with the purchase of Owners Protective Professional Insurance (OPPI), an umbrella professional liability policy that will provide future savings by drastically increasing the state's protection for design related errors. OPPI covers SDA for damages created by project design professionals' errors and omissions, including those by architects, engineers and construction managers. OPPI is triggered once the design professional's underlying professional liability policy limits are exhausted. OPPI provides SDA with an added layer of up to \$25 million of coverage.

## Renewal of Owner Controlled Insurance Program

The SDA also renewed its Owner Controlled Insurance Program (OCIP) for an additional five years. OCIP provides greater opportunities for smaller contractors to participate on construction projects, as it is often difficult for smaller contractors to obtain the level of coverage required by the SDA on their own. Under OCIP, the SDA purchases insurance for itself, the general contractor and subcontractors. Using OCIP, the SDA is able to obtain insurance for its entire construction program at a lower cost than contractors and subcontractors can purchase individually, resulting in insurance savings to the SDA estimated at 0.5 to 2 percent of total construction costs. The OCIP provides \$200 million in coverage based upon an estimated construction value of \$2 billion.

# **Improving Efficiency**

### Focus on Ethics

The SDA makes it a priority to ensure that staff members are fully trained on ethics requirements and can easily access up-to-date information when guidance is needed. The SDA is on target to provide annual ethics training for every staff member by the end of 2009. As of the end of the reporting period, 89 percent of employees had received their required training through an online program or via live sessions with a New Jersey Ethics Commission representative. Remaining staff members will receive training in December 2009.

The SDA also enhanced the accessibility of online ethics reference materials. A link was added on the SDA Intranet to the Ethics Commission's Frequently Asked Questions and newsletters. SDA also furnished additional ethics forms and explanatory materials on the Intranet's Ethics Section.

## **Audits/Compliance**

The SDA is subject to review by various agencies to ensure that the Authority operates in a cost-effective, efficient and transparent manner that serves the taxpayers' interest.

One key level of review involves the Office of the State Comptroller. The 2008 legislation that provided new school construction funding directs the SDA, in consultation with the State Comptroller, "to cause an audit to be conducted of any school facilities project that has a State share that exceeds \$10 million." During this reporting period, the Authority's Internal Audit staff, in consultation with the State Comptroller, finalized a comprehensive program that will be used to audit school facilities projects. The process will be implemented in 2010.

Various other agencies, as well as the SDA's own Internal Audit Division (IAD), conduct audits of the Authority's operations and processes. The SDA works continuously to ensure that the recommendations set forth in these reports are implemented. The SDA Board's Audit Committee receives updates on the status of these efforts every two months. Since 2006, outside agencies and SDA's IAD have completed 22 audits comprising 216 recommendations. Of these, 185 recommendations, or 86%, have been fully implemented. Sixteen of the 22 reports were deemed closed because all recommendations have been completed.

The SDA's commitment to the efficient use of taxpayer dollars in the school construction program involves ongoing cooperation with the Office of the Inspector General (OIG). A 2006 Memorandum of Understanding (MOU) remains in effect and governs the relationship between the OIG and the Authority. Since their assignment in 2006, two Assistant Inspectors General (AIGs) have been located at the Authority's West State

Street offices. The AIGs review and investigate the Authority's operations and processes on an ongoing basis and have full and complete access to all SDA records. As necessary, the AIGs conduct interviews and otherwise interface with entities doing business with SDA, as well as with SDA staff.

## **Promoting Safety**

In April 2009, the SDA renewed its alliance with the U.S. Department of Labor's Occupational Safety and Health Administration (OSHA) and the New Jersey Department of Labor and Workforce Development to promote safety and health at New Jersey school construction sites. To foster greater safety for the construction industry, the SDA provides 10- to 30-hour construction safety training to its project managers and, as space allows, to staff from other supporting State agencies.

## **Online OPRA Submissions**

Continuing its efforts toward increased transparency, the SDA has made it easier to request documents through the Open Public Records Act (OPRA). The public can now go online and complete an OPRA form. Previously, requests for SDA records could be processed through mail or fax only. The OPRA online request form is available via the SDA home page at <a href="https://www.njsda.gov">www.njsda.gov</a>.

## Predictability for Business

In May 2009, SDA adopted and published a new change order policy that streamlines and clarifies the process for contractors. Additionally, SDA management initiated a new monthly report to the Board of Directors detailing all change orders and change directives processed, increasing transparency.

## **Aggregate Principal Amount of Bonds**

During the reporting period, the New Jersey Economic Development Authority (EDA) issued an aggregate \$600 million of School Facilities Construction Bonds and Notes. Specifically, the EDA issued: \$400 million of notes in June 2009, and \$200 million of bonds in August 2009. From program inception through September 30, 2009, the EDA has issued \$8.15 billion of the \$12.5 billion of debt financing authorized by EFCFA. Further financing activity generally will coincide with cash flow requirements for already-committed projects. Appendix C provides a listing of all School Facilities Construction Bonds and Notes issued through the reporting period.

The EDA Board is expected to consider the sale of Qualified School Construction Bonds (QSCB) for a future bond issuance. QSCBs are zero-interest tax-credit bonds entitling the holder of the bonds to a federal tax credit in lieu of receiving tax-exempt interest income. The QSCB program was established under the American Recovery and Reinvestment Act (ARRA) of 2009. Proceeds from the sale of QSCBs must be used to finance the construction, rehabilitation or repair of public-school facilities. Each state and certain large school districts have been allocated an aggregate amount of QSCBs that they may issue. New Jersey's allocation is \$223 million. QSCBs are subject to a number of tax-exempt bond regulations as well as some special regulations modified by ARRA. Staffs from the EDA and the New Jersey Department of Treasury's Office of Public Finance have collaborated in examining the potential benefits of a QSCB sale.

## Statement of Need to Adjust Principal Amount of Bonds

The SDA's total funding allocation is fully committed through past project expenditures, the current capital plan, and the reserve fund that is used for emergent work. However, the Long Range Facilities Plans (LRFPs) filed by SDA Districts and RODs identify a need for approximately \$25-30 billion of additional school construction projects.

# Recommendations for Change/ Looking Ahead

## **Expanding Small, Women-owned, Minority-owned Business Participation**

The SDA is committed to increasing SBE participation in its contracting and will expand its outreach efforts to SBEs. On October 30, 2009, the SDA and the Building Contractors Association of New Jersey hosted a Contractor's Fair to help small, minority- and women-owned businesses learn about working with the SDA and the general contractors involved in the school construction program. The event attracted 250 attendees including contractors, exhibitors and panelists.

The SDA will also host roundtable discussions with minority- and women-owned businesses to discuss upcoming projects to assist in their participation, giving attendees the opportunity to have their concerns addressed.

In addition, the SDA has launched a portal on its home page (<a href="www.njsda.gov">www.njsda.gov</a>) to provide easier access to resources for small, minority- and women-owned businesses. The portal provides a link to upcoming contract opportunities and general information relevant to these businesses.

## **Building Energy Efficient and Environmentally Friendly Schools**

Requiring School Projects to Earn LEED Certification

SDA projects are designed to adhere to the LEED (Leadership in Energy and Environmental Design) standards established by the U.S. Green Building Council (USGBC). In spring 2009, the USGBC issued LEED for Schools v3, which includes new standards and requirements specifically suited to building energy-efficient, sustainably designed and constructed preK-12 schools.

Moving forward, SDA will require projects begun after the adoption of the 2007 21<sup>st</sup> Century Schools Design Manual to receive certification under LEED for Schools v3. LEED certification will ensure that the building's performance is consistent with the design expectations and requirements of the SDA, DOE, the school district and program stakeholders. LEED schools are more efficient to occupy and maintain, consume less energy and water, and produce less waste and pollution.

Updating the 21<sup>st</sup> Century Schools Design Manual and Creation of a Toolkit
The 21<sup>st</sup> Century Schools Design Manual guides SDA project staff, consultants and school districts through the design process, establishing performance standards to ensure that the resulting schools are cost-effective, durable, educationally effective and energy-efficient. SDA staff will be working to update the manual to include elements such as the LEED certification requirement.

The SDA is also working to develop a Toolkit as a prescriptive companion document to the performance-based 21<sup>st</sup> Century Schools Design Manual. The Toolkit will provide solutions to common design problems, based on lessons learned and best practices. In the

future, updates to the Design Manual and Toolkit will be issued on a three-year cycle. Between updates, new SDA requirements, best practices and lessons learned will be collected and issued as bulletins for immediate use in current projects.

## Streamlining Design

The SDA has determined that several aspects of its construction would benefit from the utilization of standardized design principals. An approach using a "kit of parts" would facilitate speed of design and construction inspections. A kit of parts may include plans for a set of modules, auditoria, cafeterias, school rooms, storage areas and labs, that can fit together as needed to create a fairly standardized, yet still site-specific, school design. Adopting a streamlined design approach in specific aspects of construction; cafeterias, gymnasiums, science labs and/or media centers; would assist SDA and districts in the expeditious delivery of school projects. The SDA will work toward the creation of an architectural agreement utilizing such components in the coming year.

## E-Rate

The E-Rate Program is administered by the Universal Service Administrative Company (USAC) under the direction of the Federal Communications Commission (FCC). This program annually provides \$2.25 billion in discounts to assist schools and libraries in the United States with obtaining affordable telecommunication and Internet access. Funding is provided in the form of reimbursement of costs for eligible services. SDA's past experience with this program yielded less than successful results, owing largely to a lack of understanding of the rather complex application process.

In September of this year, SDA delivered to its board of directors the results of an intensive and detailed research initiative on E-rate. SDA's research suggests that approximately 40 projects could return an estimated \$6.06 million in E-rate discounts. An RFP for E-Rate consulting services is currently being developed with the intention of aggressively pursuing E-rate discounts in 2010.

## **Total Building Commissioning**

The SDA is committed to assuring that all school projects are designed and built with operational systems that will assure a quality lifecycle for the facility. To that end, SDA is developing plans for total building commissioning for all new school facilities projects. The U.S. Department of Energy describes commissioning as "the process of ensuring that systems are designed, installed, functionally tested, and capable of being operated and maintained according to the owner's operational needs."

Total building commissioning strives to ensure the performance of all essential elements of the school facility including its structural elements, exterior enclosure system, roofing system, life safety elements, security system, elevators, plumbing and technology systems. Successful commissioning includes the training of operation and maintenance personnel, as well as the preparation of manuals and teaching tools to support that training.

**Appendix A: Requirements of the Report** 

## **Requirements of the Biannual Report**

35. Section 24 of P.L.2000, c.72 (C.18A:7G-24) is amended to read as follows:

C.18A:7G-24 Biannual report on school facilities construction program.

24. The development authority, in consultation with the State Treasurer, the financing authority, and the commissioner, shall biannually submit to the Governor, the Joint Budget Oversight Committee, the President of the Senate and the Speaker of the General Assembly a report on the school facilities construction program established pursuant to the provisions of this act. The report shall be submitted no later than June 1 and December 1 of each year and shall include, but not be limited to, the following information for the prior six-month period: the number of school facilities projects approved by the commissioner pursuant to section 5 of P.L.2000, c.72 (C.18A:7G-5); the number of projects undertaken and funded by the development authority; the aggregate principal amount of bonds, notes or other obligations issued by the financing authority for the State share of construction and renovation of school facilities and whether there is a need to adjust the aggregate principal amount of bonds, notes or other obligations authorized for issuance pursuant to subsection a. of section 14 of P.L.2000, c.72 (C.18A:7G-14); the number of approved projects which exceeded the facilities efficiency standards, the components of those projects which exceeded the standards, and the amount of construction by individual districts and Statewide estimated to have exceeded the standards; and recommendations for changes in the school facilities construction program established pursuant to this act which have been formulated as a result of its experience with the program or through collaboration with program stakeholders.

In addition, the biannual report shall include a comparison of the costs of school facilities projects undertaken and funded by the development authority to similar school facilities projects constructed in the New York City Metropolitan Statistical Area and the Philadelphia Metropolitan Statistical Area as defined by the United States Department of Labor. The development authority shall include in the report an explanation of the methodology used in making the comparison

To address the August 2007 statutory requirement that costs of school facilities projects undertaken and funded by the SDA be compared to similar school facilities projects constructed in the New York City and Philadelphia Metropolitan Statistical Areas (MSAs), the SDA subscribes to specific statistical data reports from McGraw-Hill Dodge Construction Reports.

The U.S. Office of Management and Budget (OMB) is responsible for developing the standards for defining MSAs and for applying these standards with Census data.

In addition to using the OMB's definitions of MSAs and to broaden comparisons of SDA projects with cost per square foot of other relevant projects, the SDA has supplemented its review with a recognized national-construction data source – the School Planning and Management 2009 Annual School Construction Report – as well as information from the School District of Philadelphia and the New York City Department of Education School Construction Authority. The use of multiple sources to monitor and analyze construction costs provides assurance that industry-wide pricing trends are addressed. The table below provides a comparison of cost per square foot for new school construction (public and private schools) within the Philadelphia and New York MSAs. For the period from April 1 through September 30, 2009, the MSA comparative cost per square foot was measured by cost-at-bid award.
