The ReachNJ campaign, announced in Governor Christie's State of the State address, has included a television commercial, radio ads, digital ads, and billboards. All are designed to alert the public to the www.ReachNJ.gov website and helpline 1-844-ReachNJ which connect those impacted by substance use disease with a variety of services and resources where they can get the help they need.

Since launching the campaign, thousands of people have accessed ReachNJ and the ad campaign has increased the number of people connecting with the service. For the first three months of 2017, there were almost 4,000 inquiries to ReachNJ. From April 1 to May 4, there were 2,685 contacts. In March, after the first wave of ads concluded, there were 921 contacts. For April, after the ads resumed, there were 2,385, an increase of 159 percent over the month

Website traffic also has vastly increased. ReachNJ website visits from January through March were 1,819, while there were 57,747 unique visits from April 6 to May 4. Those visitors spent an average of five and a half minutes on the site. In addition, more than 75 percent of the people who arrive on the ReachNJ home page, go on to visit other pages on the site.

Governor Christie continues to urge New Jerseyans battling addiction to seek help. There is no reason to suffer and they are not alone.
