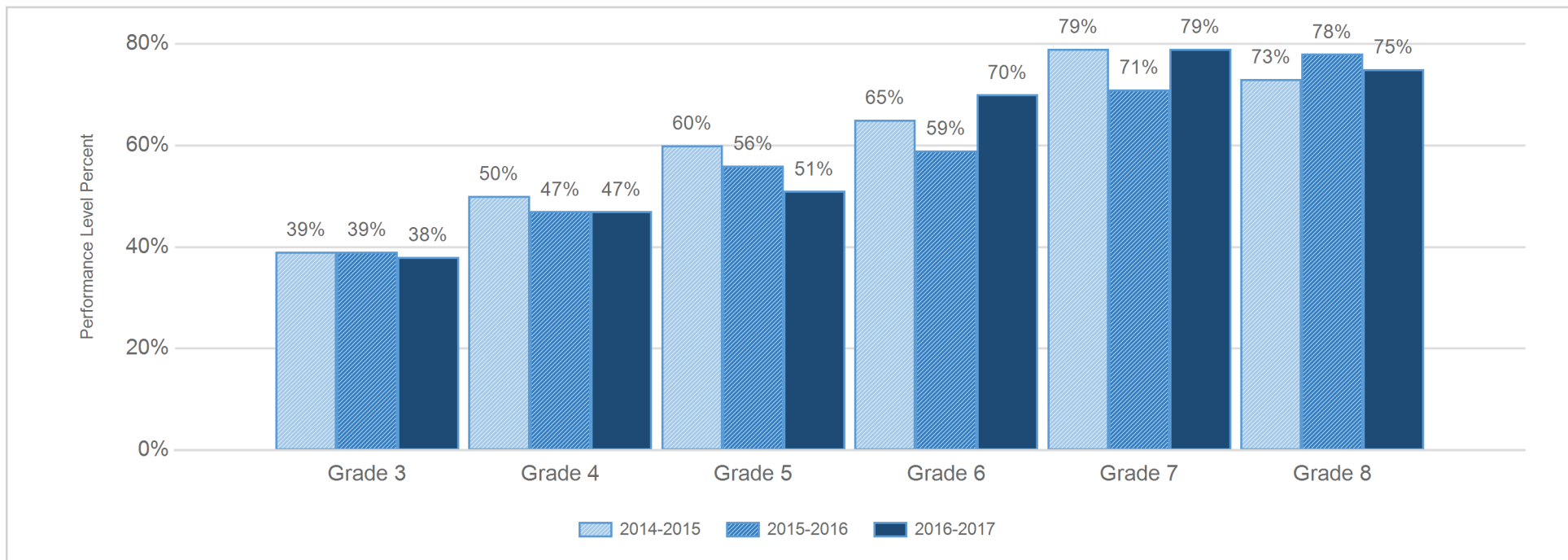

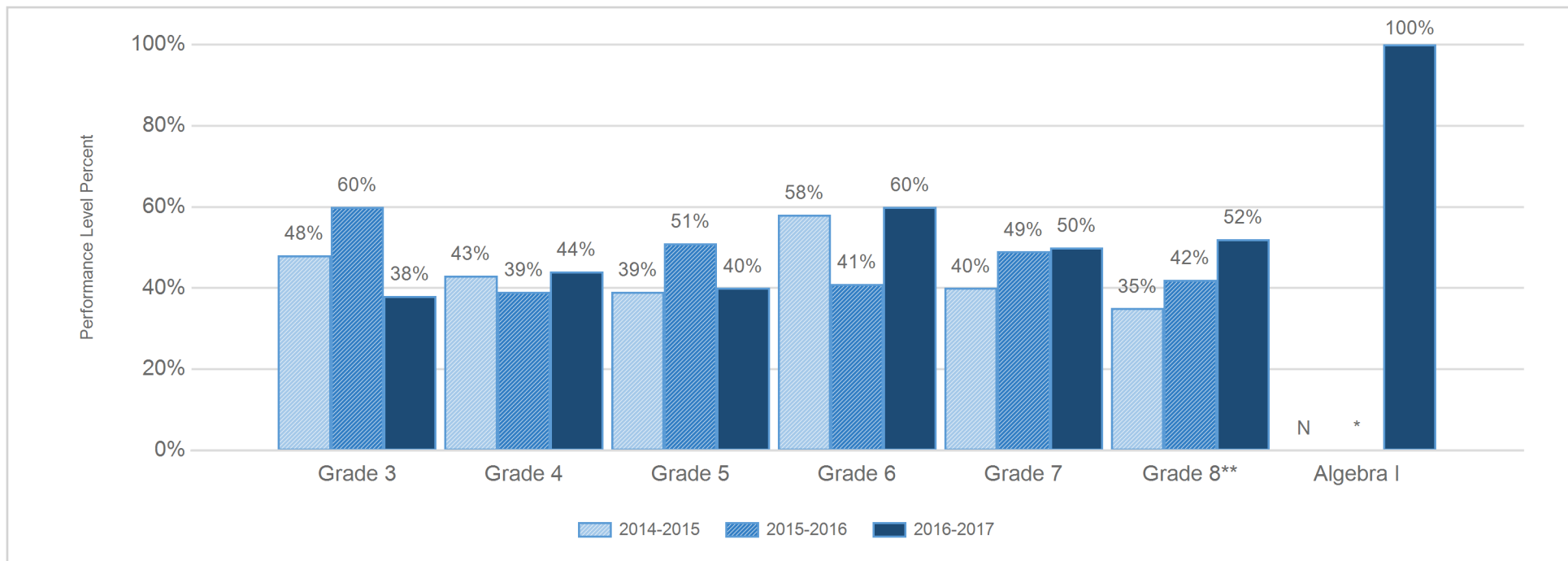

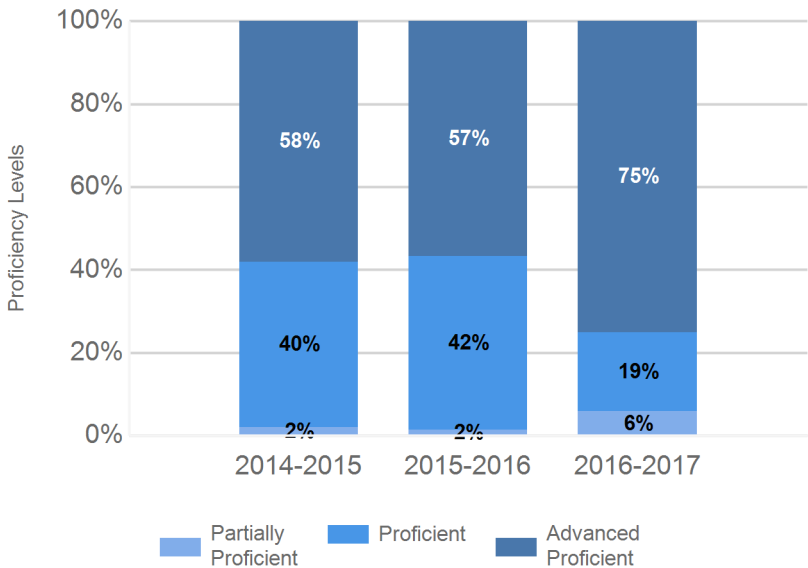

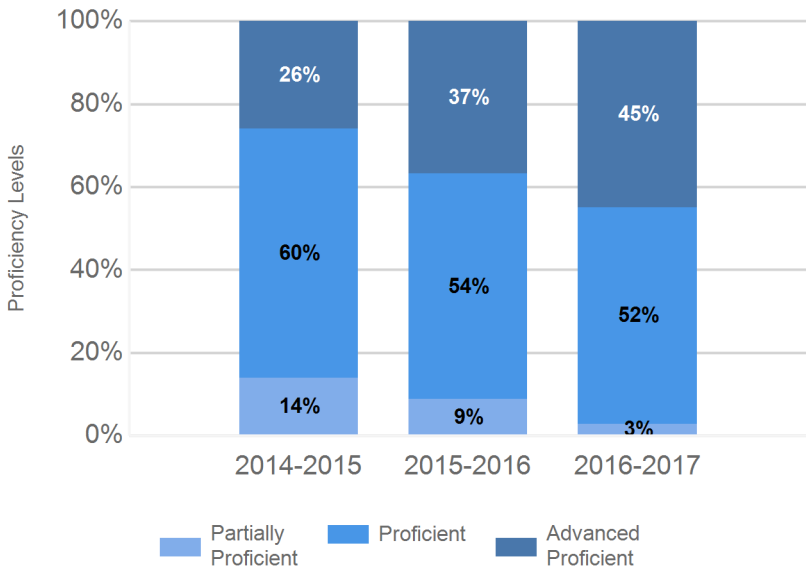

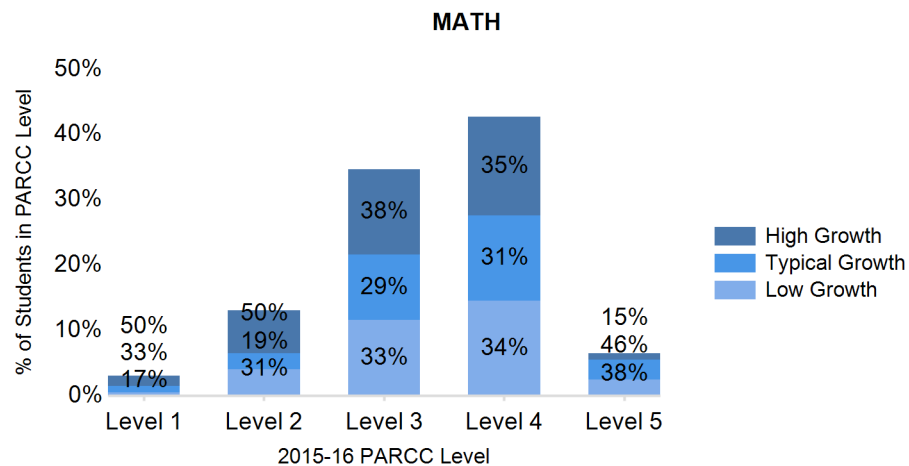
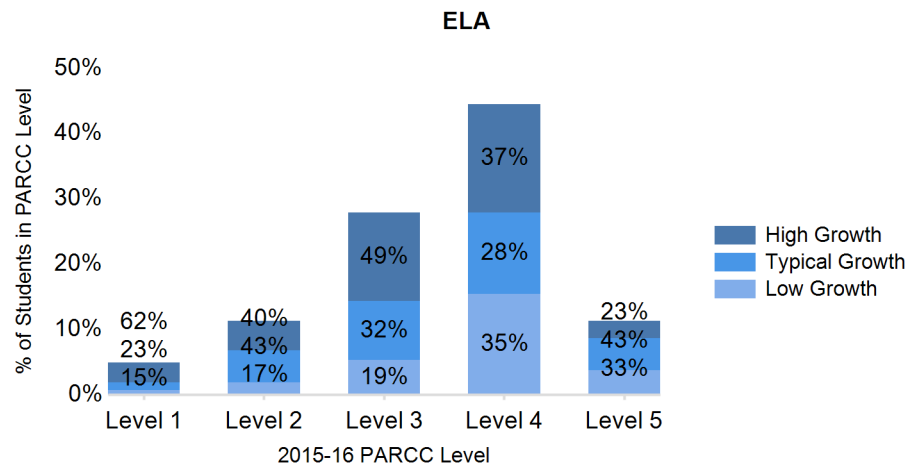

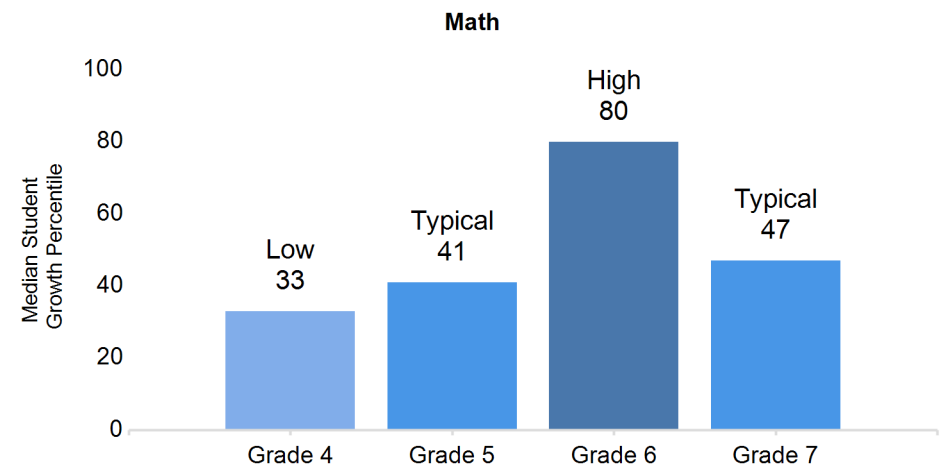
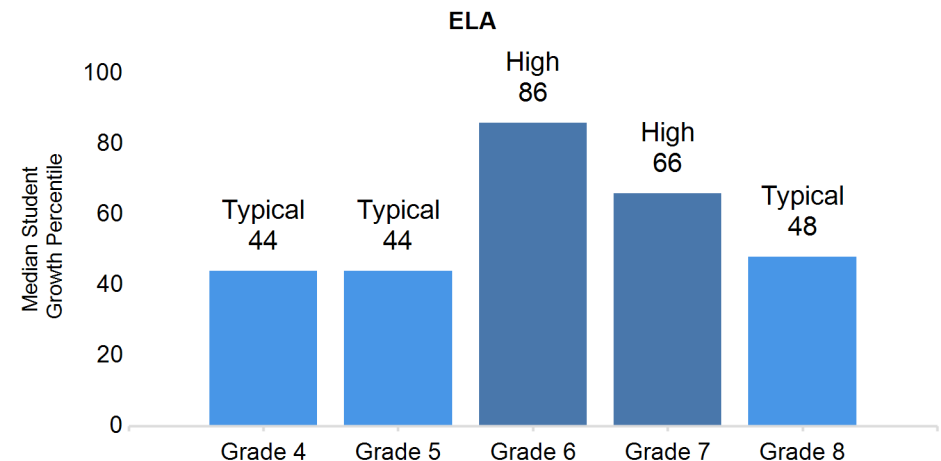
Student Growth by Performance Level

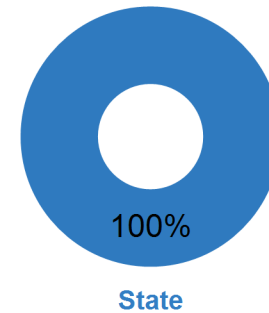

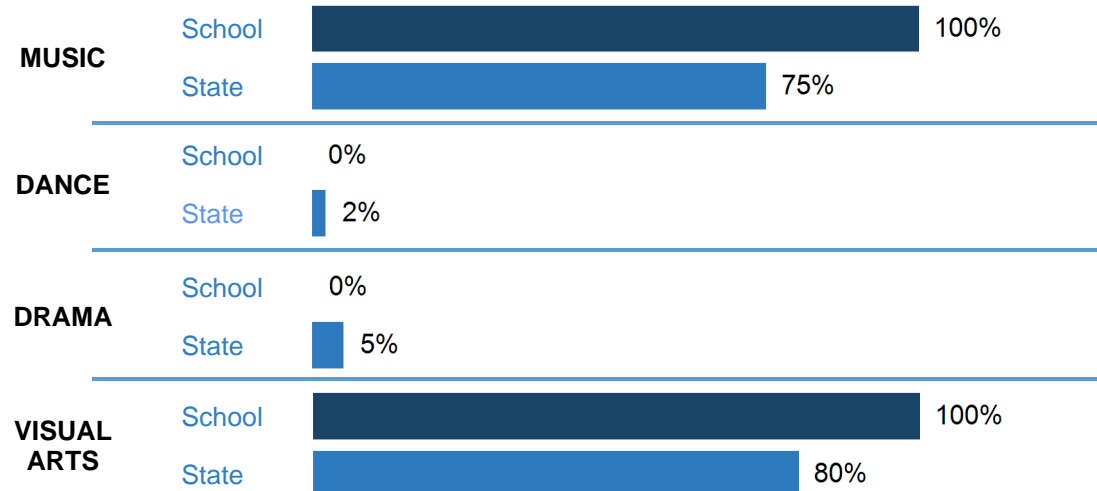

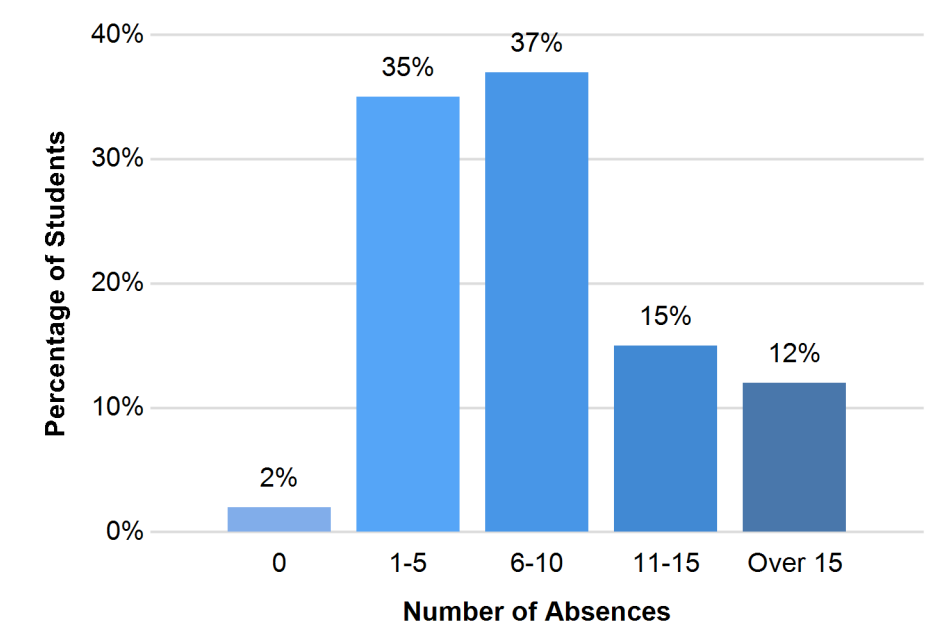

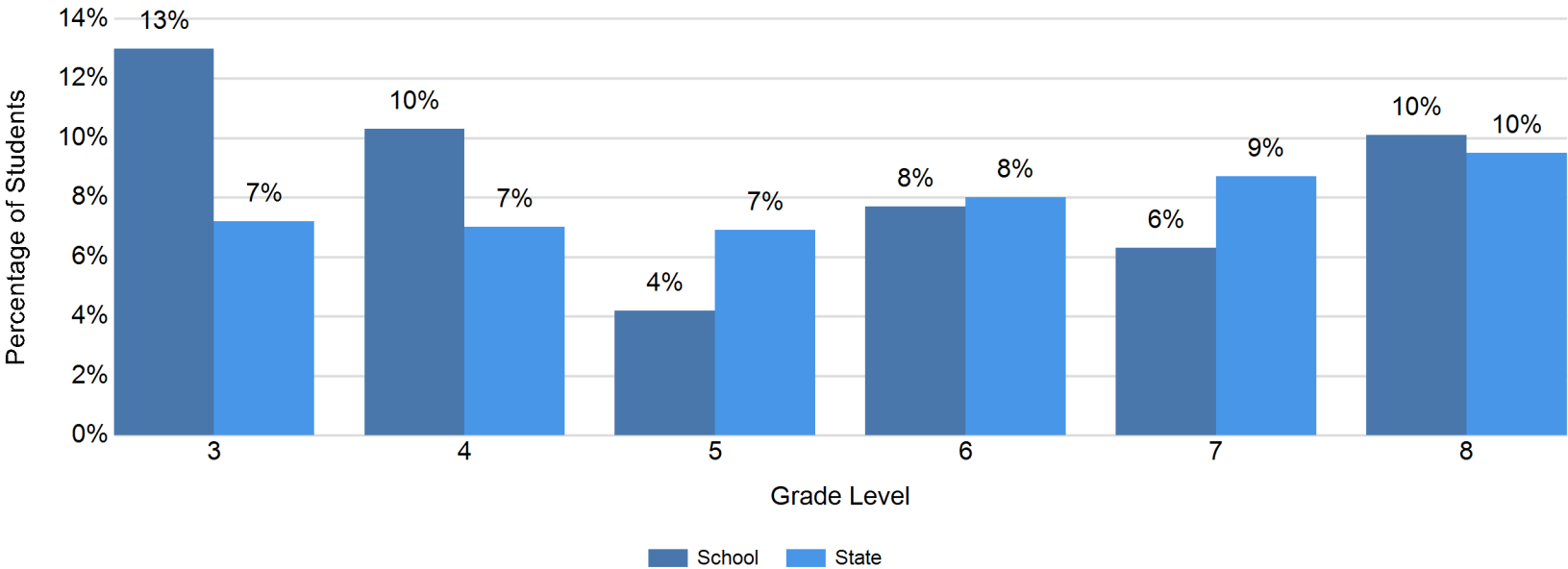
Days Absent

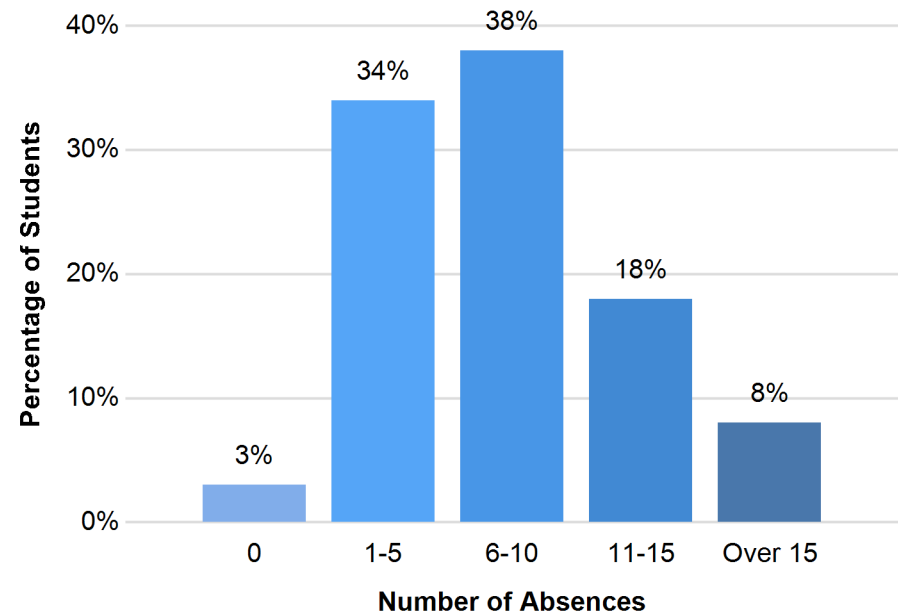

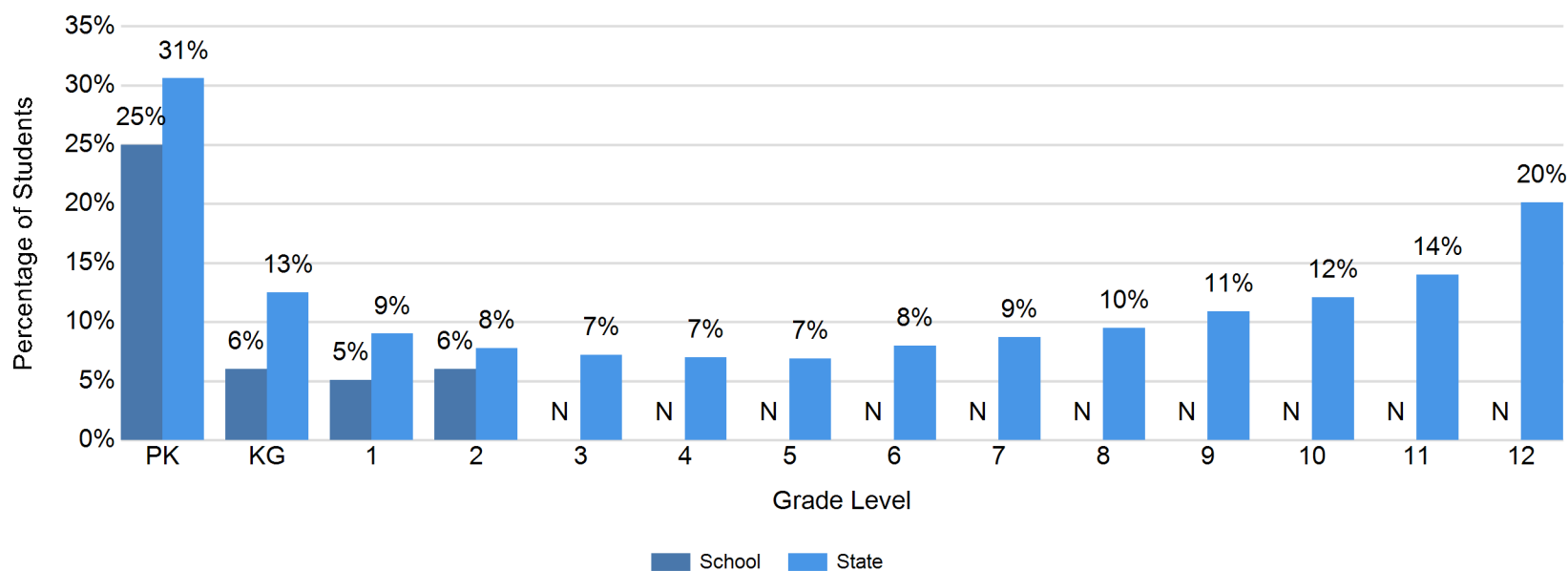

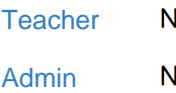
#### Bachelor's Degree
