EXECUTIVE SUMMARY

The New Jersey Wiretapping and Electronic Surveillance Control Act allows certain "consensual" intercepts to occur without the need for a prior court order. Specifically, *N.J.S.A.* 2A:156A-4c permits any person acting at the direction of an investigative or law enforcement officer to intercept a wire, electronic or oral communication where that person is a party to the communication or where one of the parties to the communication consents to the intercept. Because the officer directing the intercept is not a party to the communication, this class of intercepts is collectively designated "third party" consensual intercepts.

NFW JERSE

Likewise, *N.J.S.A.* 2A:156A-4b permits any investigative and law enforcement officer to intercept wire, electronic or oral communications where the officer himself is a party to the communication or where another officer who is a party to the communication requests or requires that he do so. Because the officer is a party to the communication being recorded, this class of intercepts is collectively referred as "non-third party" consensual intercepts.

The Wiretap Act directs the Attorney General to collect and maintain records of all intercepts falling into either of the above categories, regardless of whether the intercept is carried out by his office, a county prosecutor or local law enforcement agency. The Act further requires that the Attorney General report annually to the Governor and Legislature on the manner in which both classes of intercepts are conducted.

N.J.S.A. 2A:156A-23c provides as follows for third party intercepts:

In addition to reports and records otherwise required by law, the Attorney General and the county prosecutor shall maintain records of all interceptions authorized by them pursuant to [*N.J.S.A.* 2A:156A-4c], on forms prescribed by the Attorney General. Such records shall include the name of the person requesting the authorization, the reasons for the request, and the results of any authorized intercept. The Attorney General shall require that copies of such records maintained by county prosecutors be filed with him periodically and he shall report annually to the Governor and the Legislature on the operation of section 4c. *N.J.S.A.* 2A:156A-23d similarly provides for non-third party intercepts: In addition to reports required to be made by applicants pursuant to Federal law, the Attorney General shall receive and maintain records of all interceptions authorized pursuant to [*N.J.S.A.* 2A:156A-4b] and shall include such information in his annual report to the Governor and the Legislature. It shall be the obligation of all law enforcement agencies in the State to file with the Attorney General on forms prescribed by the Attorney General information pertinent to the operation of section 4b. The information on the forms shall include, but not be limited to (1) the name of the investigative or law enforcement officer making the interception; (2) the law enforcement agency employing the officer involved in the interception; (3) the character of the investigation or activity involved; and (4) the results of such activity.

The report that follows contains all the required information for 2001 concerning the operation of all non-third party and third party consensual intercepts permitted by *N.J.S.A.* 2A:156A-4b and c. In accordance with the statutory scheme, this report identifies the law enforcement agencies utilizing consensual intercepts, the character of the investigation or activity for which each intercept was sought and the results of the investigation or activity. In addition to the narrative highlights provided for applications and consensual intercepts for the year 2001, detailed intercept information for the current report year as well as supplemental follow-up data for consensual intercepts reported in previous calendar years are provided in the appendices.

THIRD PARTY CONSENSUAL INTERCEPTS (*N.J.S.A.* 2A:156A-4c) 2001

Third Party Consensual Intercept Applications

In 2001, 927 third party consensual intercept applications were reported statewide in accordance with *N.J.S.A.* 2A:156A-4c. Of the total applications seeking authorization, 197 were processed through the Attorney General's Office. These applications were submitted by the Division of State Police and the Division of Criminal Justice. The other 730 reported applications were processed by the 21 county prosecutors' offices.

- All 927 applications reported for consensual intercepts were authorized.
- . Of those 927 intercepts authorized, 686 were installed and used. In all, 241 intercepts were never implemented.

The type of surveillance conducted is categorized as wire, oral, or electronic communication.

Of the 888 intercepts authorized and for which type of surveillance was reported: (The type of surveillance conducted for 39 intercepts was not reported.)

- 356 (39%) involved both wire and oral intercepts;
- 291 (32%) involved wire intercepts;
- 209 (23%) involved oral intercepts;
 - 24 (3%) involved wire, oral and electronic communications intercepts;
 - 4 involved wire, oral and electronic communications intercepts;
 - 3 involved oral and electronic communications intercepts; and
 - 1 involved an electronic communications intercept.

Offense data collected and analyzed consider only the most serious substantive

offense investigated. Of those 927 consensual intercepts authorized, almost half (46%) were

authorized in conjunction with criminal investigations involving controlled dangerous

substance offenses. A list of intercepts granted by category of most serious offense

2001 Third Party Intercept Outcome

Summary information regarding outcomes is provided below with detailed information in Appendix A.² The information provided concerns intercept and investigation outcomes, arrest and referral actions, defendant indictments resulting from each intercept application, the most serious offense charged, defendant dispositions, and administrative actions.

At the close of the report year (December 31, 2001), a total of 311 arrests were made and 147 defendants were indicted statewide as a result of 2001 third party consensual intercepts.

Of those 147 defendants indicted, considering the most serious offense charged, 68 (46%) were indicted for controlled dangerous substance offenses.

In addition, 21 (14%) defendants were indicted for theft offenses, 19 (13%) were indicted for official misconduct, 11 (7%) were indicted for sexual assault, 9 (6%) were indicted for forgery or fraud offenses, and 6 (4%) were indicted for gambling offenses.

Four defendants were indicted for arson/risking widespread injury, 3 were indicted for weapons violations and 2 were indicted for murder offenses.

Moreover, one defendant was indicted for each of the following offenses: burglary, endangering the welfare of a child, strict liability, and perjury.

In addition to those 147 defendants indicted, 138 were arrested and awaiting grand jury action at the close of the report year and 18 were referred for further action (15 were referred to another jurisdiction for criminal investigation or prosecution, 1 was referred to family court, 1 was referred to municipal court and 1 was referred for administrative action).

In addition, 4 defendants were admitted into pre-indictment diversionary programs and 1 pled guilty to a disorderly persons offense.

At the close of the report year, 71 of the147 defendants indicted reached final disposition.

Of those 71 defendants with indictments reaching final disposition, 65 (92%) were convicted through plea, 5 had charges dismissed, and 1 was accepted into a post-indictment diversionary program.

NON-THIRD PARTY CONSENSUAL INTERCEPTS (N.J.S.A. 2A:156A-4b) 2001

In 2001, 413 non-third party consensual intercepts were reported in accordance with *N.J.S.A.* 2A:156A-4b. Of the total non-third party intercepts reported, 68 were processed by the Attorney General's Office and 345 were processed by county and local law enforcement agencies.

Seven of the 21 counties (Atlantic, Bergen, Burlington, Cape May, Hunterdon, Monmouth, and Warren counties) reported non-third party intercepts processed by either county law enforcement agencies or local police departments.

Of the 413 non-third party intercepts reported, 390 were installed and used. The remaining 23 were never implemented.

The type of surveillance conducted is categorized as wire, oral, or electronic communication.

Of those non-third party intercepts installed and utilized and for which the type of surveillance was reported (396):

316 (80%) involved oral intercepts;

49 (12%) involved wire intercepts;

25 (6%) involved both wire and oral intercepts;

- 3 (1%) involved electronic communications intercepts; and
- 3 (1%) involved oral and electronic communications intercepts.

New Jersey State Library

Offense data collected for non-third party intercepts and analyzed consider the most serious substantive offense investigated. Offenses investigated were reported for 409 of the 413 intercepts. A list of all intercepts by most serious offense, offense category or violation investigated follows.

2001 Non-Third Party Intercept Outcome

Summary information regarding intercept outcomes is provided below with detailed information provided in Appendix B.⁴ The information provided concerns intercept and investigation outcomes, arrest and referral actions, defendant indictments resulting from each intercept application, the most serious offense charged, and defendant dispositions.

³ Includes four intercepts for which the offense data was missing and one each of the following: bribery, burglary, murder, obstruction of justice, and a zoning violation.

⁴ In addition to defendant indictment and disposition data for 2001 non-third party consensual intercepts, Appendix B provides supplementary follow-up data for intercepts reported in previous calendar years.

At the close of the report year (December 31, 2001), a total of 55 defendants were indicted statewide as a result of 2001 non-third party consensual intercepts.

Of those 55 defendants indicted, considering the most serious offense or offense category charged, 45 (82%) were indicted for controlled dangerous substance violations.

In addition, 3 defendants were indicted for official misconduct and 3 were indicted for theft offenses.

The remaining four defendants were indicted as follows: two were indicted on gambling offenses; one was indicted on endangering the welfare of a child; and one was indicted on a weapons violation.

In all, 2001 non-third party consensual intercepts resulted in 154 arrests during the report year.

In addition to those 55 defendants who were indicted, 79 were pending grand jury action at the close of the report year, 13 defendants were referred to another agency or jurisdiction for prosecution (5 of which were referred to another jurisdiction for criminal prosecution, 4 were referred to family court for disposition, and 4 were referred to municipal court for disposition), 5 had charges administratively dismissed, 1 was admitted into a pre-indictment diversionary program, and 1 was no billed.

At the close of the report year, 16 of the 55 defendants indicted reached final disposition.

Of those 16 defendants reaching final disposition, 13 were convicted through guilty pleas, 2 were admitted into a pretrial diversion program, and 1 had charges dismissed.
