Messrs. Gilfillan, Parker and Mses. Ferguson, Maxwell, and Bliss were present at the July 15, 2019 Council Meeting. Mr. Delany was present at this meeting. All applications for decision were approved on a motion by Mr. Johnson and a second by Mr. Maxwell. Mr. Babb informed the applicants they have 30 days to sign their lease agreements and pay the lease fees.

\*\*\*Note: Mr. Edward M. Dwyer's application for lot 412.1 in Great Bay-Big Creek had been previously approved at the July 15<sup>th</sup> Council Meeting. After approval, the US Army Corps of Engineers had raised navigation concerns in using floating oyster gear on that lease. To alleviate this issue, Mr. Dwyer's was moved from lot 412.1 to the adjacent lot 411.1. Mr. Dwyer was also present at this meeting.

#### 6. Old Business:

Offshore Wind Update

Mr. Cimino gave a brief update on the status of offshore wind projects in New Jersey. He informed the Council that there was no new information to specific cable routes but would update the Council as new information becomes available.

## 7. New Business:

NJDOT Herbicide Spraying

Mr. Johnson stated that NJDOT has been spraying herbicide throughout Ocean County and the overspray was going directly into the watershed. He proposed that Council sends a letter raising their concerns with the herbicide spray runoff and its impacts on shellfish resources.

## 2019-2020 NJ Surf Clam Harvest Quota

The Bureau of Shellfisheries completed its annual surf clam inventory in June 2019. The 2019 standing stock estimate was 30,800 standard bushels (20,328 industry bushels). In August, the Bureau discussed the quota with the Surf Clam Advisory Committee (Committee). The Committee recommended a minimal quota for the 2019-2020 season to be set at 1,824 industry bushels, which was less than 10% the estimated standing stock as per N.J.A.C. 7:25-12. Harvest has been non-existent for well over a decade. It was anticipated that there would be no harvest of the quota during the 2019-2020 season. The minimal quota was set to the industry's place hold in the fishery if stocks were to improve in the future. A motion was made by Mr. Johnson to approve the committee's recommendation for the surf clam quota and was seconded by Mr. Maxwell.

#### Milford Aquaculture Seminar

Mr. Avery informed the Council that the Milford Aquaculture Seminar will be held January 13-15th, 2020 in Shelton, Connecticut.

#### Leases availability GEHB

Mr. Gormley asked if there were any shellfish leases available in Great Egg Harbor Bay. He suggested that if nothing was available, he had an interest in proposing a new lease area. Mr. Maxwell informed him that there was a procedure for proposing a new lease area and he could submit a proposal for discussion at the next Leasing Committee meeting in January 2020.

Lease Renewals

Mr. Babb informed the Council that lease renewals would begin on October 15, 2019.

Having no further business, the meeting was adjourned on motion by Mr. Johnson and seconded by Mr. Maxwell.
