





A student's SGP falls between 1 and 99 and can be grouped into three level

Low Growth: Less than 35

Typical Growth: Between 35 and 65

High Growth: Greater than 65






These graphs show the percentage of students by 2016-17 PARCC performance level that fall into each of the three levels of growth based on their 2017-18 test scores.

































