1. NEW LOCATION AND MAIL ADDRESS FOR DIVISION OF ALCOHOLIC BEVERAGE CONTROL.

On March 26, 1988, the Division of Alcoholic Beverage Control moved from the Richard J. Hughes Justice Complex, in Trenton, to the 3rd and 4th floors of the TRW Complex, Building 20, located at 200 Woolverton Street, also in Trenton. The mailing address for the Division was not changed and remains as CN 087, Trenton, NJ 08625-0087. Telephone numbers also remain unchanged.

2. APPOINTMENT OF PERMANENT EXECUTIVE OFFICER FOR DIVISION OF ALCOHOLIC BEVERAGE CONTROL.

In Bulletin 2451, Item 4, the Division announced organizational changes and the creation of the position of Executive Officer. The permanent Executive Officer was appointed effective July 18, 1988, in the person of Peter B. Ellis, of Marlton, New Jersey. Executive Officer Ellis' direct telephone number is (609) 984-2692.

3. RECENT LEGISLATION - AMENDMENTS TO "TIED-HOUSE" STATUTE (N.J.S.A. 33:1-43) - TEXT OF AMENDED STATUTE - DIRECTIVE REGARDING APPLICATION OF THE AMENDMENT.

On January 15, 1988, Governor Kean signed S-2891, which had earlier, in 1987, been recommended by the A.B.C. Study Commission and sponsored in both houses by the legislator-members of the Study Commission, as Chapter 433 of the Laws of 1987. The new law makes two amendments to N.J.S.A. 33:1-43, commonly known as the "Tied-House Statute".

The first amendment is to N.J.S.A. 33:1-43,a, which adds the words "in New Jersey" to clarify that the restriction on a supplier or wholesaler from having an interest in the retailing of alcoholic beverages applies only to a retail interest in New Jersey and not in another state or country. This was necessary because some states permit such interests and some suppliers who legally have retailing interests in those states or countries where permitted and who have New Jersey manufacturing or wholesaling licenses could be viewed as violating the New Jersey law by having the out-of-state retailing interest absent the amendatory language.

The other amendment is to N.J.S.A. 33:1-43, c(3). A prior amendment (L. 1983, c. 572) permitted, as an exception to the tied-house law, the holder of an alcoholic beverage manufacturing or wholesaling interest to have an interest in a hotel or motel having a retail consumption license in this State, providing certain criteria were met. That exception, however, prohibited the sale in that hotel or motel of any product manufactured or wholesaled, whether directly or indirectly, by the person or corporation having the interest in the hotel. The new amendment ameliorates this prohibition by allowing sales of such alcoholic beverage products, but only to the extent that those products do not exceed five per cent of the total annual volume of alcoholic beverages purchased and sold by the hotel or motel licensee.

The full text of N.J.S.A. 33:1-43, as amended by L. 1987, c. 433, now reads as follows:

33:1-43. a. It shall be unlawful for any owner, part owner, stockholder or officer or director of any corporation, or any other person whatsoever interested in any way whatsoever in any brewery, winery, distillery or rectifying and blending plant, or any wholesaler of alcoholic beverages, to conduct, own either in whole or in part, or be directly or indirectly interested in the retailing of any alcoholic beverages in New Jersey except as provided in this chapter, and such interest shall include any payments or delivery of money or property by way of loan or otherwise accompanied by an agreement to sell the product of said brewery, winery, distillery, rectifying and blending plant or wholesaler.

b. It shall be unlawful for any owner, part owner, stockholder or officer or director of any corporation, or any other person whatsoever, interested in any way whatsoever in the retailing of alcoholic beverages to conduct, own either whole or in part, or to be a shareholder, officer or director of a corporation or association, directly or indirectly, interested in any brewery, winery, distillery, rectifying and blending plant, or wholesaling or importing interest of any kind whatsoever.

No interest in the retailing of alcoholic beverages shall be deemed to exist by reason of the ownership, delivery or loan of interior signs designed for and exclusively used for advertising the product of or product offered for sale by such brewery, winery, distillery or rectifying and blending plant or wholesaler.

c. Nothing in this section shall prohibit:

(1) The exercise of limited retail privileges by Class A or Class B licensees conferred pursuant to R.S. 33:1-10, R.S. 33:1-11, by rule or regulation or by special permit issued by the director;

(2) Any owner, part owner, stockholder, officer or director of any corporation, or any other person whatsoever interested in any way whatsoever in any brewery, winery, distillery, rectifying and blending plant or any wholesaler of alcoholic beverages, from conducting, owning, either in whole or in part, or being directly or indirectly interested in the retailing of

any alcoholic beverages, under any retail consumption license or State issued permit, in conjunction with and as a part of the operations of a hotel or motel; or

(3) Any owner, part owner, stockholder or officer or director of any corporation, or any other person or corporation interested in any way whatsoever in the retailing of alcoholic beverages, under a retail consumption license or State issued permit, in conjunction with and as a part of the operations of a hotel or motel from conducting, owning, either in whole or in part, or being a shareholder, officer or director of a corporation or association, directly or indirectly interested in any brewery, winery, distillery, rectifying and blending plant, or wholesaling or importing interest of any kind whatsoever.

No more than 20% of the total gross annual revenues of a hotel or motel described in paragraphs (2) and (3) shall be derived from the sale of alcoholic beverages by the hotel or motel. A retail licensee described in paragraphs (2) and (3) shall not purchase or sell any alcoholic beverage product produced or sold by the brewery, winery, distillery, rectifying and blending plant, wholesaler or importer that has any interest in the retail license of the hotel or motel, unless the total of all such products is 5% or less of the total volume of alcoholic beverage products purchased and sold annually by the hotel or motel holding the retail license. The retail licensee shall, within 30 days following the effective date of this act, file with the Division of Alcoholic Beverage Control a list of all alcoholic beverage products which shall not be purchased or sold by the hotel or motel except to the extent permitted herein. Thereafter, the retail licensee shall file a new or amended list with the division within 30 days of any changed circumstances which affect the information on the list. This list shall be made available to the public upon request.

For purposes of this subsection "hotel" or "motel" means an establishment containing at least 100 guest room accommodations where the relationship between the occupants thereof and the owner or operator of the establishment is that of innkeeper and guest.

Retail licensees operating a hotel or motel pursuant to the exception in N.J.S.A. 33:1-43,c (2) or (3) are reminded that, in addition to filing the list of "tied" products with the Division, as has previously been required, records adequate to demonstrate that the "tied" products purchased and sold by the licensee do not exceed 5% of the total annual volume, measured in wine gallons, of all the alcoholic beverages purchased and sold by such retail licensee, must be maintained and available for inspection by persons authorized to enforce the alcoholic beverage control laws. At the time of filing the annual license renewal application, the retail licensee operating a hotel or motel pursuant to the exception in N.J.S.A. 33:1-43,c (2) or (3) shall also certify to the Division that not more than 5% of its total volume of alcoholic beverages purchased and sold during the preceding year was produced, imported or sold by or purchased from a person or corporation having a "tied-house" relationship with such retail licensee.

4. NOTICE TO RETAIL CONSUMPTION LICENSEES: SUMMARIZATION OF PERMITTED PROMOTIONAL PRACTICES INVOLVING "FREE" OR COMPLIMENTARY ALCOHOLIC BEVERAGES - WHEN PERMITTED; SIZE OF COMPLIMENTARY DRINK; HOTEL PACKAGES; GENERAL REMINDER TO ALL LICENSEES.

Due to the increasing number of questions received in the Division regarding the permissibility to offer "complimentary" alcoholic beverage drinks to patrons, it is appropriate to reiterate the Division's position in this area.

In *Bulletin 2381, Items 2 & 4* (December 12, 1980) and *Bulletin 2440, Item 2* (March 27, 1985), three exceptions that allow a retail licensee the option to offer a patron a free or complimentary alcoholic beverage under specific circumstances were noted. Normally, a retail licensee cannot sell or deliver alcoholic beverages, either in an original sealed container for off-premises consumption or in an open container for on-premises consumption, below the retailer's cost. *N.J.A.C. 13:2-24.8*. Computation of cost is based on invoice price and a fuller development of how cost is computed is contained in *Bulletin 2429, Item 3* (December 14, 1982).

The first exception allows a licensee to offer a patron a free drink. In conducting this promotion the licensee can utilize a ticket, token or coupon to represent the free drink. Receipt of the free drink cannot be conditioned upon buying another drink, and only one coupon may be redeemed per person for any single twenty-four hour time period.

The Division recognizes as a second exception the practice of a licensee's offering a patron a free drink as a gesture of good will and friendship. A licensee, however, may not advertise a program that it will offer the free drink at stated intervals or based upon the number of drinks a patron purchases. The offer of a free drink must not be conditioned upon some other drinking activity by the patron. In that regard it should be noted that where someone identified as other than the licensee, such as the "band" or "DJ" offers a free drink for certain patrons or during certain time periods, those activities will only be permitted if the licensee could lawfully conduct such a promotion. The "band" or "DJ" is considered for alcoholic beverage control purposes as the licensee's "employee" since their services are in furtherance of the licensed business. The licensee is responsible for their actions. Thus, a promotion that offers one free drink "on the DJ" can be lawful because the licensee itself could conduct such a promotion. An offer of free drinks to all ladies for two hours "on the DJ" cannot be done because it involves more than one free drink and cannot be done by the licensee.

The third exception involves the ability of a licensee to offer and include a complimentary alcoholic beverage with a meal. It should be emphasized that the licensee can only provide one drink with a meal. Promotions which offer to the general public unlimited alcoholic beverages at "Champagne Brunches" or the like are not

allowed. That type of promotion specifically violates the provisions of N.J.A.C. 13:2-23.16. Only one "free" or complimentary drink can be offered with a meal. Only at private parties which are not open to the general public, such as weddings, may a licensee offer to the sponsor of the party an "open bar" for the sponsor's guests. (This practice has also been permitted for New Year's Eve parties, even though such functions might be open to the general public. That, however, is the only exception.)

Having restated the three "free drink" exceptions, it is now appropriate to address the question: What is the permissible size or container for the free or complimentary drink? Initially, the Division did not feel it necessary to prescribe the size of the free drink and had indicated that the "drink" could be a carafe, pitcher, glass, etc. Bulletin 2381, Item 4 (December 12, 1980). The Director is concerned with the lack of size limit on free or complimentary drinks and, in the interest of responsible consumption practices, previous policy shall be modified. Henceforth, "free" or complimentary alcoholic beverage drinks with a meal may only be offered in the glass from which the patron will drink, or a "split" (187 ml.) of wine may be given to two persons. Except for the "split", other intermediate containers such as carafes and pitchers, from which the beverage is then poured into the drinking glass, will not be permitted.

One final question that has frequently arisen in this context concerns the offering of a bottle of champagne or similar sparkling or still wine to patrons in connection with certain hotel promotions. The complimentary drink exceptions stated above are generally restricted to serving an open container glass to the patron. It is recognized, however, that under certain circumstances it may be appropriate, and it will henceforth be permitted, to offer a complimentary bottle of champagne or wine (not to exceed 750 ml. in size) in its sealed original container to hotel guests as part of a weekend, honeymoon or other specialty package by retail licensees operating at hotels or motels, provided that the primary occupants of the room are at least twenty-one years of age.

Finally, the Director reminds all licensees that they are entrusted with the high responsibility of dispensing alcoholic beverages to the public. Vigilance and concern must be taken to avoid service of alcoholic beverages to actually or apparently intoxicated patrons. Promotions which unduly promote the consumption of alcoholic beverages are not consistent with these responsibilities and must be avoided.

This notice supersedes all prior Bulletin items on the subject of "free" or complimentary drinks.

5. NOTICE TO RETAIL CONSUMPTION AND CLUB LICENSEES REGARDING PACKAGES WHICH INCLUDE AN "OPEN BAR": SALES TAX; UNDERAGED PERSONS ATTENDING.

In Item 4 of this Bulletin, the permissibility of offering an "open bar", or the unlimited availability of alcoholic beverages, for private parties (such as wedding receptions) not open to the general public, or for New Year's Eve parties, was noted. It has come to the attention of the Director, however, that licensees not infrequently offer and sell an entire food and beverage package at a single price and, when billing it to the customer, charge New Jersey retail sales tax on the entire price. This is improper.

The charging of retail sales tax by retail licensees was discussed in *Bulletin 2434, Item 5* (March 13, 1984), and in *Bulletin 2437, Item 8* (December 27, 1984). Therein it was noted that N.J.S.A. 54:32B-8.34 of the New Jersey Sales and Use Tax Act provides an exemption from sales tax for the retail sales of alcoholic beverages as defined in the Alcoholic Beverage Tax Law.

Because the retail sales of alcoholic beverages are exempt from sales tax, it is impermissible for a licensee to include alcoholic beverages in a package price and charge sales tax on the entire amount. The amount of the package attributable to alcoholic beverages must be separately stated to the consumer and must be separated from the total bill (for the food, rental, etc.) on which sales tax must be charged. (This is not applicable in the case of the "free" or complimentary drink included with a meal, as was also discussed in Item 4 of this Bulletin, because there the alcoholic beverage is "free", even though it is realistically charged for in the meal price.)

Similarly, where there will be persons under the age of 21 years attending a party where there is an "open bar" included, the amount of the package attributable to alcoholic beverages must be deducted for the number of such persons attending. It is the responsibility of the licensee to ascertain from the person arranging the party the number of underaged persons who will be in attendance, and to thereafter take proper steps to assure that alcoholic beverages are not available to or served to those underaged persons. In this situation, it is permissible, but not required, for the licensee to assess a non-alcoholic beverage charge for such underaged persons; but this charge should realistically be less than the alcoholic beverage charge and, if made, it is subject to sales tax. It is also not required for a licensee to deduct the alcoholic beverage portion of the package for persons aged 21 or over who are identified as not being consumers of alcoholic beverages.

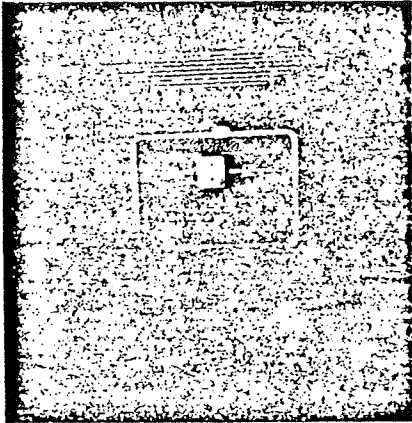
6. VIDEO POKER AND OTHER SIMILAR TYPE MACHINES - RESTATEMENT OF BAN - ADDITIONAL EXCEPTIONS.

In *Bulletin 2430, Item 3* (March 31, 1983), notice was given that video machines which resemble games of cards, dice, roulette, etc., are not permitted in liquor licensed premises in New Jersey as they are violative of N.J.A.C. 13:2-23.7(a)4. In *Bulletin 2434, Item 9* (March 13, 1984), the ban was reiterated, but certain exceptions were granted where the machine is an entertainment device in the true

sense of the word rather than a gaming device. In that Bulletin item, four exceptions were identified; three were added in *Bulletin 2435, Item 4* (April 19, 1984); and two more were added in *Bulletin 2437, Item 4* (December 27, 1984)

Since that time, four additional exceptions have been issued:
