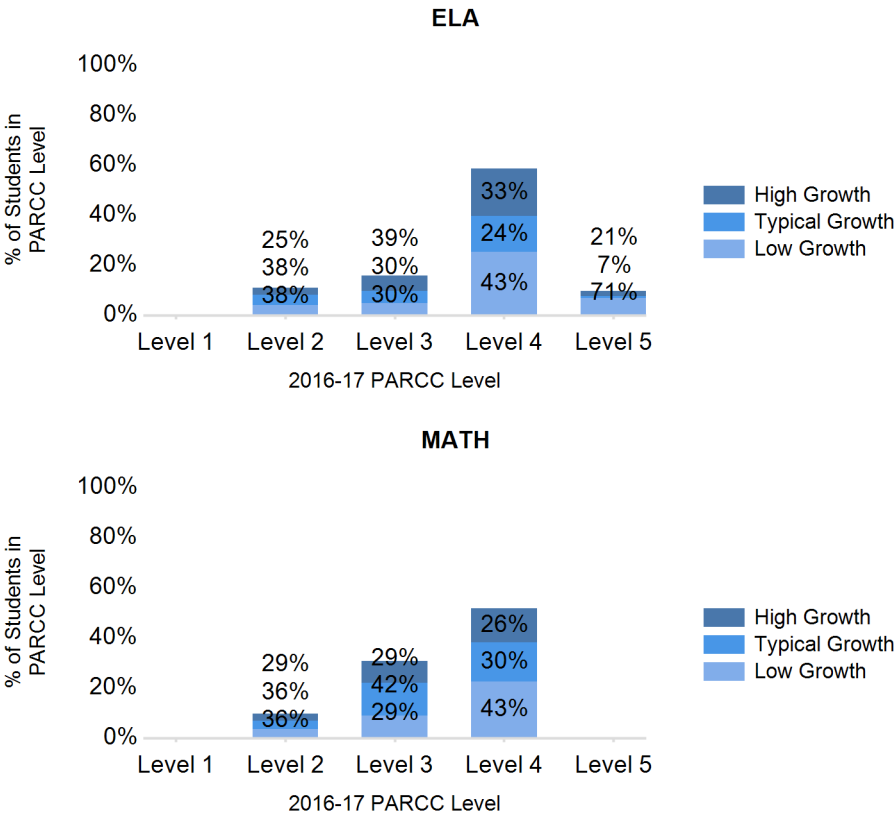

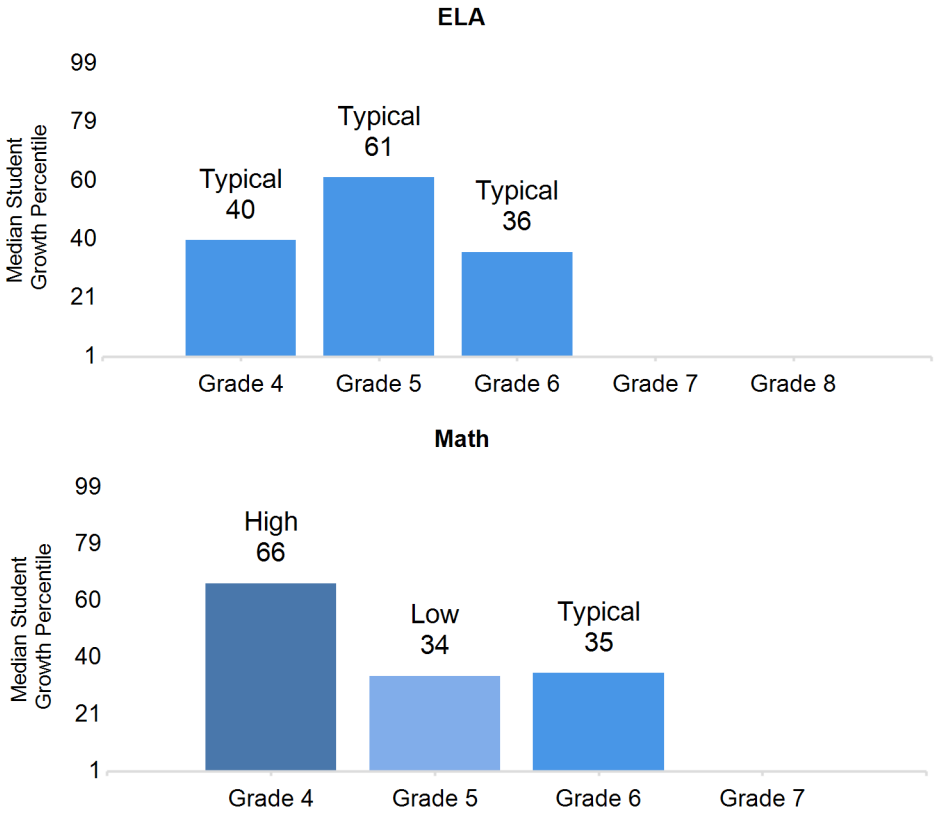
Student Growth by Performance Level

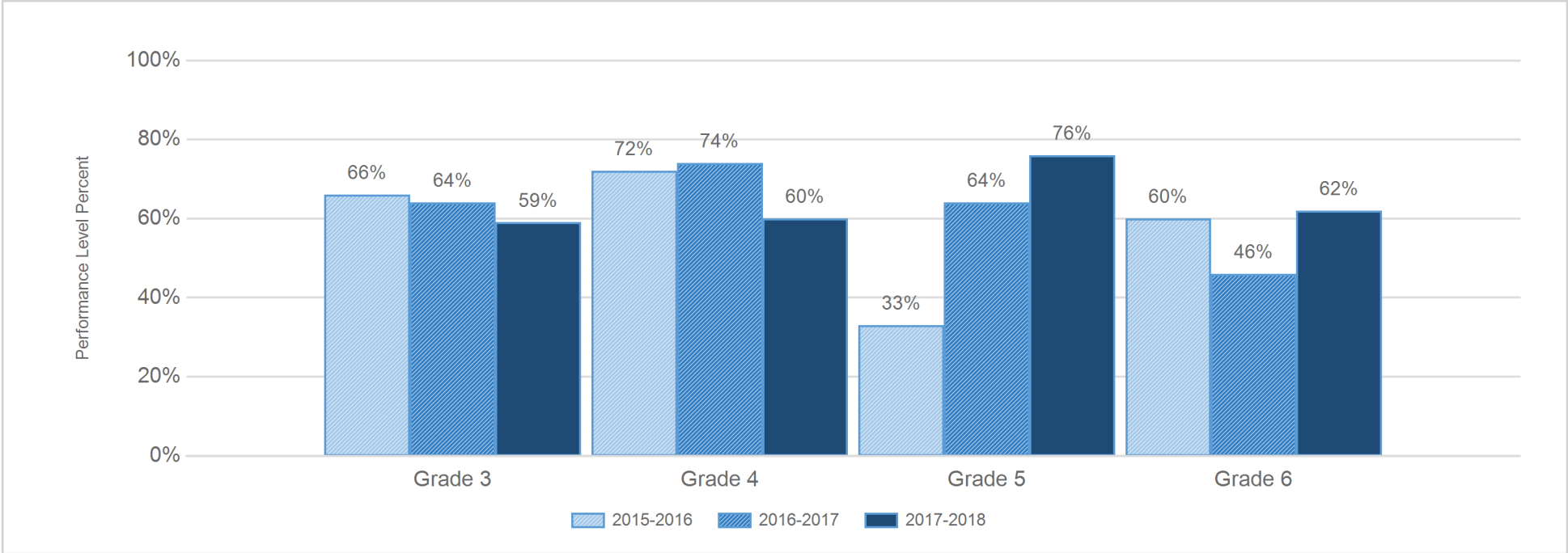

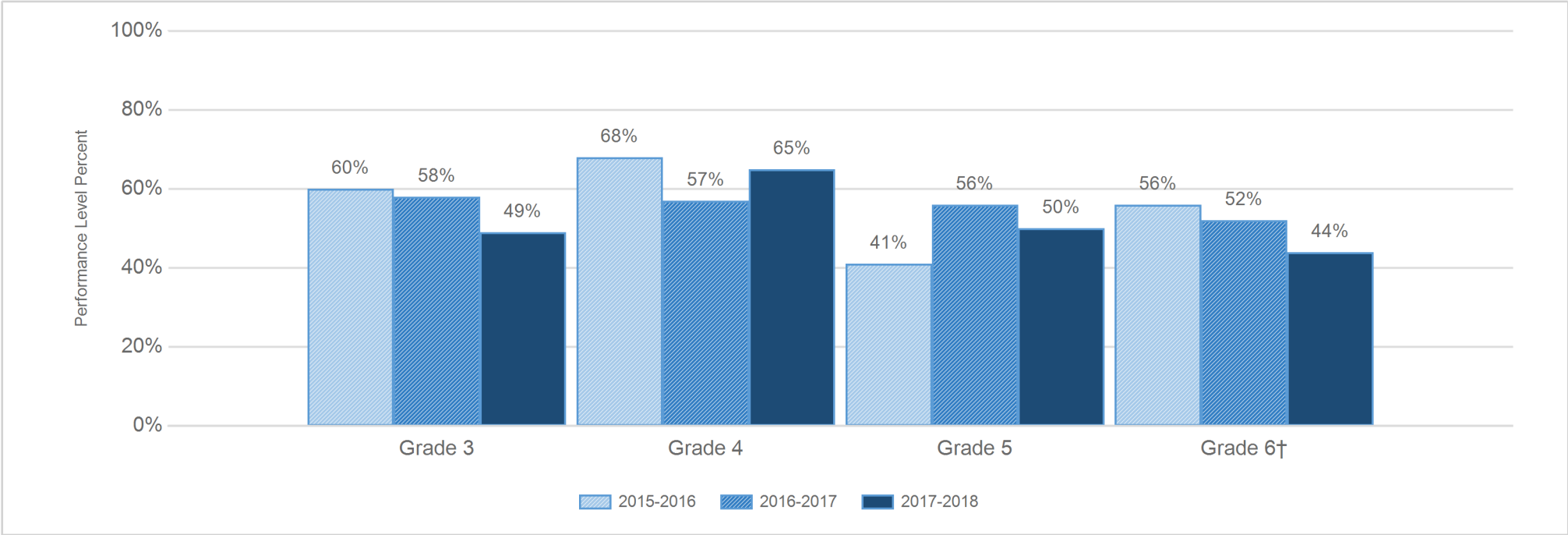

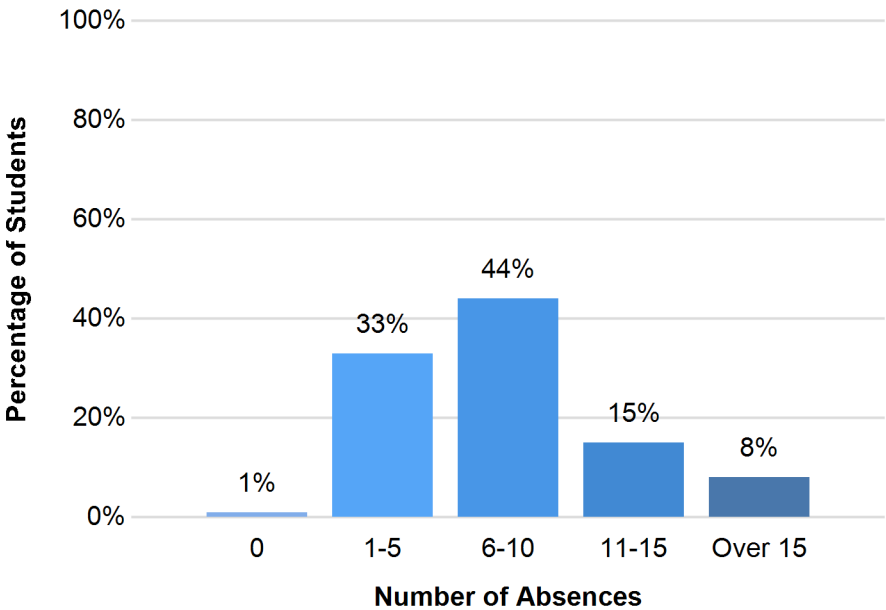

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.





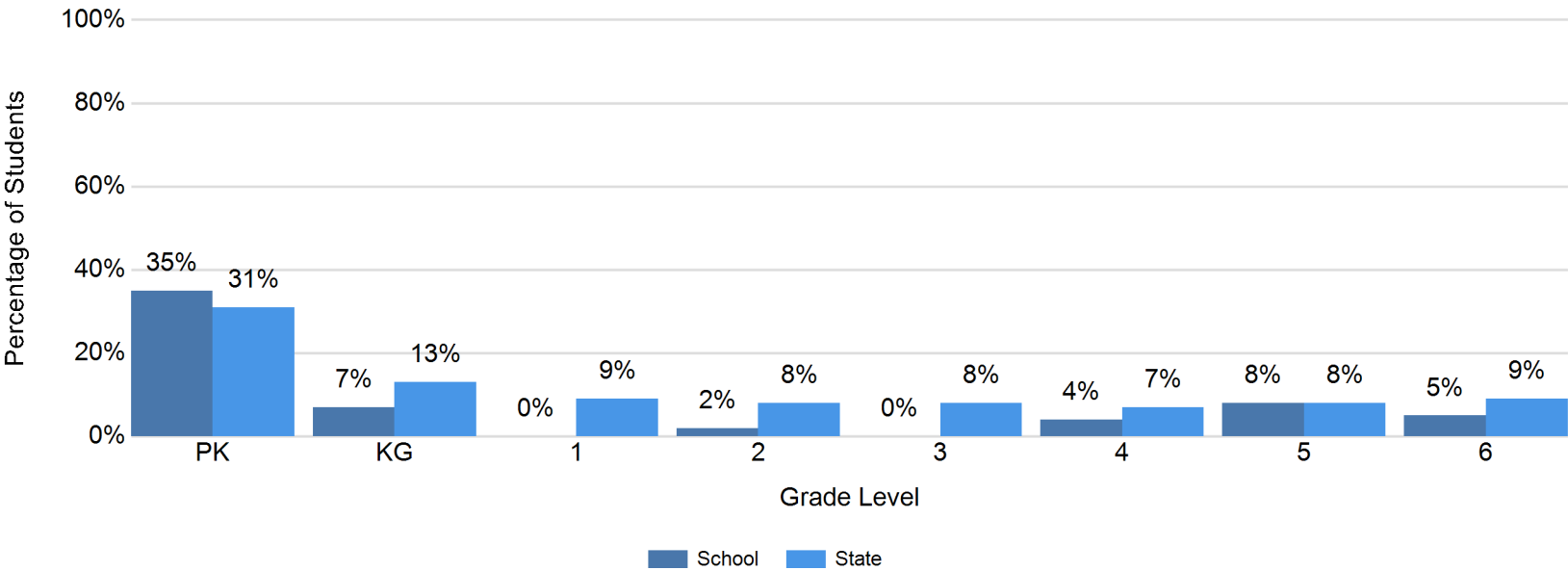

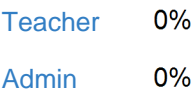

These courses encourage our children to become creative, collaborative problem solvers ready for the future! Students are also exposed to STEM activities during enrichment throughout the year. Using Title IV funds provided by the state, student also have the opportunity to engage in STEM activities after school as certain times during the year.
