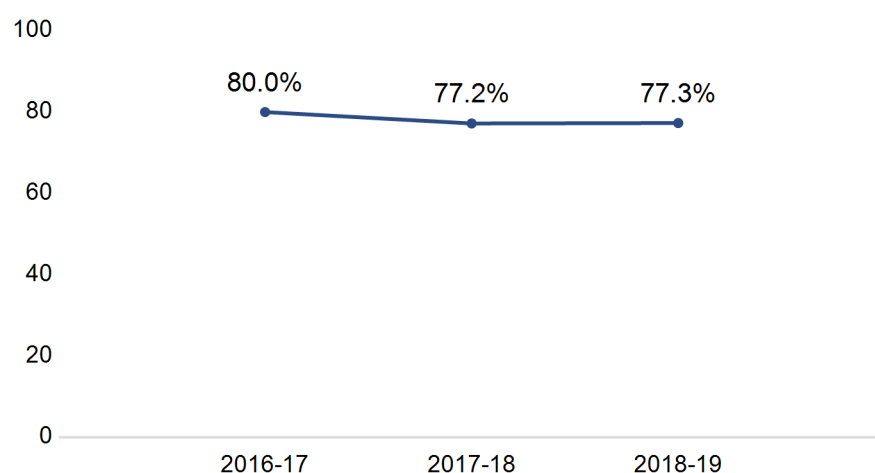

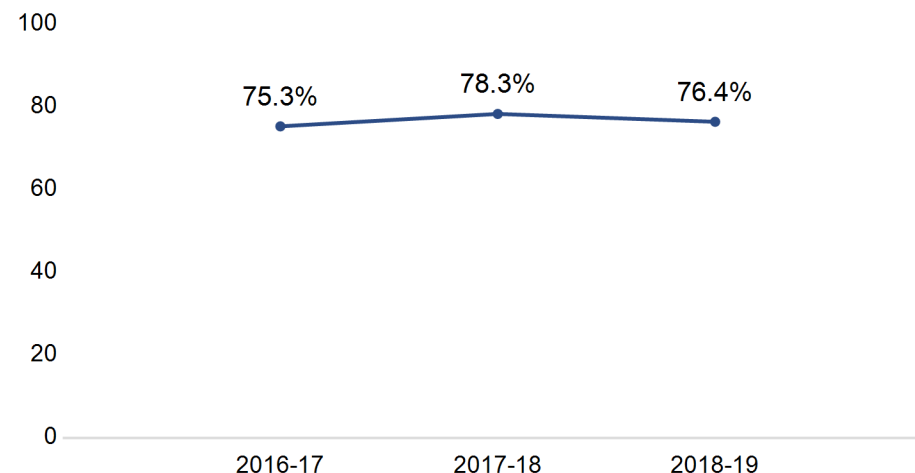
## English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the statewide assessment (NJSLA for 2018-19 and PARCC for 2016-17 and 2017-18) and the DLM alternate assessment. 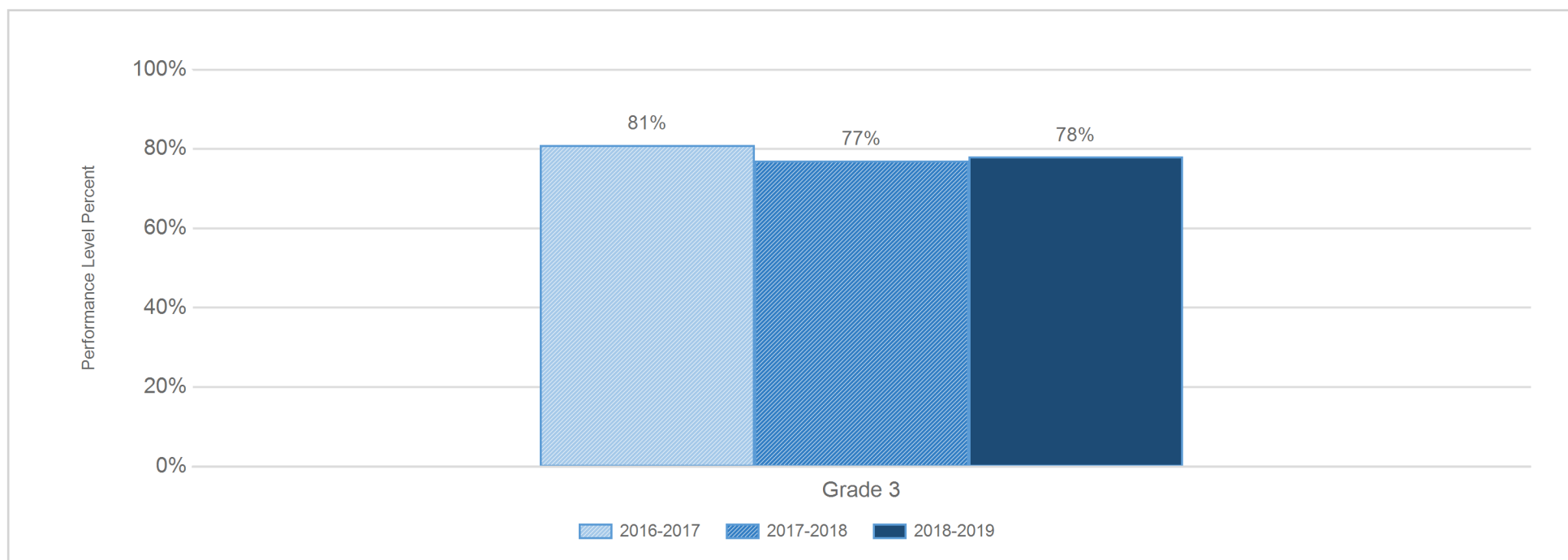

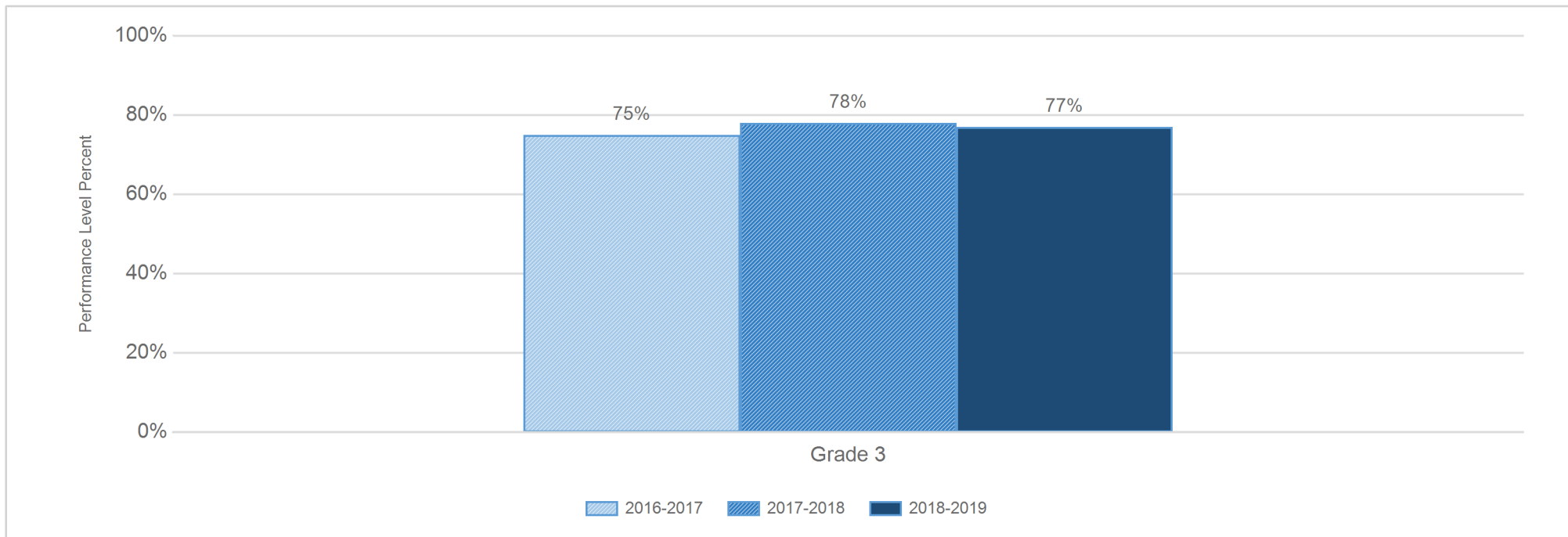

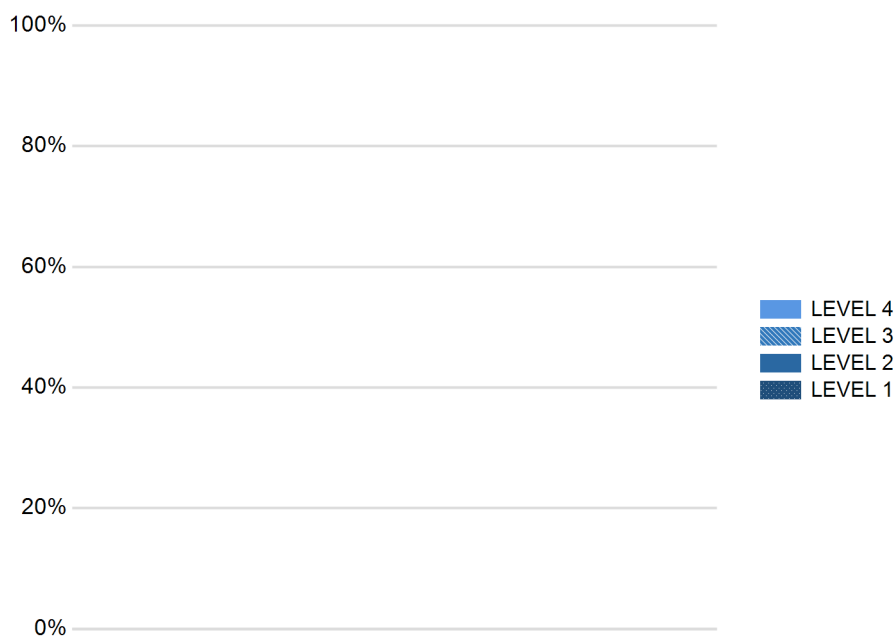

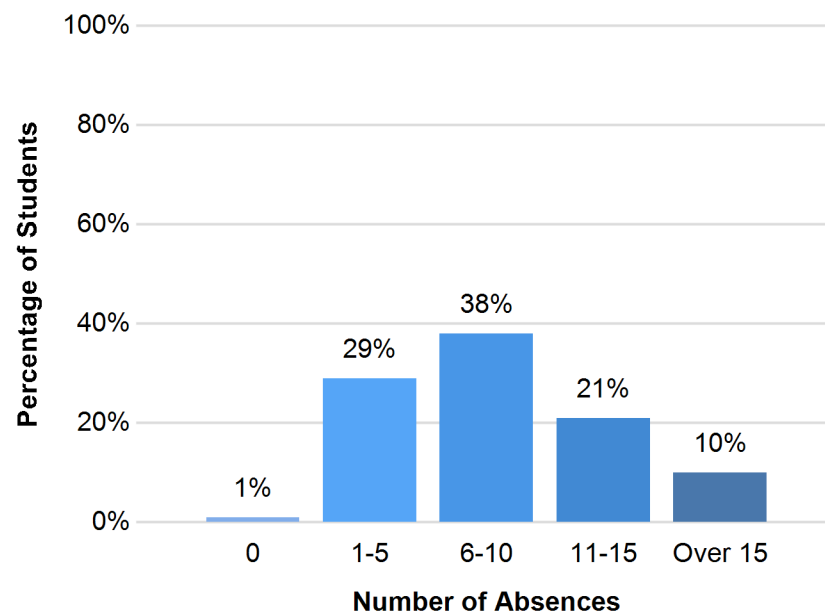

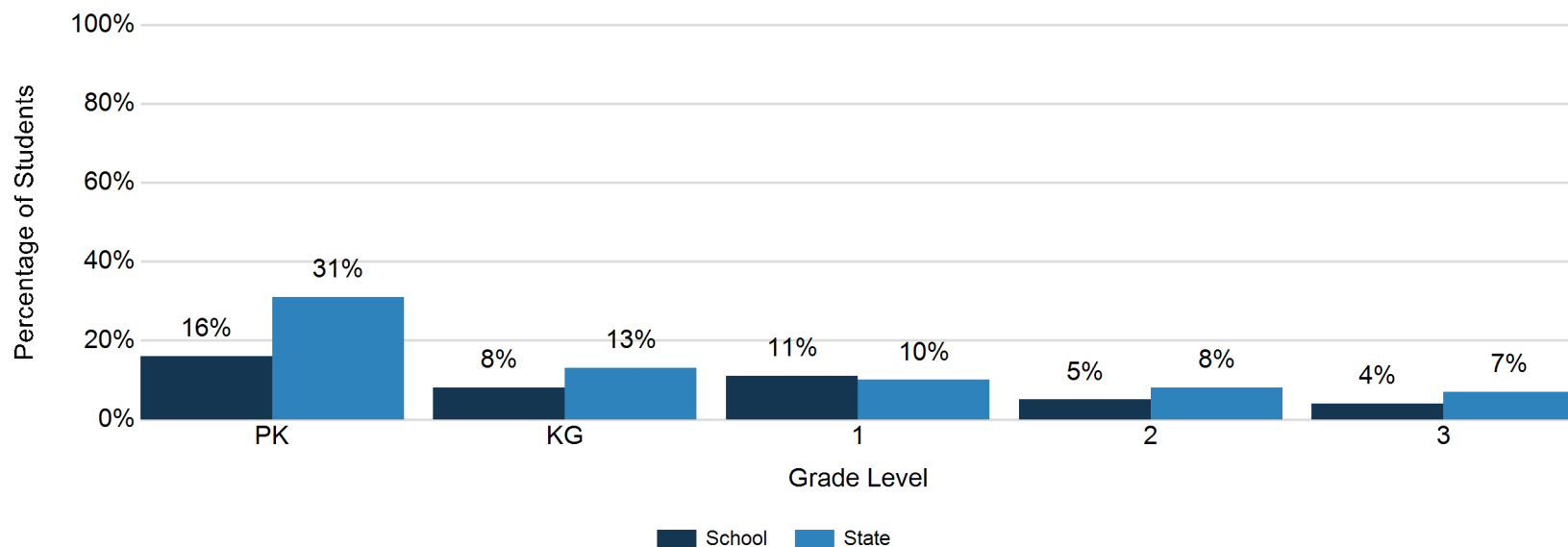

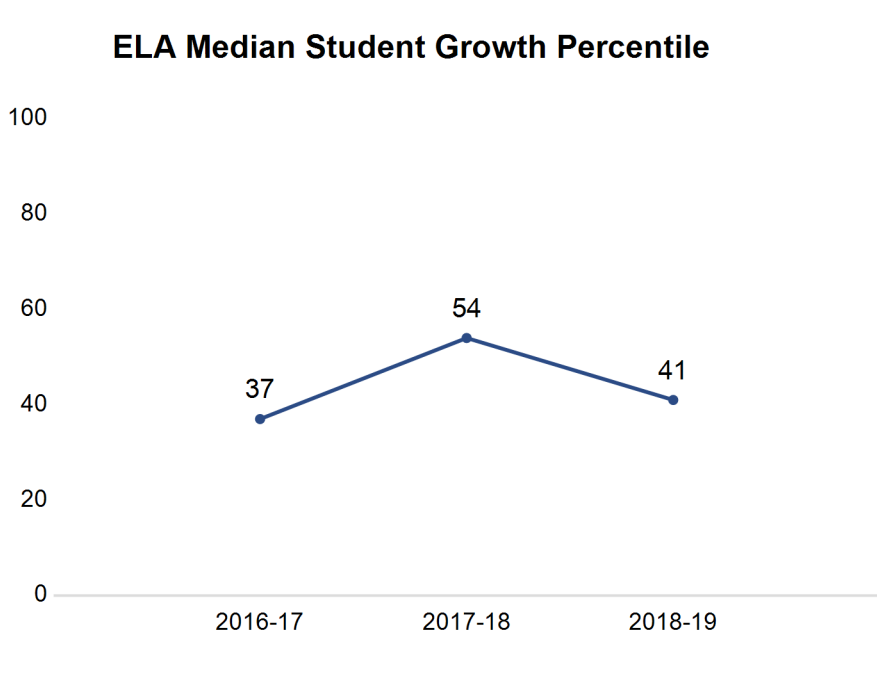

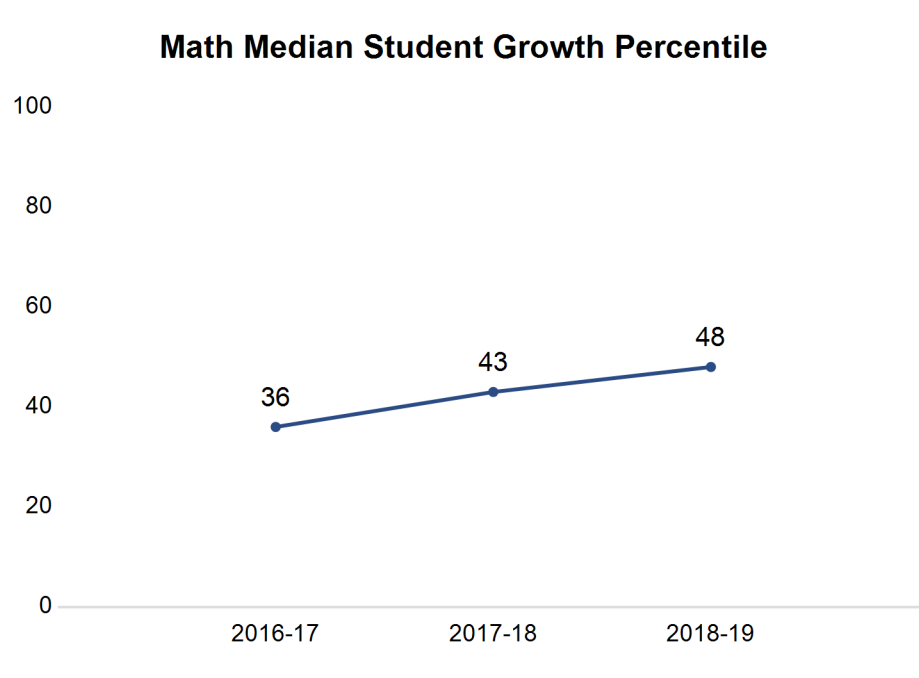

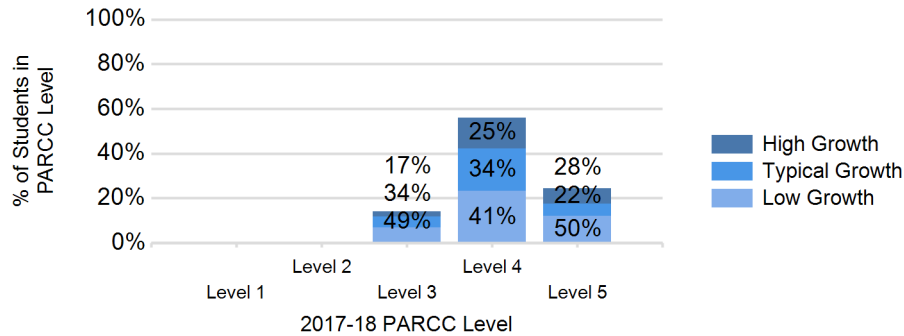

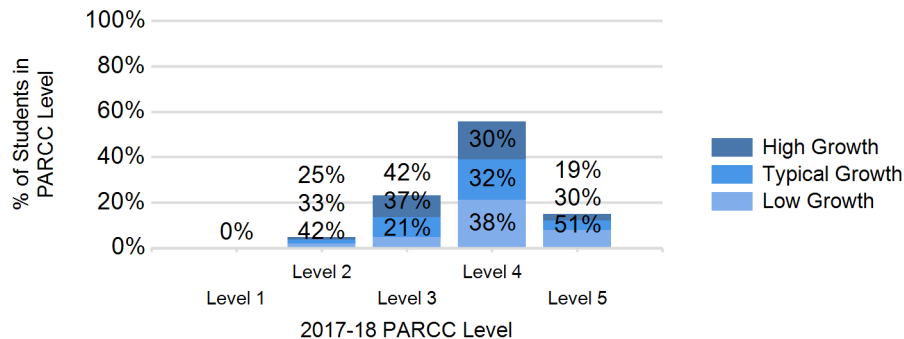
**Student Growth by Performance Level**

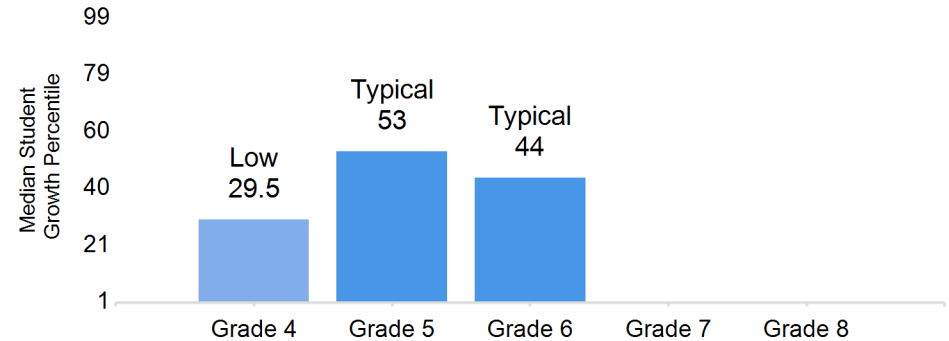

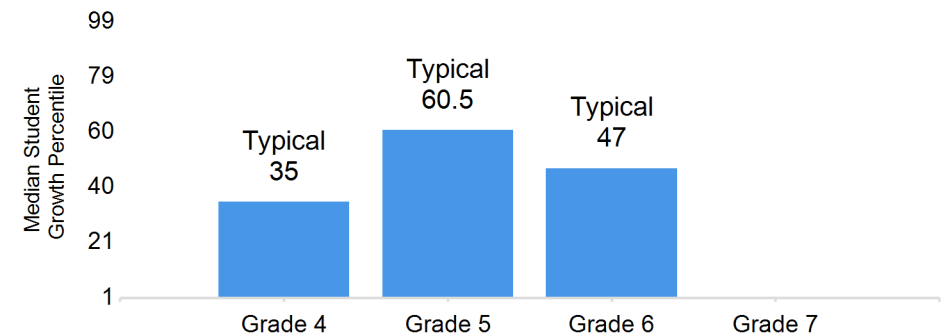
**Student Growth by Grade**

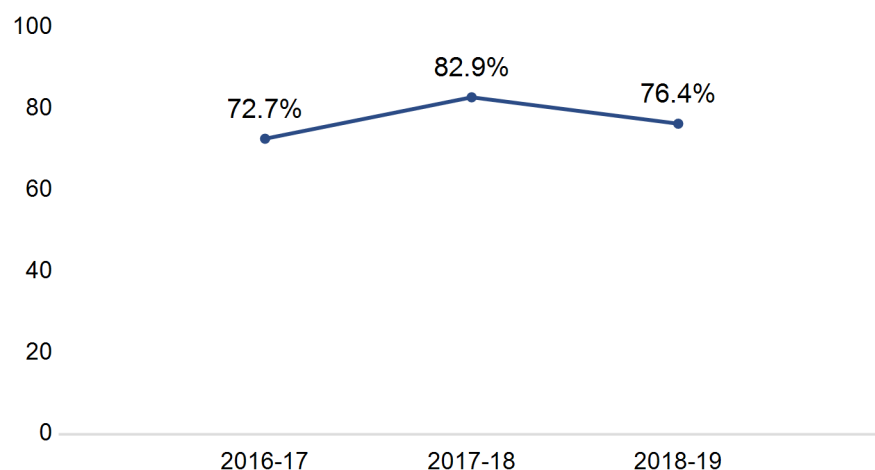

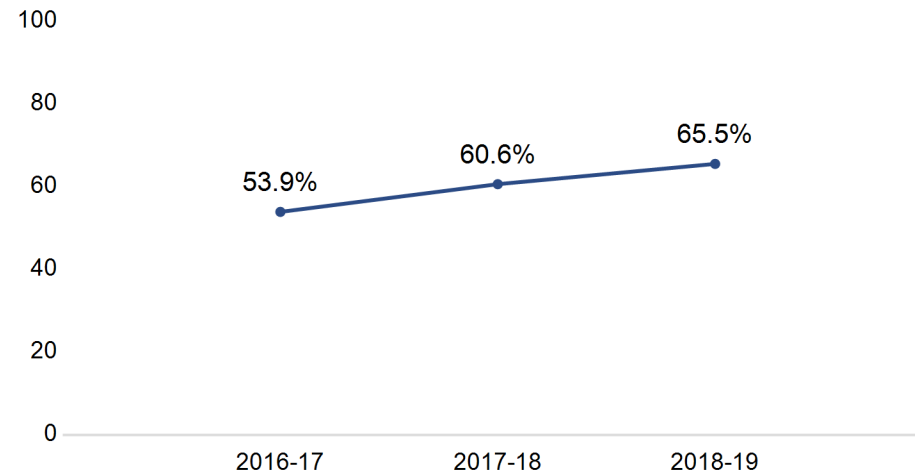

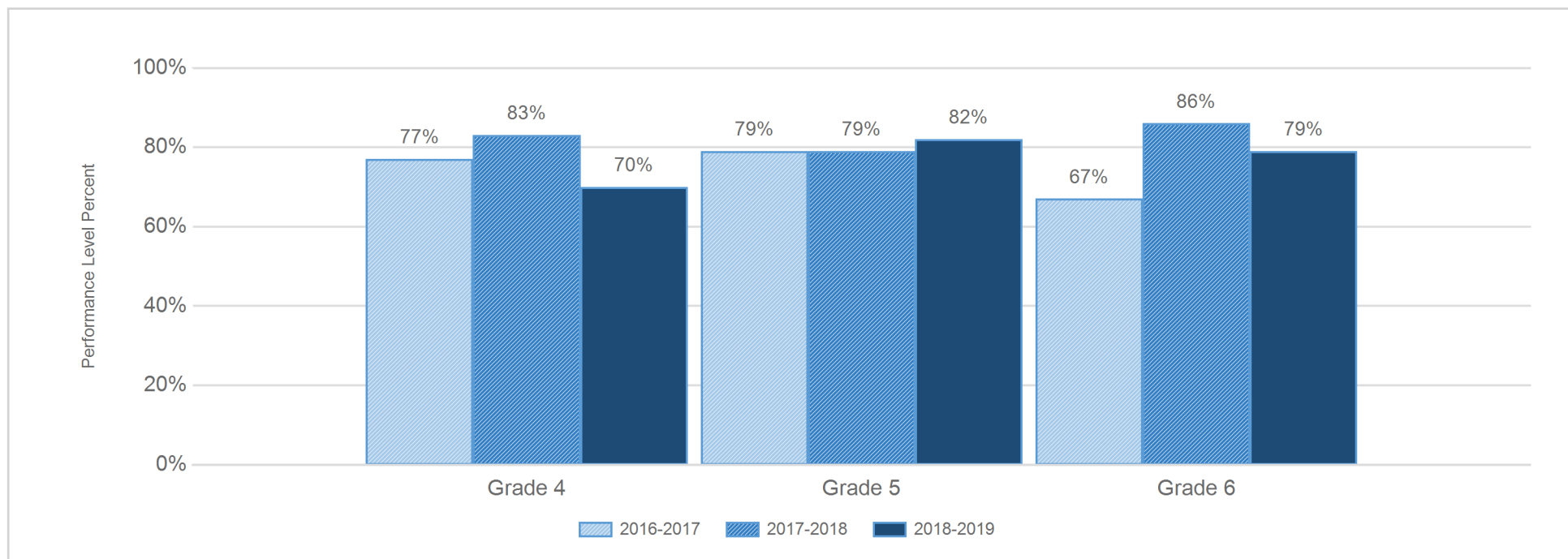

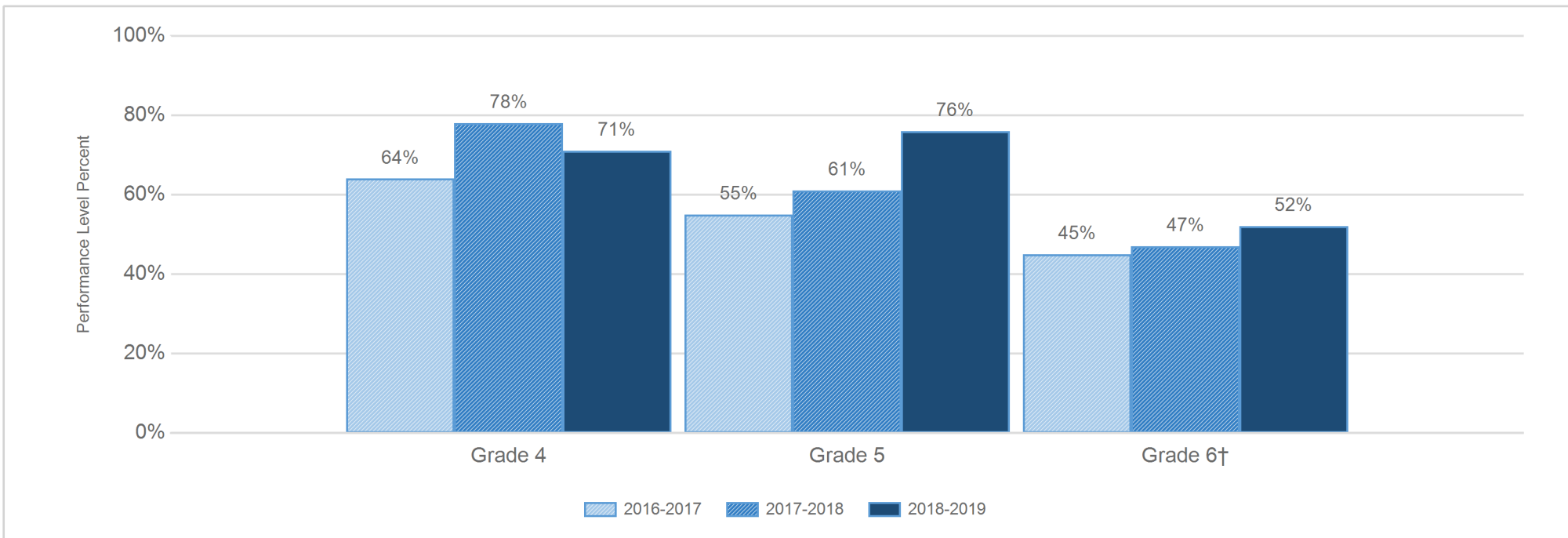

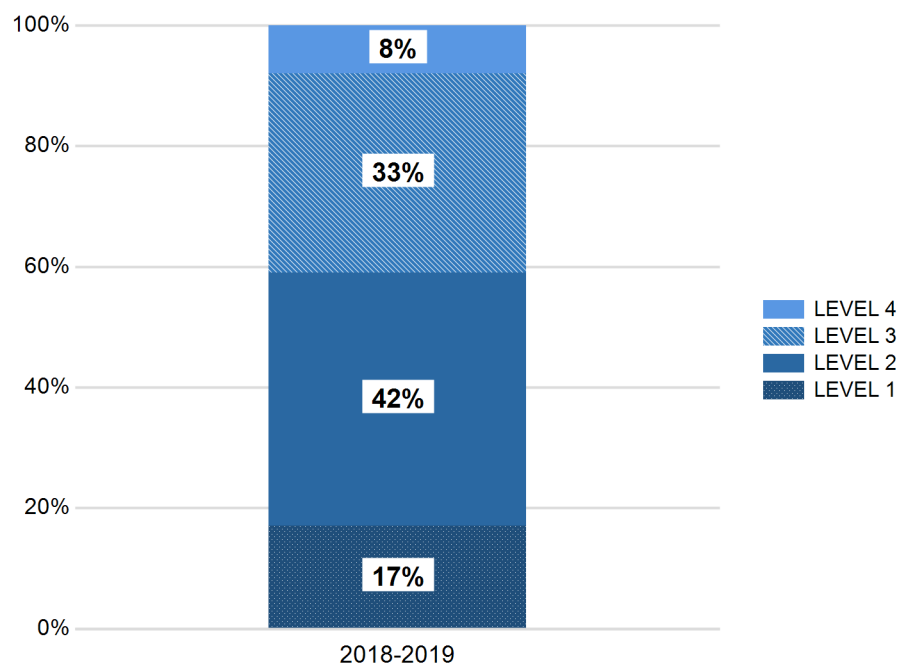

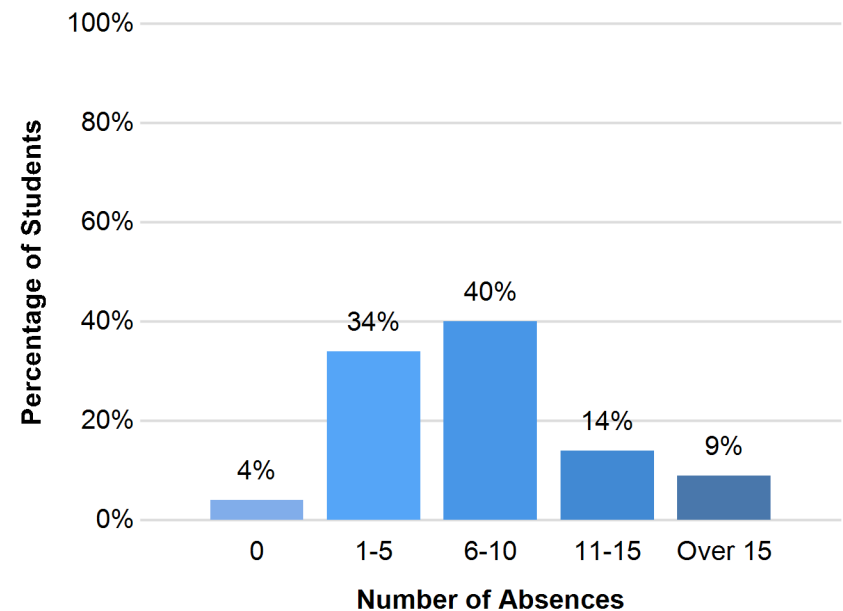

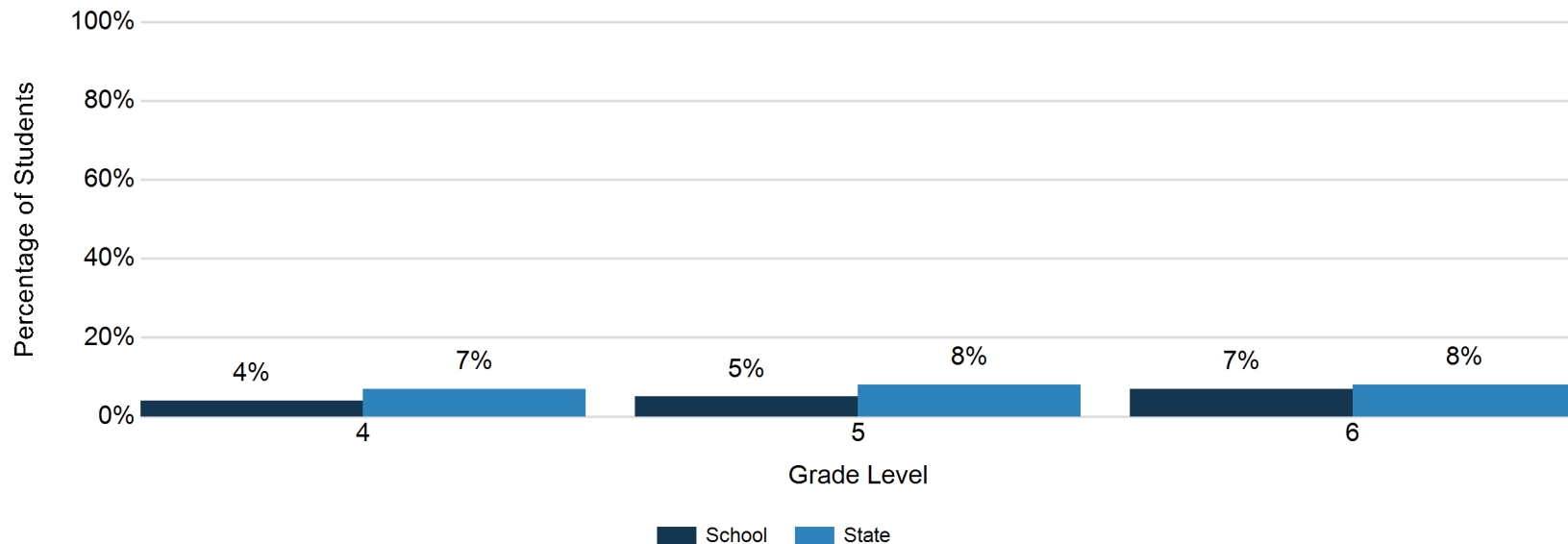

This arrangement has allowed children in K-6 to be dropped off at Stevenson School in the morning rather than the Tiny Treasures facility. This has eliminated the need to bus the students from Tiny Treasures facility to school. Grades 4-6 are then bused to Churchill to start their day. A Climate and Culture survey was conducted with students, teachers, parents, and administration being involved. The Culture and Climate Team analyzed the results and identified areas needing improvement. Over the past 3 years, these areas were addressed. A follow up survey was taken in June 2019, which showed considerable improvement in the areas of concern. .
