Academic Achievement

Academic Achievement measures the content knowledge students have in language arts literacy and math. A proficiency rate is calculated by summing the count of students who scored either proficient or advanced proficient on the assessment and dividing by the count of valid test scores.

College and Career Readiness

This school outperforms **68%** of schools statewide as noted by its statewide percentile ranking and **48%** of schools educating students with similar demographic characteristics as noted in its peer school percentile ranking in the performance area of College and Career Readiness. Additionally, this school is meeting **60%** of its performance targets in the area of College and Career Readiness.



College and Career Readiness measures the degree to which students are demonstrating behaviors that are indicative of future attendance and/or success in college and careers. For high schools, this includes measures of participation in college readiness tests such as the SAT or PSAT and in rigorous coursework as defined by participation in AP courses in English, math, social studies and science.

Graduation and Post-Secondary

This school outperforms 85% of schools statewide as noted by its statewide percentile ranking and 84% of schools educating students with similar demographic characteristics as noted in its peer school percentile ranking in the performance area of Graduation and Post-Secondary. Additionally, this school is meeting 100% of its performance targets in the area of Graduation and Post-Secondary.



This graph presents the count of students who were 'on roll' by grade in October of each school year.




Total School Enrollment Trends




Enrollment by Ethnic/Racial Subgroup






Proficiency Trends - Math




NJASK Proficiency Trends - Language Arts Literacy -**Grade Level - 07**








graph presents the grade level outcomes in the categories of Advanced Proficient, Proficient, and Partially Proficient over the last four years.





Students in high schools begin to demonstrate college readiness behaviors long before they actually graduate from high school. Among those behaviors are taking college entrance exams and challenging themselves with rigorous course work. The table below presents five such indicators: the percentage of students enrolled in the 12th grade who took the SAT, the percentage of 10th and 11th graders who took the PSAT, the percentage of students who scored above the SAT benchmark of 1550, the percentage of 11th and 12th graders who took at least one AP test in English, math, social studies or science, and the percentage of those AP tests that were scored a 3 or higher.









This graph presents the count of students who were 'on roll' by grade in October of each school year.




Total School Enrollment Trends




Enrollment by Ethnic/Racial Subgroup



















This graph presents the count of students who were 'on roll' by grade in October of each school year.




Total School Enrollment Trends




Enrollment by Ethnic/Racial Subgroup
