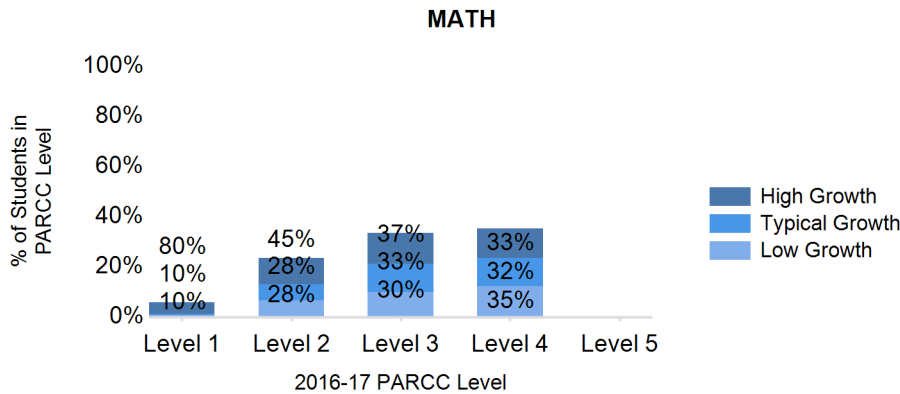
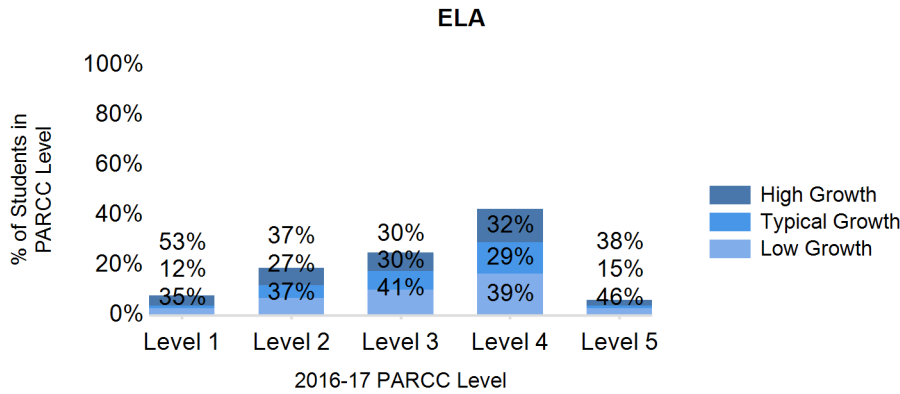

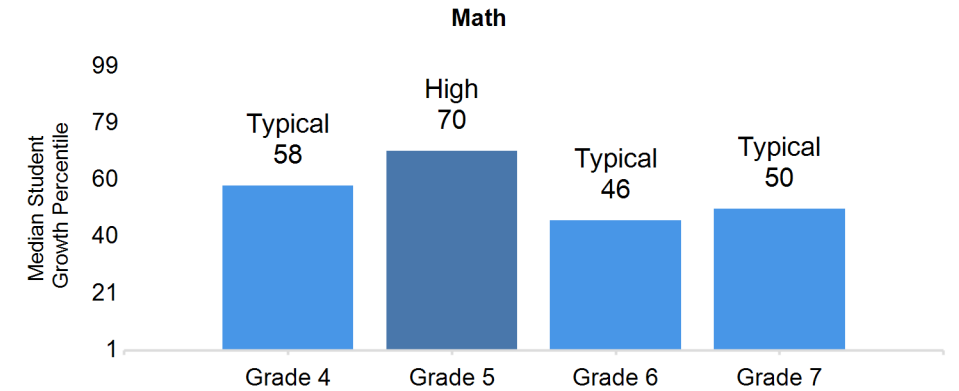
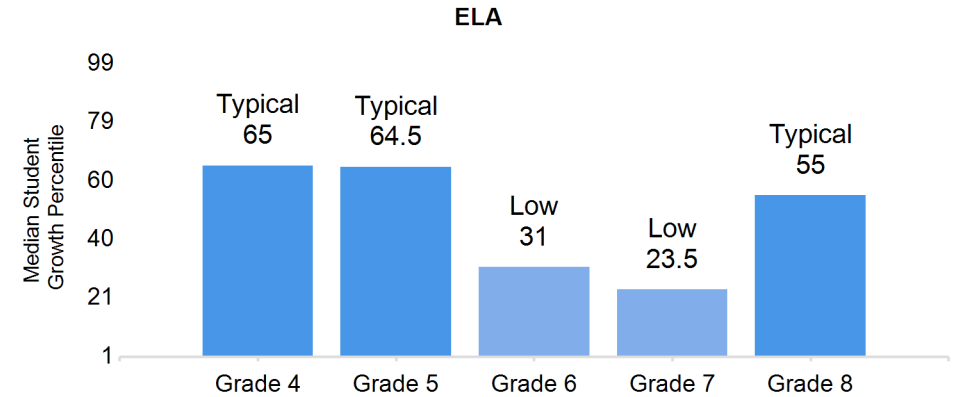
Student Growth by Performance Level

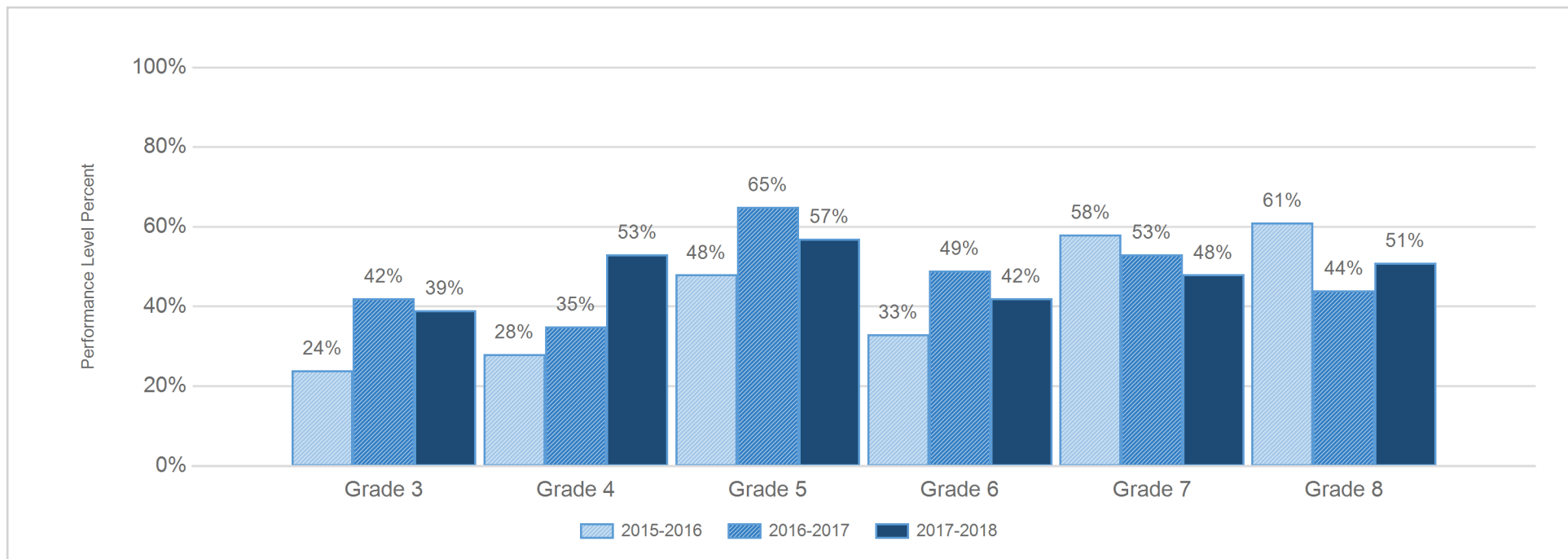

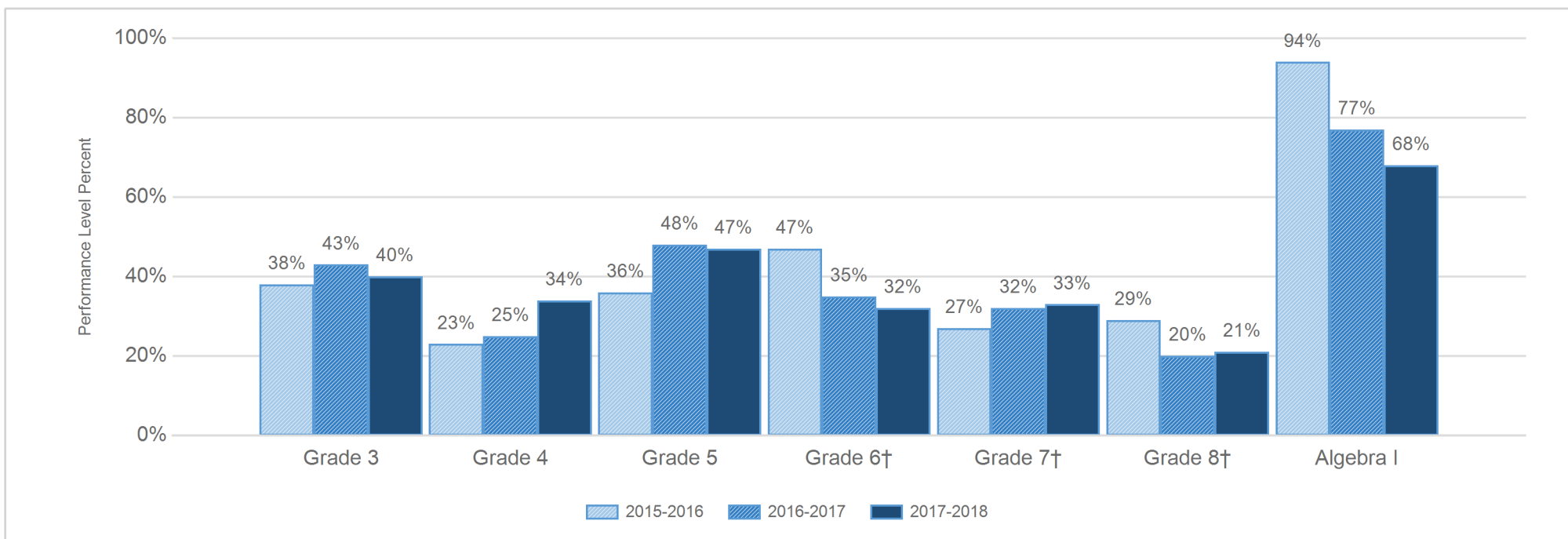

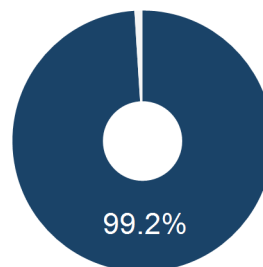

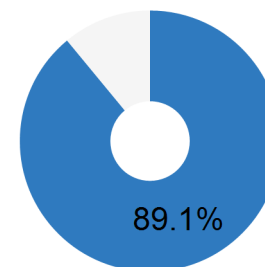

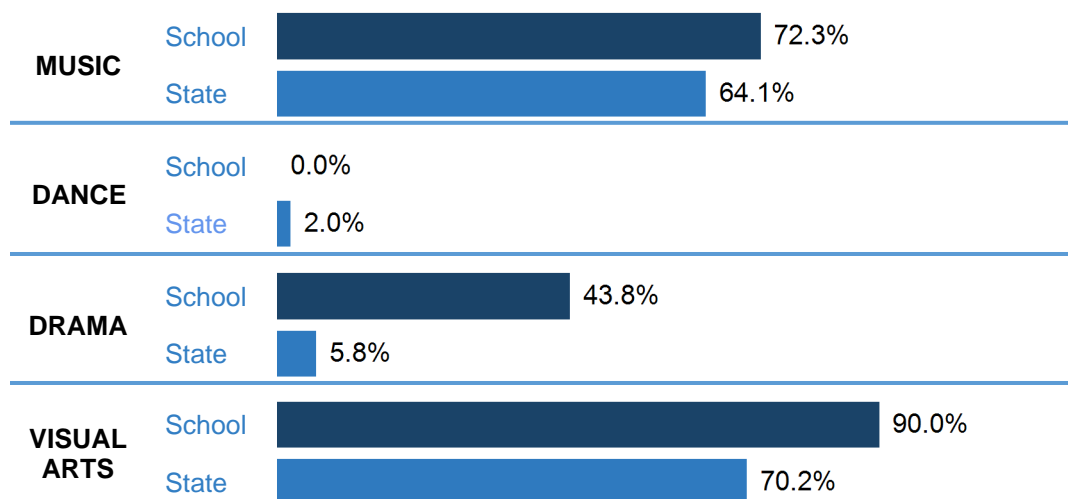

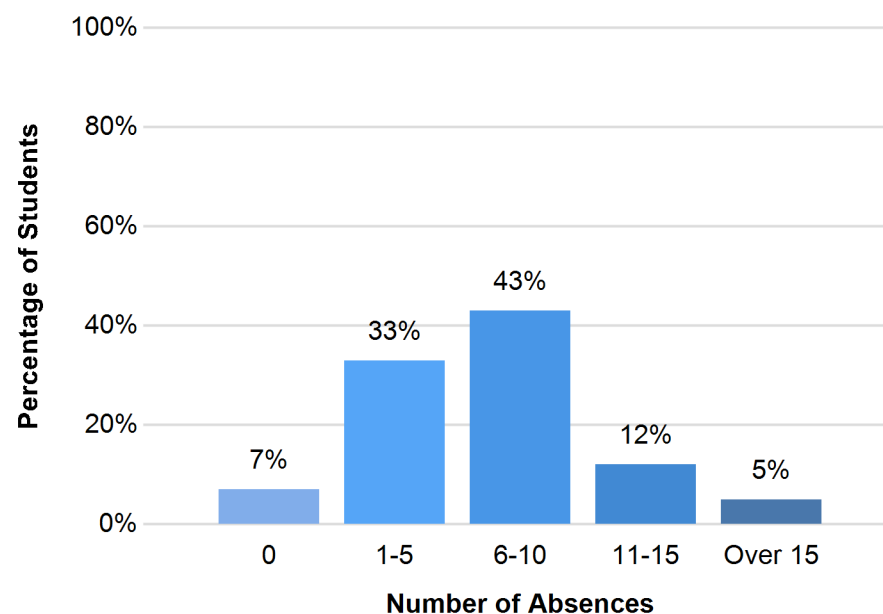

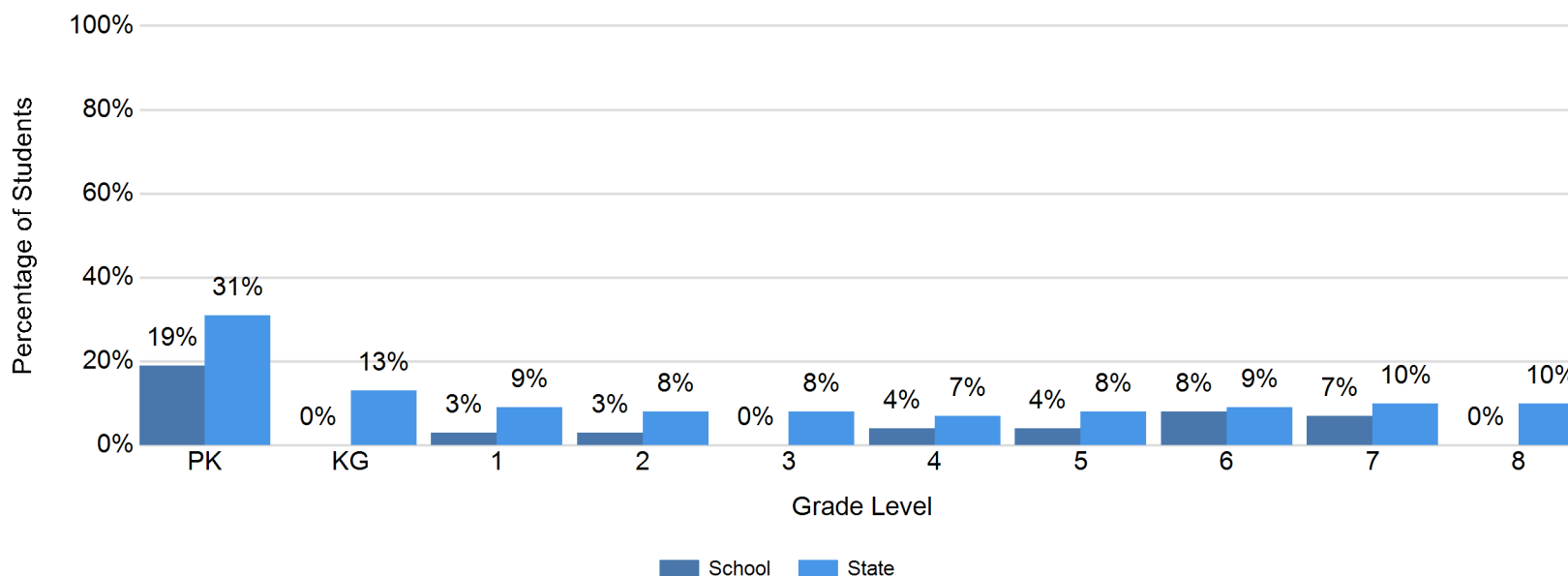

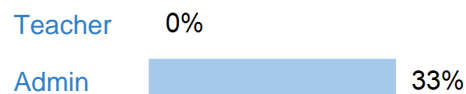

Student Supports and Services:

Student support is provided through the Child Study Team; made up of a learning disability teacher consultant, school social worker, school psychologist, speech language specialist, a part-time occupational and physical therapist. In addition to the CST, a school counselor works closely with students, teachers, and parents in the area of social and emotional development. The Intervention & Referral Services Team assists classroom teachers in establishing strategies to enhance classroom learning and support students experiencing difficulty with academic, emotional, or behavioral issues.



Student Health and Wellness:

The health curriculum is taught to students in K-8 by classroom teachers and the physical education teacher. In addition, the school counselor teaches a middle school course titled, Social and Emotional Learning. The school nurse oversees the health and wellness committee at Folsom. Folsom has been recognized by AtlantiCare Healthy Schools for many initiatives that promote healthy eating and physical fitness.
