#### **MINUTES**

### Governor's Council on Alcoholism and Drug Abuse December 20, 2011

#### Call to Order

The two hundred sixty eighth regular meeting of the Governor's Council on Alcoholism and Drug Abuse was called to order at 10:00 a.m. by Acting Chairman Neil Van Ess.
