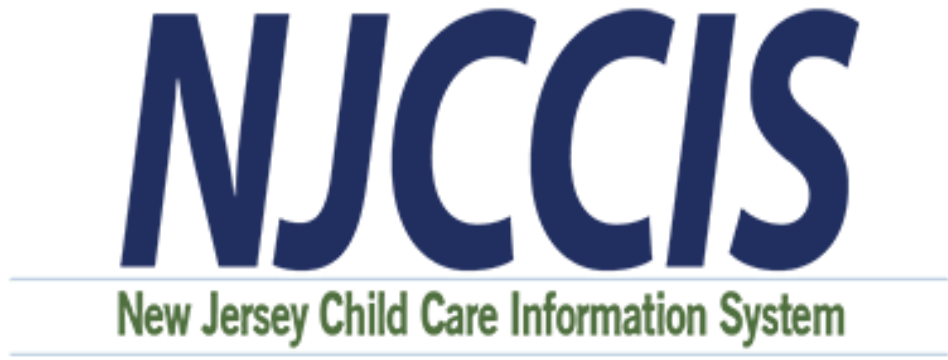

NJCCIS is a collaboration between the New Jersey Department of Children and Families, Office of Licensing (DCF/OOL) - which oversees licensing and the Department of Human Services, Division of Family Development (DHS/DFD) - which oversees the Child Care Assistance Program, the NJ Workforce Registry and quality initiatives including Grow NJ kids.

NJCCIS supports the many business processes related to child care licensing, family child care registration, grants, inspections, and complaints. Providers can update their information to share with consumers. NJCCIS also is the point of access to the NJ Workforce Registry - allowing early childhood and school-age care professionals to maintain a record of their experience, education and professional development and to access in-person online training resources. Providers also can enroll in Grow NJ Kids and other Quality initiatives.
