1. NOTICE

TO ALL MUNICIPAL ISSUING AUTHORITIES:

It has been found necessary to make several changes in application forms for retail licenses and license certificates for the next fiscal year beginning July 1, 1949. Consequently, to avoid any possible confusion, I am publishing herein, in full, the prescribed form for application for Plenary Retail Consumption, Plenary Retail Distribution, Seasonal Retail Consumption and Limited Retail Distribution Licenses and the form of application for Club License for the next fiscal year as follows:

Item 2 - New form of application for all municipal retail licenses, except Club License.

Item 3 - New form of application for Club License.

(Note: The above changes show revisions of Questions Nos. 11, 13, 18, 28, 34, 41, 43, 47, 48 and 49 of application for all municipal retail licenses, except Club License, and Questions Nos. 7, 22, 32, 36, 38, 39, 40 and 41 of application for Club License, heretofore shown in Bulletin 650, Items 2 and 3, respectively.)

The application forms herein promulgated are effective for the fiscal year commencing July 1, 1949 and thereafter.

The license certificate forms have been revised as follows:

Item 4 - New form of license certificate for Plenary Retail Consumption License.

Item 5 - New form of license certificate for Plenary Retail Distribution License.

Item 6 - New form of license certificate for Seasonal Retail Consumption License.

Item 7 - New form of license certificate for Limited Retail Distribution License.

Item 8 - New form of license certificate for Club License.

Effective July 1, 1949 the application forms shown in Bulletin 650, Items 2 and 3, and license certificate forms shown in Bulletin 395, Items 4, 5, 6, 7 and 8, are superseded in their entirety.

At this time I again wish to point out to all License Issuing Authorities the extreme importance in requiring that applicants answer all questions fully and completely. Under no circumstances should an application be passed upon unless each question is answered fully and completely.

I urge that all License Issuing Authorities take immediate steps to obtain a sufficient supply of application forms and license certificates at the earliest possible moment so that they will be available when the time comes for the renewal of licenses for the next fiscal year.
