The DEP BULLETIN is an information service provided free of charge by the N.J. Department of Environmental Protection. It contains a list of construction permit applications filed with or acted upon by DEP. Interested persons will thus be able to determine the status of applications dealing with Waterfront Development permits, Wetland permits, Stream Encroachment permits, Sewerage Extension permits, and CAFRA permits (Coastal Area Facility Review Act). In addition the circular provides a calendar of Events and Interest and a Schedule of Public Hearings. (THE PUBLIC HEARINGS HOWEVER ARE NOT OFFICIAL NOTICES.) Environmental Impact Statements acted upon during the week are also shown. Any additional information concerning the permits may be obtained by contacting the appropriate person listed below.

The Office of Business Advocacy's objective is to cut red tape and get solutions to permit problems. OBA will designate a Permit Expediter to your project. The Permit Expediter will:

- A. Advise you of the state permits required for your project, upon completing the "ONE STOP" PERMIT IDENTIFICATION FORM.
- B. Coordinate contacts with relevant local and state regulatory agencies upon request.
- C. Monitor the progress of your permit applications.
- D. Act to ensure processing of most permits within 90 days of application.
- E. Schedule "OVER THE COUNTER" processing for permits meeting appropriate criteria.

GENERAL INFORMATION

I. STREAM ENCROACHMENT (Over-the-Counter-Permit)

DEP now has a one-day processing service for certain minor stream encroachment permits. This "over-the-counter" service is limited to minor projects which do not adversely change the water carrying capacity of the floodway, do not increase erosion or sedimentation in the stream, and do not require substantial channel modification or relocation. For further information contact the Bureau of Flood Plain Management, CN 029, Trenton, NJ 08625.

II. SEWER EXTENSIONS (Over-the-Counter-Permit)

(609) 984-4429

DEP has a one-day processing service for "minor" sewer extension projects. Eligible projects must meet certain criteria, such as, length of 1000 linear feet or less, cost of \$25,000 or less, sewage flow per day of 12,000 gallons or less. No projects with pump stations, force mains, siphons, gallongage transfers or holding tanks will be processed over-the-counter. Projects can not be located in areas under sewer bans, administrative orders, or litigation.

Projects must be in-house by 9:30 a.m., and all administrative documents must be in proper order. Pre-application conferences are strongly recommended. For further information contact Division of Water Resources, CN 029, Trenton, NJ 08625.

MASTER PERMIT INFORMATION APPLICATION

DEP has developed a Master Permit Information Application which, upon completion, will indicate all the DEP permits required for the project. Forms may be obtained by contacting the Office of Business Advocacy (See inside cover for details).

DEP PUBLIC HEARINGS, ADMINISTRATIVE HEARINGS, AND DEP EVENTS OF PUBLIC INTEREST

Public Hearings (Quasi-Legislative) are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest.

Administrative Hearings (Quasi-Judicial) are held between the state and a particular party involving an application, enforcement - violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.
