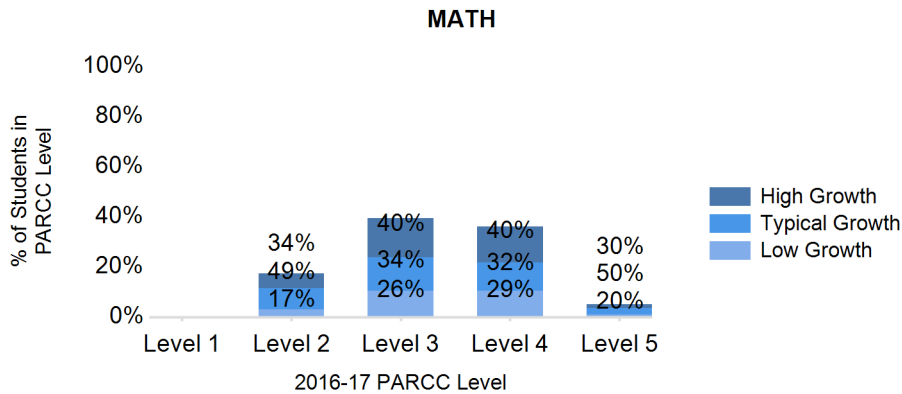
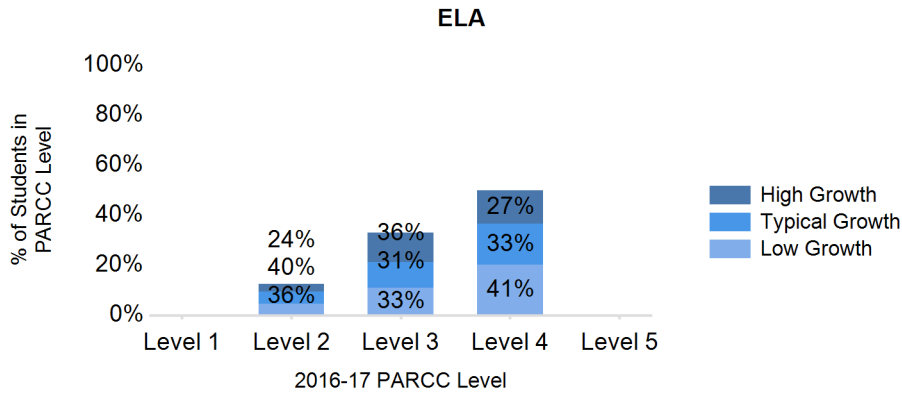

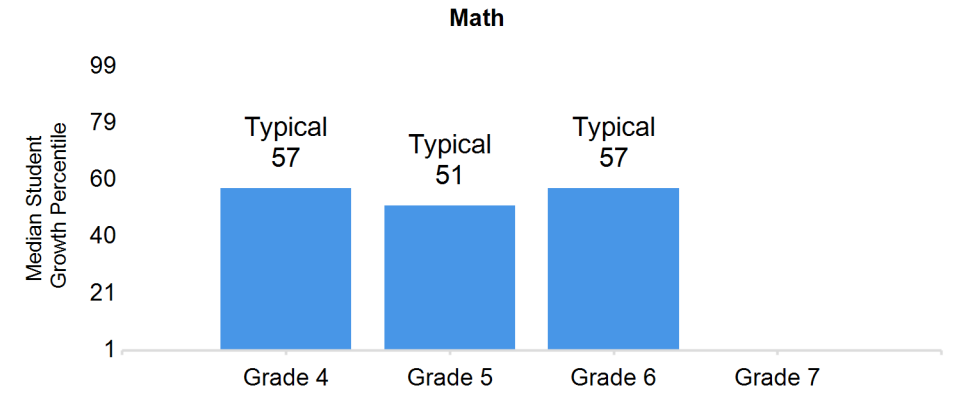
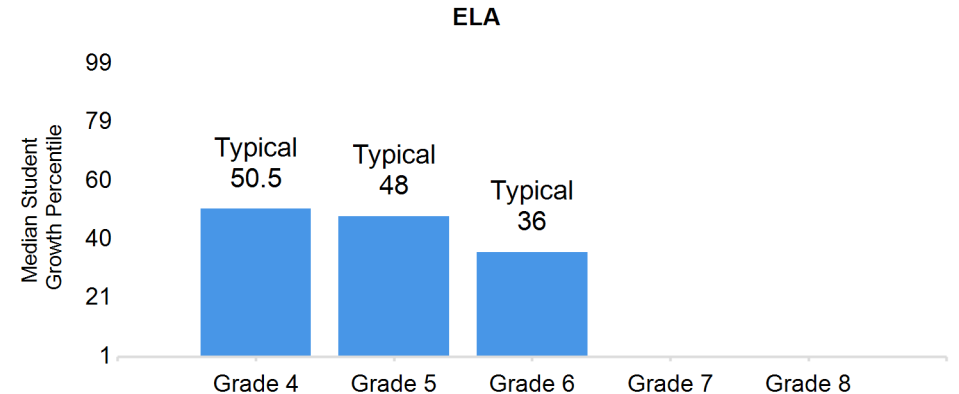
Student Growth by Performance Level

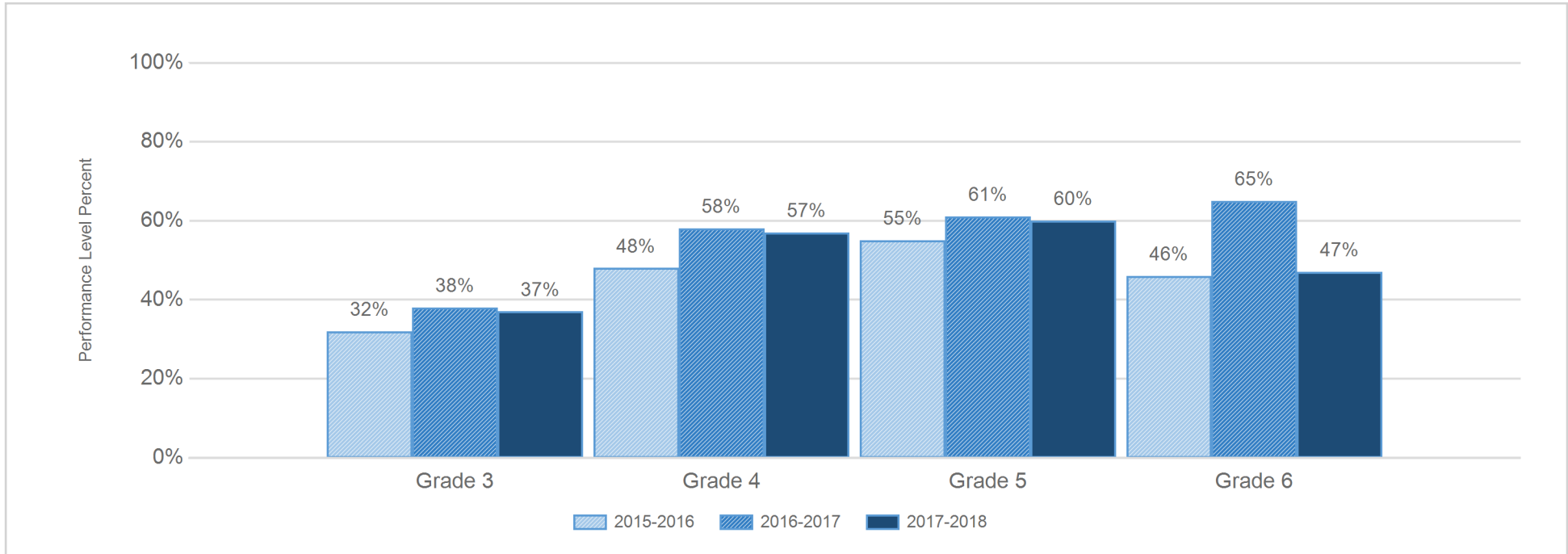

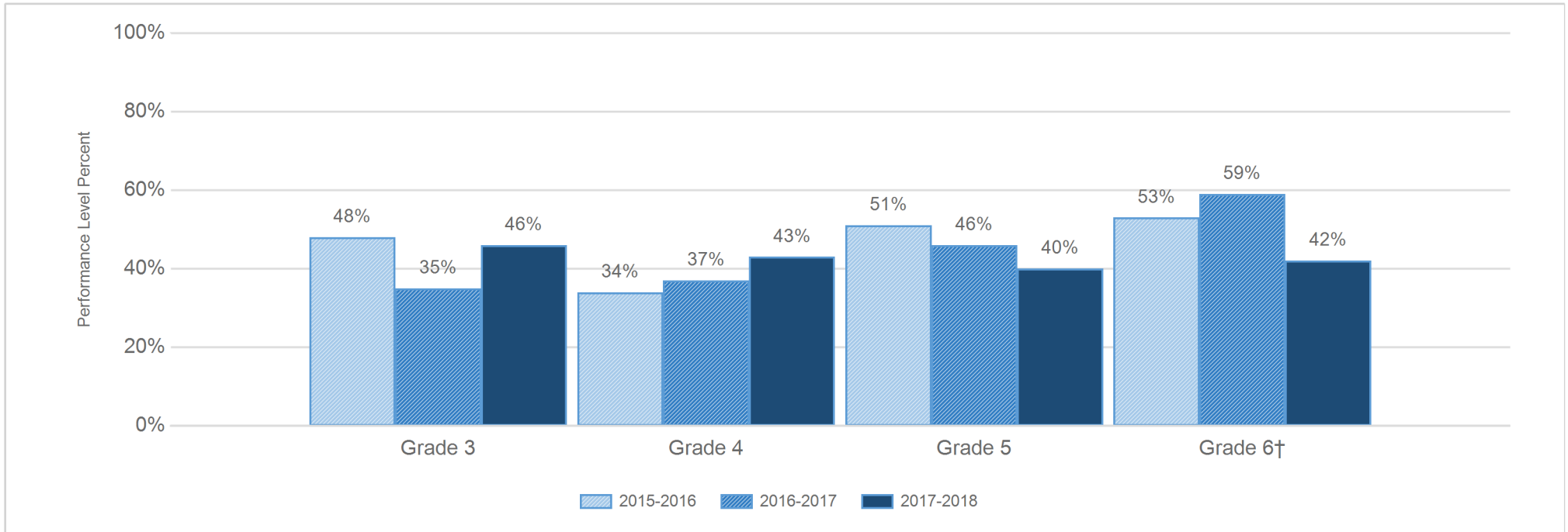

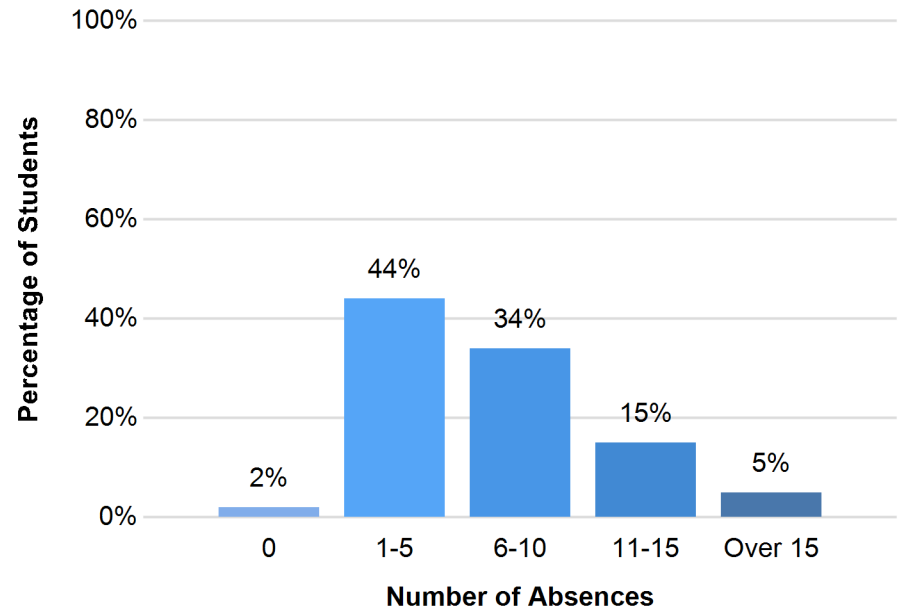

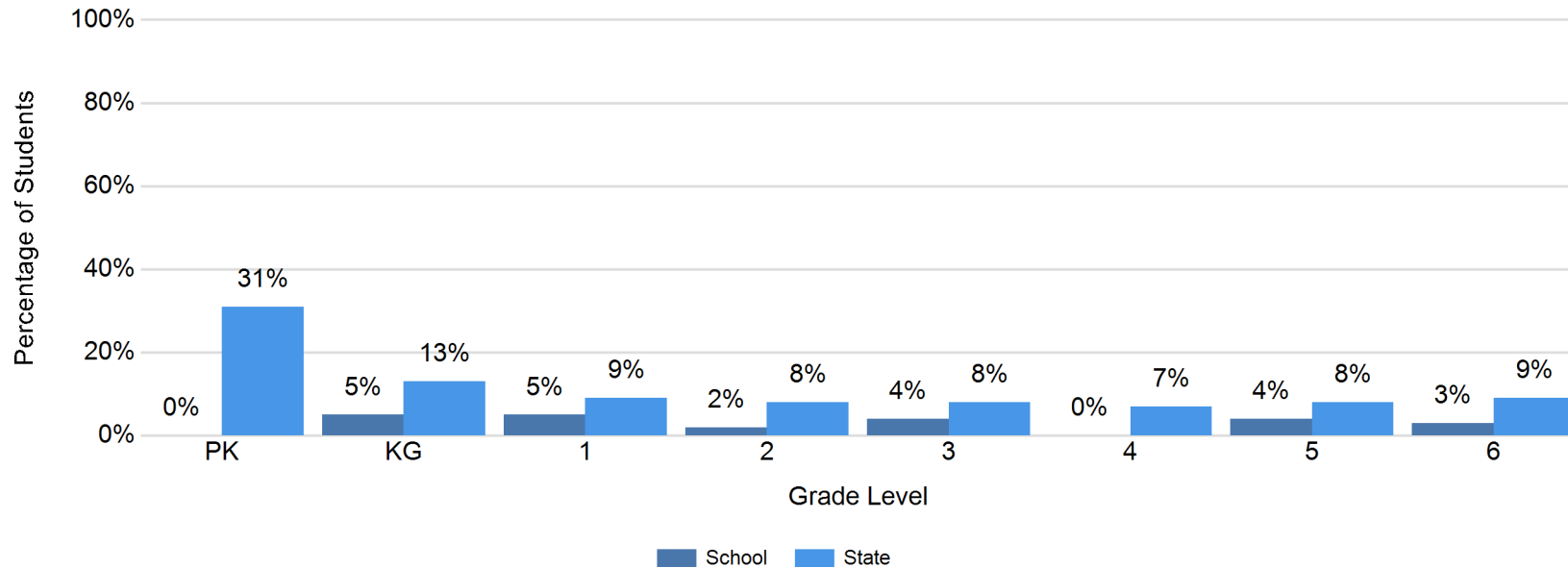

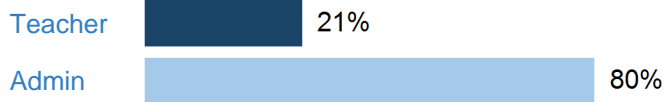
Teachers and Administrators - Level of Education

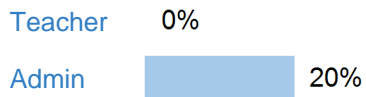
