### **Grant Programs Announced**

Guidelines and applications for the grants listed below are now available.

Grant Program:

**Internet Access for Public Libraries** 

**Amount Available:** 

Up to \$40,000; maximum grant is \$800.

Purpose:

To increase electronic access to information through the use of

specialized resource databases on the Internet.

**Eligible Projects:** 

Grant funds may be used to: contract with a mid-level Internet provider to establish accounts; pay telecommunication costs and training fees for staff; install telephone lines; or purchase modems, telecommunication software and reference materials on the use of the Internet and its resources.

Eligible Applicants:

Any public library that does not presently have access to the Internet or whose only access is through NJ Link. All applicant libraries must be staffed by a full-time certified librarian and meet State Per Capita Aid requirements.

Priority for Award:

All eligible applicants whose applications are complete and who agree to comply with certifications contained in the RFP will be funded. If there are insufficient resources to fund all eligible applications, names of all applicants will be placed in a lottery and winners will be chosen by a representative of state government from an agency other than the State Library.

Deadline for Submission:

October 20, 1994

**Grant Program:** 

Internet Access for High School Library Media Centers in Public Schools

**Amount Available:** 

Up to \$60,000; maximum grant is \$800.

Purpose:

To increase electronic access to information through the use of specialized resource databases on the Internet.

**Eligible Projects:** 

Grant funds may be used to contract with a mid-level Internet provider to establish accounts; pay telecommunications costs and training fees for staff; install telephone lines; or to purchase modems, telecommunication software and reference materials on the use of the Internet and its resources.

Eligible Applicants:

Any public high school library media center that does not presently have access to the Internet or whose only access is through NJLink. All applicant libraries must be staffed full-time by a certified Educational Media Specialist or Associate Educational Media Specialist.

**Priority of Award:** 

All eligible applicants whose applications are complete and who agree to comply with certifications contained in the RFP will be funded. If there are insufficient resources to fund all eligible applications, names of all applicants will be placed in a lottery and winners will be chosen by a representative of state government from an agency other than the State Library.

Deadline for Submission:

November 15, 1994

Grant Program:

Collection Evaluation and Development

Amount Available:

Up to \$175,000; maximum grant for an individual project is \$10,000, for a cooperative project \$25,000.

Purpose:

To increase New Jersey resident access to a variety of materials by developing or strengthening specialized subject collections in public libraries.

**Eligible Projects:** 

Individual projects: grant funds may be used for the purchase of library materials to develop or strengthen a specific subject collection in a public library. Cooperative projects: grant funds may be used for the support of cooperative projects involving two or more public libraries. In a cooperative project, each participating library must indicate an area or areas of specialization which will be developed.

**Eligible Applicants:** 

Any public library or group of public libraries may apply for funding. All applicants must meet all State Per Capita Aid requirements. A written collection development policy or coordinated collection development policy, as appropriate, must accompany the application.

Priority of Award:

To be eligible for funding, an application must achieve a total average score of 65 or better. Eligible applications will be funded in rank order from the highest to lowest, to the extent funds are available.

Deadline for Submission:

November 4, 1994

Grant Program:

Institutional Library Services: Developmental Grants

Amount Available:

Up to \$50,000

Purpose:

To assist state, county and municipal institutions which <u>do not</u> <u>meet minimum standards</u> for library services in meeting those standards in order to improve library service to persons who do not receive the full benefits of library service due to disadvantages related to institutionalization.

**Eligible Projects:** 

Funding may be used by state, county or municipal institutions to assist in meeting one or more of the minimum standards for institutional library services.

Projects from institutions whose libraries meet all minimum standards are not eligible for this program nor are projects for areas in which a library already meets standards.

Eligible Applicants: All state, county and municipal institutions, as described in

N.J.A.C. 6:68-7.1, whose library services do not meet minimum standards. Municipal, public and school libraries are not eli-

gible.

Priority for Award: To be eligible for funding, applications must receive a total

average score of 65 or better. Eligible applications will be funded in rank order from the highest to lowest, to the extent

funds are available.

Deadline for Submission: November 7, 1994

Technical Assistance: October 7, 1994

Grant: Maintenance and Preservation of Library Collections

Amount Available: Up to \$150,000; maximum grant for Program A is \$15,000;

maximum for Program B is \$3,500.

Purpose: To assist libraries in the preservation and conservation of

collections of historical significance and statewide importance

to New Jersey; to initiate preservation planning.

Eligible Projects: Eligible projects in Program A include reformatting to micro-

forms or non-microforms; physical treatment including binding, mending, minor repair; and preparation of materials for

storage, matting, boxing or other protective enclosure.

Eligible projects in Program B include surveys and examinations of collections of materials to determine preservation needs and options, to develop cooperative mechanisms for

sharing of preservation expertise and/or to explore the feasibility of sharing facilities or services by two or more institu-

tions.

Eligible Applicants: All New Jersey libraries and library -related agencies which

meet the definition of a library as stated in N.J.A.C. 6:68-1.2.

Priority for Award:

To be eligible for funding, an application must achieve a total

average score of 65 points or more. Eligible applications will be funded in rank order from the highest to lowest, to the extent

funds are available.

Deadline for Submission: November 23, 1994

Technical Assistance: October 13, 1994. See RFP for details.

Grant Program: Institutional Library Services: State Institutions

Amount Available: Up to \$100,000; maximum award is \$10,000.

Purpose: To assist state institutions in improving or enhancing direct

library services to residents.

**Eligible Projects:** Funding may be used for collection development, purchase of

library equipment or furniture, contractual services for cataloging and collection organization, and for other enhance-

ments of access.

Eligible Applicants: All state institutions, as described in N.J.A.C. 6:68-7.1).

County and municipal institutions are not eligible under this

program.

Priority for Award: To be eligible for funding, applications must receive a total

average score of 65 or better. Eligible applications will be funded in rank order from the highest to lowest, to the extent

funds are available.

Deadline for Submission: January 9, 1995

Technical Assistance: October 7, 1994

Registration is required. See RFP for information.

### GRANT AWARDS ANNOUNCED

**Multilingual Materials Acquisitions Center** July 1994

The Newark Public Library will receive \$150,000 to continue for a fourth year the operation of the Multilingual Materials Acquisitions Center which acquires materials in 11 foreign languages. The Center provides the following services: monthly booklists available to all requesting libraries, bulk loans, on-site review of materials, current vendor data, full cataloging information, continuing education workshops, translation and interpreting services, and a toll-free consultation

#### After-Hours Toll-Free Reference Service New Jersey Nightline June 1994

The East Brunswick Public Library will receive \$175,000 to continue for a fourth year the operation of this very popular, after-hours, ready reference service.

#### Academic/School/Public Library Cooperation Resource Sharing Grants July 1994

This program was designed to encourage school library media centers and public or academic libraries to work together to develop resource sharing programs. The following libraries received grants:

# Municipal Branch Library Services, Program B Assistance for Operations and Improvements Projects Serving At-Risk Children and Young Adults June 1994

The purpose of this grant program is to assist municipal libraries in the improvement of branch library services through programs targeted for at-risk children and young adults. The following libraries received grants:

The purpose of this grant is to assist state, county and municipal institutions in meeting the minimum standards for library services in institutions. The following institutions received grants:

### Frequently Asked Questions About Grant Applications

- Q. Who is the chief financial officer?
- A. Public Library: The city/township/municipality treasurer

School Library: The chief business administrator

Academic Library: The comptroller

Institutional Library: The business manager

- Q. Who is authorized to sign the application?
- A. President, chair or designated officer of the legal governing body of the organization.
- Q. May I have an extension of the deadline date for the submission of the application?
- A. No, all deadline dates are firm.

- Who is listed as the project director? Q.
- The individual responsible for the day-to-day operation of the project. A.
- What will happen if I change my mind after I submit the application? Q.
- An application can be withdrawn at any time after the submission date. A.
- The board will not meet in time for me to submit the resolution with the application; O. may I send it in after the deadline date?
- No, all grant programs provide a minimum of 60 days to prepare an application. All A. supporting documents must be submitted with the application.
- Who may sign the resolution for a special library? Q.
- Non-profit: The secretary or designated officer of the organization. For-profit: The corporate officer responsible for the library.
- Does the public library board of trustees have to use the "Board of Education Resolution O. to Apply" which is part of the application or can they make up their own that states "Board of Trustees"?
- The resolution to apply that is part of the application document must be used by all A. applicants. The word "Trustees" may be typed over the word "Education."
- The application asks for code numbers for the county and LEA/other; where do I find what O.
- It is not necessary to fill in those boxes, nor do you have to complete the section that asks A. for the "duration of the project."
- Q. Who should sign all documents?
- The documents should be signed by the designated officer of the agency who has been A. authorized to submit the applications on behalf of the agency.

PLEASE NOTE: It is IMPERATIVE that all applications (an original and four copies) be submitted with the following documents:

- A completed Application Title Page
- Signed Statement of Assurances (This signature should be from the same person who signs the Application Title Page.)
- · Board Resolution to Apply
- Budget Summary

If any document is missing from the application, the applicant will be disqualified.

Another frequently asked question related to the grants process is:

- Why doesn't the State Library have more grants for school, special and academic libraries? Q. The State Library has two sources of funds for grant programs: A.
  - Federal (LSCA)
  - State (Incentive Aid and State Library Assistance Programs)

The laws and regulations which govern these programs are very specific about who is eligible for grants. Very little of the funding can be used for school, special and academic libraries.

Federal (LSCA) funds for grants are divided into three titles:

- Title I development and improvement of public libraries
- Title II construction of public libraries
- Title III interlibrary cooperation and resource sharing

Title III is the only source of federal funds which allows grants for academic, schools and special libraries.

State funds (Incentive Aid and State Library Assistance programs) laws and regulations are very specific about the grant programs and who is eligible to apply. Only county and municipal libraries may apply for Incentive Aid. Certain programs are targeted to institutional libraries. The only specific grant program that academic, school and special libraries can apply for is the preservation program.

As you can see by the above, most of the federal and state money is targeted to public libraries by law and regulation. The State Library does not have discretion in determining who can apply and be funded.

There are a number of bills being considered by the U.S. Congress for technology projects. As written, school and academic libraries may be eligible. Also under consideration is a bill which will provide funding for schools to purchase school library media resources. Depending on the passage of these bills, the picture may change dramatically, with funding targeted to school and academic libraries.

With this issue of the *Grant\$ Bulletin*, the type of library eligible for the grant is set in bold type in the eligible applicant paragraph. Only designated libraries may apply for a specific grant. Each year, the Library Development Bureau receives a number of applications from libraries who were not eligible for a specific grant and whose application is excluded from the grant review process. Libraries applying for grants should read carefully the eligible applicant section in the RFP so that they do not apply for a grant for which the library is ineligible.
