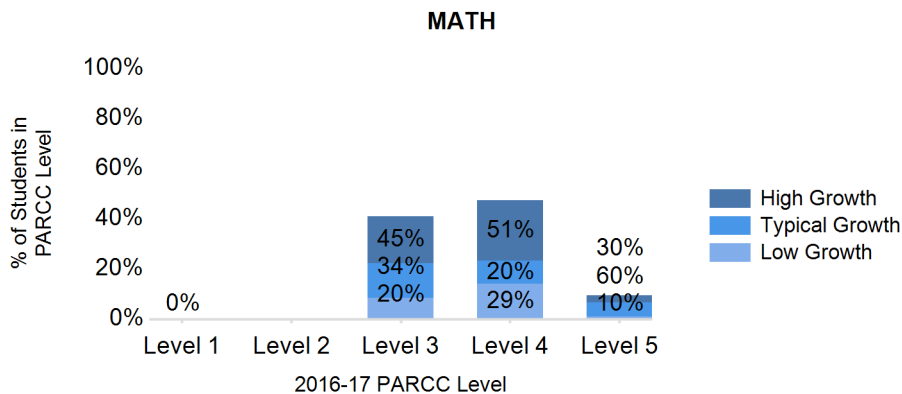
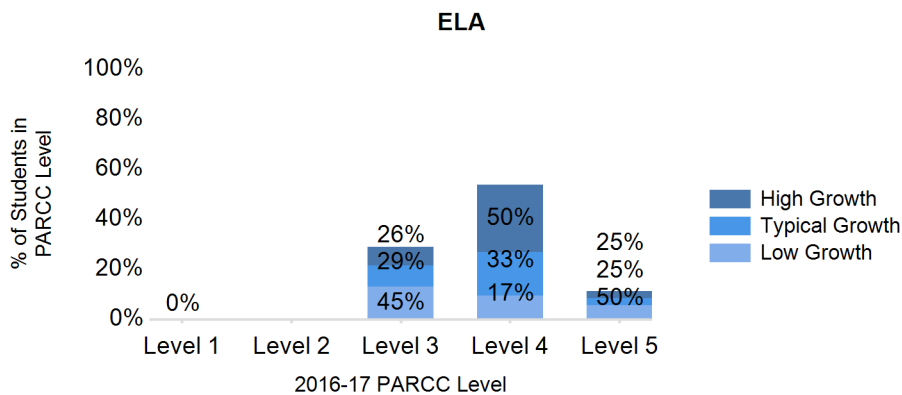

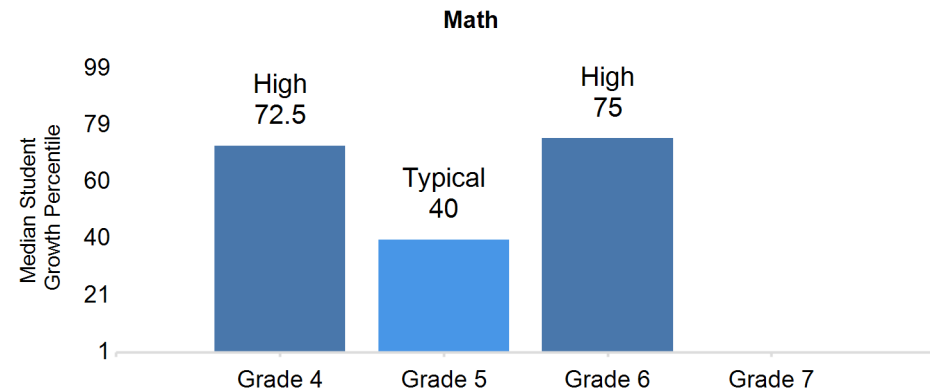
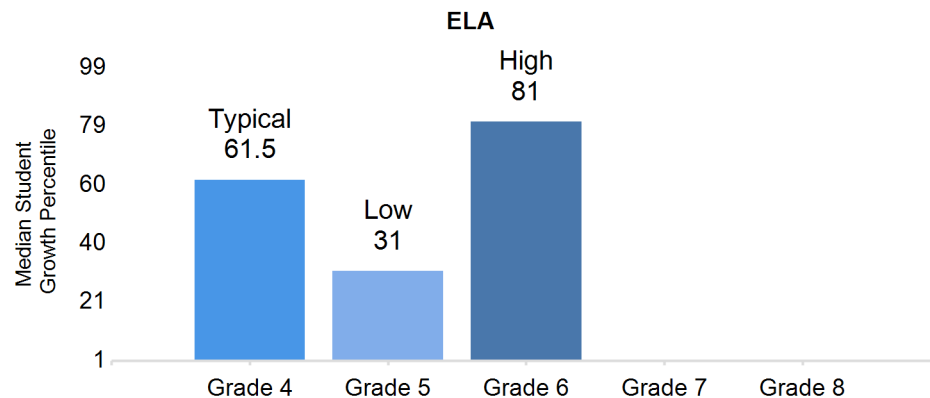
**Student Growth by Performance Level**

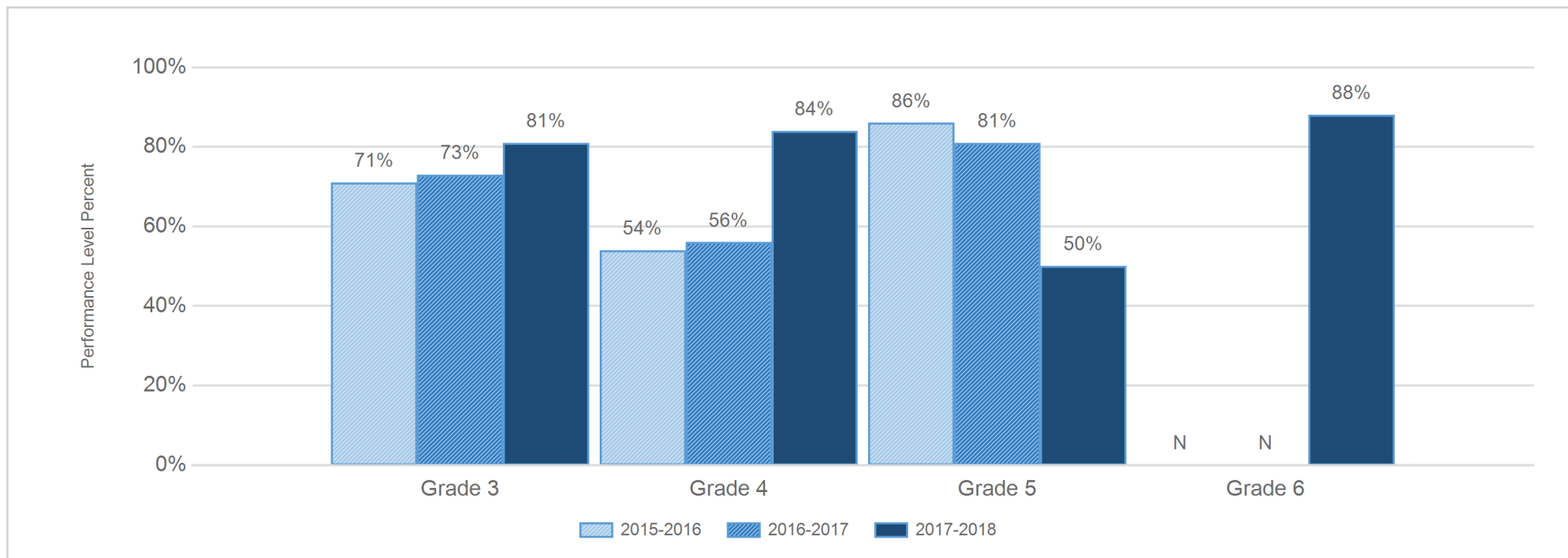

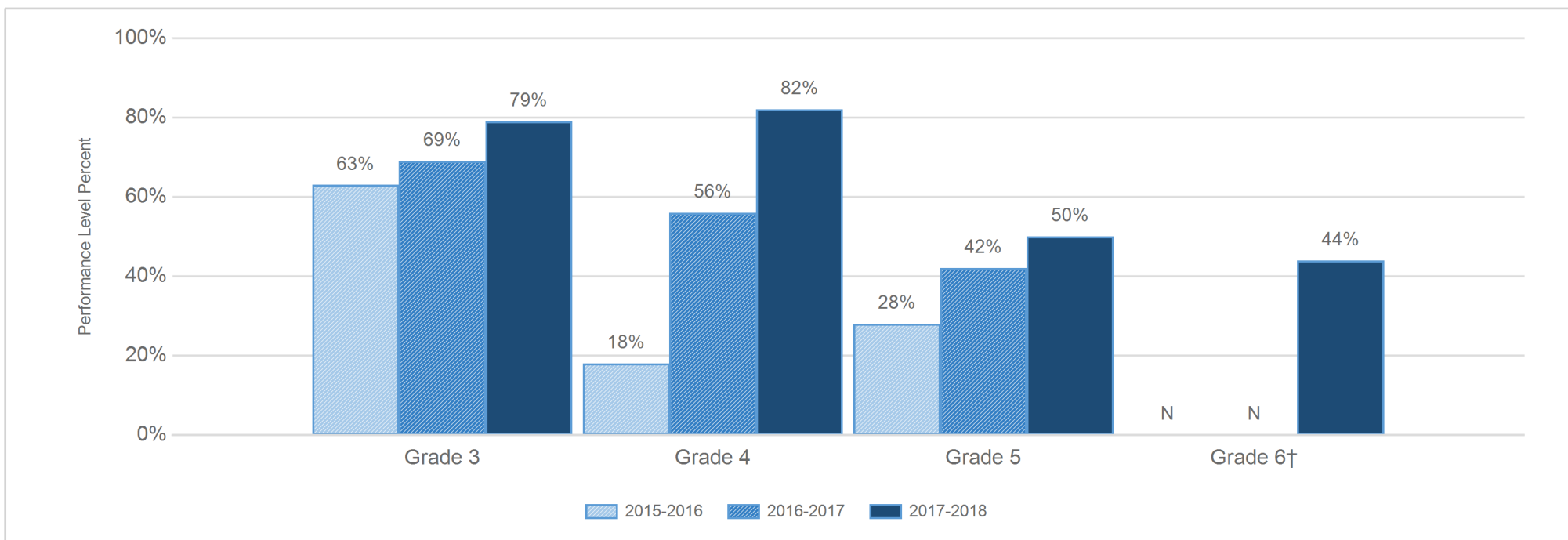

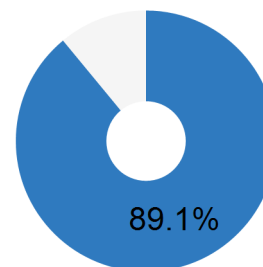

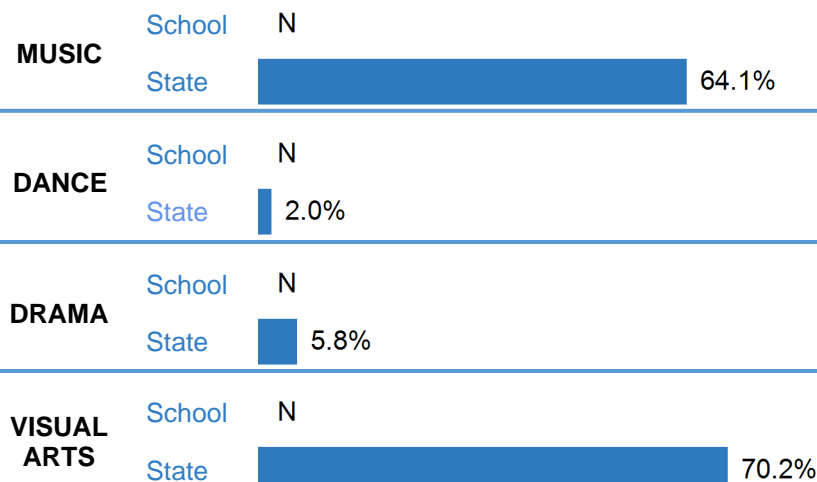

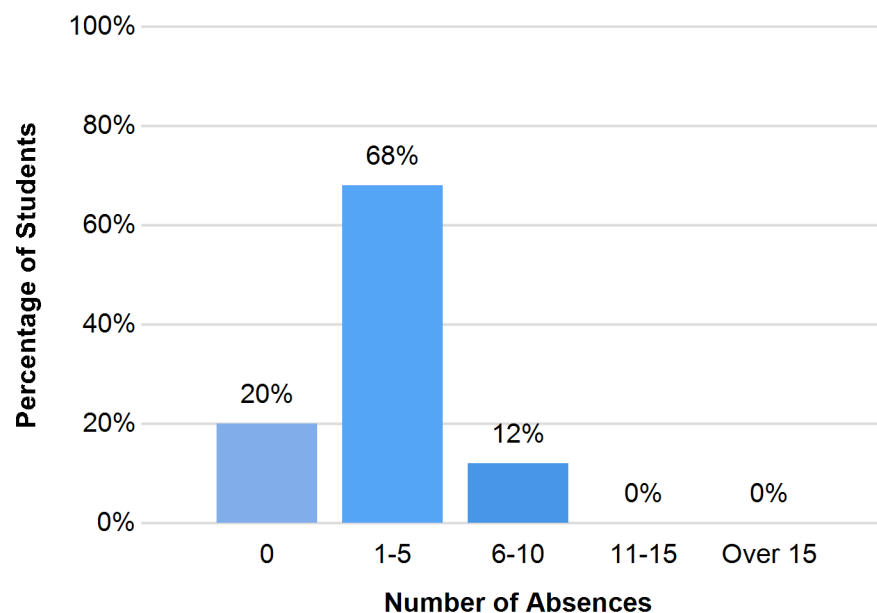

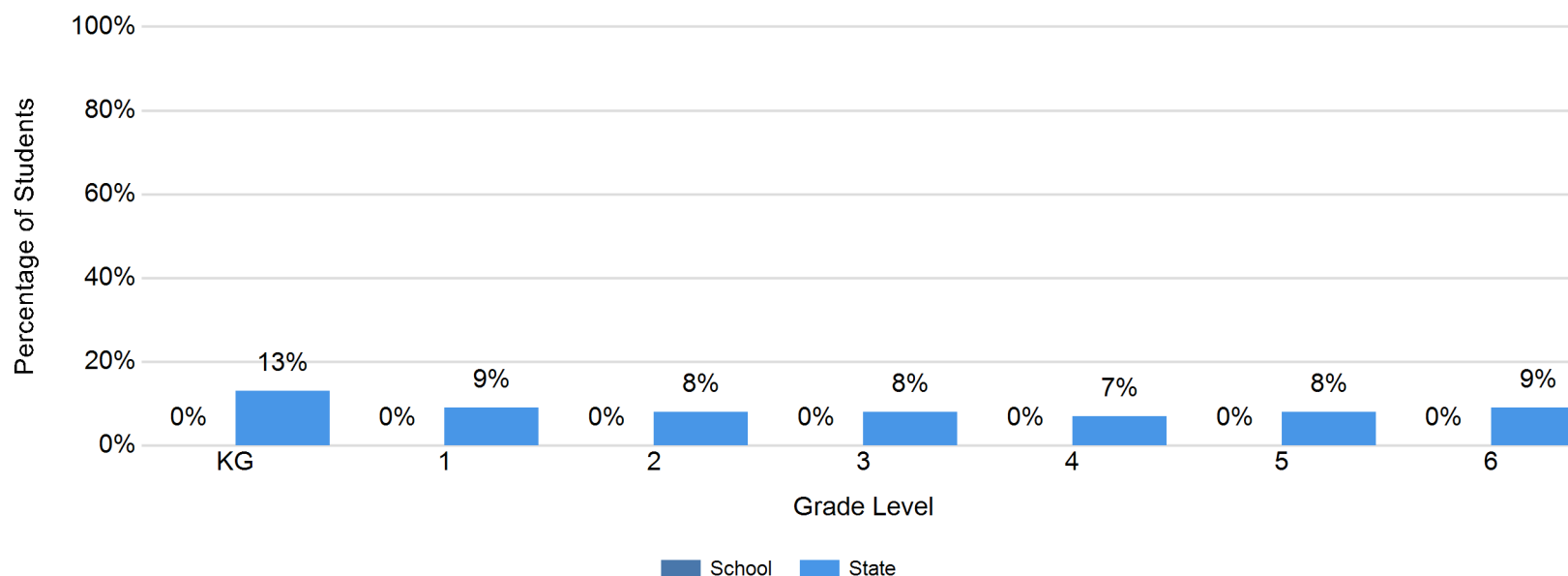

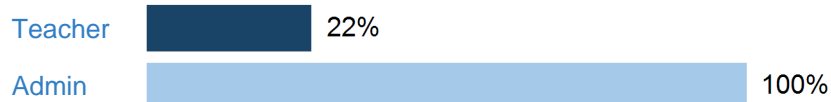
### Teachers and Administrators - Level of Education
