Frequently Asked Questions: Working Papers for Minors



According to [New Jersey law](#), all youth workers – under the age of 18 – who accept a job offer need Working Papers to be employed in the state.

Remember: Minors only apply for Working Papers *after* getting an offer of employment.

As of [June 1, 2023](#), the New Jersey Department of Labor (NJDOL) oversees and administers Working Papers for minors. (This process was previously handled by the New Jersey Department of

Education.)
