New Jersey's March 1, 2007 Prospective Plantings

As of March 1, 2007, New Jersey farmers expect to plant more acreage of corn, wheat, and sweet potatoes. Barley acreage remained unchanged from the previous year. Soybean growers intend to plant less acreage than 2006.

Corn planted acreage is expected to total 90,000, up 10,000 acres from 2006 and 2005.

Barley planted acreage is expected to total 3,000, unchanged from 2006 and 2005.

All hay acreage intended for harvest is expected to total 120,000, up 5,000 acres from a year ago.

Soybeans planted acreage is expected to total 80,000, down 8,000 acres from last year and 15,000 acres from two years ago.

Sweet potato acreage is expected to total 1,200 acres, unchanged from 2006, 2005 and 2004.

Winter wheat seeding for the 2007 season totaled 31,000, up 3,000 acres from December and 6,000 acres from a year ago.

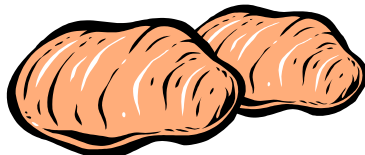

March 2007 Farm Prices Received Index Increased 3.9 Percent From Last Month

The preliminary All Farm Products Index of Prices Received by Farmers in March 2007, at 133, based on 1990-92=100, is 3.9 percent above the February 2007 Index. The Crop Index is up 4.3 percent while the Livestock Index increased 4.2 percent. Producers received higher commodity prices for cattle, broilers, lettuce and oranges. Lower prices were received for hogs, corn, celery and strawberries. The seasonal change in the mix of commodities farmers sell, based on the past 3-year average, also affects the overall index. Increased average marketings of strawberries, broilers and milk offset decreased marketings of cattle, oranges and corn.

This preliminary All Farm Products Index is up 18.0 percent from March 2006. The Food Commodities Index, at 134, is 4.7 percent above last month and up 17.0 percent from March 2006.

Prices Paid Index Increased 1.3 Percent From Last Month

The March Index of Prices Paid for Commodities and Services, Interest, Taxes, and Farm Wage Rates (PPITW) was 155 percent of the 1990-92 average. The index was up 1.3 percent from February but 5.4 percent above March 2006. Higher prices in March 2007 for feeder cattle, feed concentrates, complete feeds and diesel fuel more than offset lower prices for feed grains, trucks, tractors and autos.
