TRENTON — La gobernadora Mikie Sherrill respondió hoy a la carta del 24 de julio de un grupo de miembros republicanos de la Cámara de Representantes en la que reiteraban su continuo enfoque en solucionar el problema del MVC y denunciaban su largo historial de socavar activamente las elecciones.

«Mi administración está totalmente comprometida a garantizar que las elecciones en Nueva Jersey sigan siendo libres y justas, y tratamos la integridad de las elecciones estatales con la máxima seriedad... Este trabajo sigue siendo mi objetivo».

«Los republicanos de Washington, por otro lado, parecen estar mucho más preocupados por utilizar el tema para obtener beneficios políticos que por proteger nuestras elecciones. Varios de los firmantes de la carta que me envió el 24 de julio han apoyado al presidente Trump en sus esfuerzos por socavar nuestro sistema electoral y desfinanciar la seguridad electoral. Siete de ustedes intentaron anular las elecciones de 2020 y votaron a favor de impugnar los votos electorales de los estados. Y, en particular, uno de los firmantes de su carta contrató a un agente condenado por fraude electoral, soborno y chantaje».

Re: July 24, 2026, Letter to Governor Sherrill

Dear Representative Van Drew and Undersigned Members of Congress:

Today, I write in response to your letter dated July 24, 2026.

My administration is fully committed to ensuring that elections in New Jersey remain free and fair, and we treat the integrity of the State's elections as a matter of the utmost seriousness. Consistent with that, I publicly disclosed on July 21, 2026, three days before your letter, that a registration error occurred years before I took office and the State was moving immediately to correct it. My administration has since moved aggressively to remediate the issue and remove affected individuals from the voter rolls. In addition, I ordered



an immediate investigation that is ongoing, conducted by a bipartisan firm led by the former state Attorney General for a Republican Governor.

This work remains my focus.

Washington Republicans on the other hand, seem much more concerned with using the issue for political gain than they are with protecting our elections. Several signatories to your July 24th letter to me have supported President Trump in his efforts to undermine our election system and defund election security. Seven of you attempted to overturn the 2020 elections and voted to challenge the electoral votes of states. And notably, one of the signatories to your letter employed an operative convicted of voter fraud, bribery, and blackmail.

Furthermore, you misrepresent in your letter that the SAVE America Act would have prevented this system error. I encourage you to become more familiar with the legislation you have cosponsored. As your letter acknowledges, the affected individuals answered that they were not citizens (although subsequent investigation indicates that some may, in fact, have had valid registrations).

In addition, as you are aware, the SAVE database that President Trump has used to purge voter rolls has well-documented accuracy issues. This has led to the disenfranchisement of eligible, citizen voters. For instance, in Texas, the Secretary of State acknowledged that the SAVE database flagged U.S. citizens as potential ineligible voters, and some of whom were likely unfairly removed from voter rolls.

Proposals to expand the federal government's role in voter registration systems, including through a centralized registry of voters, raise important concerns regarding personal privacy and abuses of power under President Trump, who has shown time and time again that he will do anything to ensure that only those who support him are able to vote. It is exactly this type of concern that our Founding Fathers sought to guard against when they gave the states the power to administer elections.

We will continue to approach this issue with transparency, integrity, and accountability. That commitment is a matter of record. I will continue to report publicly on this matter, as I have done from the outset. Additionally, the answers to many of the questions posed in your letter are already matters of public record or have been addressed through information released by my administration.¹ For your convenience, we have included citations to those materials.
