







MESSAGE FROM THE ACTING COMMISSIONER




The growing population of elderly people in New Jersey has led to an increasing need for long-term care and community services.

The publication of this revised Guide for Long-Term Care and Community Services in New Jersey is intended to meet a vital public need by identifying available resources for elderly and disabled persons in need of long-term care. Since its initial publication, the guide has been of considerable help to social service workers, medical and health professionals, families, and others seeking health care services in New Jersey.

This guide was originated by and is periodically updated by the Division of Medical Assistance and Health Services and is offered as a public service by the Department of Human Services. A companion publication, the Caregiver's Handbook: A Home Care Guide for Families, contains helpful information for families caring for the elderly and disabled.

INTRODUCTION

This booklet, "A Guide to Long-Term Care and Community Services in New Jersey", was prepared by staff of the New Jersey Division of Medical Assistance and Health Services (New Jersey Medicaid Program) and the Department of Human Services' Unit for Health Care and the Elderly as a guide for adults, children, and their families who need information about community services and nursing home care in New Jersey. It should also prove useful to health care professionals working in the long-term care system. It is a companion to "A Caregiver's Handbook," which discusses issues important to families caring for the elderly and disabled.

There is growing recognition that home care is the choice of many impaired elderly and disabled individuals. Federal and state funding is now increasingly available for such care, supplementing the efforts of family and friends. Through a combination of resources, many elderly and disabled people can continue to live in their own homes or with their families. A nursing home is no longer the only solution for people with chronic health problems.

Despite considerable expansion of nursing home capacity in the last several years, a nursing home bed shortage continues to exist, particularly for the Medicaid client, with a waiting period of up to a year. The decision to enter a nursing home may be difficult for both the client and the family, and that decision should be preceded by a careful examination of the possibility of home care. It is hoped that this booklet will convey to the public the range of options currently available for elderly and disabled people.

Section I of this booklet describes several new community-based programs and services. Section II explains the nursing home placement process. Section III provides a statewide and county listing of community resources, both institutional and home-based.



SECTION I

A GUIDE TO COMMUNITY CARE

This section discusses three new programs being administered by the Division of Medical Assistance and Health Services: (1) The Community Care Program for the Elderly and Disabled (CCPED), (2) the Home and Community-Based Services Waiver for Blind or Disabled Children and Adults (Model Waiver), and (3) the Personal Care Program.

The purpose of each of these programs is to enable individuals who are both medically and financially eligible to receive sufficient support services to remain in the community. These programs reflect the state's concern that in the past many people were unable to receive home care services under Medicaid because of rules which made them eligible only when they entered a nursing home. Often a person who had a chronic health problem had no option but to seek nursing home care. Today, a variety of programs exist, and others are being developed, to provide services in the home. Following is a brief discussion of these programs.

A. Community Care Program for the Elderly and Disabled (CCPED)

CCPED is a special three-year program that offers an array of home care services. The New Jersey Medicaid Program is offering these services to help eligible individuals continue to live in the community rather than in a nursing home. The program will offer services to an enrollment of 1800 eligible persons in its first three years of operation.

Services available under CCPED are:

1. **Home Health Services.** These may include skilled nursing care, homemaker/home health aide services, physical, occupational, and speech therapy, medical social work services, and certain medical supplies.
2. **Medical Day Care.** Health and supportive services are provided on an outpatient basis several days a week within a nursing home or other health care facility.
3. **Medical Transportation.** This is non-emergency transporting of the individual by a suitable vehicle to obtain health service.
4. **Case Management.** A group of services is selected on behalf of clients to meet their individual needs. There is an assessment, service planning, and ongoing monitoring of the plan.
5. **Homemaker Services.** These include personal care and household tasks related to maintaining individuals at home.
6. **Social Adult Day Care.** This is a planned program of services offered during the daytime which includes nutrition and socialization.
7. **Respite Care.** This is a temporary service offered on a flexible basis to relieve families caring for individuals at home

An individual may be eligible for CCPED if he or she is Medicare eligible and is 65 and over, or is determined eligible for disability by Social Security Administration (SSA) and is eligible for Medicare. The level of care needed must compare with the kind of care that a nursing home would offer.

An individual must not currently be receiving Medicaid services in the community. Income and assets must meet the financial guidelines of the program. Monthly income cannot be higher than the highest Medicaid income standard for nursing home patients, which in January 1985 was \$975. Depending on income, the individual may be asked to share in the cost of the program.

Applications may be made by an individual or a family member to the County Welfare Agency or Board of Social Services in the county of residence. This agency will decide whether the individual meets the income and asset standards of eligibility based on the

financial information provided. The individual's doctor will need to indicate the level of care required by completing a form.

If the applicant is financially eligible, a nurse and social worker from the Medicaid District Office visit the applicant to explain the program, determine the client's current level of care, and collect information to help in providing community care.

Once the individual agrees to participate in CCPED, a case manager from a service agency in the county will work with the individual and family to arrange for the necessary services and assure their proper delivery on an on-going basis.

Further information may be obtained by contacting the county Medicaid District Office listed in Section III of this guide.

B. Home & Community-Based Services Waiver for Blind or Disabled Children and Adults (Model Waiver)

This program is for individuals who are in need of the type of care received in long-term institutions. The purpose of the program is to help eligible individuals remain in the community or return to the community rather than be cared for in a long-term facility or a hospital.

This is a very small program serving a maximum of 50 individuals statewide.

To be eligible, the individual must be in need of an institutional level of care and must meet, at a minimum, the nursing home level of care criteria. Total income must exceed the SSI Community Standard and be below \$975 (as of January 1985), or be ineligible in the community because of SSI deeming rules. Applicants must be blind or disabled children or adults. Individuals who are currently eligible for community services under Medicaid are not eligible for the Model Waiver.

The Model Waiver provides all New Jersey Medicaid services plus the services of a case manager.

Further information may be obtained by contacting the Medicaid District Office listed in each county in Section III.

C. Personal Care

This is an expanded service available only to people eligible for the regular Medicaid Program. It is a non-medical support service for individuals with chronic, but stable, disabilities which interfere with activities of daily living such as bathing, dressing, and grooming. It also includes limited household duties directly related to the individual's health. This service must be prescribed by a physician and supervised by a nurse.

Further information may be obtained by contacting the Medicaid District Office listed in each county in Section III.

SECTION II

A. DECIDING ON NURSING HOME CARE

The decision to enter a nursing home may be a difficult one to make. Most individuals and families have mixed feelings. Some people know they need nursing home care but do not want to leave their homes. Home care may be possible with appropriate support from family, friends, and/or community services. However, when family members are elderly, ill, or overwhelmed by other responsibilities, full-time home care may not be available to the very disabled person. Sometimes a nursing home can be the best choice when full-time care is needed.

To help you decide whether nursing home care may best meet your needs, ask yourself or your relative these questions:

- What are my service needs (e.g., special diet, bathing, medication, physical therapy)?

- What are the support services available to me in my community? (Please see Sections I and III of this booklet.)
- To what extent can my family and/or I make the necessary adjustments so I can remain at home?

Before deciding on nursing home care, discuss the situation with family, friends, clergy, doctor, social worker, nurse or whomever is involved at your home or in the hospital. They can help you find out what supportive services are available for home care in your community, and if needed, can help you apply for nursing home care.

B. NURSING HOME PLACEMENT PROCESS

1. Payment for Care

- Private Funds — If you have money available, you can pay for nursing home care privately.
- Private Health Insurance — Some insurance plans, such as Blue Cross or another major medical plan, may pay a portion of the bill for a limited period of time.
- Medicare — Medicare will pay only for skilled nursing care or rehabilitation in a nursing facility for a limited period of time following hospitalization. Medicare does not provide coverage for the costs of long-term care in a nursing home or at home.
- Medicaid — Medicaid will pay for medically necessary care if you are financially eligible. If you wish to enter a nursing home under Medicaid, you can apply at the County Welfare Agency or Board of Social Services. There is a limit to the amount of financial resources (assets) and income that you may have in order to be eligible for Medicaid.

The following individuals may qualify for nursing home care under Medicaid:

- Individuals who apply to the Social Security Office and are eligible to receive Supplemental Security Income (SSI) payments.
- Individuals who qualify under SSI as an "ineligible spouse" of the SSI recipient.
- Individuals who apply to the County Welfare Agency or Board of Social Services and are eligible for financial assistance.
- Individuals who apply to the County Welfare Agency and who meet applicable financial and/or medical eligibility criteria for "Medicaid Only."

If you are considering nursing home care at the time that you file an application for SSI or Medicaid, please tell the Social Security Office or County Welfare Agency.

If you have questions or problems concerning nursing home care, contact the local Medicaid District Office.

Medicaid requires that most of the monthly income of a resident in a nursing home be applied to the cost of this care. As a Medicaid client you are under no obligation to give any donations or pay extra charges to the nursing home. The Medicaid payment includes services such as: laundry, personal hygiene and nursing items, linen, medical and recreational supplies, prescription and non-prescription drugs, medically ordered transportation, and use of medical equipment such as wheelchairs and walkers.

Thirty-five dollars a month of your income is set aside for personal items, which you choose to purchase, that are not covered by Medicaid. You may decide how to manage your "Personal Needs Allowance" money. You may handle your own money or may give written permission for your family or the nursing home to manage these funds.

Each nursing home sets up its own payment policy for nursing home care. For example, some nursing homes accept payment only by insurance or private funds, and not Medicaid.

When selecting a nursing home, make sure to get a contract stating the nursing home payment policy. Have the nursing home staff fully explain what your responsibilities are for

payment. For your own protection, any agreement for payment should be in writing. Consult your county legal service agency or the Ombudsman for the Institutionalized Elderly if you have legal questions regarding a contract. (Please see Section III for legal services in your community.)

Remember that signed contracts may make you and/or your family financially liable for future payment. If you intend to go from private or Medicare payment to Medicaid payment, make sure the nursing home is aware of your plans. It is important that you discuss your Medicaid payment plans as soon as possible with the nursing home administrator. Any agreement with the nursing home for payment should be in writing and signed by you and/or your family and nursing home administration before admission.

You should be aware that the Governor has signed legislation prohibiting private pay contracts and discrimination against Medicaid eligible patients. In general, this legislation prohibits long-term care facilities from requiring private pay contracts or donations under certain conditions on behalf of Medicaid eligible patients. Long-term care facilities are prohibited from soliciting gifts, money or donations from the families of Medicaid patients as a precondition for admission or as a condition for the patient's continued stay in the facility. Voluntary contributions are not prohibited. For further information, contact your Medicaid District Office.

If the nursing home in which you are already residing will not accept Medicaid reimbursement, and you are required to pay the nursing home on a private basis, you may be eligible for other Medicaid services, such as doctor visits, drugs, medical transportation, dental, eye care, etc.

2. Medicaid Approval Process For Nursing Home Care

After completing the financial forms, the County Welfare Agency will supply you or your family with a form called a PA-4, to be completed by your doctor. Remember, you always have the final word on whether you want to enter a nursing home, and even if your doctor signs the form indicating that you need a nursing home level of care, you still may choose to remain at home.

When the PA-4 form is returned to the County Welfare Agency, it is sent to the Medicaid District Office serving your county. The eligibility process may take up to eight weeks depending on the extent of verification of resources required. Financial eligibility is decided by the County Welfare Agency and medical eligibility by the Medicaid District Office, with the approval of your physician.

If you are living at home or in a nursing or boarding home, a nurse and a social worker from the Medicaid District Office will visit you to determine your medical, nursing, and social needs. The information is taken back to the Medicaid District Office where your need for nursing home care is discussed with a Medicaid physician. The purpose of this team evaluation is to determine the level of care you need.

If you are in a hospital, the hospital social worker or discharge planner will help you make arrangements for your care.

A decision is made at the Medicaid District Office whether to approve or deny your request for Medicaid payment for nursing home care. Within a few weeks you will receive a written notice of the decision.

If you are denied nursing home care under Medicaid, you may request a fair hearing from the Division of Medical Assistance and Health Services, CN-712, Trenton, New Jersey 08625, Attn: Fair Hearing Section. If you do not object to the denial and wish to obtain supportive care at home, check with your County Welfare Agency to determine if you are eligible for health-related services through Medicaid or other agencies. (Please refer to Section III for the location of community service agencies.) The Medicaid social worker who visited you at home also may be able to help you find home care services.

If you are approved by Medicaid for nursing home care, you will want to start looking at nursing homes. A list of homes can be obtained from the Medicaid District Office, the County Office on Aging, or Section III of this guide.

Due to the bed shortage for Medicaid applicants in some counties, it is suggested that you and/or your family visit a number of nursing homes, not limiting yourself to one facility or even one county. It is likely that the more information the nursing home staff has about your situation, the more likely it is that you will be accepted as a resident in the facility.

It is important to remember that it is up to you to decide whether or not you want to go into a nursing home. Your family and others interested in your care may help you make a decision but you are the final person to decide. At any point in the process you may withdraw your application. If your plans have changed, please notify the Medicaid District Office that serves your county.

Depending on the nursing home you choose, there may be a waiting period of three months to one year before you will be admitted. If you need care while you are waiting, the Medicaid social worker in your Medicaid District Office will assist you in contacting the service agencies in your county. (Please refer to Section III for the available services in your community.)

3. Preparation For Admission To A Nursing Home

It will be easier to get used to the idea of entering a nursing home if you visit several homes that interest you before selecting one. If you can't do this yourself, ask someone you know to visit for you. Try to visit at different times of the day to observe recreational activities, meals, nursing services, etc. The location should allow family and friends to visit easily; however, the bed shortage may not always make this possible. Take a tour of the home, talk to patients and staff members. Ask about rules, mealtimes, visiting hours, and activities that are available. Ask what personal possessions are permitted, such as: TV set, radio, favorite chair, footstool, pictures, etc. When you are ready to enter the nursing home, make sure you do the following:

- Notify your post office of your change of address.
- Mark your clothing with your name, whether or not your laundry will be done at the nursing home.
- Bring a clock and calendar with you.
- Continue receiving your favorite magazines and newspapers at the nursing home.
- Leave small valuables with family members or friends. Most nursing homes discourage bringing any small valuable possessions unless they are kept in the facility safe.

4. Adjusting To The Nursing Home

Going to live in a nursing home will take some adjustment for you and your family. There will be many changes in your day-to-day activities and, of course, the surroundings will be different. You will not be giving up your rights and individual preferences, but some adjustments to the nursing home routine will be necessary. Perhaps the biggest change for most people is sharing a room with someone else. Give yourself time to get used to these changes. Talk over your worries and fears, your plans and hopes for the future, with your family and friends.

Unless you require bed care due to your condition or illness, you will dress daily and have the freedom to move about. You will be encouraged to continue to take care of your own personal needs as much as you can. Talking with other residents will help you maintain an interest in life around you.

There are many services available to you in nursing homes:

- Medical Care — Will be provided by a physician periodically and if you become ill.
- Nursing Services — Will be provided directly by a professional nurse or by an aide under supervision, as needed.
- Social Services — Will be available to help you with any personal or family concerns.
- Rehabilitation Services — Will be available if the physician feels you will benefit from physical, speech, and other therapies.
- A Dietitian — Will talk with you concerning your food likes and dislikes and provide for a special diet if needed.
- Other Medical Services — Such as medicines and care for your eyes and teeth will be available.
- Recreation Activities — Will be offered to you. Community programs, group recreational programs, crafts and educational programs will be available; you should be able to continue with your favorite hobbies and interests.
- Religious Programs — There will be opportunities for you to practice your religion, attend services, and visit with the clergyman of your choice.

5. Rights As A Nursing Home Resident

The Patient Bill of Rights — A set of rules that all nursing homes must follow, New Jersey Public Law 1976, Chapter 120 assures that your personal and civil rights must be respected. A list of rights is available in all nursing homes for you to read and sign. Among the important rights you should be aware of are:

- Your right to have a complete record and quarterly accounting of personal money and property kept by the nursing home, daily access to your money, and the right to retain and use your personal property.
- Your right to visit with whomever you choose between 8 A.M. and 8 P.M. daily.
- Your right to privacy including the sending and receiving of unopened mail and access to a telephone.
- The right to wear your own clothing and to a safe and decent living environment.
- The right to retain your personal physician and to have information on your medical condition and care.

Leave of Absence — According to Medicaid policy you are permitted to leave the facility overnight to visit family and/or friends up to 24 days a year with your doctor's approval. Medicaid will pay to hold your bed for these overnight visits. Medicaid will also pay to hold your nursing home bed for up to 10 days if you are hospitalized. You also may choose to leave the nursing home during the day with your doctor's approval.

Complaints — If problems occur in the nursing home for any reason, discuss them first with the staff in the nursing home — the nurses, the social worker or the administrator. If you do not receive any satisfaction or the problem continues, talk to the Medicaid nurse or Medicaid social worker who frequently visit the facility. You may wish to forward your complaints in writing to the Medicaid District Office. (Please see Section III for the phone number of each Medicaid District Office.) In addition, there should be a telephone number posted at each pay telephone in the nursing home (1-800-792-8820) which is the Ombudsman for the Institutionalized Elderly. Anything you say will be kept confidential and you will receive assistance with problems. The Ombudsman's Office is set up specifically to deal with all complaints and problems of nursing home residents.

Transfers — If you wish to transfer to another facility, write a letter to the Medicaid District

Office stating why you wish to transfer. A transfer may take a long time because, with the limited bed vacancies, other patients coming from home or hospitals may have priority. If the nursing home requests your transfer, it must have good reason to justify this request. You must be given reasonable advance notice by the nursing home administration prior to any transfer. The Bill of Rights discusses this issue.

6. Length Of Stay In A Nursing Home

How long you will stay in a nursing home depends on many things: the state of your health, the amount of care you need, and whether suitable home care is available in your community.

From the day of admission to a nursing home, the nursing staff and Medicaid staff will begin plans to help you improve so that you may eventually be discharged. A nursing home does not have to be a permanent home. People in nursing homes often do get well. They learn to walk, to dress, to feed themselves, and they take a new interest in life.

7. Leaving The Nursing Home

Your health and ability to care for your needs may improve so much that you will feel that you no longer need nursing home care. Your doctor may agree that you are ready to move back to your community. The nursing home staff will help you make the necessary arrangements. You may choose to leave the nursing home at any time. You should talk with your doctor if you decide to move back home. If you decide to leave against your doctor's advice, you will be asked to sign a form releasing the nursing home of further responsibilities.

If you are a Medicaid client, the Medicaid staff will visit you regularly to check your progress. When you have improved so that nursing home care is no longer required, the Medicaid doctor may contact your doctor to discuss alternate plans. If the Medicaid staff at some point decides that you no longer need nursing home care, you will be notified by letter. You will have a chance to talk over this decision with family, nursing home, and Medicaid staff. The nursing home staff should help you plan for your move back into your community.

SECTION III - A GUIDE TO COMMUNITY SERVICES

A. How to Use Section III

Future Additions/Deletions to the Guide

This section of the guide can serve as a starting point in the search for community long-term care resources. Although the information is detailed, it is not possible to provide a listing of all available resources throughout the entire state. Agencies come and go, their services vary with funding changes, and there is always a lag before publication. In order to avoid repeating errors or omissions in future editions, a form is made available for suggested additions or deletions to update this guide. See page 59.

Referrals by Health and Social Service Professionals

The listing of an agency name and telephone number to a potential service consumer will not always ensure a successful referral. The professional user of this guide will often have to contact an agency or nursing home to prepare the agency for the prospective client. The consumer must also be prepared for contact with the service provider. Finally, advocacy and follow-up services are often required to assure adequate service provision and utilization.

Agency Classification System

The reader must also be cautioned not to follow rigidly any system (including the one used in this guide), which attempts to classify agencies or nursing homes based only on the type of service they provide, or the geographical areas they serve. Agencies specializing in one type of service may also have the capacity to respond to other client needs or know of agencies that will. They may also have more flexibility in their geographical service area than their name would imply. A search through the listings of adjacent counties may be helpful since service areas of many voluntary agencies cross county lines.

Multi-Service Agencies

The reader is urged to use this guide creatively, and not to be afraid of asking for help from agencies which may not seem appropriate sources. This is particularly true of multi-service agencies such as County Welfare Agencies, County Offices on Aging, municipal governments, and some voluntary agencies. The reader may freely contact these agencies for complete information about their services, or whenever information about particular services is difficult to find.

Statewide Agencies

Finally, the reader will please note that in the interest of conserving space, those agencies that provide services on a statewide basis have been listed separately. Therefore, a resource search is not complete until the county listings, statewide listings, and the list of toll-free numbers have been consulted.

B. Community Service Descriptions

These descriptions are provided in order to advise the reader about the services which are available. The reader will undoubtedly find exceptions, since the descriptions are general. Please contact the agency in question to find out about the nature and scope of that agency's services.

Adult Day Care Programs

Adult day care centers provide a range of services to promote social, emotional, and physical well-being. Some provide opportunities for counseling and health services. Day care center services are intended to support community living. Medical day care centers provide health and health-related services under medical supervision and are licensed by the State Department of Health. Medicaid pays for medical day care for eligible clients. Social day care emphasizes socialization and nutrition. Medicaid does not pay for social day care in the regular program.

Financial Services

The agencies listed provide direct assistance to those who qualify. Municipal welfare departments (not listed here but in your phonebook) can often provide help until the County Welfare Agency's or Board of Social Services' resources are available. Also, many municipal welfare agencies can pay for needed services, such as home health and transportation services. Private and voluntary agencies can at times provide short-term financial assistance to those in need.

Health Services

Many agencies in the statewide and county listings provide services to those with acute or chronic health conditions. Most counties and municipalities provide a variety of health services to their residents. Contact should be made to the appropriate county or municipal health department for specific information.

Home health agencies provide one or more of the following services: nursing, physical, occupational, and speech therapies, medical social services, homemaker/home health aide services, or medical supplies.

Hospice Services

These are services for the terminally ill, primarily focused on home care, with hospital services when home care is not feasible. Total patient care involves the family and others. Service is extended to the family during the bereavement period.

Housing Services

Senior citizen housing and housing for the disabled are usually managed by counties or municipalities. Rent subsidies are sometimes available. Some housing programs provide services, such as the Division on Aging Congregate Housing Program available to residents of certain buildings.

Boarding homes and rooming homes are now required to be licensed by the Department of Community Affairs, and their current status should always be checked. The County Welfare Agency provides services to residents of the homes and maintains files on each home. Licensure for both categories are subject to change and this should be checked with the State Department of Community Affairs. These homes are not listed in Section III.

Legal Services

These are services which enable clients to deal with such issues as wills, power of attorney, settling estates, settling disputes, etc. For those who cannot afford a lawyer, these may be available through Legal Aid or the County Office on Aging.

Licensed Residential Health Care Facilities

These facilities provide personal care services, including assistance with activities of daily living. They also must provide limited health maintenance and monitoring services by a professional nurse; however, they do not provide "hands-on" nursing care. They are licensed by the State Department of Health and their current licensure status should be checked. They are listed in Section III.

Life Care Communities

These are usually housing units which also have available services such as meals, housekeeping, health services and nursing home care. Usually residents pay an initial fee and monthly charges which include any necessary care.

Meal Programs

These nutrition services are usually of two types, home delivery of meals to frail elderly and disabled persons and congregate meals for those who are mobile enough to leave their homes.

Nursing Homes

Skilled Nursing Facilities (SNFs) provide 24-hour skilled care under the direction of a physician, and are covered by Medicaid and, under certain conditions, by Medicare or private insurance. Intermediate care facilities (ICFs) provide intermittent skilled care and are for clients whose needs are less intense. These are covered by Medicaid, provided a client is eligible, **but not by Medicare**. Nursing homes are listed in Section III. The Medicaid District Office should be contacted regarding Medicaid nursing home placement.

Respite Care

Respite care is a temporary service offered to relieve caregivers. The service can be provided by a homemaker or aide, a nurse or even through a temporary placement of the patient in a nursing facility. There are no separate listings for respite care in this resource guide.

Senior Centers

Senior centers provide a wide range of social, recreational, and educational opportunities to people 60 years of age or older and their spouses. These services are often coupled with congregate dining programs offering nutritious noon meals at low cost. The County Office on Aging should be contacted for complete information.

Social and Mental Health Services

Those agencies listed provide a variety of direct services to adults and families, such as individual, group, and family counseling.

Telephone Services

The agencies listed provide information and referral services, crisis hotline services, reassurance calling services, or all three. Reassurance calling programs provide for daily telephone contact with homebound individuals to ensure their well-being.

Transportation Services

Services range from regular senior citizen mini-bus routes to dial-a-ride services. Escort services to appointments or on shopping trips may be available.

Volunteer Programs

These programs provide opportunities for seniors to render services to others, as foster grandparents, friendly visitors, or in other ways. Also listed are programs which provide volunteers to seniors to help with domestic chores, escort needs, companionship, letter writing, etc.




