- A. Advise you of the state permits required for your project, upon completing "MASTER PERMIT INFORMATION APPLICATION FORM"
- B. Coordinate contacts with relevant local and state regulatory agencies upon request.
- C. Monitor the progress of your permit application.
- D. Act to ensure processing of most permits within 90 days of application.
- E. Process "Over The Counter" certain permits meeting appropriate criteria.

OVER-THE-COUNTER PERMITS

I. STREAM ENCROACHMENT (609) - 292 - 4869

DEP now has a one-day processing service for certain minor stream encroachment permits. This "over-the-counter" service is limited to minor projects which do not adversely change the water carrying capacity of the floodway, do not increase erosion or sedimentation in the stream, and do not require substantial channel modification or relocation. For further information contact the Bureau of Flood Plain Management, P.O. Box CN029, Trenton, NJ 08625.

II. WATERFRONT DEVELOPMENT (609) - 292 - 0060

DEP has a one-day processing service for minor waterfront development projects. This over-the-counter service applies to waterfront construction activity in man-made lagoons and minor maintenance and/or repair or replacement of lawful existing structures. For further information contact: Waterfront Development, P.O. Box 1889, Trenton, NJ 08625.

III. SEWER EXTENSIONS (609) - 292 - 3846

...

DEP has a one-day processing service for "minor" sewer extension projects. Eligible projects must meet certain criteria, such as, length of 1000 linear feet or less, cost of \$25,000 or less, sewage flow per day of 12,000 gallons or less. No projects with pump stations, force mains, siphons, gallonage transfers or holding tanks will be processed over-the-counter. Projects can not be located in areas under sewer ban, administrative orders, or litigation.

Projects must be in-house by 9:30 a.m., and all administrative documents must be in proper order. Pre-application conferences are strongly recommended. For further information contact Division of Water Resources, P.O. Box CN029, Trenton, NJ 08625.

DEP has developed a Master Permit Information Application which, upon completion, will indicate all the DEP permits required for the project. Forms may be obtained by contacting the Office of Business Advocacy (See inside cover for details).

Administrative Hearings (Quasi - Judicial) - are held between the state and a particular party involving an application, enforcement - violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP RECAP

(Recent press releases in capsule form)

February 1--STATE SUPPORT FOR FEDERAL COASTAL ACT--DEP Assistant Commissioner Donald T. Graham was to represent Governor Brendan Byrne February 2 before the House Merchant Marine Sub-Committee on Oceanography at an Atlantic City hearing on reauthorization of the federal Coastal Zone Management Act. He was to urge a minimum of a ten year reauthorization.

February 1--COMMISSIONER ENGLISH AT ARKANSAS CONFERENCE--DEP Commissioner Jerry Fitzgerald English represented Governor Byrne at the Conference on State Strategies for Energy Security in Little Rock, Ark.

February 1--HEARING ON POLLUTION CONTROL IMPROVEMENTS--Commissioner English Announced a DEP public hearing March 7 in Atlantic City to receive comments on proposed agreement between DEP and the Atlantic City Electric Company on scheduling compliance of the company's B.L. England Generating Station in Upper Township, Cape May County. The schedule calls for installation of more efficient air pollution control devices at the plant by March 31, 1982. The hearing will be at City Hall, 1301 Bacharach Blvd., at 10 a.m.

January 31--TEN-STATE HAZARDOUS WASTE PLAN PROBED--DEP has met with nine northeastern states to open studies on a regional nazardous waste manifest system. New Jersey now has such a system in-state, but greater areas must be covered to better control disposition of hazardous wastes. The states are Delaware, Connecticut, Maryland, Massachusetts, New Hampshire, New York, Pennsylvania, Rhode Island and Vermont, plus the Interstate Sanitation Commission and Regions I and II of EPA.

January 31--POLLUTION PENALTY IN CAMDEN COUNTY--DEP's Division of Water Resources has announced a \$2,300 penalty against William Gassel Company, Inc., for illegal operation of sewage lines, a wet well and a pumping station in Lindenwold Plaza, Lindenwold, without the proper operation permit. The Lindenwold Borough Municipal Utilities Authority sewage treatment plant lacks capacity for the plant effluents, according to Division Director Arnold Schiffman.

January 30--INDUSTRY SURVEY FOR DANGEROUS MATERIALS--Commissioner English announced a year-long survey of some 15,000 businesses and industries to ascertain uses and dispositions of toxic or carcinogenic substances. About 155 substances will be checked as part of the ongoing program of DEP's Office of Cancer and Toxic Substances. Findings can reinforce new pollution control regulations.

January 30--CAFRA PERMIT DENIED FOR HIGHRISE IN ATLANTIC HIGHLANDS--DEP's Division of Coastal Resources has denied a Coastal Area Facility Review Act (CAFRA) permit sought by the King James Corporation to erect a 12-story, 234-unit senior citizen complex in Atlantic County. Currently inadequate water and sewerage facilities led to the rejection.

January 29--COMMISSIONER ENGLISH IN WASHINGTON MEETING--Commissioner English was to go to Washington, D.C. to meet with Douglas Costle, federal Environmental Protection Agency (EPA) administrator, and the New Jersey congressional delegation on a number of subjects, including resource recovery, hazardous waste, the Pinelands and Liberty State Park improvements.

January 29--SHELLFISH BEDS REOPENED--Commissioner English announced reopening for shellfishing of waters in the vicinity of Little Egg Harbor inlet, closed January 9 after an oil barge ran aground and leaked a quantity of oil into the sea. A threat to public health no longer exists, she said.

January 28--YCC RECRUITMENT FOR 1980 BEGINS--March 15 is the deadline for applications for service in the Youth Conservation Corps (YCC). Applications are available at high schools, state parks and forests and many community organization. About 450 youngsters will be employed.
