Aviation Department

April's 2.7 percent growth and record 10.7 million passengers - 284,000 more than April 2015 - kept our airports on a record-setting pace. Domestic traffic set the tempo with a 3.1 percent increase and new record of 7.1 million passengers for the month of April. International traffic, too, set a new monthly mark, with 3.6 million passengers, despite a modest 2.1 percent growth rate. The region's passenger traffic growth benefitted from three factors: a 3.2 percent increase in seat capacity, strong underlying demand that raised load factors to 81 this year from 71 in 2015, and downward pressure on ticket prices. The region's cargo performance posted its fourth consecutive monthly decline, as it edged down 0.9 percent. International freight continued to underperform as it recorded its 12th consecutive monthly decline and led the fall with a 2.9 percent drop. Following an 11.9 percent gain in March, domestic cargo increased 2.9 percent.
