### **Deletions from the 2013 Ineligible List**

The New Jersey Lawyers' Fund for Client Protection declares that past due payments or exemption certifications for the following attorneys were received before publication of the 2013 Ineligible List. These payments or exemption certifications were received after the publishers' deadline, so publication of the names could not be prevented.
