January 1981

Total nonagricultural wage and salary employment in New Jersey increased by 17,900 in December to a seasonally adjusted total of 3,057,300. This was the fifth consecutive monthly increase as total jobholding reached its highest level since March.

The nonmanufacturing sector, which reached an all-time seasonally adjusted high in December of 2,282,700, was primarily responsible for the job gain. Within nonmanufacturing, the service industry, spurred by the opening of two new casinos, increased by 8,800 on a seasonally adjusted basis.

In addition to services, other noteworthy employment gains were in construction and trade. The normal winter slowdown in building activities was less severe this December possibly due to the mild temperatures early in the month, which led to an over-the-month gain of 2,100 on a seasonally adjusted basis. The retail segment of trade accounted for 2,500 of the 3,500 sector increment with better-than-usual holiday hiring in department stores.

The manufacturing level rose by a seasonally adjusted 6,600 from November to December. The increase continued an uptrend that began in September. The industries with sizeable gains were apparel, chemicals, and miscellaneous manufacturing.

The weekly earnings of New Jersey's production workers was \$318.17 during December, \$21.65 above the December 1979 level. After seasonal adjustment, the workweek edged down by 0.1 hours to 41.1 hours in December.

ANNUAL AVERAGE ESTIMATES FOR 1980

Department analysts noted that the 1979-1980 annual average comparisons of employment data distort the picture of the New Jersey economy in 1980. The 1980 recession began in February and ran for approximately six or seven months so that annual average comparisons do not fully reflect the recessionary fluctuations and their effects at the time.

A comparison of the preliminary annual averages for 1980 and 1979 showed a total nonfarm employment increase of 11,900. The net rise resulted from a 30,900 nonmanufacturing gain and a 19,000 manufacturing loss.

The nonfactory increase rested primarily on a 27,500 job-increment in the service industries which include the fast growing segments of casino/hotels, medical/health services, and business services. The Atlantic City Labor Area accounted for 9,000 or about one-third of the statewide increase in service employment because of the effect of continued casino-related expansion in 1980.

In the rest of the nonmanufacturing group, government and finance/insurance/real estate experienced employment increases over the year, while construction, transportation, and trade saw employment decline in 1980. The losses amounted to 4,300 in construction, 4,500 for transportation and 2,500 in the trade industry. The gains were 11,700 in government and 2,900 in finance/insurance/real estate.

The 4,500 loss in transportation services was due almost entirely to the state takeover of Transport of New Jersey: the state government employment figures were correspondingly inflated by the same amount. Government was also higher over the year due to the hiring by the federal government of 1980 census workers.

The factory sector which usually suffers the heaviest job losses in an economic turndown had significant declines in paper, rubber and plastics and in auto-related fabricated metals and transportation equipment industries. The closing of the Ford plant in Mahwah was a major factor in the transportation equipment losses.



TECHNICAL NOTES

Nonfarm Wage and Salary Employment

Employment data refer to persons on establishment payrolls who received pay for any part of the pay period which includes the 12th of the month. The data exclude proprietors, the self-employed, unpaid family workers, farm workers, and domestic workers in households. Salaried officers of corporations are included. Government employment covers only civilian employees; federal military personnel are excluded.

Persons on an establishment payroll who are on paid sick leave (when pay is received directly from the firm), on paid holiday or paid vacation, or who work during any part of the pay period but are unemployed or on strike during the rest of the period, are counted as employed. Not counted as employed are persons who, during the pay period which includes the 12th, are laid off, on leave without pay or on strike for the entire period, or who are hired but do not work during the period.

Average Hours and Earnings

Hours and earnings data are derived from reports of payroll and man-hours for production and related workers in manufacturing. When the reported pay period exceeds one week, the payroll and man-hour figures are reduced to a weekly basis.

Average hourly earnings for manufacturing are on a "gross" basis, reflecting not only changes in basic hourly rates, but also such variable factors as premium pay for overtime and shift work, and changes in output of workers paid on an incentive plan. Excluded from average earnings are irregular bonuses, retroactive items, payments of various welfare benefits, and payroll taxes paid by employers.
