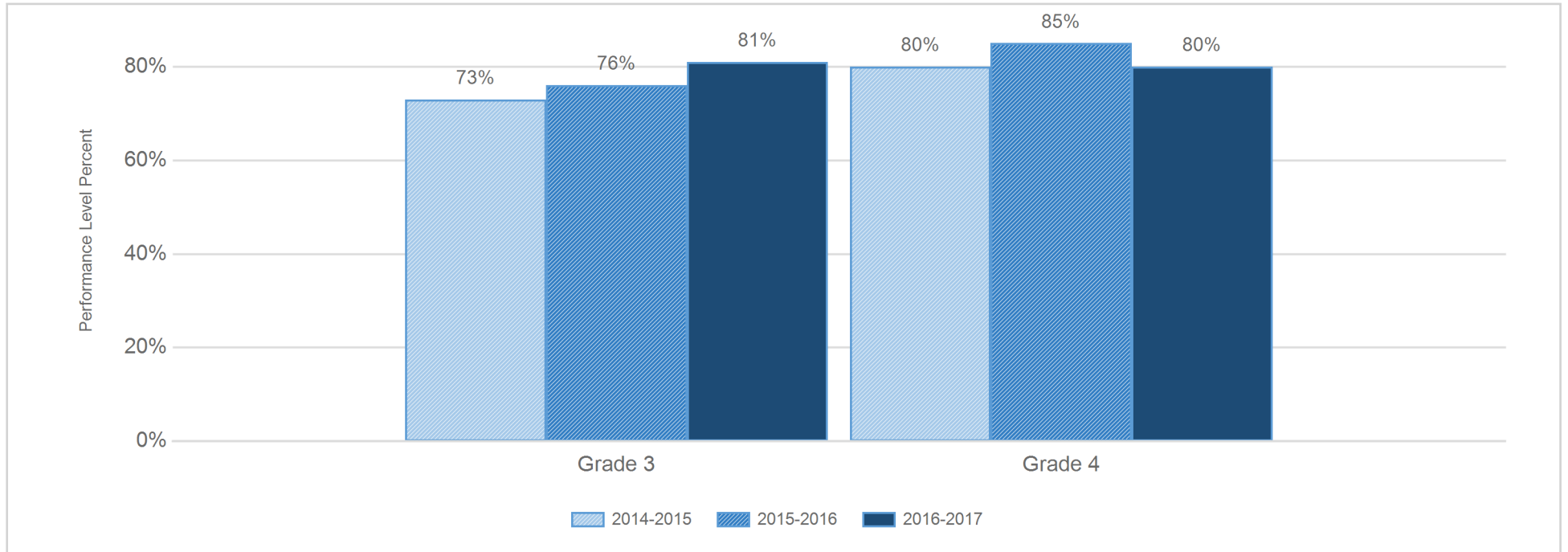

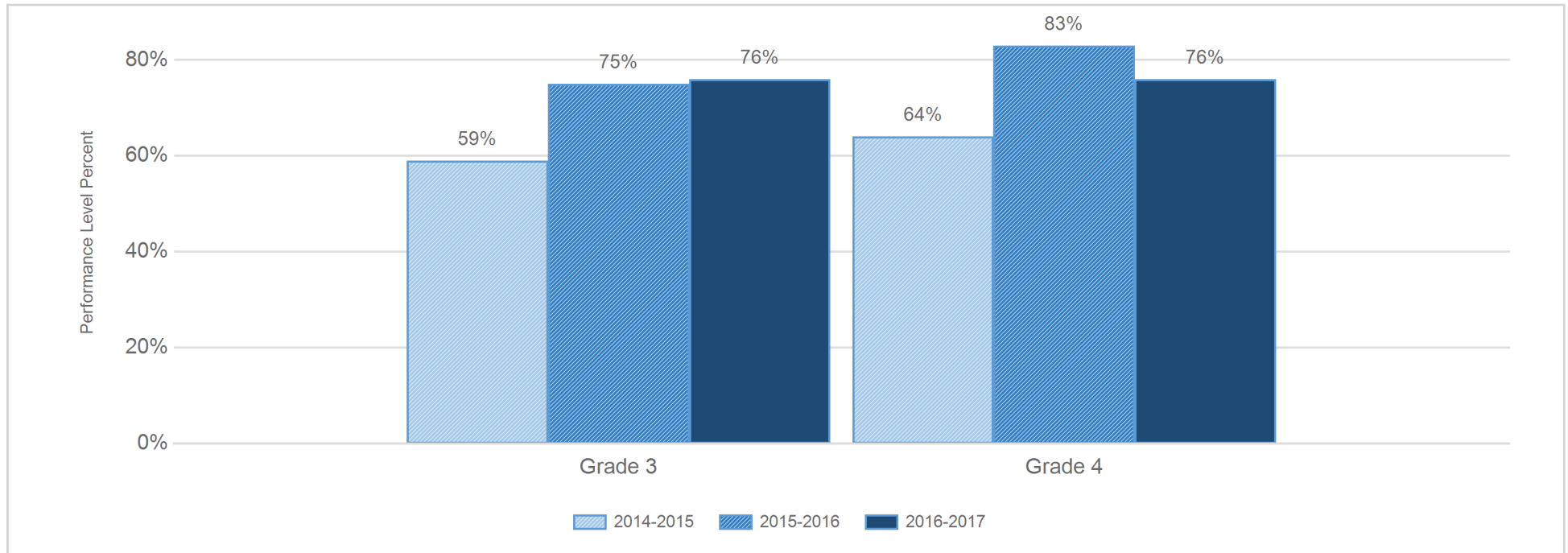

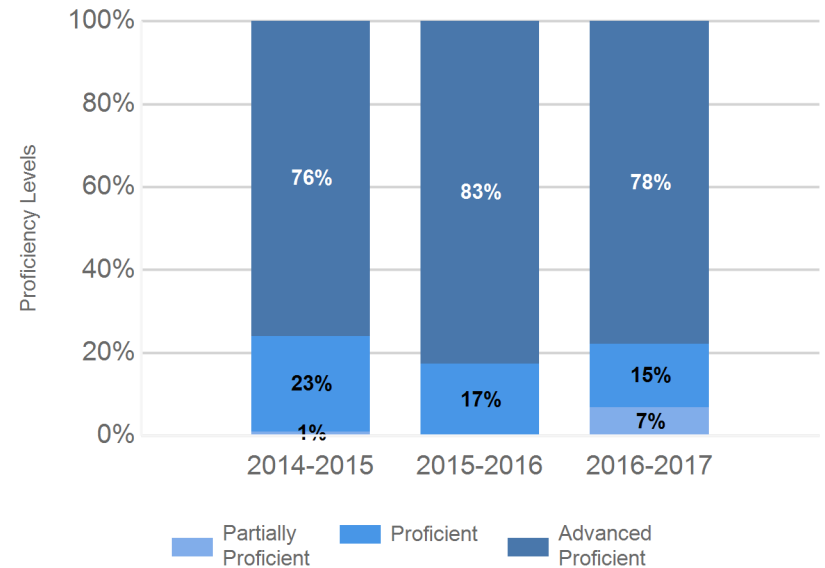

This section of the performance report shows information on student growth which measures how much students are learning each year. Each student receives a **Student Growth Percentile (SGP)** for English Language Arts/Literacy (ELA) in grades 4 through 8 and for Mathematics in grades 4 through 7 that explains their progress compared to students who had the same test scores in the prior year.

A student's **SGP** falls between 1 and 99 and can be grouped into three levels: **Low Growth: Less than 35** **Typical Growth: Between 35 and 65** **High Growth: Greater than 65**

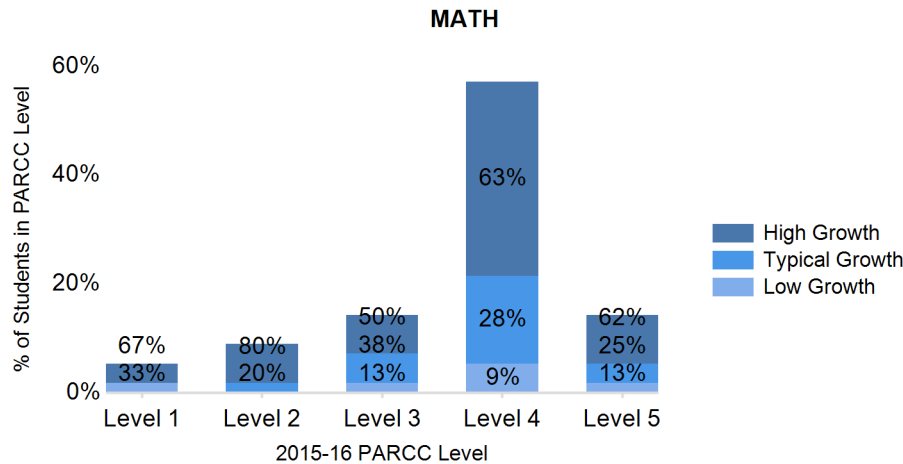
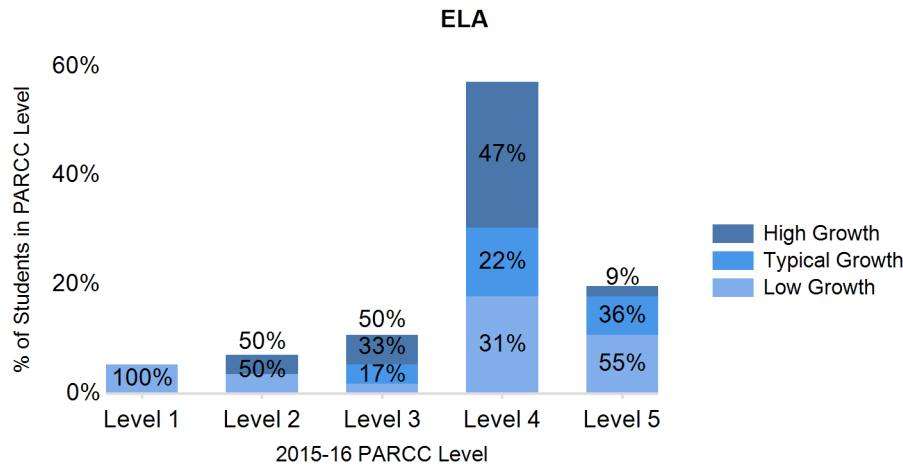

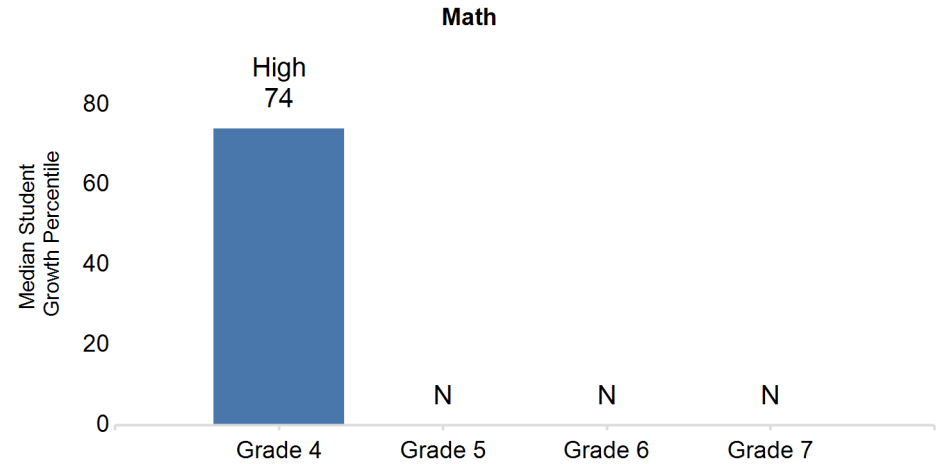
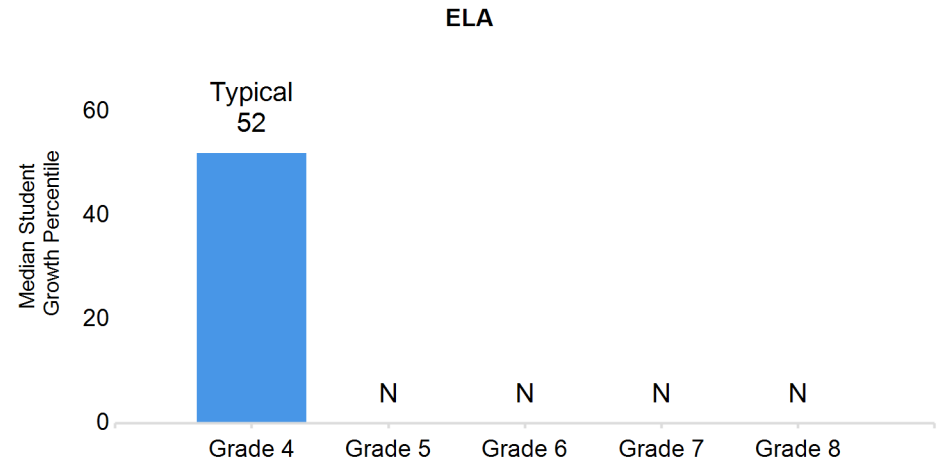

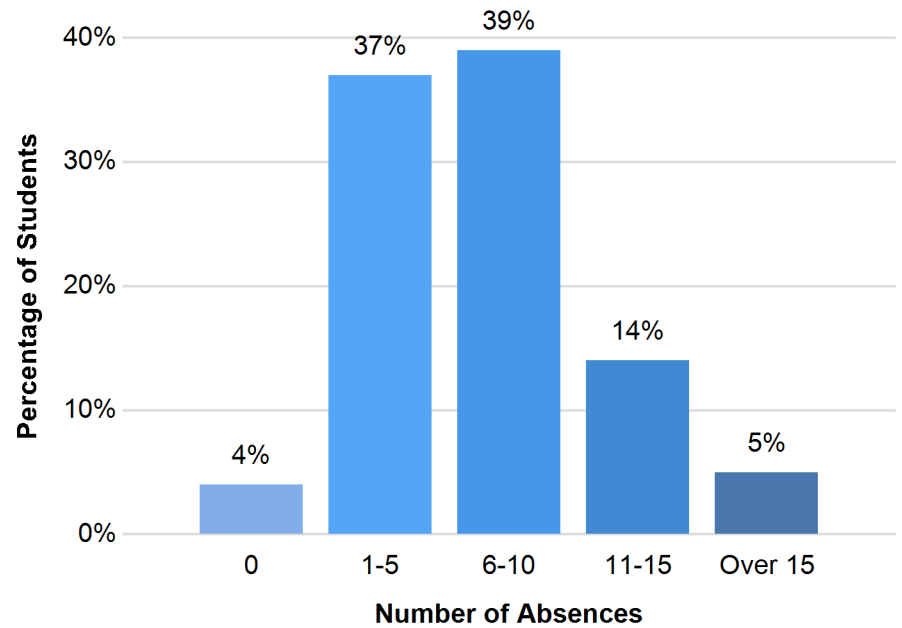

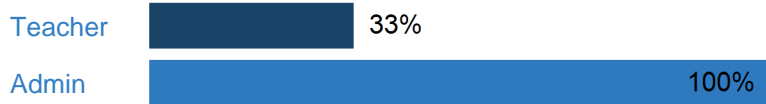

Other Information:

Hilltop has a dedicated team of professionals that work together to meet the needs of our pre-kindergarten through fourth-grade students. These young learners are immersed in programs that will prepare them socially, emotionally and academically for the world beyond the Mendham Borough School District. Along with a rigorous academic schedule that includes Teachers College Reading and Writing Project and Everyday Math 4, all students participate in art, music, library, physical education and technology programs in their related arts. Our third and fourth-grade students receive instruction in Spanish two times each week. Our fourth graders can choose a brass or orchestra instrument to play, with lessons given weekly in a pull-out setting. Our district's Integrated Pre-Kindergarten is located at Hilltop. The students have Physical Education and Art classes each week. A unique feature of Hilltop School is our use of a community-building program called Responsive Classroom. All 15 classes have a daily morning meeting where students gather to greet one another, share news, and warm up for the day ahead. The Responsive Classroom offers a way for teachers to emphasize the social, emotional and academic growth of all students in a strong, safe, school setting. 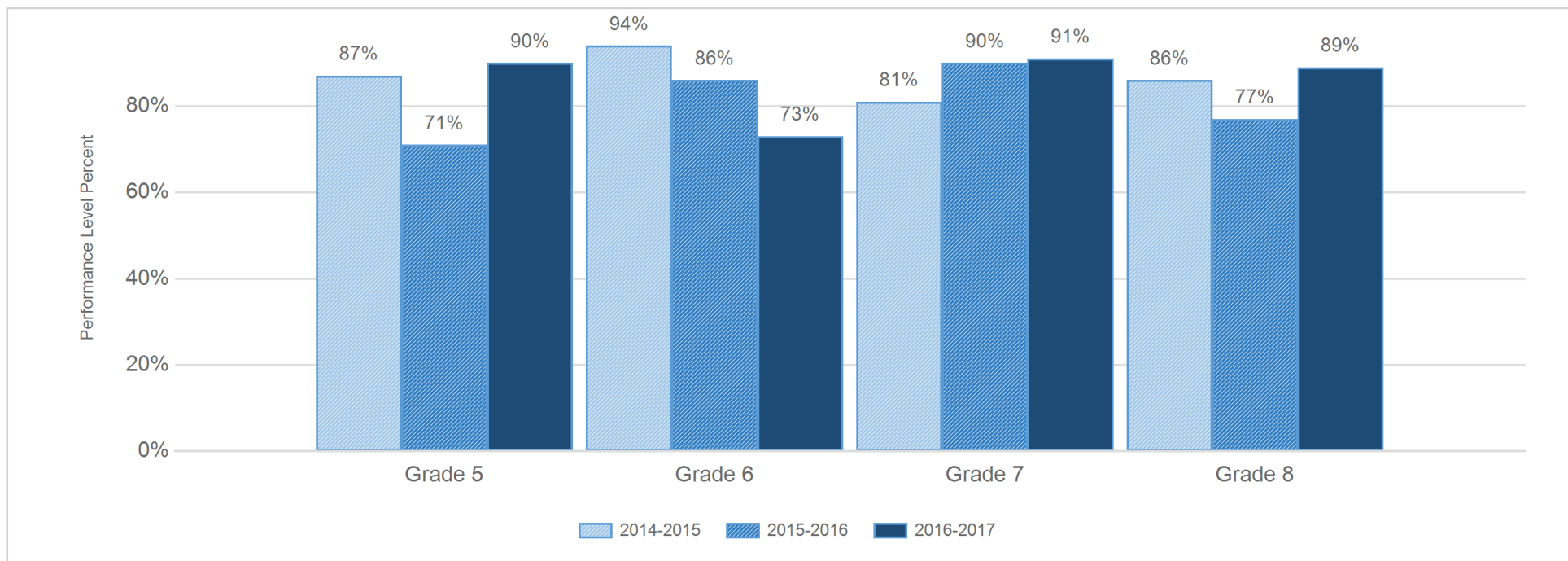

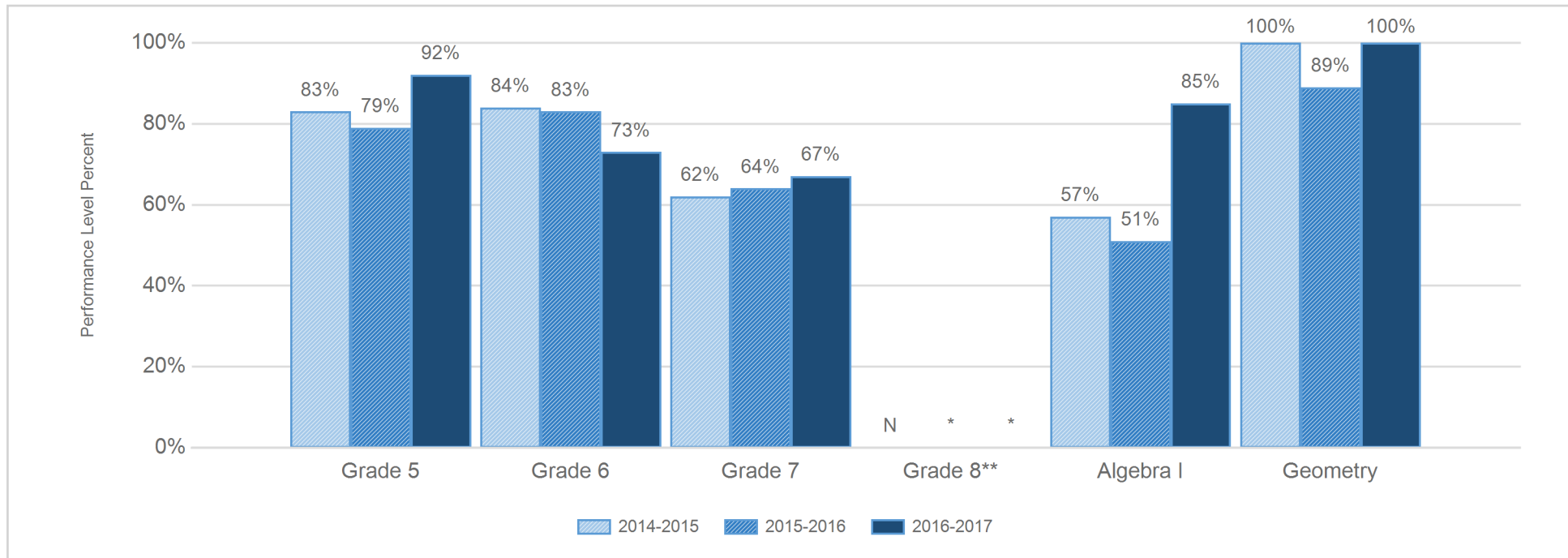

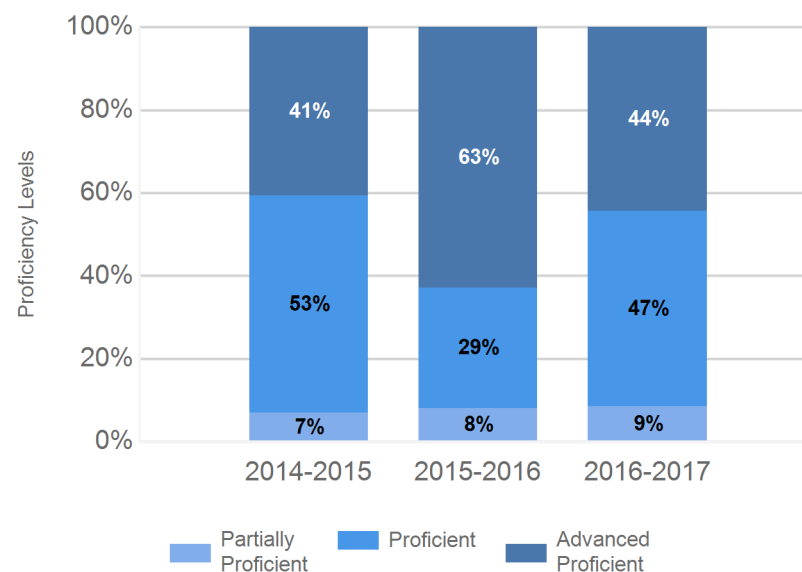

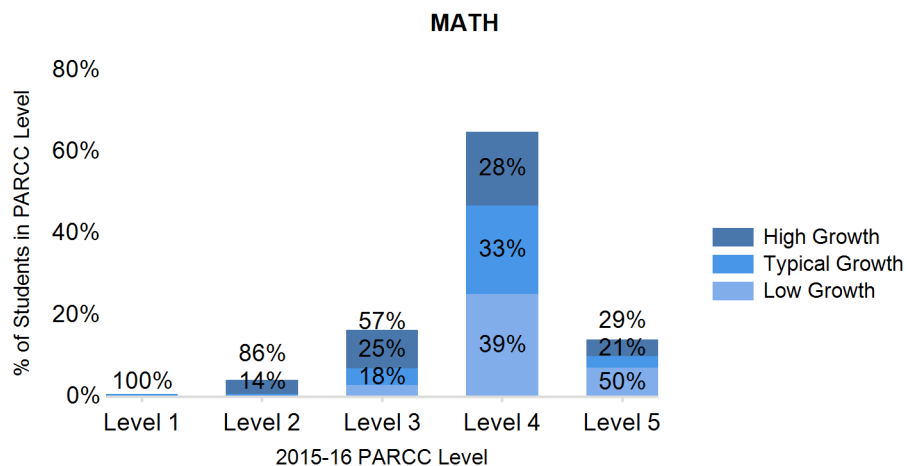

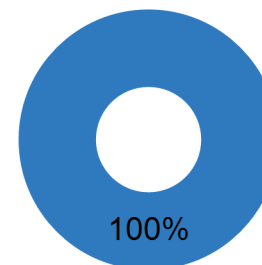

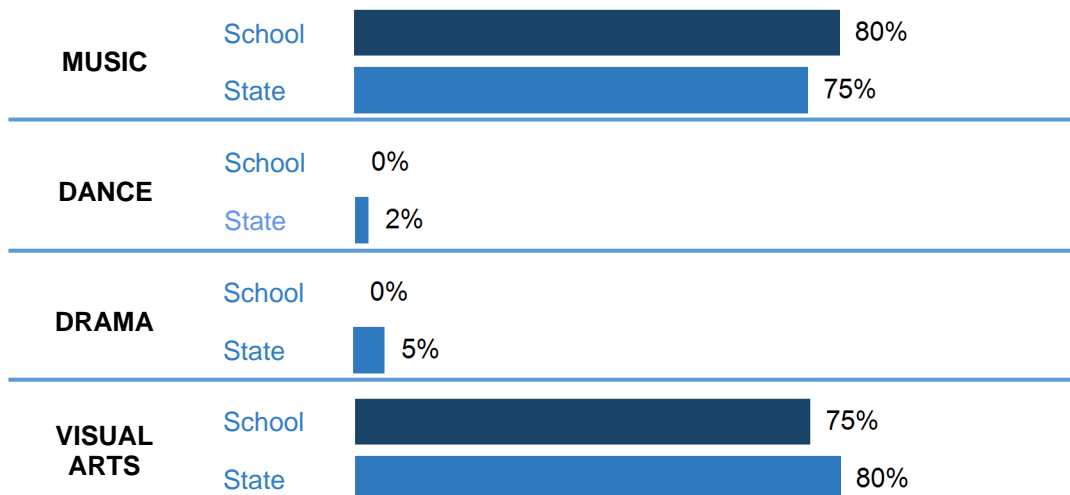

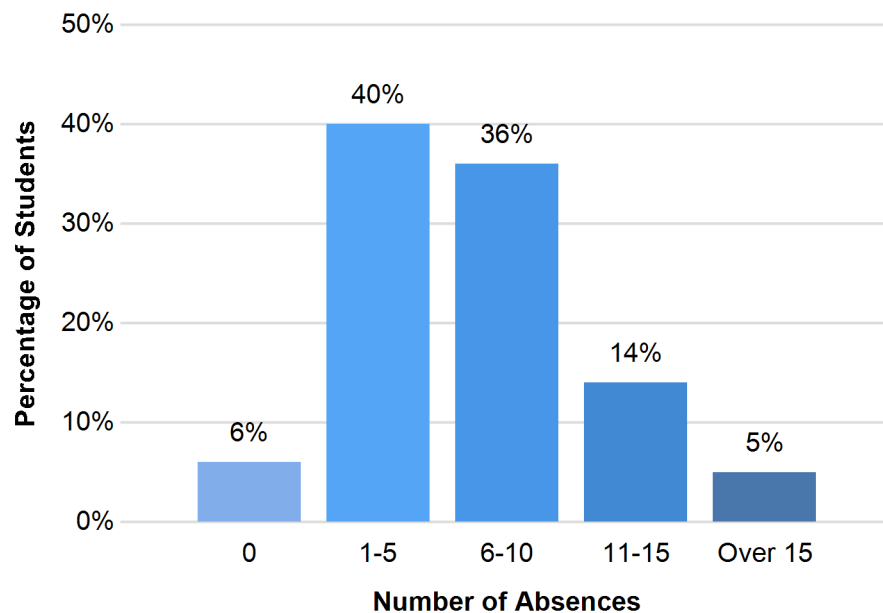

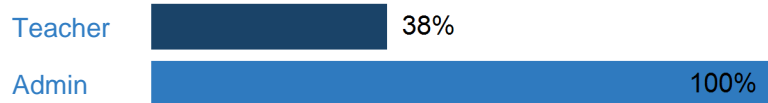

Mountain View Middle School implements a teaming structure, a middle-level best practice. Students at each grade level share the same Language Arts, Social Studies, Science, and Mathematics teachers. Students follow a 7 block schedule, which contains 6- 52 minute Core and Related Arts courses. In addition, all students participate in an “EEE” block, which provides opportunities for extension and enrichment of the core curricula.
