New Jersey's nonfarm wage and salary employment slipped on a seasonally adjusted basis by 1,000 from February to a March level of 3,246,600. This small employment decline came as no surprise to Department analysts, who expected a slight pause from the galloping upturns of previous months.

Analysts noted that layoffs were comparatively few, and there was continued expansion in retail trade and other service-producing industries. The seasonally adjusted decline was due primarily to seasonal hiring that fell short of expectations in construction and to the closing of the Owens-Illinois glassworks in Bridgeton, which furloughed 600 employees in February after the survey week. There were also about 800 more workers idled by strikes than a month earlier.

Manufacturing employment dropped by 1,700 jobs to a seasonally adjusted level of 729,700 in March, primarily reflecting the glassworks closing and a strike in the chemical industry.

Employment in nonmanufacturing rose by 700 on a seasonally adjusted basis to 2,516,900 in March. Wholesale and retail trade rose by 1,800 jobs. Service employment, up by 900 from February, hit a record high seasonally adjusted level of 707,600 in March.

The largest nonfactory employment decline was recorded in construction, where hiring fell short of seasonal expectations by 2,200 jobs. However analysts noted that, in spite of the decrease, the construction sector's level of employment remained at a near record high due to the healthy increases which occurred in January and February.

After seasonal adjustment, the average factory workweek contracted sharply by 30 minutes to 41.1 hours in March from 41.6 hours in February, because of reduced overtime.

Department analysts also noted that the originally reported February workweek data were revised downward from 41.9 hours to 41.6 hours, based on more complete employer response.

The Department of Labor survey also revealed that the average production worker in New Jersey's manufacturing industries earned \$387.28 during the March survey week, \$3.24 less than in February, reflecting reduced overtime. However, the average weekly earnings were \$17.01, or approximately five percent, more than for the same period last year.

The 13-month tables found on pages 6-16 contain February data. The March tables were unavailable at the time of publication.



Labor Area Comments (Not Seasonally Adjusted)

The employment increases which had been occurring during recent months in most areas, lessened from February to March as only four of New Jersey's ten major labor areas recorded increases that were as large as seasonally expected. Five areas recorded increases that were less than anticipated, and one area registered a contra-seasonal decline. The largest over-the-month gain occurred in the Newark Labor Market Area, which increased by 5,800, due mainly to upturns in the nonmanufacturing sector. The Vineland-Millville-Bridgeton Labor Area recorded the only decrease over the month, down by 500, due primarily to the closing of a major glassworks company in Bridgeton.

TECHNICAL NOTES

Nonfarm Wage and Salary Employment

Employment data refer to persons on establishment payrolls who received pay for any part of the pay period which includes the 12th of the month. The data exclude proprietors, the self-employed, unpaid family workers, farm workers, and domestic workers in households. Salaried officers of corporations are included. Government employment covers only civilian employees; federal military personnel are excluded.

Persons on an establishment payroll who are on paid sick leave (when pay is received directly from the firm), on paid holiday or paid vacation, or who work during any part of the pay period but are unemployed or on strike during the rest of the period, are counted as employed. Not counted as employed are persons who, during the pay period which includes the 12th, are laid off, on leave without pay or on strike for the entire period, or who are hired but do not work during the period.

Average Hours and Earnings

Hours and earnings data are derived from reports of payroll and man-hours for production and related workers in manufacturing. When the reported pay period exceeds one week, the payroll and man-hour figures are reduced to a weekly basis.

Average hourly earnings for manufacturing are on a "gross" basis, reflecting not only changes in basic hourly rates, but also such variable factors as premium pay for overtime and shift work, and changes in output of workers paid on an incentive plan. Excluded from average earnings are irregular bonuses, retroactive items, payments of various welfare benefits, and payroll taxes paid by employers.
