



Governor Murphy Signs Executive Order No. 414 Terminating 51 Inactive Advisory Entities

TRENTON – Governor Murphy today signed Executive Order No. 414, terminating a number of inactive, expired, defunct, or otherwise no longer needed advisory councils, commissions, committees, task forces, and other similar bodies.
