


Program Project Priority List ("SFY2023-2nd Amended Transportation Bank PPL")

The New Jersey Infrastructure Bank (the "I-Bank") and the New Jersey Department of Transportation (the "NJDOT") are pleased to present the **SFY2023** 2nd Amended Transportation Financing Program Project Priority List (the "PPL") to the New Jersey State Legislature pursuant to the New Jersey Infrastructure Trust Act N.J.S.A. 58:11 B-1 et seq. ("the Act"). The New Jersey Transportation Infrastructure Financing Program (the "Transportation Bank") is a joint financing program between the I-Bank and the NJDOT. The PPL is a compilation of all eligible projects for which an application has been submitted to the Transportation Bank for financing on or before September 30, 2022, and which have not already received long-term financing. The Act authorizes the I-Bank to amend the PPL four times during the State fiscal year. The PPL for SFY2023 was originally submitted to the Legislature in January 2022, in preparation for the upcoming program year. This submission serves as the second such amendment.

The Act established the Transportation Bank to make low interest loans for local transportation infrastructure projects with a mission of reducing the cost of financing critical transportation projects for New Jersey counties and municipalities.

The SFY2023 <u>2nd</u> Amended Transportation Bank PPL, set forth in Appendix A, consists of **28 projects** with an estimated value of **\$121.8 million**. Of these 28 projects, 20 had been allocated funds in prior quarters totaling \$88.8 million and are currently undergoing engineering design or construction activities, and five (5) projects totaling \$29.3 million have yet to be allocated. The new funding allocations for this 2nd quarter of SFY2023 are limited to projects that demonstrate a high likelihood of awarding construction within 12 months, on or before September 30, 2023 (or September 30, 2024 for bridge assets). Three (3) projects met this requirement and received funding allocations in early October 2022 with an estimated value of \$3.8 million for a total allocated amount of **\$92.5 million**.




