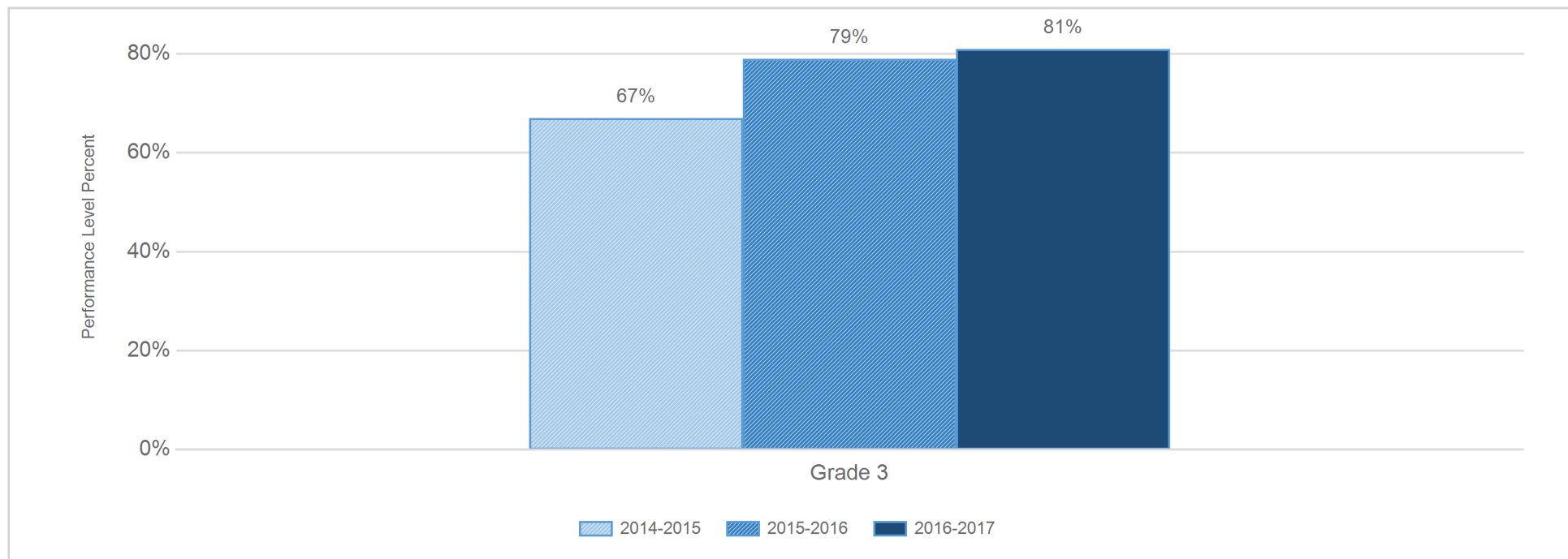

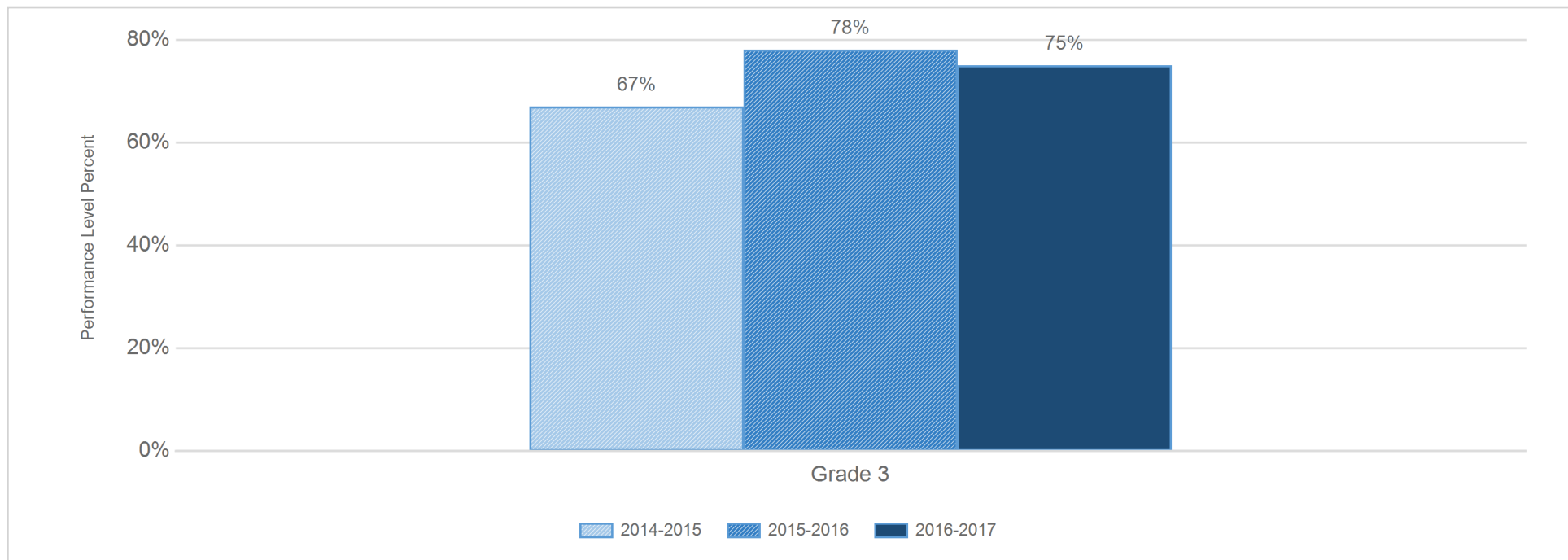

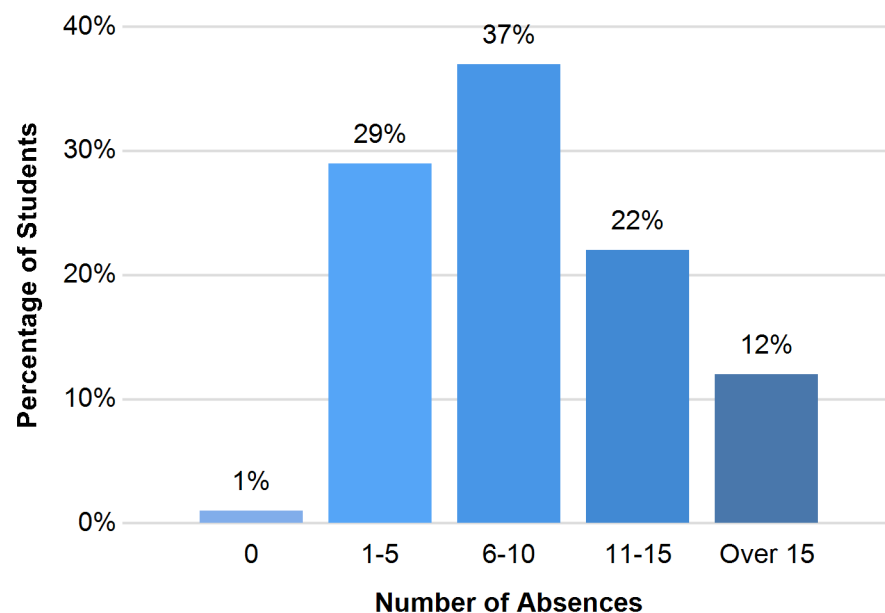

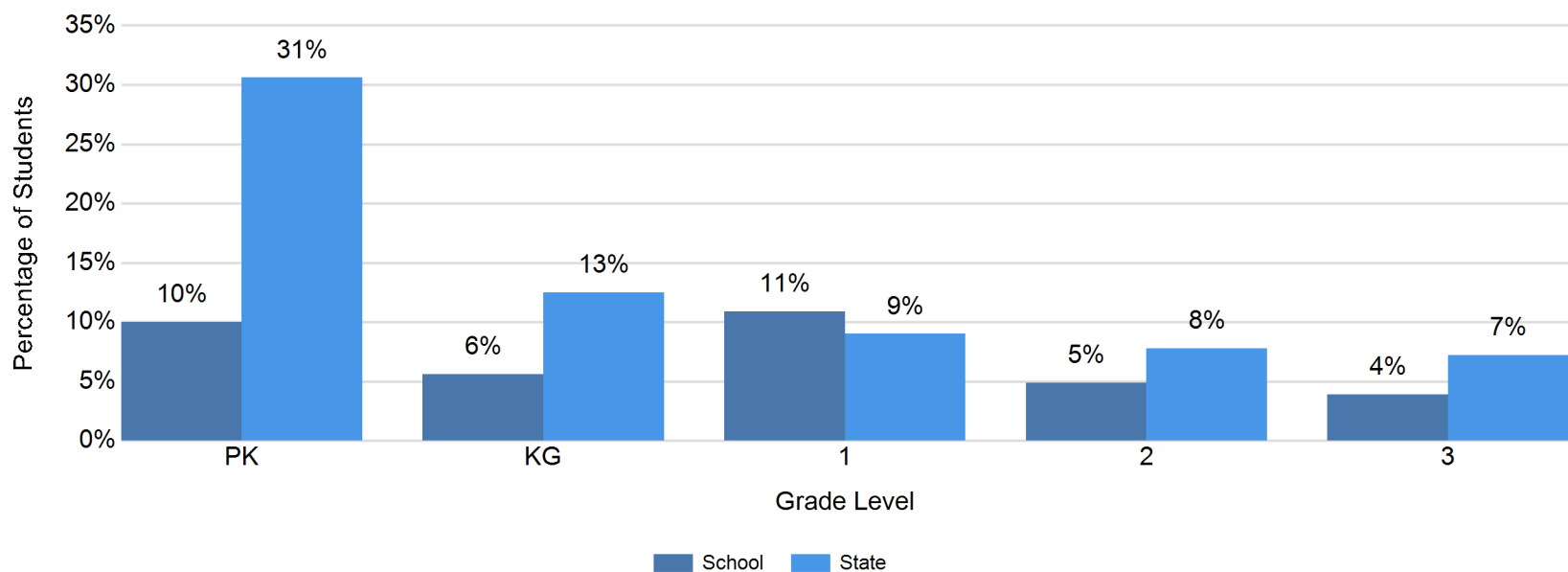
### Days Absent

### Technology Readiness

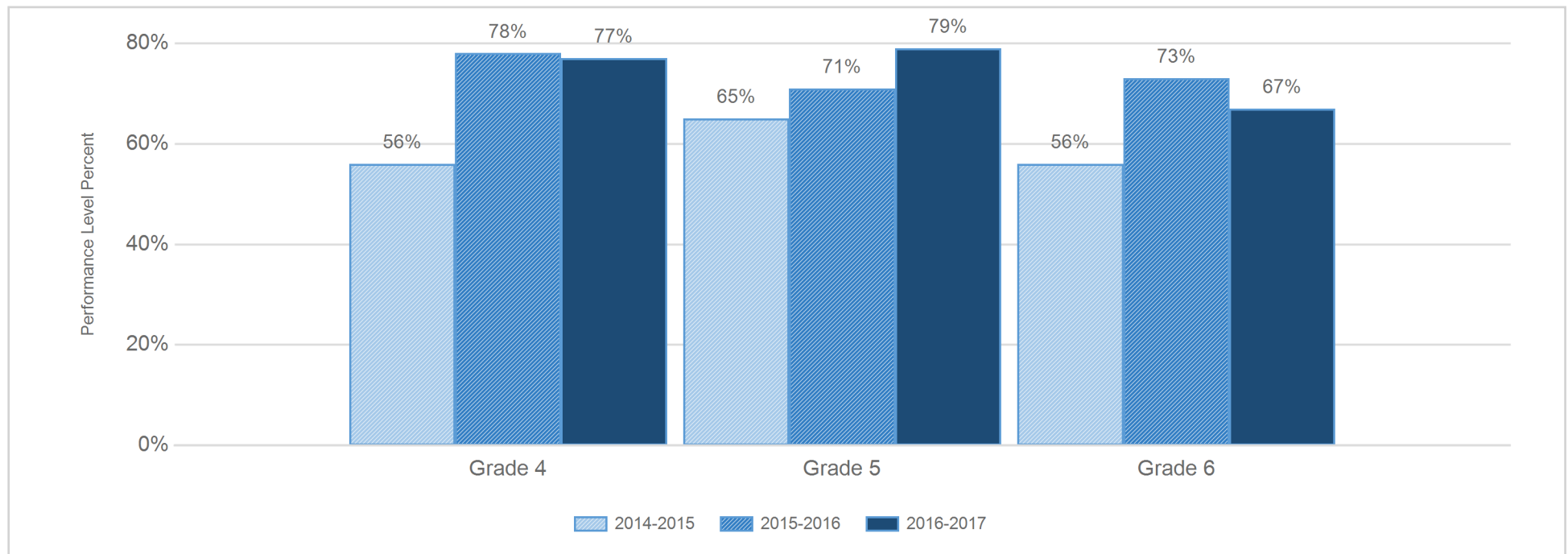

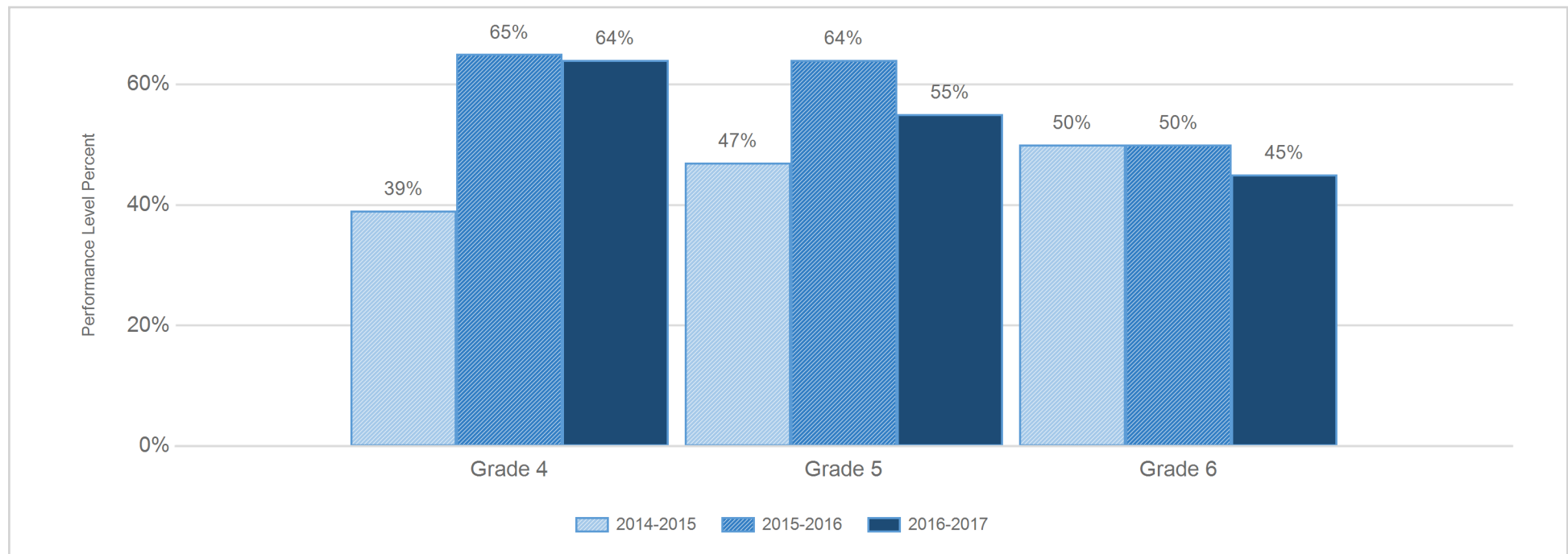

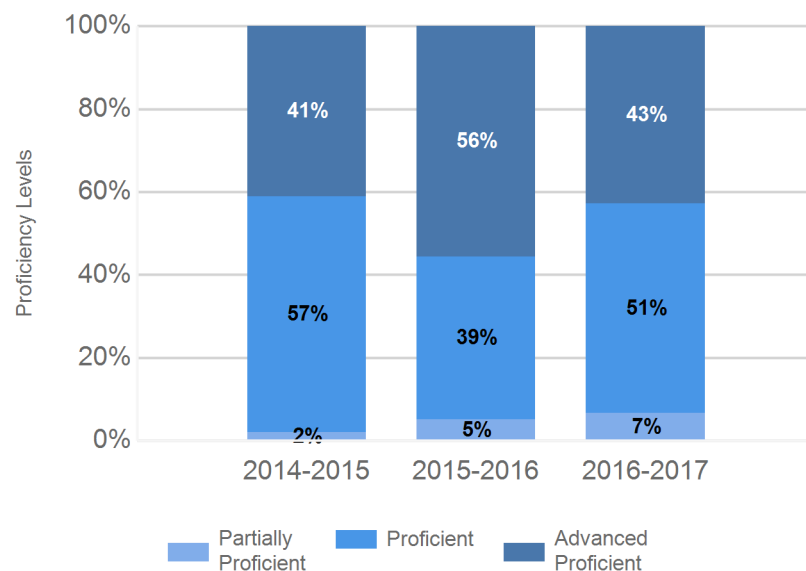

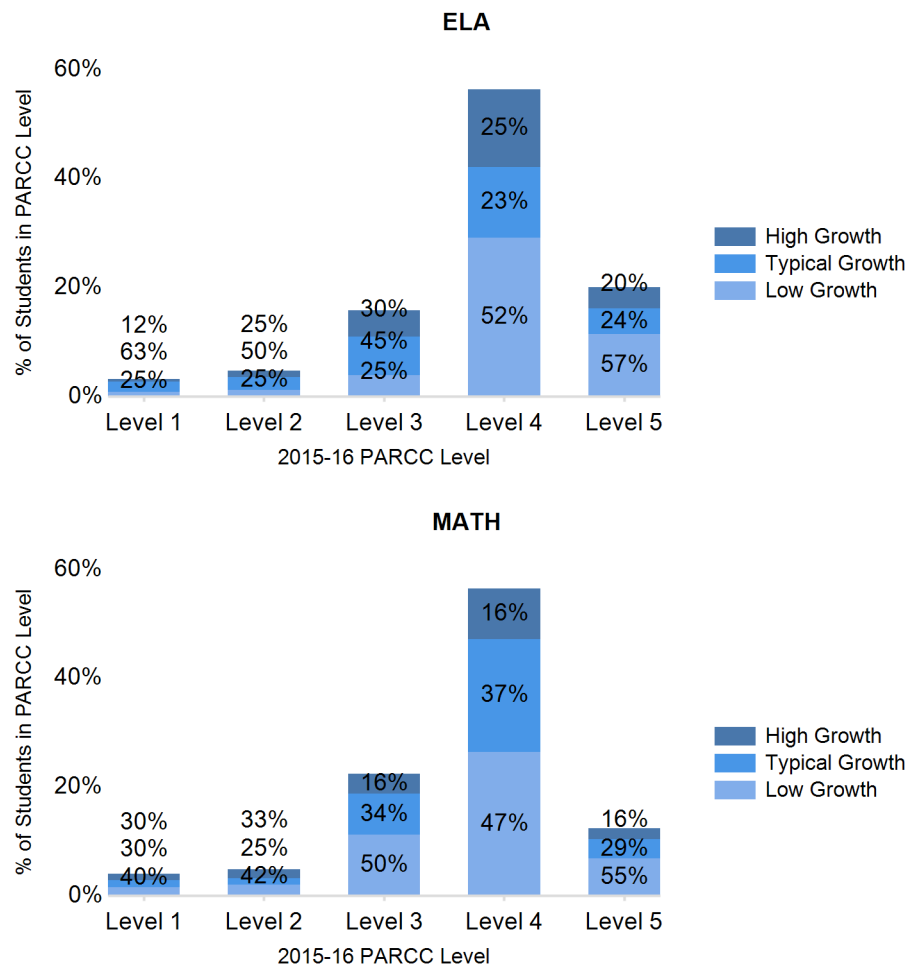

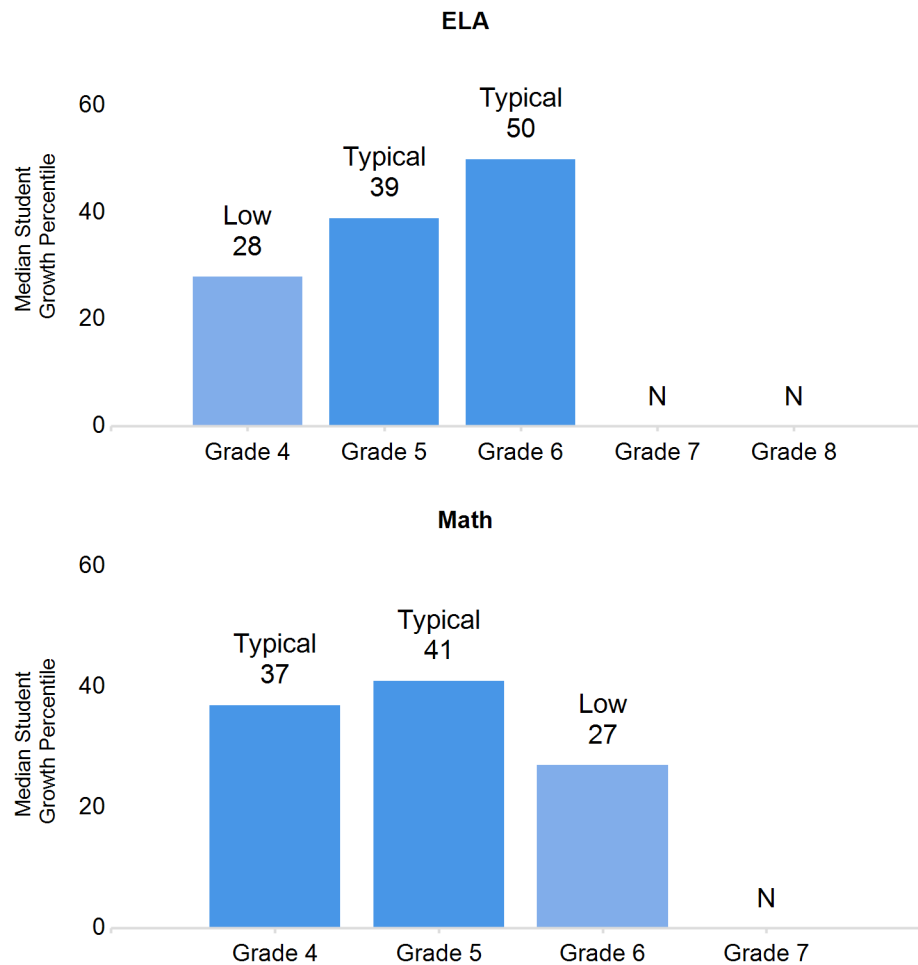

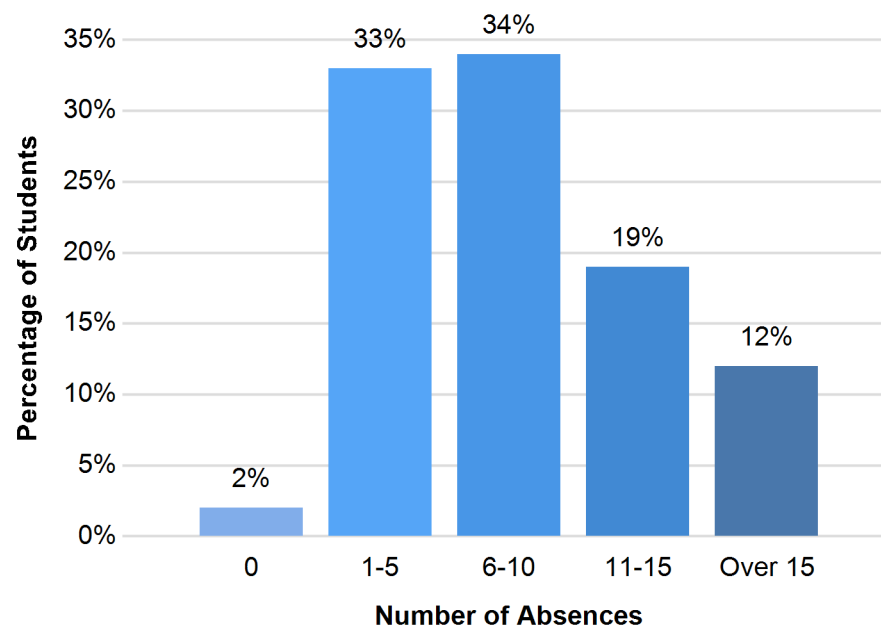

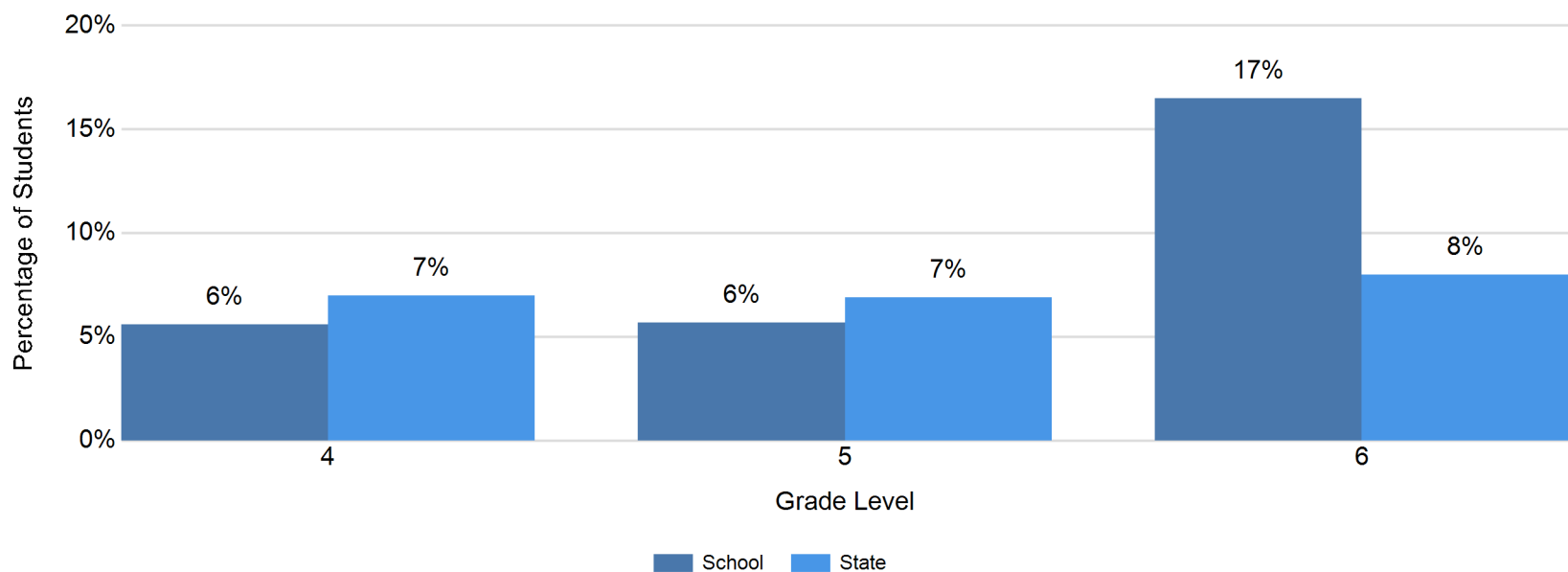
### Days Absent
