NJNG supports Boy Scouts Camporee at West Point

There were approximately 6,000 scouts from across the United States and 400 volunteer West Point Cadets at the event. The annual Boy Scout Camporee was hosted by the West Point Scoutmasters' Council, a cadet organization comprised of former Boy Scouts and Girl Scouts who currently attend the academy, and was held at the banks of Lake Frederick.

Lunchtime lecture series: New Jersey and the politics of the Civil War

Noted historian to present lecture at the Trenton War Memorial

TRENTON – On Thursday, May 19, the National Guard Militia Museum of New Jersey's Trenton War Memorial Annex will host a noontime lecture by assistant curator Joseph G. Bilby, which will present untold and long-forgotten stories of New Jerseyans and how they coped with the Civil War and its memory.

"The arrival of the Civil War Sesquicentennial [150th anniversary of the conflict] provides Garden State residents with an excellent opportunity to learn more about our state's contribution to the Union war effort," said Bilby, the author or editor of 14 books on New Jersey's history. "Especially with regard to the politics of the day, there is a treasure trove of interesting people and stories that left their mark on our history."

Bilby will discuss, with slide illustrations, the stories of African-American communities in South Jersey that fought off slave catchers before the war.

In addition, he will tell the story of the "Hoboken Bounty Jumper Sting" in which the Jersey City mayor lost the city's money but won re-election anyway. And in homage to attention seekers both past and present, he will discuss Gen. Judson Kilpatrick's politically inspired "Great Reunion," one of the first postwar reenactments that more closely resembled a three ring circus.

Highlighting the long struggle for equality, Bilby will also offer a history of the 1961 New Jersey Civil War Centennial Commission's principled stand against racism.

"Most everyone remembers the Gettysburg Address, Sherman's March, and the Emancipation Proclamation," said 1st Lt. Vincent Solomeno, historian for the New Jersey National Guard and the museum's curator. "The goal of this lecture is to increase public awareness of the sometimes consequential, often times humorous, history of New Jersey politics in the Civil War era."

"New Jersey and the Politics of the Civil War" is the first of a



series of lunchtime lectures highlighting the people, places, and events that shaped New Jersey's Civil War experience. It will be held at 12 p.m. on Thursday, May 19, at the National Guard Militia Museum of New Jersey's Trenton War Memorial Annex. Attendees are encouraged to bring a lunch. Additional services for primary
Family Caregivers of eligible post9/11 Veterans and service members
include a stipend, mental health services, and access to

health care insurance, if they are not already entitled to

care or services under a health care plan. Comprehensive Caregiver training and medical support are other key components of this program.

Free state registry Web site available for NJ anglers



Attention saltwater anglers. There is a federal mandate that requires everyone 16 or older to register and carry with them a printed registration when fishing in New Jersey's saltwater.

Effective May 4, the New Jersey Department of Environmental Protection has launched the state's free web-based saltwater fishing registry, keeping recreational saltwater fishing in New Jersey a sport that anyone can enjoy without having to pay fees.

All saltwater anglers and forhire vessel operators will now be able to register through the no-fee State system rather than the fee-based federal system.

Those who fish from a for-hire party or charter fishing vessel

that is registered with the New Jersey Saltwater Recreational Registry Program are not required to file for an individual registration.

Everyone 16 or older must register and carry the printed registration with them when fishing. People who fish for shellfish such as crabs, clams or lobster are not required to register, though existing license or permit requirements may be required depending on the gear used.

Any person who fails to register with NJSRRP is subject to a penalty of \$300 to \$3,000 for a first offense and \$500 to \$5,000 for subsequent offenses.
