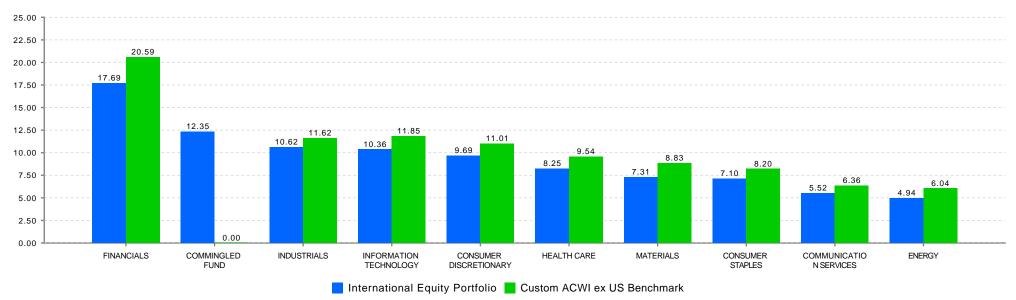

### Select Portfolio Sector Weightings Int'l Equity with Hedges Composite

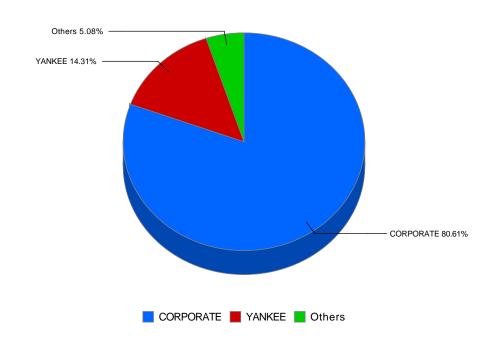

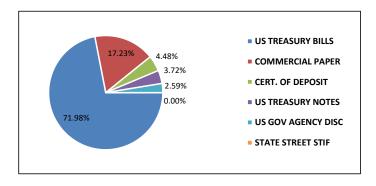
