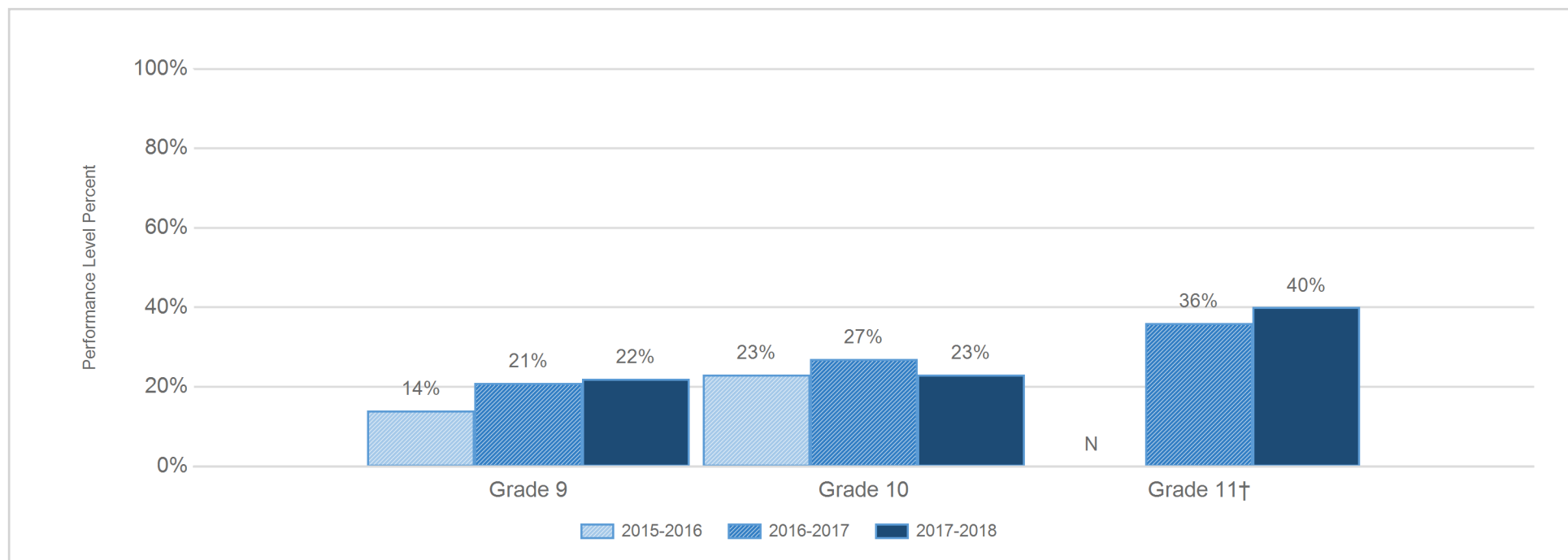

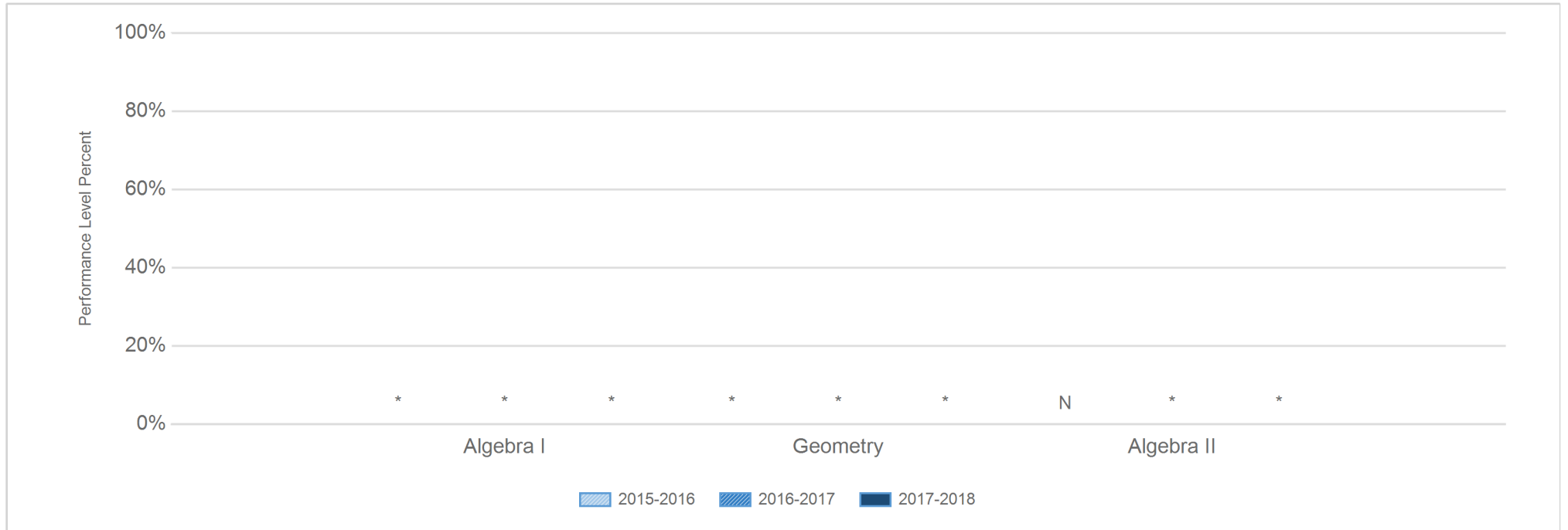

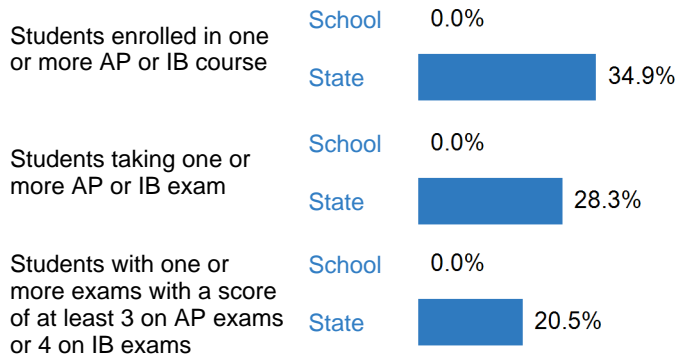

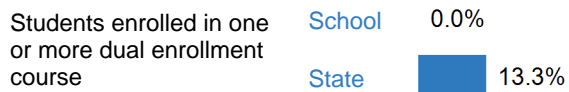

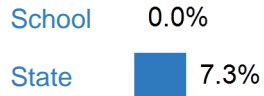

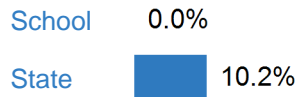

 (completed only one course in an approved CTE program)



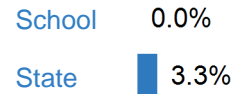

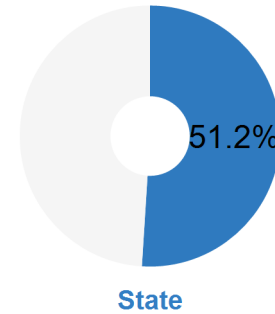

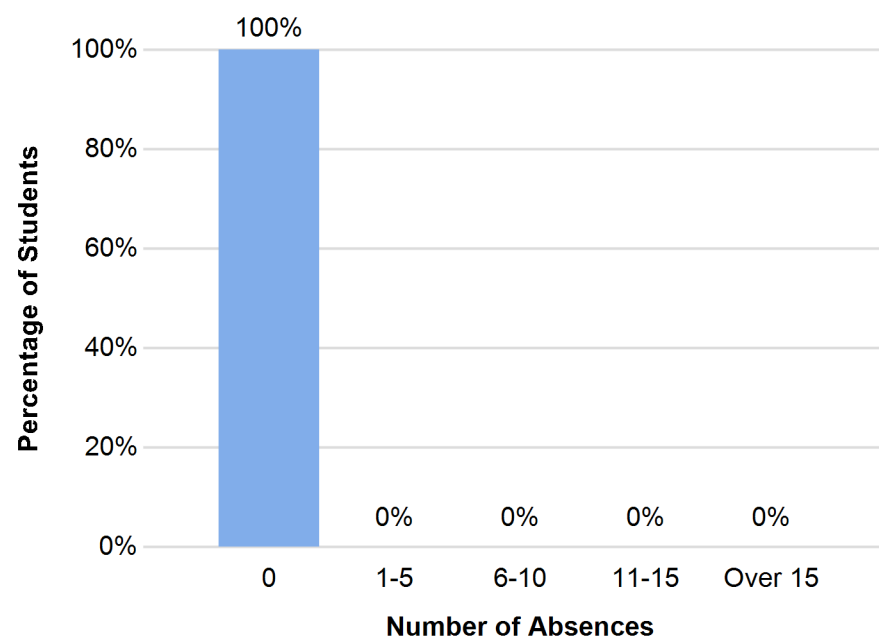

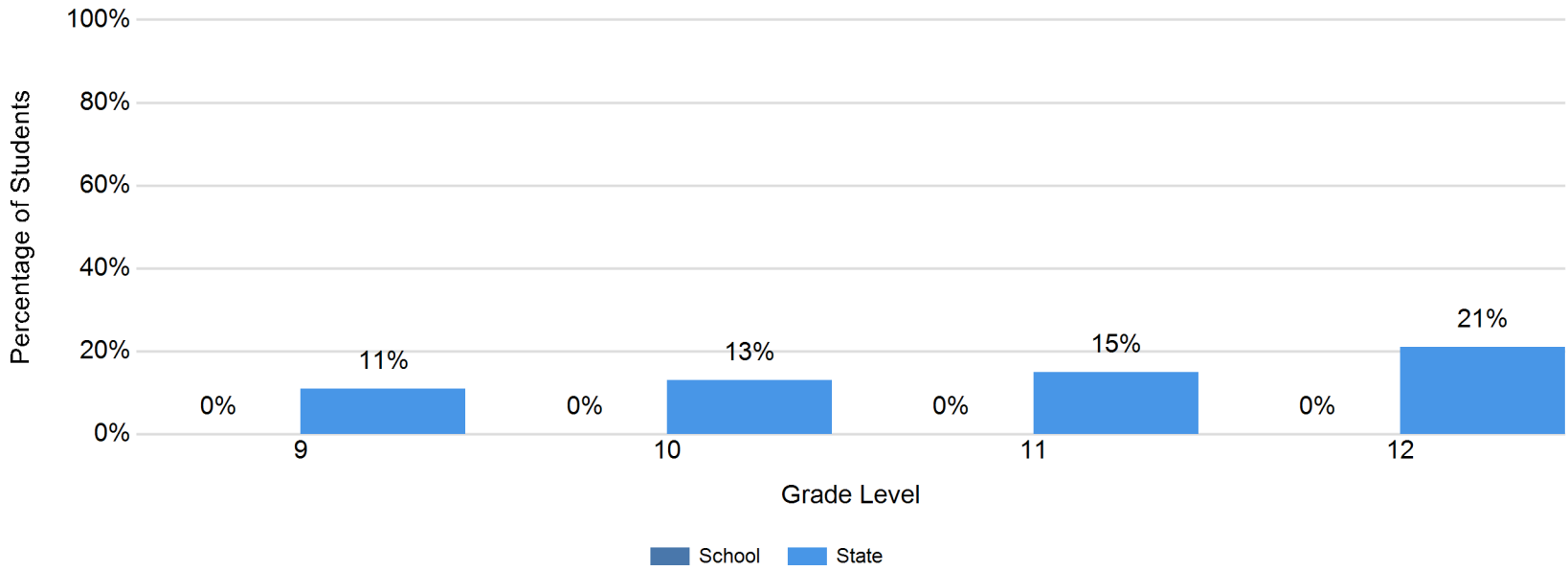
