#### **Governor's Council on Alcoholism and Drug Abuse**

**July 19, 2022**

## **Executive Director's Report**

Executive Director Celina Levy thanked the Council members once again for attaining quorum consistently since January. She also expressed her gratitude to the GCADA Review Team, County and Municipal Coordinators and the GCADA Alliance Unit for their hard work.

Ms. Levy shared that new members, John Armato and Eileen Fishman, had been appointed to the Council in June, as well as Moira Nelson who had been confirmed in March. She asked the new members to share a bit about their background as well as what made them become interested in the work of the Governor's Council.

Ms. Levy also shared that she and Deputy Director Rebecca Alfaro continue to work with the Governor's office on options for alternative funding streams and long-term sustainability for the program and also continue to be engaged in collaborative planning for the state's harm reduction efforts. Ms. Levy shared information about the opioid settlement fund that she had received from the Governor's office. Ms. Alfaro and Director of Prevention and Planning, Sara Thode, have been in conversation with the county directors and coordinators about the settlement fund process and have received input about the need for the Alliance program to be involved. Ms. Levy will continue to keep the Council updated as things move forward.

Director of Prevention and Planning, Sara Thode informed the Council that the Municipal Alliance Grant System (MAGS) is expected to go live for the FY24 grant year and that the Alliances would be trained on how to use the new online grant management system and FY23 will be the last year for paper plan submissions.

Ms. Levy thanked the Council members for their input and support, the County Coordinators and Alliances for their good work despite the continued challenges and GCADA staff for their strong work ethic, and to Neil Van Ess for his ongoing leadership.
