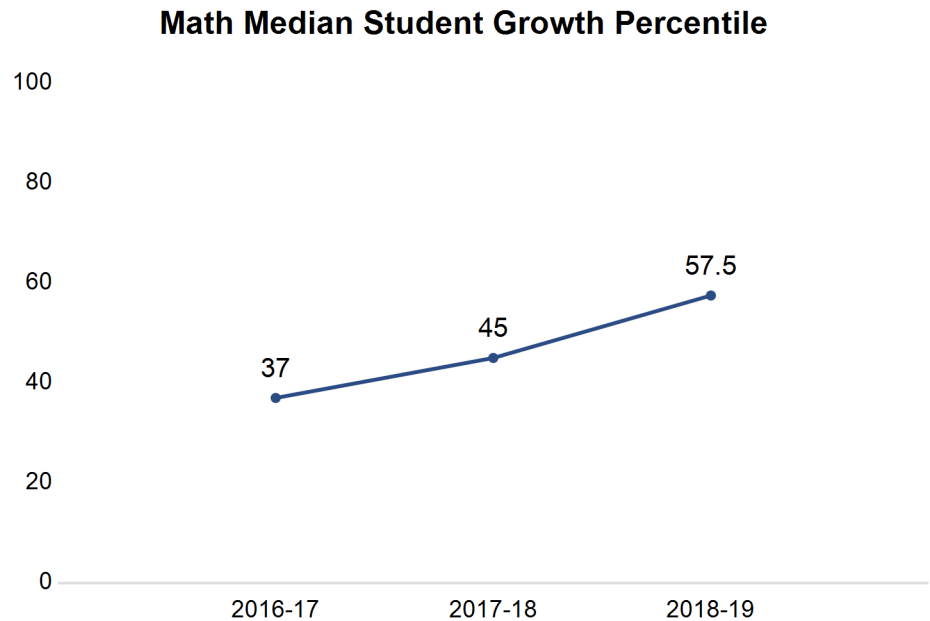
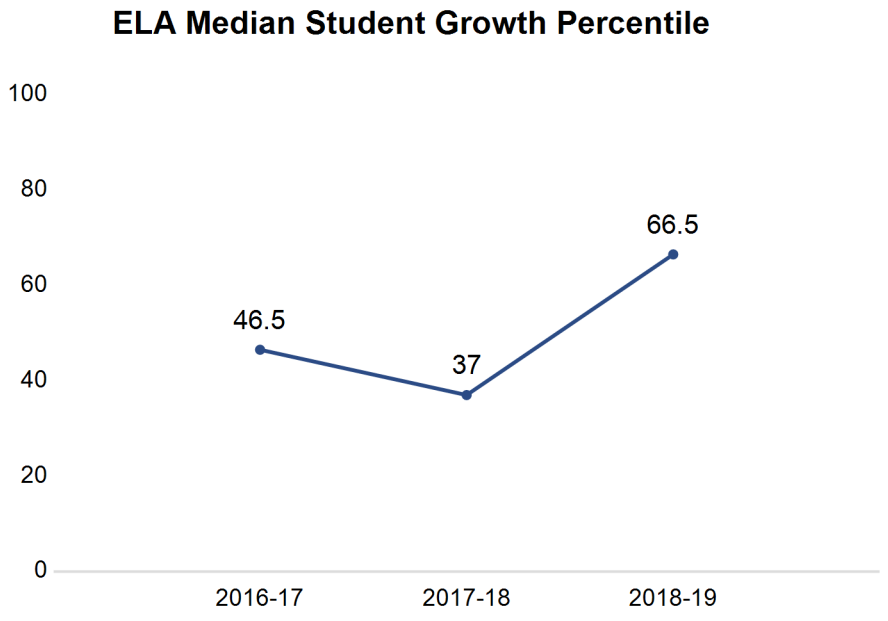

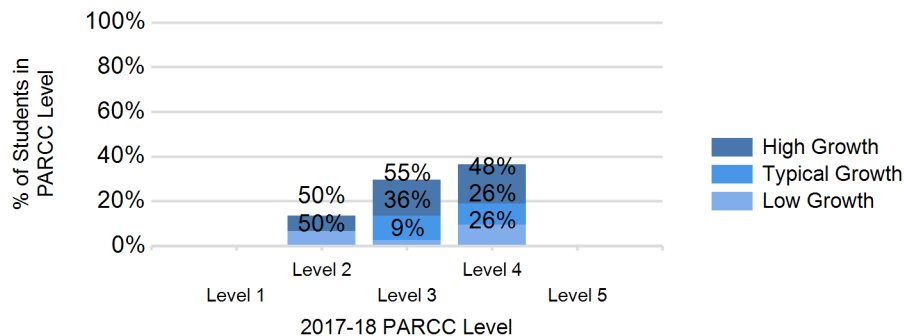

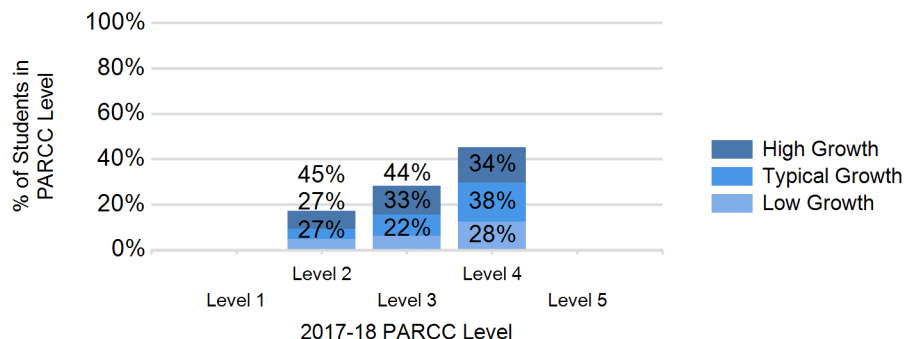
Student Growth by Performance Level

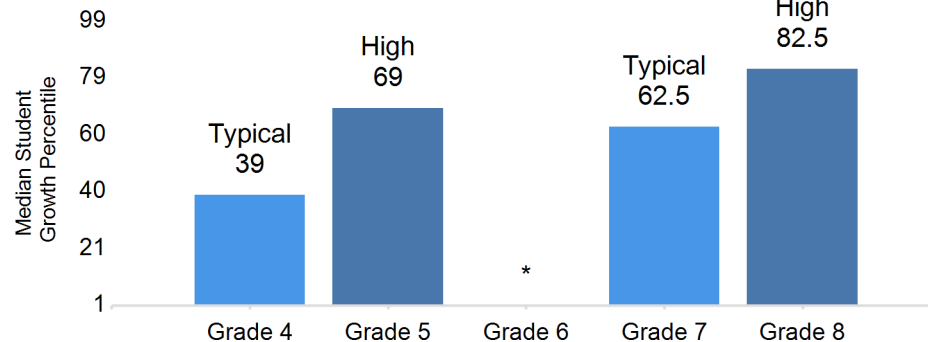

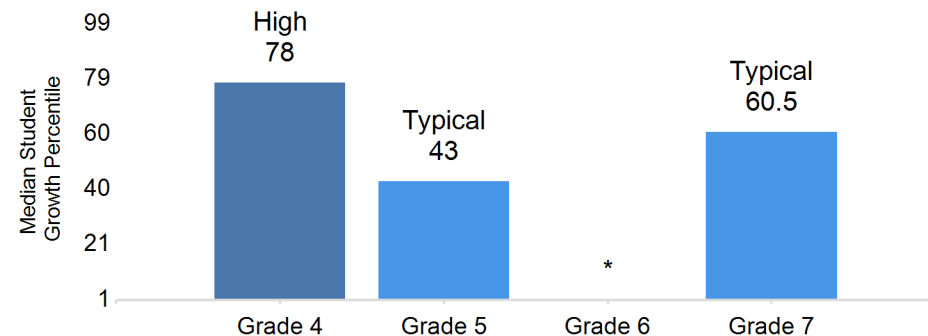
Student Growth by Grade

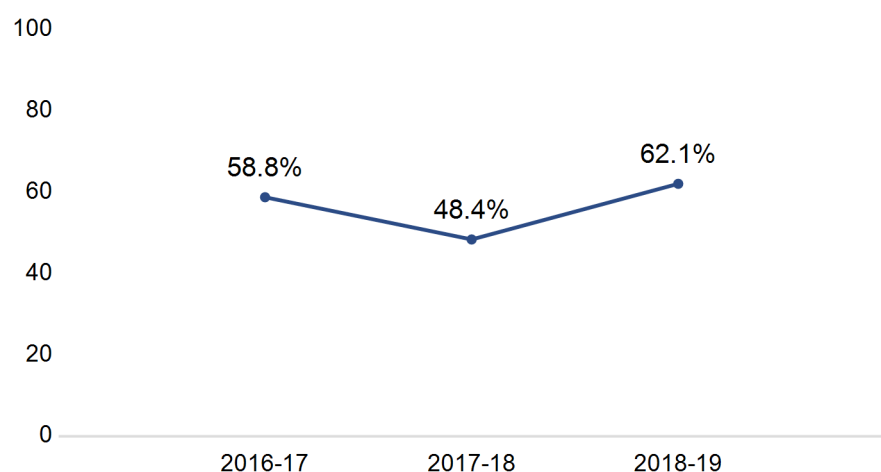

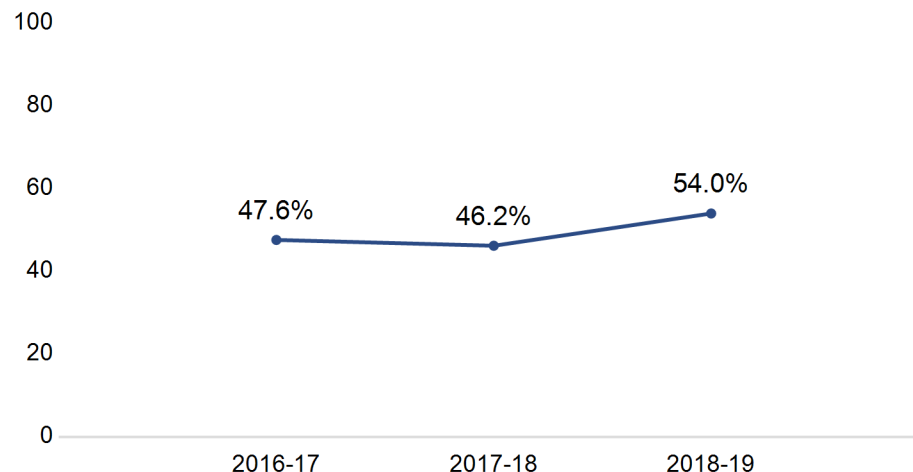
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the statewide assessment (NJSLA for 2018-19 and PARCC for 2016-17 and 2017-18) and the DLM alternate assessment. The Proficiency Rate for Federal Accountability measures the percentage of students that met or exceeded expectations on the assessments (NJSLA/PARCC or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA/PARCC results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. The table below provides participation rates, proficiency rates, annual targets and status in meeting the targets, and statewide proficiency rates.

English Language Arts Assessment - Participation and Performance

This table shows performance on statewide assessments for English Language Arts both overall and by student group. It includes the results of students taking both the NJSLA and DLM assessments. NJSLA results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. A student is considered to have met or exceeded expectations if he/she scores at Level 4 or 5 on the NJSLA assessment or at Level 3 or 4 on the DLM assessment.

This table shows both the percentage of students that met or exceeded expectations and a proficiency rate used for federal accountability. The proficiency rate for federal accountability will be lower if the participation rate is below 95%. This table also shows progress towards meeting the state's long term goal of 80% proficiency by 2030. Annual targets are specific to each subgroup, school, and district and represent the expected proficiency needed to stay on track to meet the state's long term goal. Student groups where the annual target fields are grayed out are not required to meet annual targets under ESSA accountability. 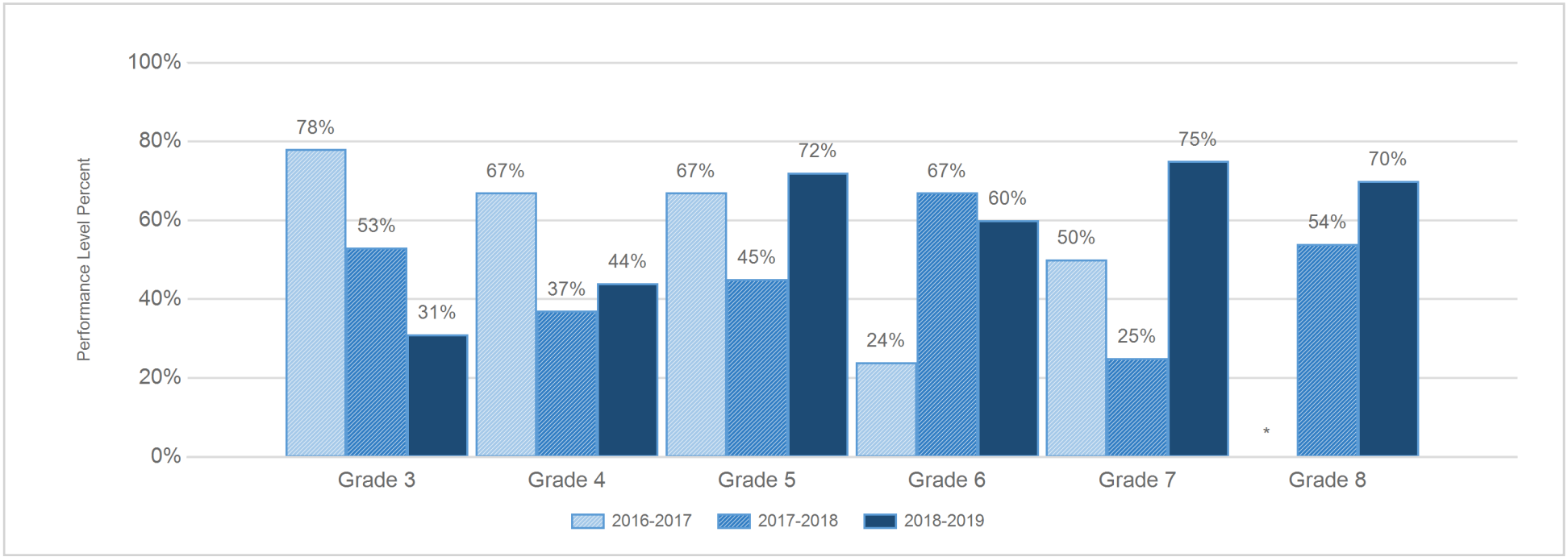

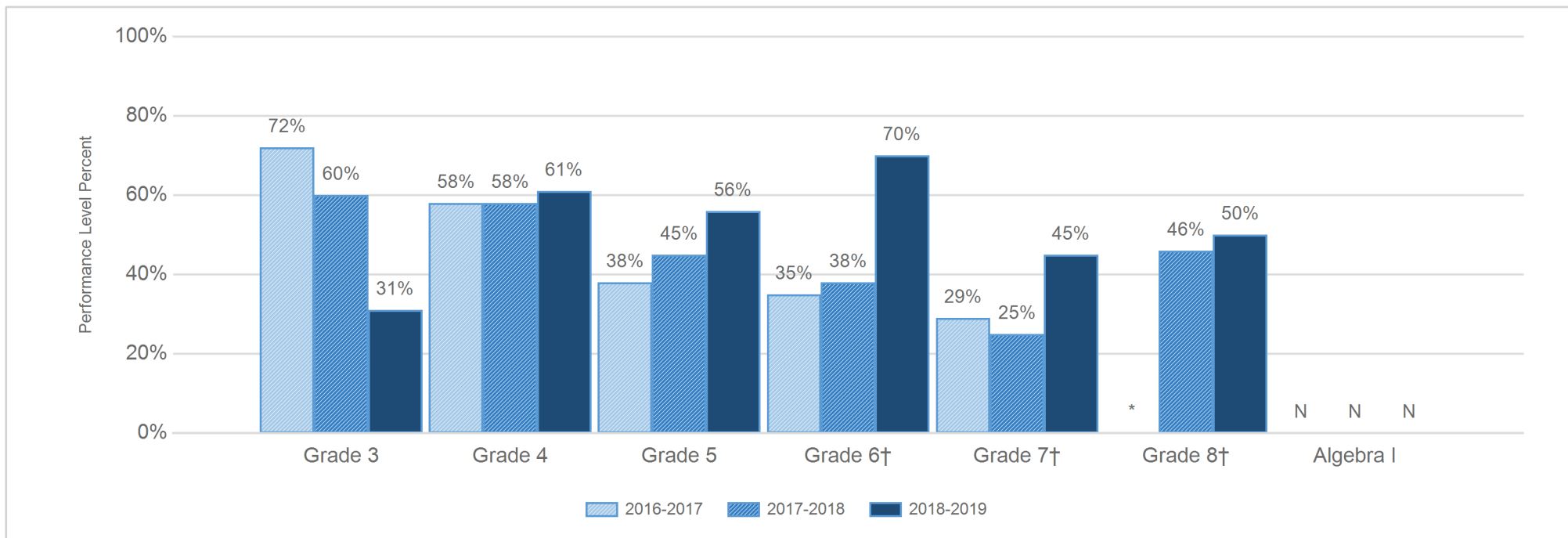

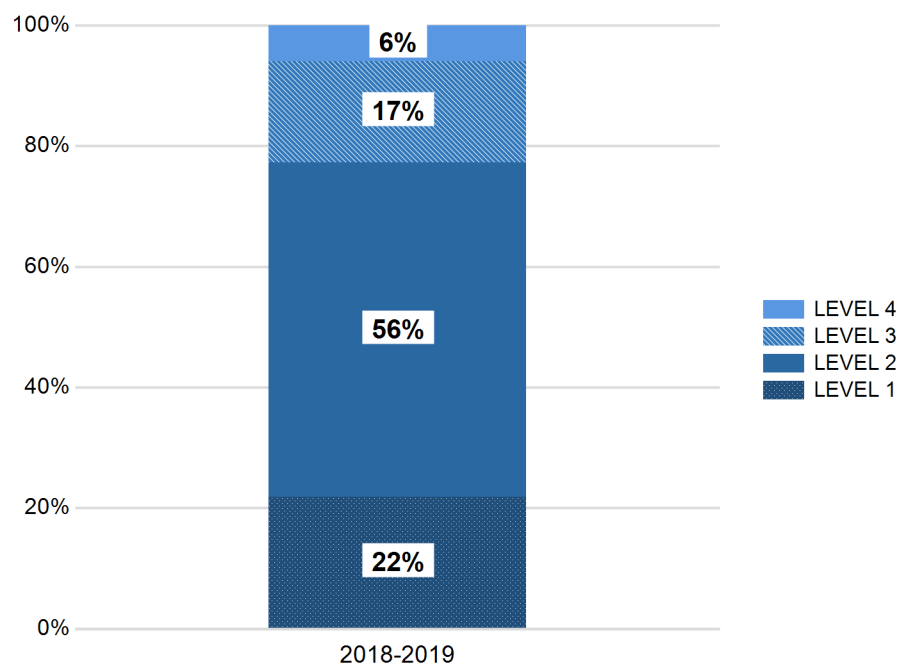

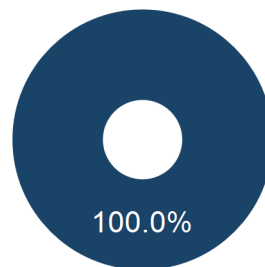

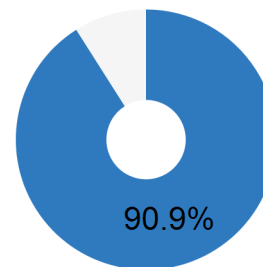

Students enrolled in one or more **visual and performing arts** classes

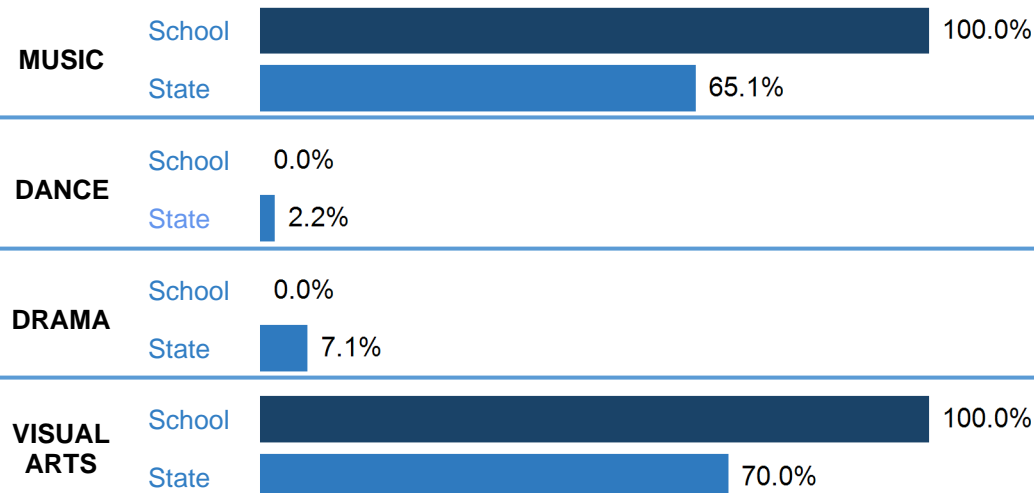

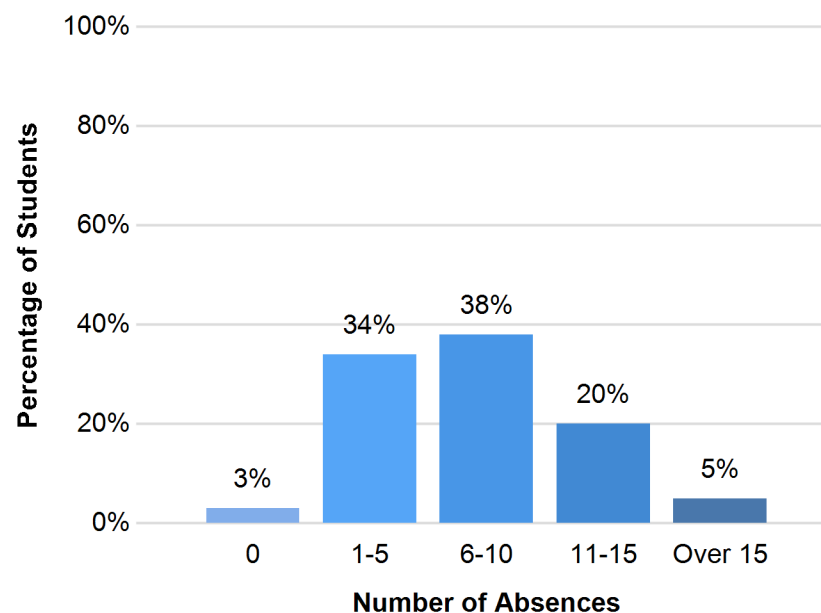

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.





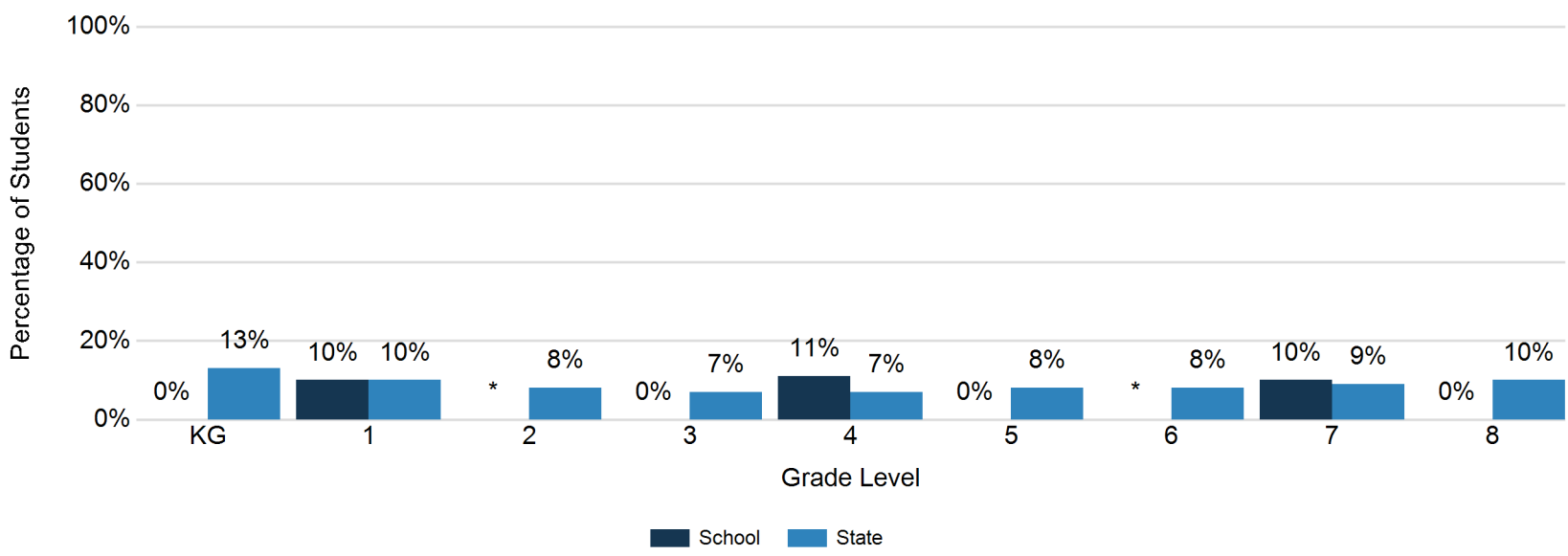

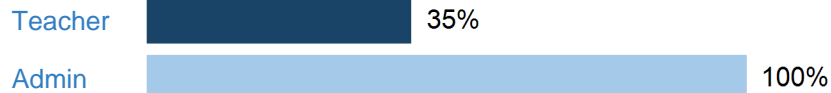

Other Information

Elsinboro Township School is an Interdistrict School Choice district located in a rural community nestled in the southwestern corner of Salem County. The community consists of farmland, homes and riverfront estates along the Delaware River. Elsinboro Township School has a structured Gifted and Talented program. The program was designed to provide challenging and rigorous curriculum for gifted children with strong academic skills. The framework of the program makes provisions for an ongoing K-8 identification process for gifted and talented students that include multiple criteria for admission. Elsinboro implements MAP, or Measure of Academic Progress, testing. MAP is a computerized adaptive test which helps teachers, parents, and administration improve learning for students and make informed decisions to promote a child's academic growth. MAP tests are given three times per year. Technology and the tools of technology are familiar sights in every classroom. Students now use technology as an everyday resource. In grades 3-8, Google Chromebooks are issued to every student for use in all their classes. iPads are utilized in the lower grades. Elsinboro Township School has SMART Boards for all classrooms. The SMART Board allows a more interactive learning environment. A combination of traditional whiteboards and computer technology, the boards will enable our teachers to project digital images from a computer to the board, where they can be manipulated and annotated by both teacher and student. Attendance rates of students and staff are above the 95th percentile. We feel this is important because studies have shown that the continuity of instruction is the key to student success and that there is a direct correlation between attendance and academic success. Grades K-3 are self-contained and grades 4-8 are departmentalized. Physical education, Health, Art and Music are taught by our specialists.
