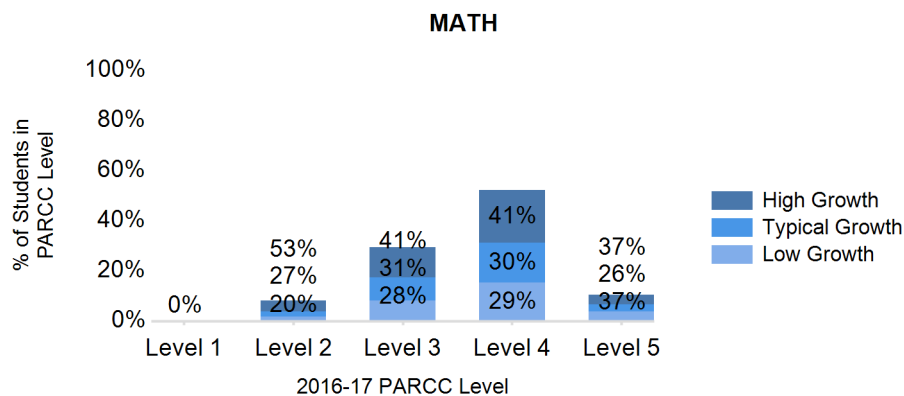
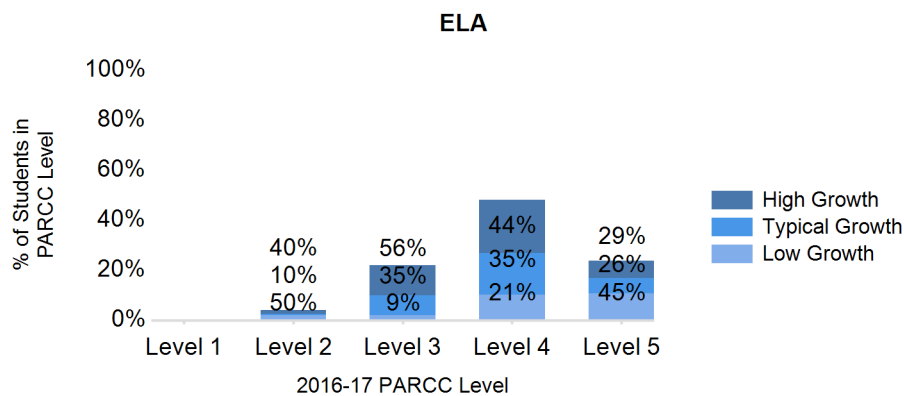

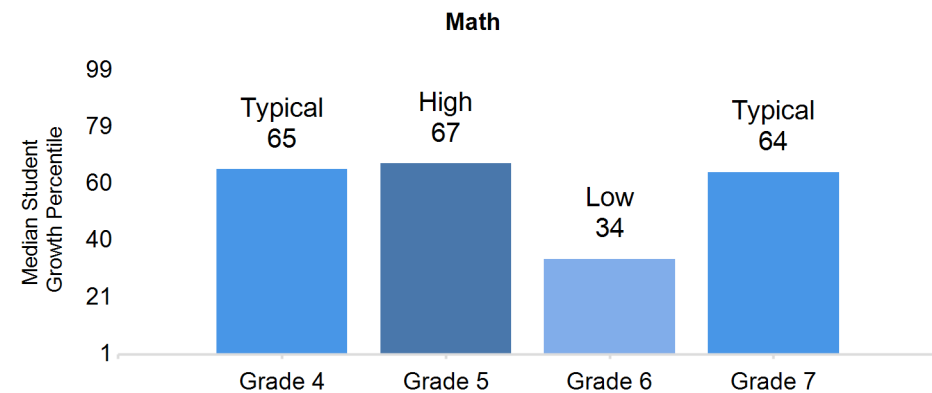
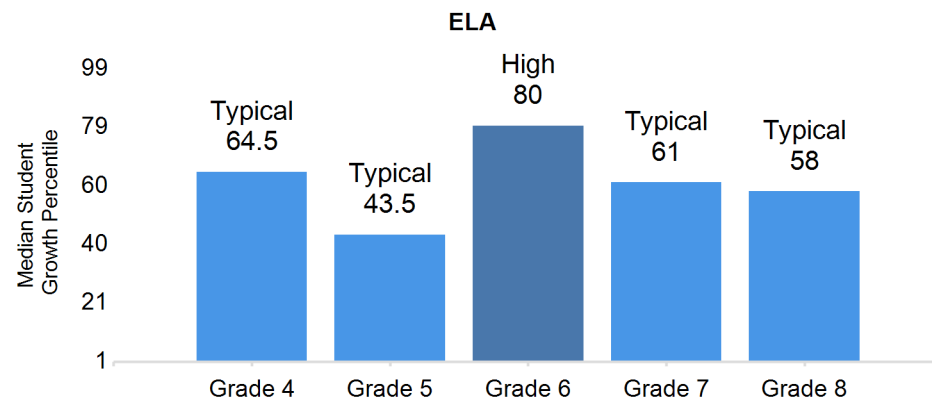
Student Growth by Performance Level

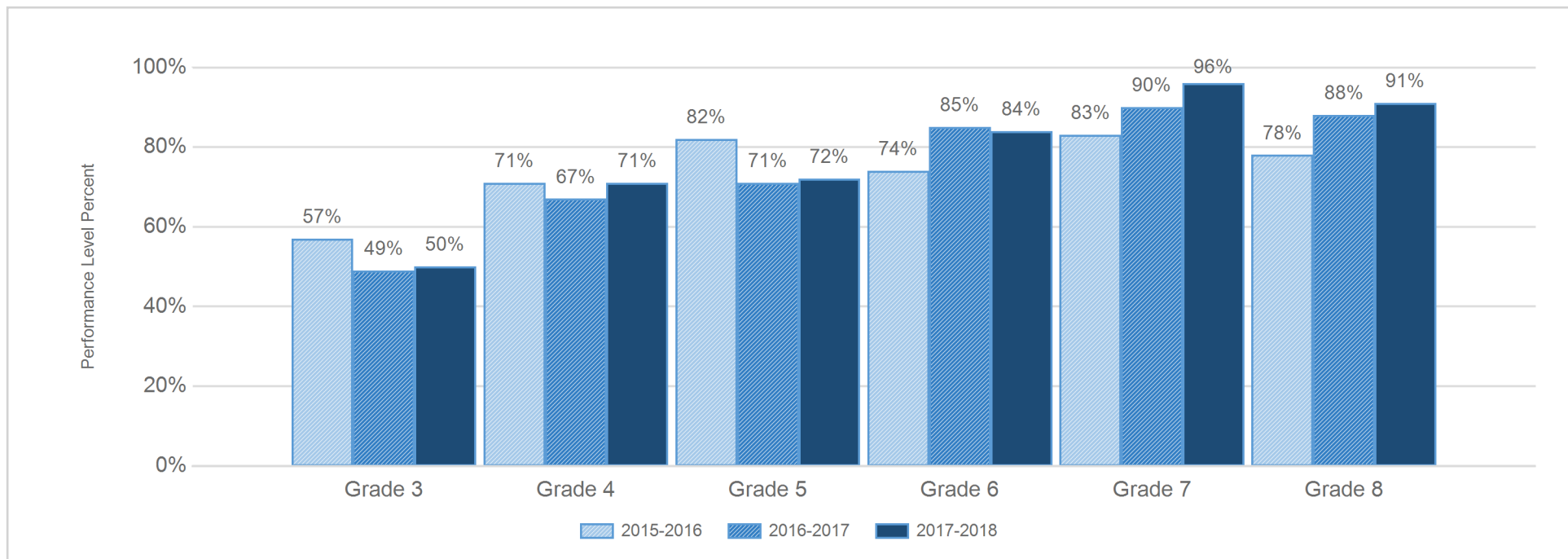

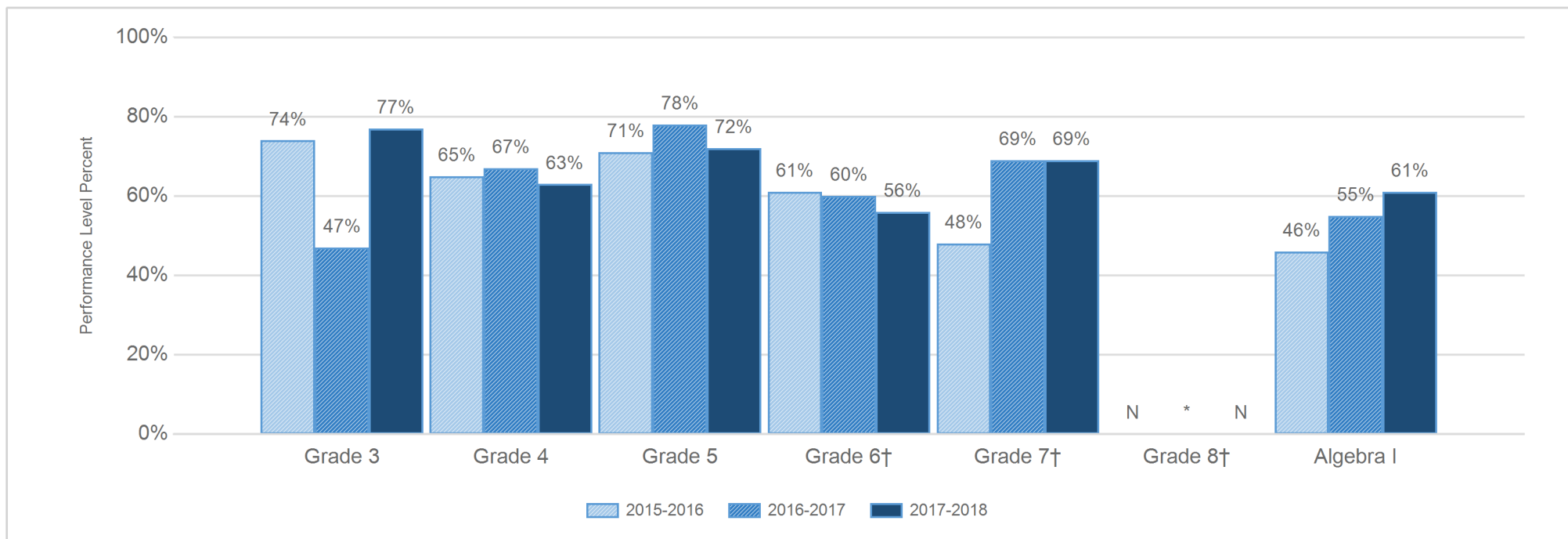

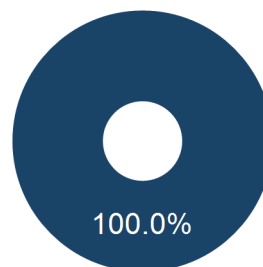

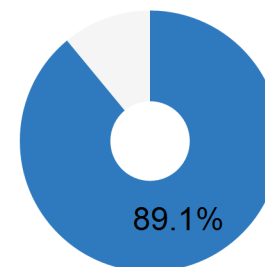

Students enrolled in one or more **visual and performing arts** classes

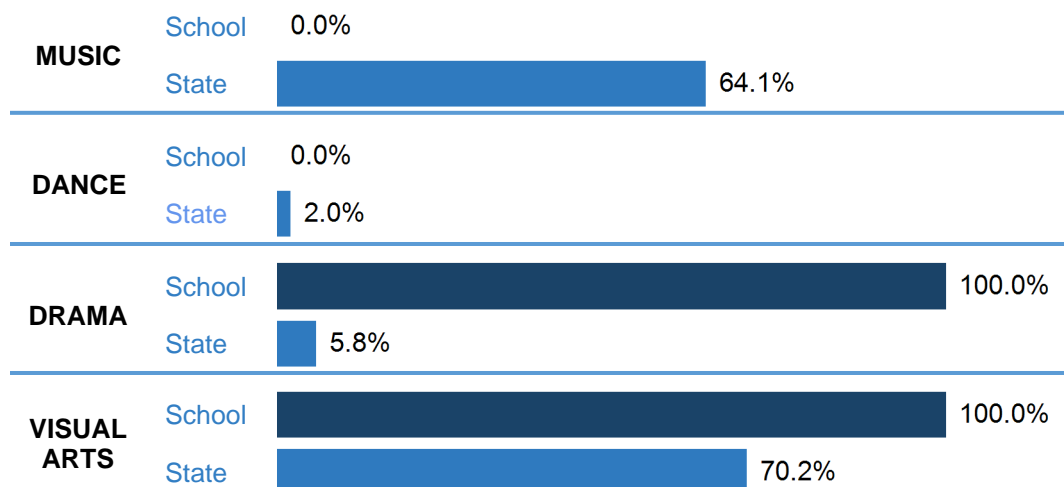

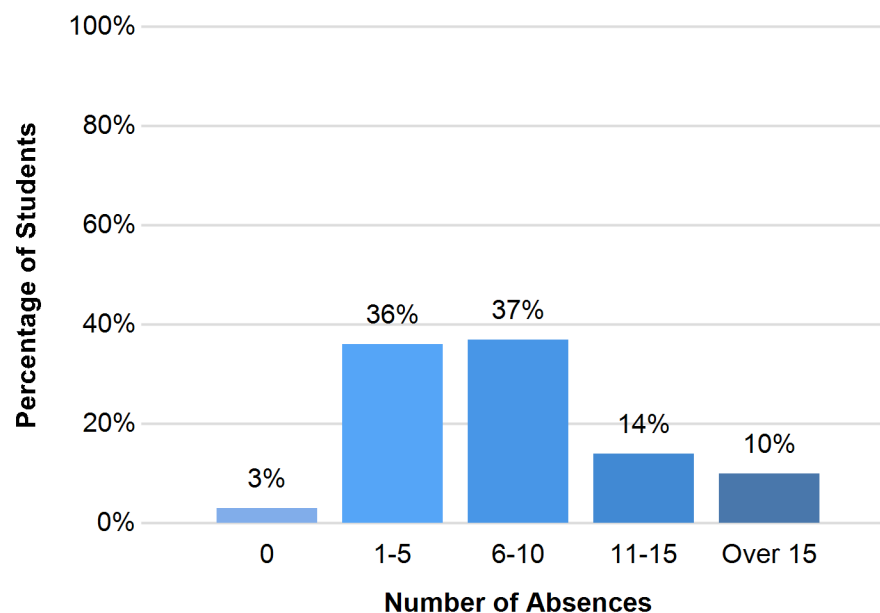

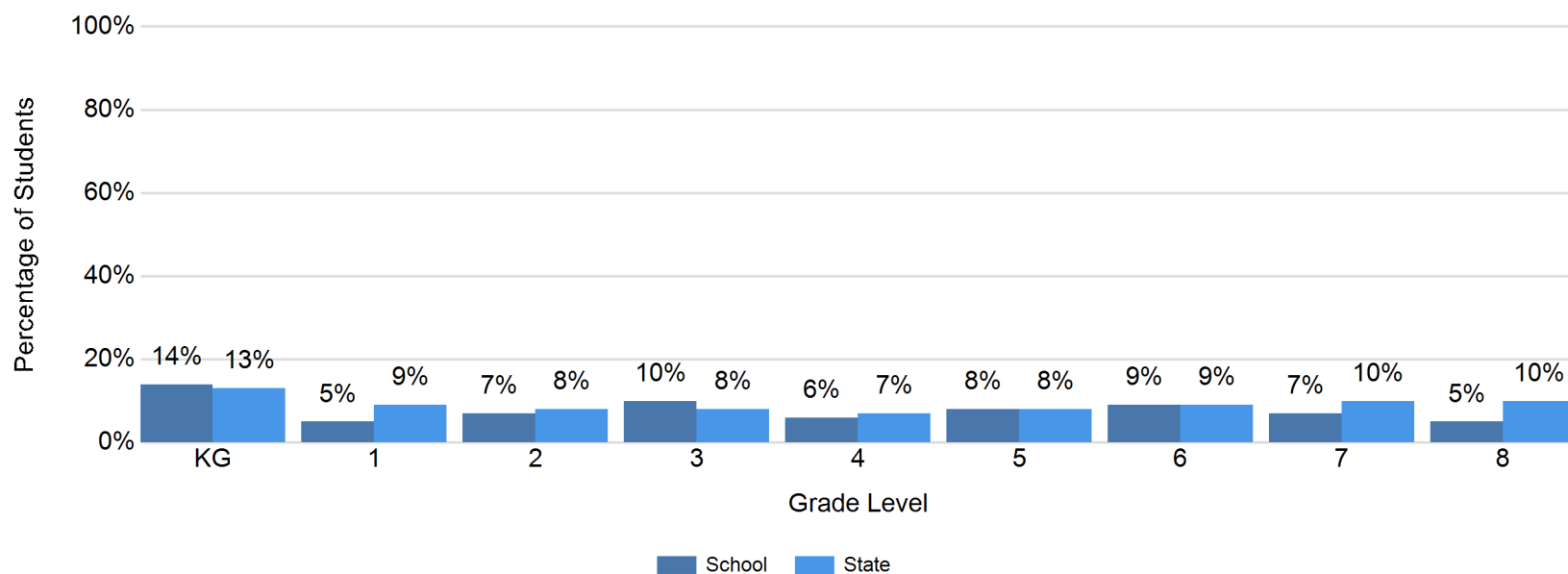

We are a NJDOE School of Choice and presently have 49 students attending from various other towns throughout Sussex and Warren County.
