Mr. Normant provided the Council with copies of Mr. McCourt's lease application. A biological investigation was not required for the lease application in Dry Bay (per N.J.A.C. 7:25-25.6(c)1). Mr. McCourt was not present at this meeting and must attend the next meeting to fulfill his requirement of attending one of two meetings at which the Council would review his application. Pursuant to the leasing regulations, a decision will be rendered at the next meeting.

#### 6. Old Business

## Relay

Mr. Joseph briefly discussed the criteria for the resumption of the hard clam relay program. He stated that in order to resume the program in 2007, certain criteria had to be met, such as funding for enforcement, adequate participation and acceptable OPX results. The OPX results indicated that most of Sandy Hook Bay would be opened to harvest. Mr. Joseph stated that an average of 10 participants per day over a 30-day period was required. At the suggestion of Council during the January 2007 meeting, it was agreed that the 30-day period would only include days when the relay harvesters indicated that they were going to work as opposed to 30 continuous workdays (a one month period). To coordinate with the Bureau of Law Enforcement on the days the relay harvesters were going to work, a relay coordinator was to be designated. Mr. Johnson stated that Mr. Edward Mulligan was designated as the relay coordinator. Mr. Mulligan indicated that several issues had come up and that they would like to suspend the 2007 relay program and try to resume the program again in 2008. Mr. Mulligan listed several reasons contributing to the decision to suspend the relay program in 2007, including: participants might not have dock slips due to the sale of the marina they were using and several individuals would only participate if cages were allowed. He stated that there were too many last minute obstacles to resume the relay this year. Mr. Joseph stated that he was concerned from the outset due to the relatively low numbers of 5A and 5B permits that were sold (13 total). Mr. Joseph inquired if it was the official position of the Council to suspend the 2007 relay and to try to resume the relay program in 2008. Mr. Johnson indicated that it was. Mr. Johnson stated that to ensure adequate participation during the relay, they would need a minimum of 20 participants to meet the participation requirement. Mr. Joseph stated that the Department needs adequate participation to justify the expense of operating the program. He also stated that the same three conditions for the relay would apply next year. Further discussion on the matter ensued. Mr. Meyer stated that those individuals that have a relay lease still must have a 5A permit.

# Lease Signage

Mr. Johnson briefly discussed signage that would be posted at local marinas advising boaters to be cautious around shellfish lease grounds. Mr. Joseph Myers from the NJ Department of Agriculture had presented the idea at the November 2006 Council meeting. The general consensus was that the original wording was

too restrictive and could cause user group conflicts. Mr. Johnson stated that after discussing the issue with others involved in the shellfish industry, Mr. Myers had come up with wording for the signage that was innocuous. Mr. Joseph stated that the signage issue was brought before the Delaware Bay Section of the Shell Fisheries Council, but no formal recommendation was made for the same reasons this Council disapproved it (i.e., the wording was too restrictive and it could cause user group conflicts). Mr. Joseph stated that he would contact Mr. Myers to attend the next meeting so the Council could make a formal recommendation to NJDA to pursue the signs. Further discussion on the matter ensued.

## 7. New Business

## Ice Breaking Operations in Northern Monmouth County Waters

Mr. Hughes stated that he had been working with the US Coast Guard over the last several days and they have agreed to send in an ice breaker into Sandy Hook Bay and up the Shrewsbury River to the Highlands Bridge to try and free it up the waters so the shellfishermen could work.

There being no further business, the meeting was adjourned on a motion by Mr. Johnson and a second by Mr. Hughes.
