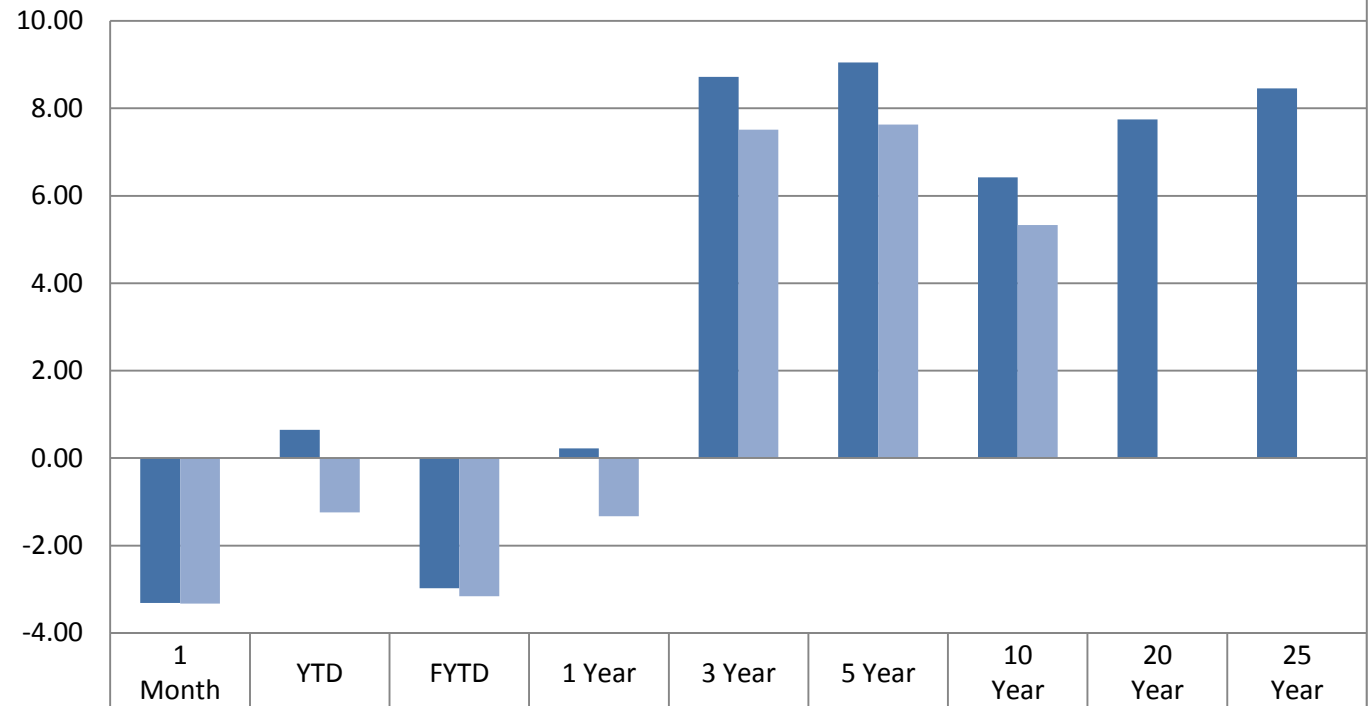

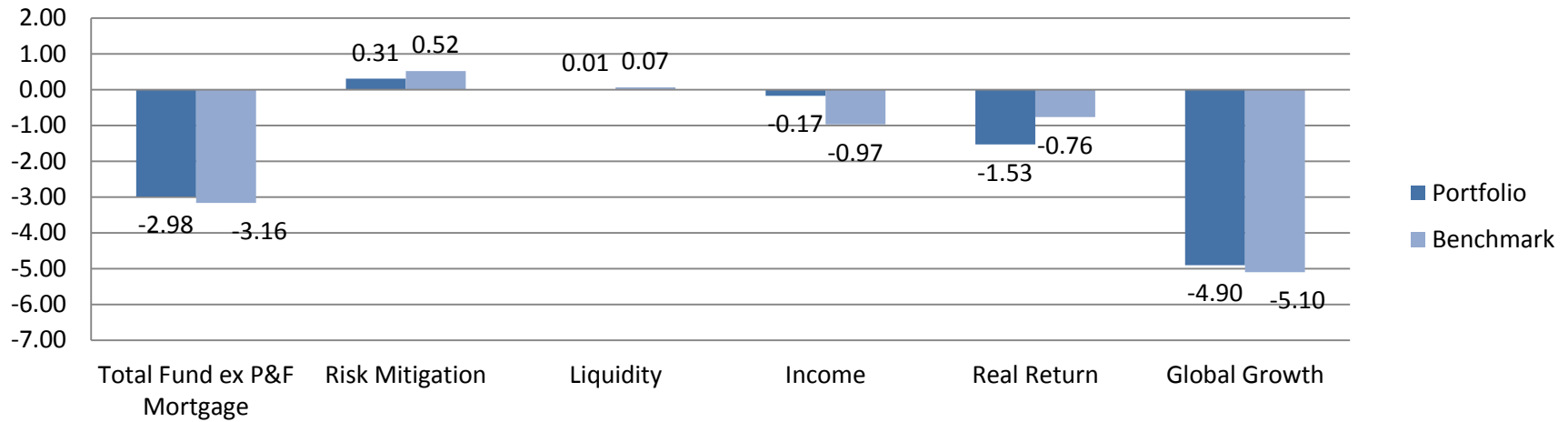
Total Fund ex Police and Fire Mortgages as of 08/31/15



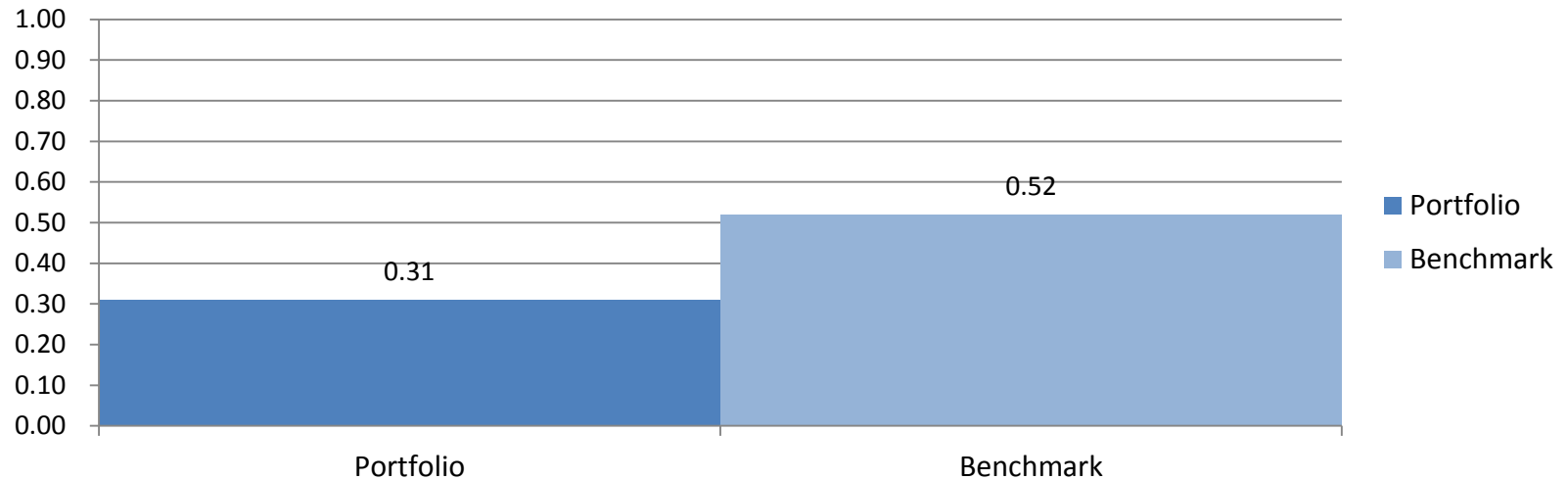

FYTD Performance by Asset Class as of 08/31/15

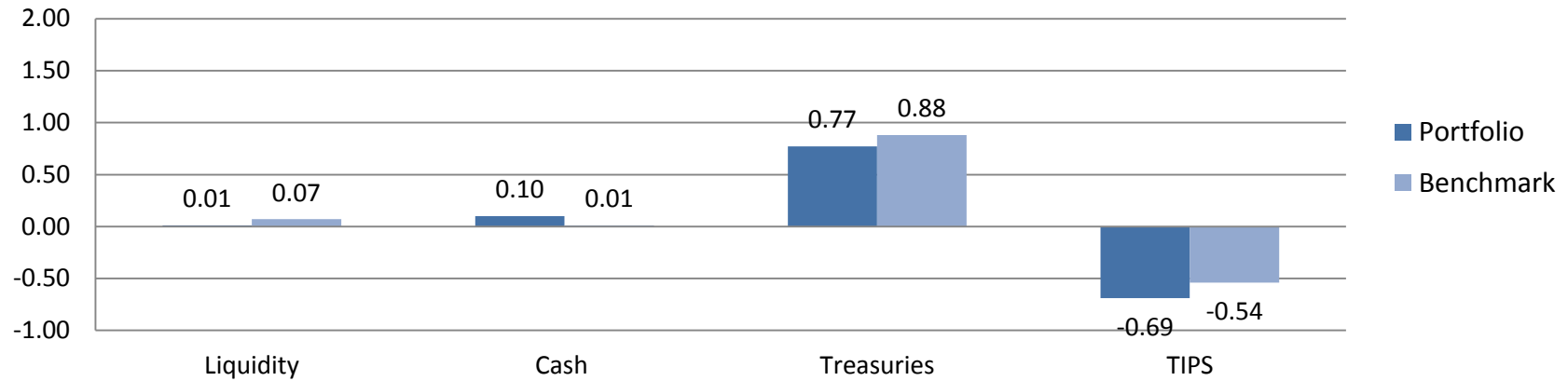


FYTD Risk Mitigation Performance as of 08/31/15

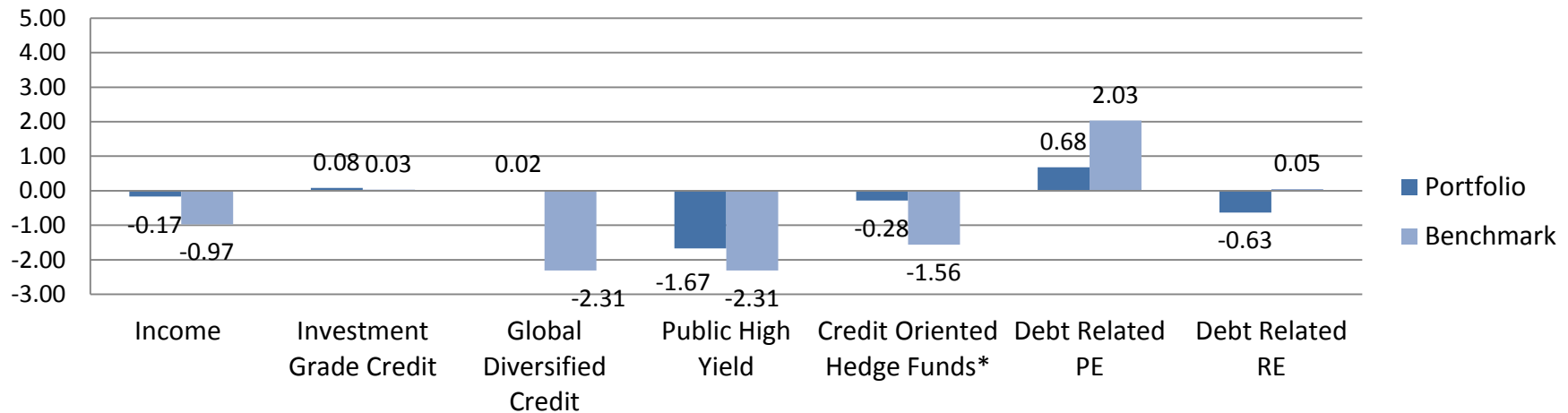

FYTD Liquidity Performance as of 08/31/15



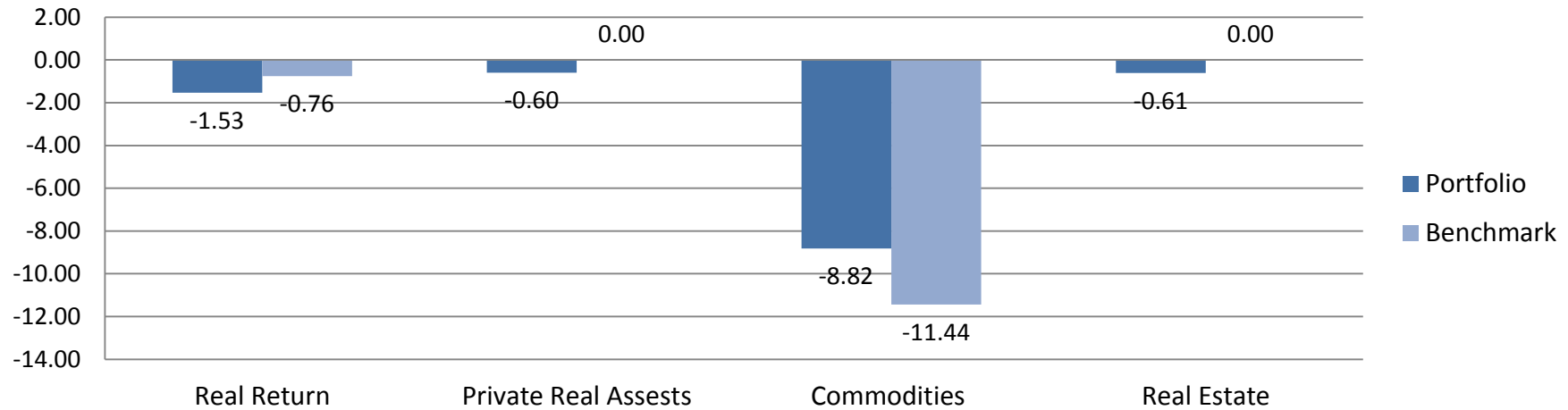
FYTD Income Performance as of 08/31/15



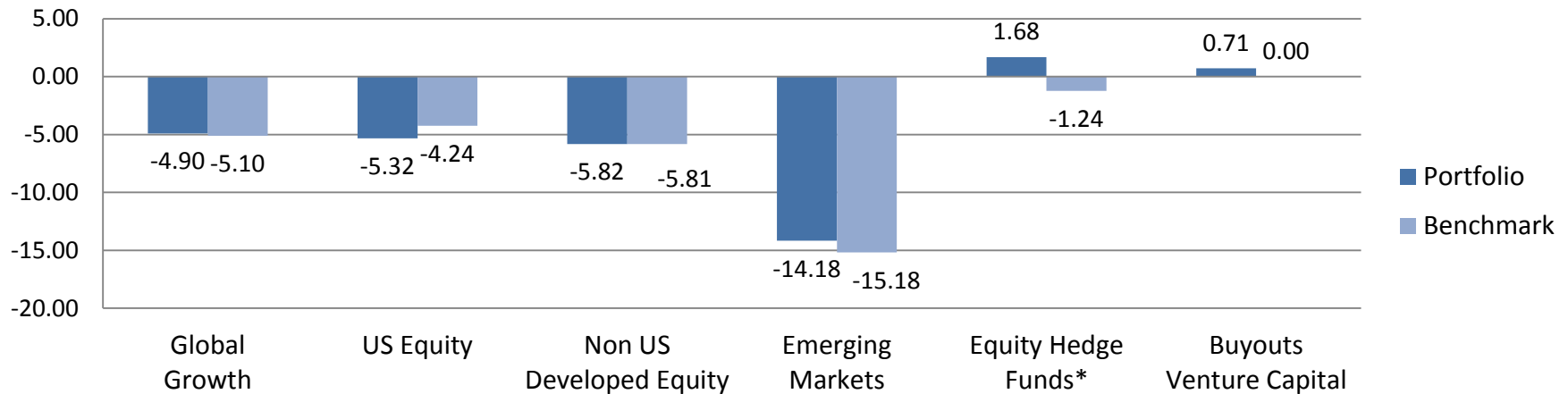

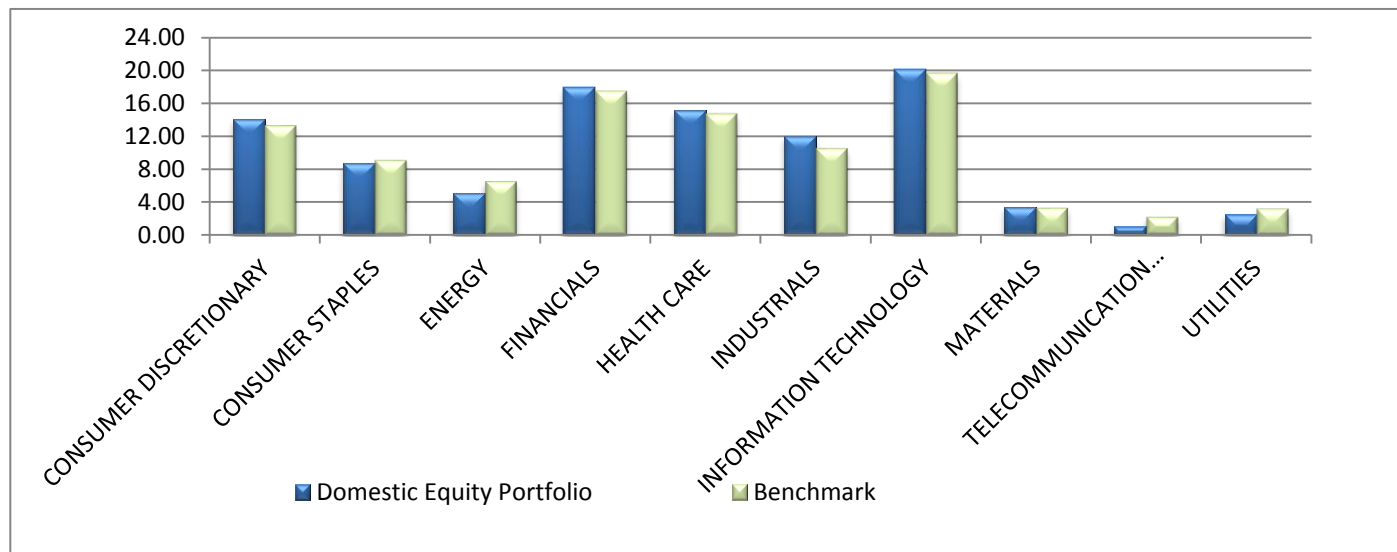

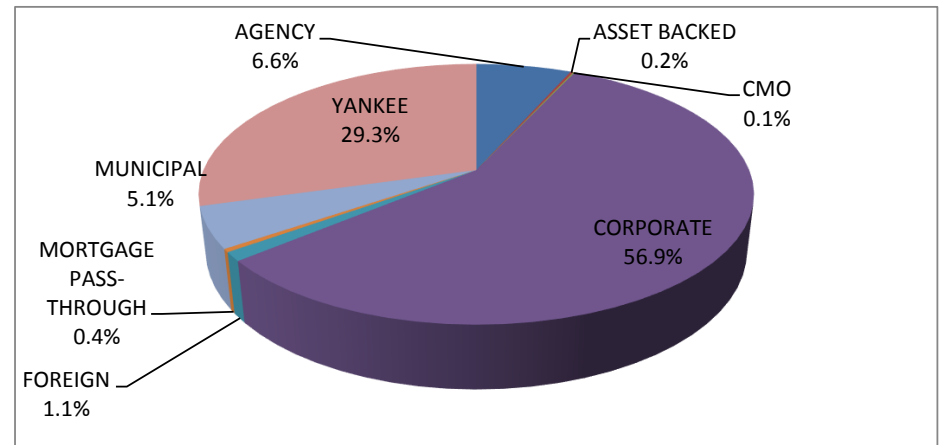

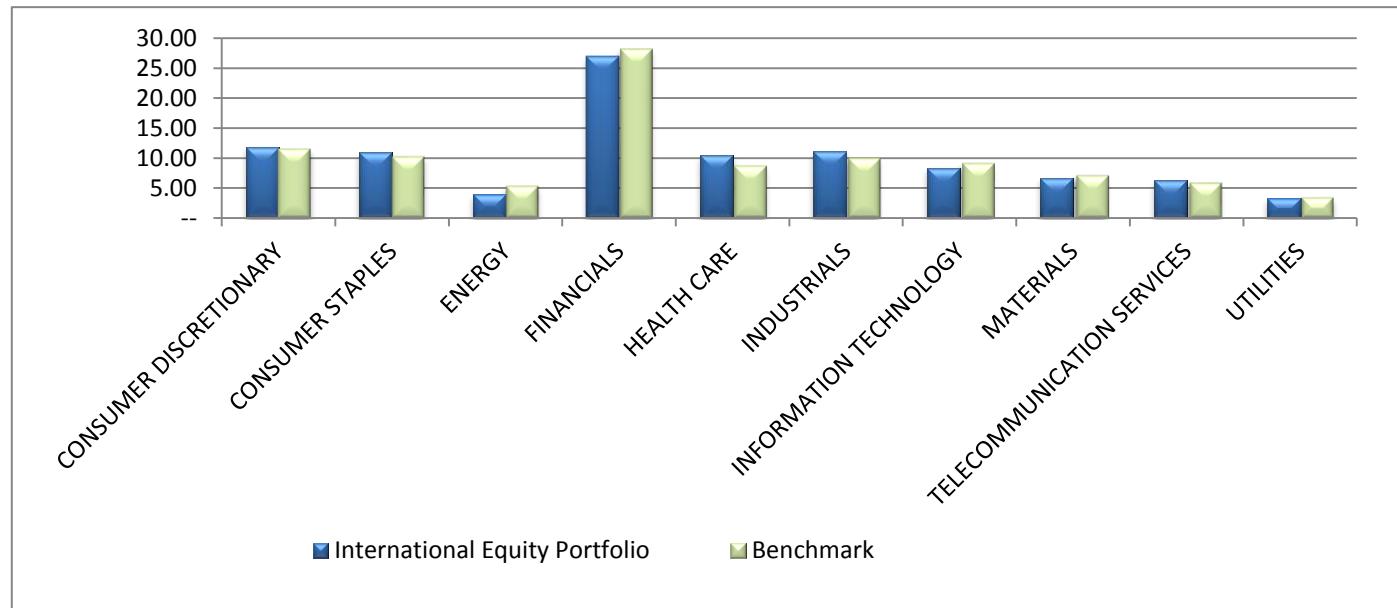

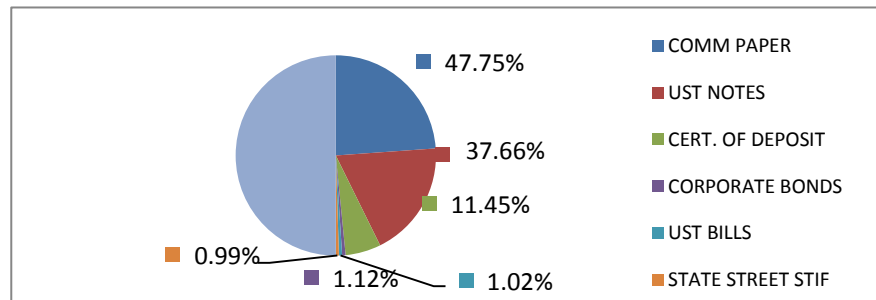
