DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS JANUARY 2022

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of January, the TANF caseload had decreased by 674 cases, from 10,512 in January 2021 to 9,838 in January 2022; a decrease of -6.4%.
- The counties with caseloads that increased the most since January 2021 were Hunterdon (18.2%), Salem (10.7%), and Union (8.9%).
- The counties with caseloads that decreased the most since January 2021 were Essex (-32.3%), Sussex (-29.6%), and Warren (-25.5%).
- Of the WFNJ/TANF cases, 2,796 or 28.4% were child-only in January 2022.
- The counties with the most child-only cases were Camden (487), Hudson (324), and Passaic (301).
- Hudson (4,017), Camden (3,592), and Essex (3,153) counties had the greatest number of persons receiving TANF in January 2022.

NJ SNAP (Formerly FOOD STAMPS)

- In January 2022, there were 468,353 households receiving NJ SNAP benefits. The number of NJ SNAP households increased by 49,089 or 11.7%, since January 2021.
- There were 902,452 persons receiving NJ SNAP benefits as of January 2022; an increase of 87,052 or 10.7% since January 2021.
- The counties having the highest caseload increase since January 2021 were Essex (23.3%), Union (14.5%), and Atlantic (14.1%).

EMERGENCY ASSISTANCE

- There were 1,196 TANF families receiving Emergency Assistance (EA) in January 2022; a decrease of 163 or -12% since January 2021.
- In January 2022, EA payments were made for 617 SSI recipients.

DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS JANUARY 2022

- There were 1,624 GA cases with Emergency Assistance payments in January 2022; a decrease of 464 or -22.2% since January 2021.
- The counties that showed the highest percent increase in Emergency Assistance payments were Salem (100%), Monmouth (34.2%), and Essex (29.4%).
- The counties that showed the highest percent decrease in Emergency Assistance payments were Cumberland (-100%), Gloucester (-66.7%), and Bergen (-64.6%).

GENERAL ASSISTANCE

- The total numbers of cases receiving GA has increased from 13,531 to 14,040 since January 2021; an increase of 3.8%.
- There were 10,239 Employable GA and 3,801 Unemployable GA cases in January 2022.
- The counties that showed a percent increase for GA cases were Camden (21.6%), Hunterdon (20.2%), and Atlantic (18.3%) since January 2021.
- The counties that showed the highest percent decrease for GA cases since January 2021 were Warren (-22.3%), Sussex (-20.8%), and Gloucester (-20.7%).
- In January 2022, GA cases showed a 1% increase since December 2021.

CHILD SUPPORT SERVICES (QUARTERLY REPORT)

- The total collection for the Child Support Services Program was about \$270 million from October 2021 to December 2021; a decrease of -8.3% over the same period from FFY 2021.
- Total distributions decreased -11.7% from December 2020.

WORK FIRST NEW JERSEY (WFNJ)

- During the report month of January 2022, there were 278 families in which at least one member was employed and an additional 71 families whose WFNJ assistance cases were closed due to employment related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (53), Hudson (52), and Atlantic (28).
- There were 217 former TANF cases receiving post-TANF support in the form of child care assistance.












Statewide NJ SNAP Persons: JANUARY 2020 Through JANUARY 2022







ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as NJ SNAP (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKiDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA) of 1996. PRWORA established Temporary Assistance for Needy Families (TANF) as the replacement for AFDC cash assistance. WFNJ includes two segments, WFNJ/TANF for families with children, and WFNJ/GA (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
