REPORT.

To His Excellency Leon Abbett, Governor of New Jersey :

SIR—Permit me to submit the following report of the condition of the State Library for the fiscal year ending October 31st, 1886 :—

According to the last annual report the whole number of books, papers, magazines and pamphlets in the Library was 30,984. During the past year the following additions have been made by exchange, donation and purchase :

By exchange from other States and Canada.....	248

Making the whole number of books, pamphlets, magazines, &c., now in the Library.....31,970

In fact, the reports of the last three years show that the natural increase of the Library, from all sources, is about 1,000 volumes a year.

In the above schedule it will be seen that 222 law books are placed in the purchase account. It should be mentioned, however that 119 of the volumes are statutes of the various States, obtained to complete the sets in the Library, as shown in the appendix.

It was stated in the last report that there were many books requiring new binding. Since the additional appropriation of \$1,000, by the last Legislature, about 200 books have been repaired and rebound, and many more in the hands of the binder will soon be ready for use. *The additional appropriation has also discharged the debt of the Library, amounting to about \$750, which had previously been carried over from year to year, besides meeting the current expenses of the year.

Permit me to make special mention of the fact, recorded in the Appendix, that the Library is particularly indebted to Judge Manning M. Knapp, of the Supreme Court, for a fine cabinet portraiture of Chief Justice Shaw, of Massachusetts, and to Ferdinand J. Dreer, Esq., of Philadelphia, for rare proof

portraits of Governor Joseph Bloomfield, and Judge Bushrod Washington, together with cabinet engravings of Chief Justice Marshal, Judge Storey, Benjamin Franklin, Gilbert C. Stuart, Dr. E. Shippen, Rufus King, Oliver Ellsworth, John Rutledge, Herbert Spencer, O. W. Holmes, S. I. Prime, and Galileo, all of which have been properly framed and hung around the Library.

It is gratifying to be able to report that the interest in the rare and valuable art works of the Library is on the increase, and that students and amateurs frequently make copies of artistic designs.

During the year there were 1682 enrolled visitors at the Library, exclusive of members of the legal profession, State officials and members of the Legislature.

The accompanying Appendix presents an itemized statement of the additions made to the Library.
