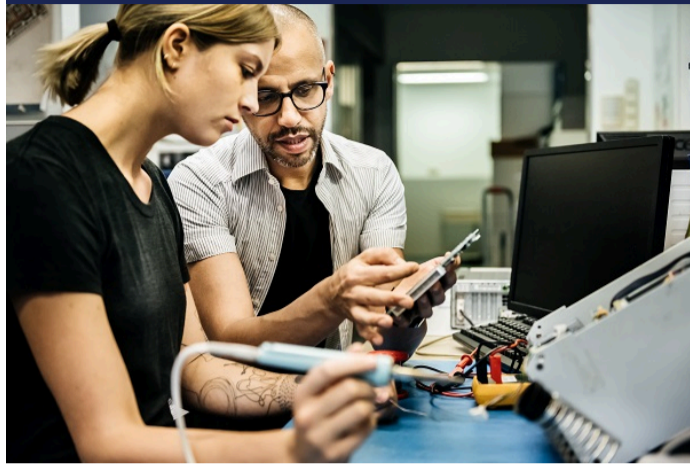

Purpose for Which Funds will be Used: The purpose of the NJYC program is to implement a statewide coordinated service system designed to help disconnected out-of-school youth, ages 16-25, without a high school diploma, reengage in educational, training and employment opportunities for a sustainable long-term career development. NJYC will provide full-time, cohort-based education and community service learning projects, individual counseling, and transition services designed to help Corpsmembers resolve barriers, obtain a High School Diploma (by way of equivalency exam) or other measurable skill gain, and transition to a qualified post-corps placement along an identified career pathway.

The Fiscal Year (FY) 2025 NJYC continuation grant will be for year 4 of a 4-year grant cycle, and is only available to current FY 2024 NJYC grantees to apply.
