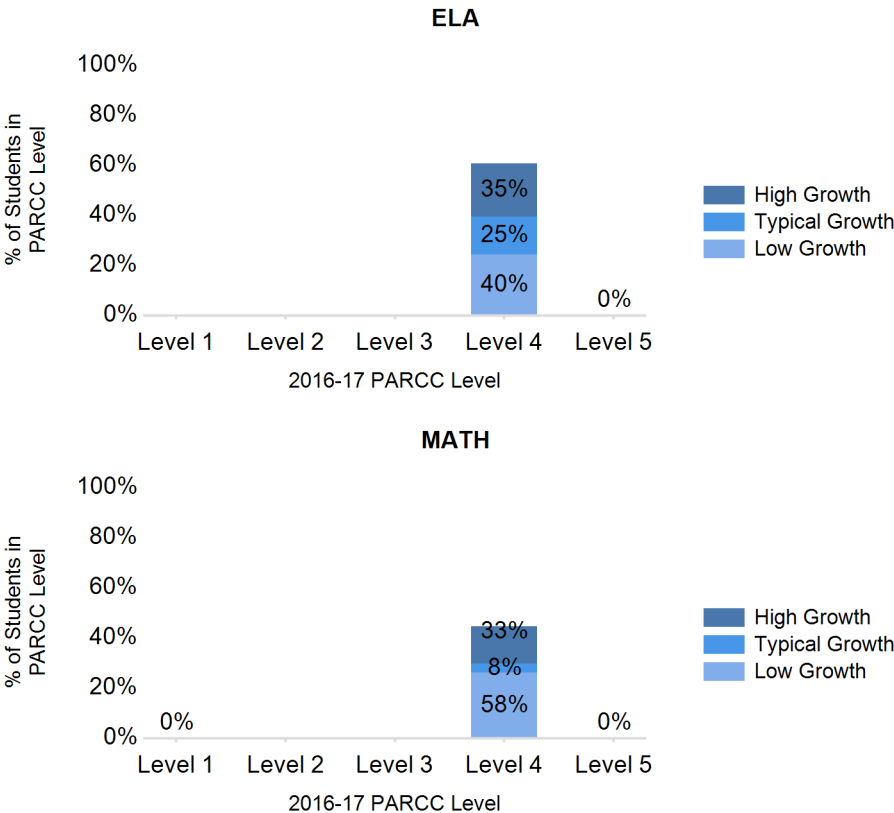

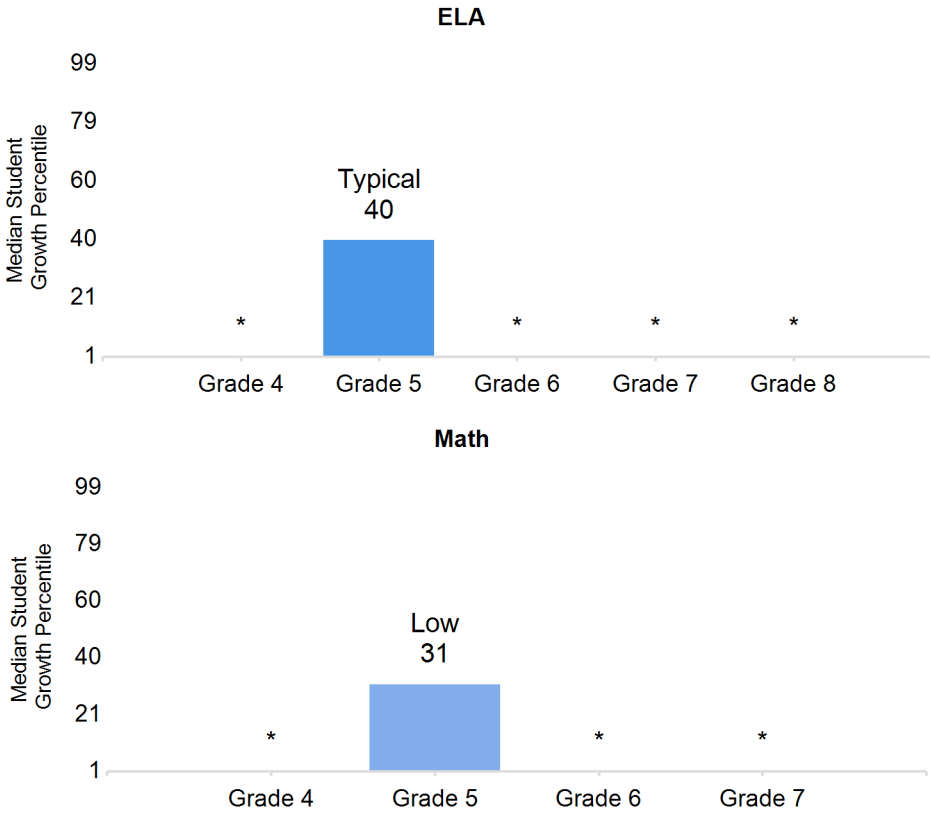
Student Growth by Performance Level

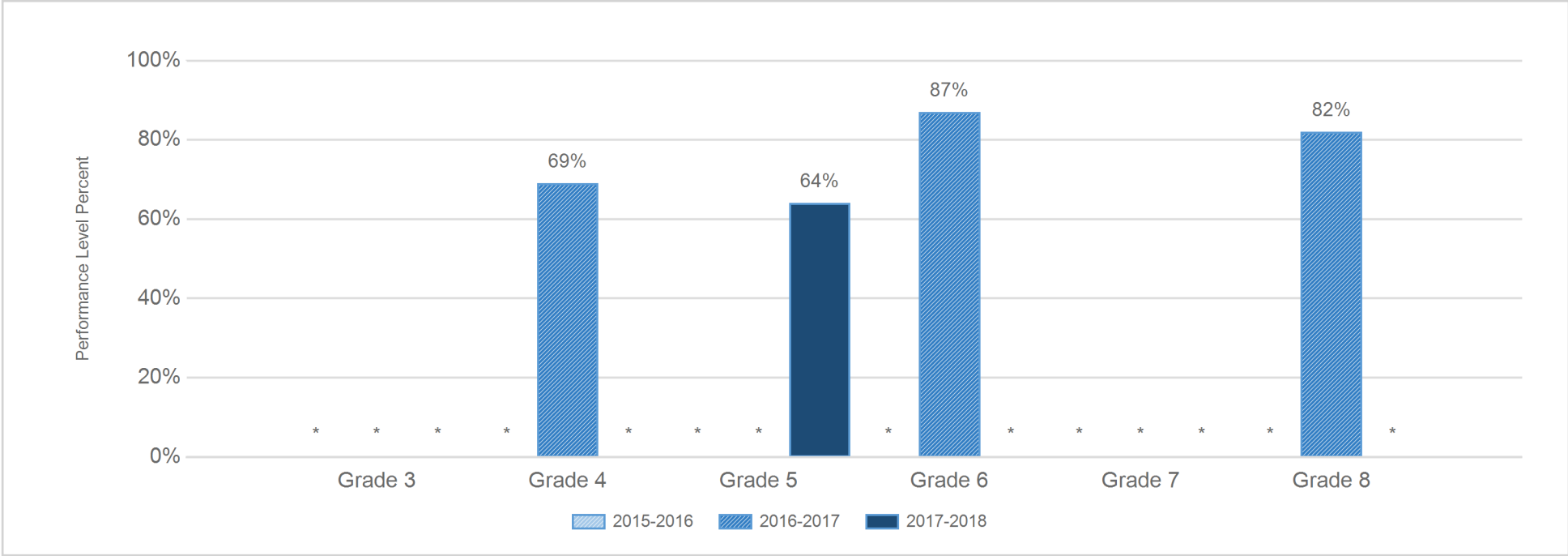

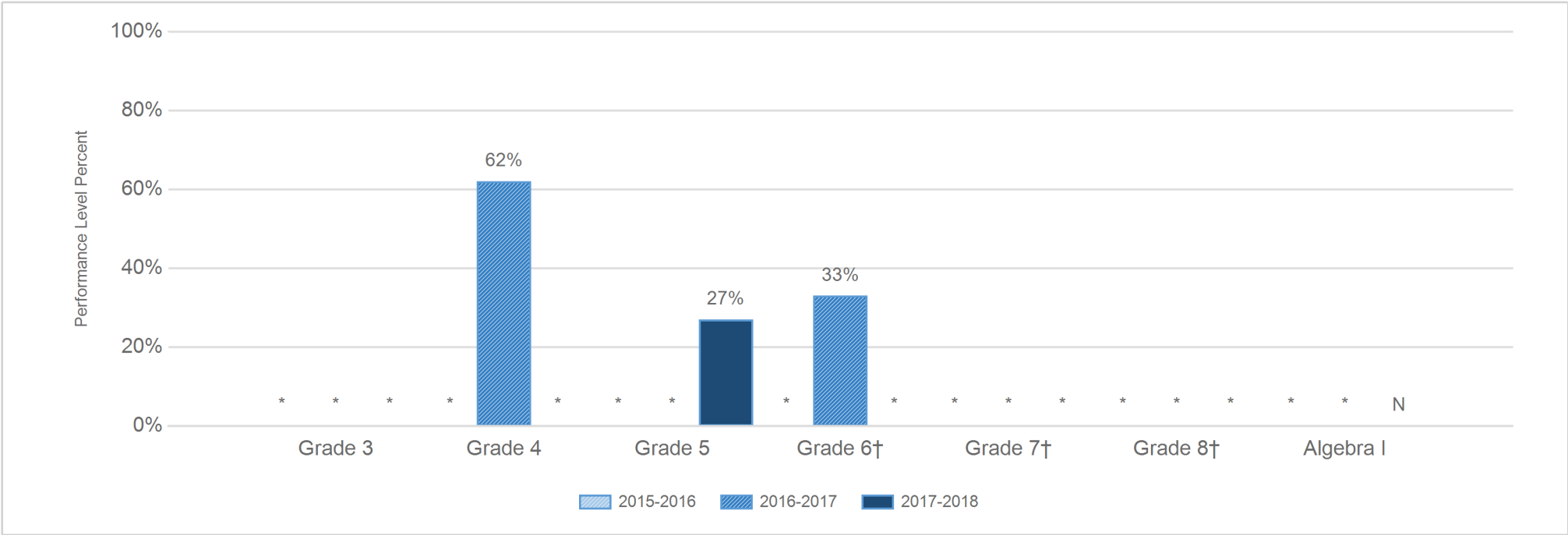

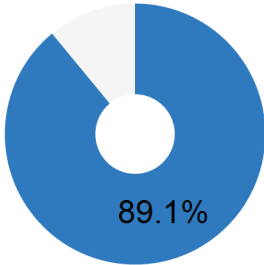

Students enrolled in one or more **visual and performing arts** classes

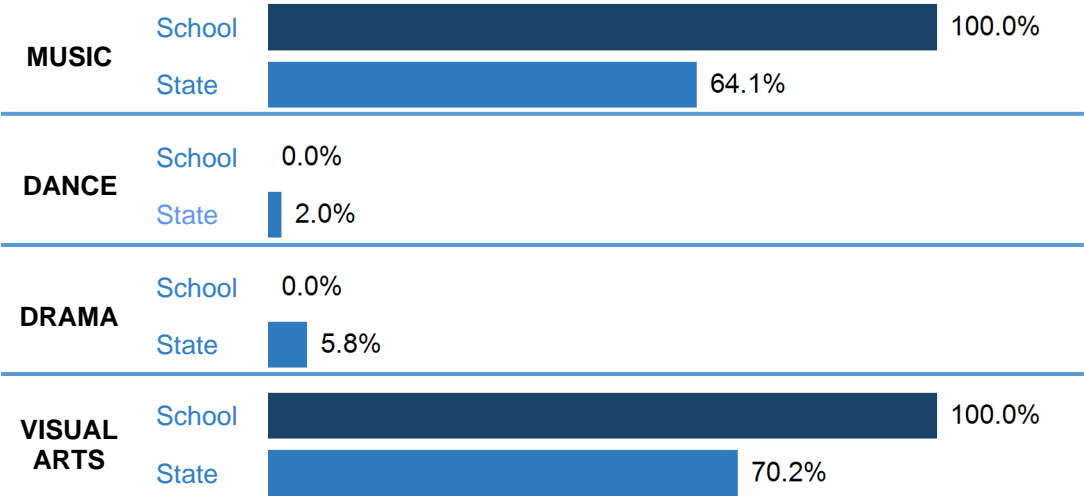

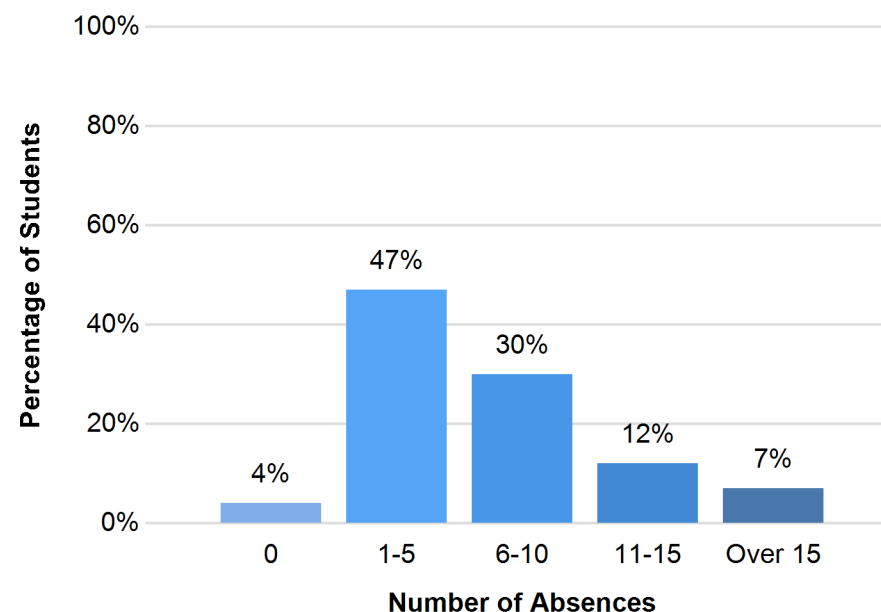

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.





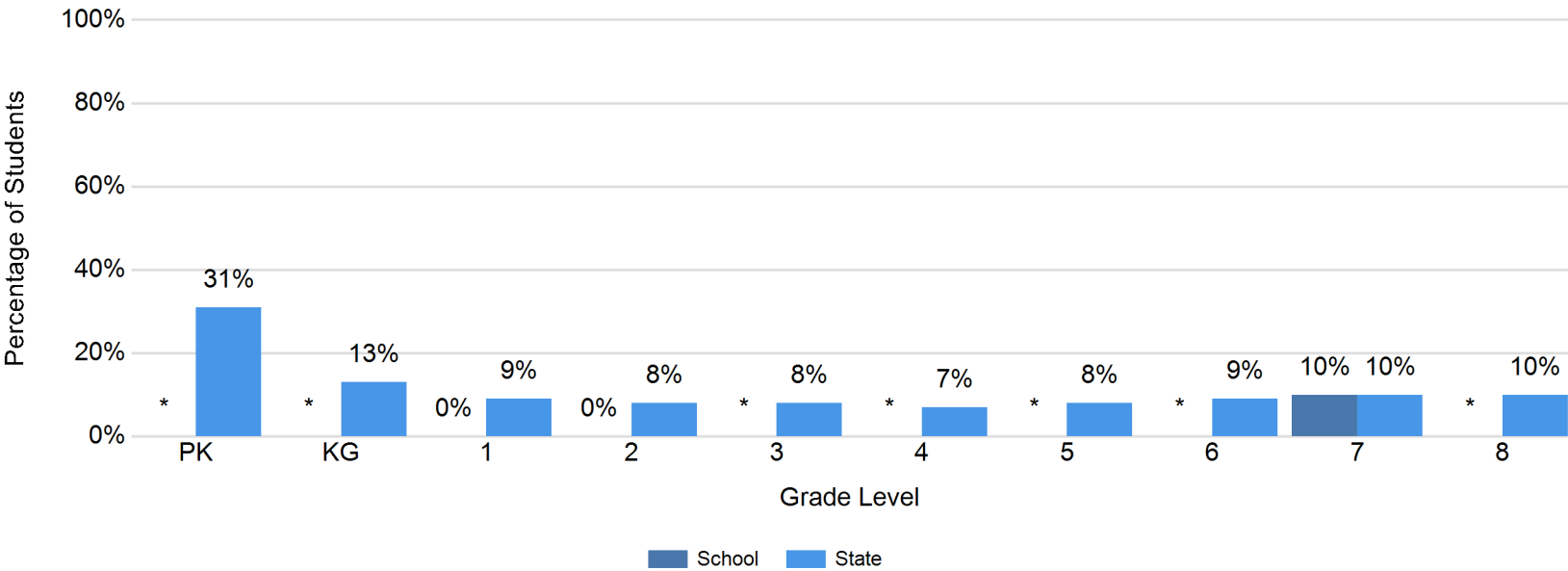

Student Health and Wellness:

The District offers breakfast and lunch programs for all students. Students take part in Physical Education and Health three days per week with 50 minutes per period. Physical Education classes take part both in the school as well as at the local field. Students also have daily recess. Our school nurse infuses health and wellness into the classes through Heimlich Heroes, CPR classes, Optical Academy, Blood Drives, Flu Shot clinics, and presentations by our local police departments regarding drugs, alcohol and bullying.
